++ CDC declares medical police state, announces power to detain the sick and punish those who do not comply

by L.J. Devon, Staff Writer (NaturalNews) Sinister, hidden motives are being revealed at the <u>U.S. Centers for Disease Control (CDC)</u>. The agency recently announced a new invasive plan for the "control of communicable diseases," by detaining people suspected of being ill and then forcibly <u>medicating them against</u> their will.

The CDC's new proposal, published in the Federal Register [#2016-18103], will give the agency police state powers, permitting CDC officials to detain and forcibly inject chemicals into anyone they deem a threat to public health. There's no rationale for such detainments either. According to the proposal, the "CDC defines precommunicable stage to mean the stage beginning upon an individual's earliest opportunity for exposure to an infectious agent."

This proposal is an open declaration that the U.S. government now owns your body. At least that's what the CDC seems to be claiming. The truth of the matter is that each individual has certain inherent, inalienable human rights that must be defended. Each human owns their own body, and should never be legally bound to become the government's property for forced injections or experimentation. Vaccines cause severe health problems; even the kangaroo court system set up by the Vaccine Injury Compensation Program cannot keep up with the increase in cases of realized vaccine damage. Thousands of cases of such damage are dismissed by the court, and in spite of this, over 3 billion in select payoffs have been issued to vaccine injured families since the court was established. (The court basically functions to give vaccine manufacturers immunity from judicial accountability.)

The CDC wants to hear from you about their proposed power trip rule. This is an excellent opportunity to tell the agency exactly how nefarious and overreaching their new proposal is.

If the CDC takes on these new powers, all they will need is for the media to build up enough public fear against some new strain of virus, for a new vaccine to be introduced and forced on the public. Anyone who dares to ask questions or refuse could then be forcibly injected and jailed. As the proposal reveals, "... individuals who violate the terms of the agreement or the terms of the Federal order for quarantine, isolation, or conditional release (even if no agreement is in place between the individual and the government), he or she may be subject to criminal penalties."

Be aware that there is a coordinated, global effort to indoctrinate and force people into vaccine and pharmaceutical obedience. You are not only viewed as a subject without rights, but according to internal WHO documents, you are viewed as an adversary who needs to be psychologically manipulated into believing in vaccine "science." If this new CDC rule goes through, it's not unrealistic to assume that any information you give out as you declare your opposition to forced injections could be used in the future to track you down and inject you against your will.

If this course of action sounds familiar, you're probably thinking of the <u>medical</u> experimentation that was forced on Jews during the holocaust. When the Nazis claimed ownership over Jewish people's bodies they eventually used police state power to round them up and do whatever they wanted with them in the camps. In essence, the CDC's new rule gives the government authority to incarcerate Americans en masse, relocating them to camps to be medically experimented on with vaccines and other pharmaceutical products.

Personal protection (by whatever means) has never been more important, as the CDC accelerates this same type of Nazi ideology by claiming ownership over your body. Furthermore, it wouldn't be hard to unleash a United Nations global police force into neighborhoods to round up vaccine dissenters. If the government claims ownership over your body, and has the military power to do whatever they want, people will take orders and do their jobs, no questions asked. As the document states,"When an apprehension occurs, the individual is not free to leave or discontinue his/her discussion with an HHS/CDC public health or quarantine officer."

Finally, the document reveals that the <u>CDC</u> is doing away with informed consent altogether, (even though the American Medical Association still upholds it): "CDC may enter into an agreement with an individual, upon such terms as the CDC considers to be reasonably necessary, indicating that the individual consents to any of the public health measures authorized under this part, including quarantine, isolation, conditional release, medical examination, hospitalization, vaccination, and treatment; provided that the individual's consent shall not be considered as a prerequisite to any exercise of any authority under this part."

Take action now while the CDC is still open to public comment.

New Forced Vaccination Law Rolling Out Soon

Federal health officials are upping the ante in the high stakes chess game that industry, government and medical trade have been playing with the freedom of the American people for a long time. Act NOW to protect your and your family's health freedom. During the last days of summer, while we were vacationing, shopping for school supplies or, in the case of Virginia families, while we were busy pleading with legislators to protect the medical and religious vaccine exemptions in state vaccine law. 3.4

Public health officials at the U.S. Centers for Disease Control and Prevention (CDC) were quietly publishing a very long Notice of Proposed Rulemaking (NPRM) in the August 15, 2016, <u>Federal Register</u> to amend federal public health law.⁵

The part of the Public Health Service Act they want to strengthen is the part that gives them power under the U.S. Constitution^{6,7} to restrict the freedom of a person entering the U.S. or traveling between states if they believe the person is infected or could become infected with certain kinds of communicable diseases.⁸ You only have until October 14, 2016, to make a public comment to the CDC and contact your legislators in Congress, so please take this seriously because what the CDC is proposing applies to all Americans who travel outside the country or between states, especially on commercial airlines.

In the future, it could extend to any form of transportation when you cross state lines, including by bus, train or car.

Involves States With Police Powers

This Notice of Proposed Rule Making (NPRM) involves the participation of federally funded state health departments and state facilities, too, because the majority of police power to detain, isolate and quarantine citizens belongs to the states.^{9,10}

Many state legislatures, which have legal authority to pass laws controlling communicable diseases within state borders, voted to give public health officials expanded police powers after September 11, 2001, by adopting the Model State Emergency Health Powers Act (MSEHPA)^{11,12,13} and The Turning Point Model State Public Health Act,¹⁴ created at Georgetown University's Center for Law and the Public's Health and the CDC Collaborating Center Promoting Health through Law.

If this NPRM is implemented and the states follow suit, you and your children could be vulnerable to detention and quarantine if health officials decide you are,

or could become, a transmitter of measles or other infections because, for example, your electronic medical records reveal you have not gotten every dose of every CDC recommended vaccine.

Let's not forget that no government agency, corporation or person who creates, produces, sells, licenses, recommends, mandates or administers a federally recommended vaccine to you or your child, has accountability or liability in a court of law in front of a jury of your peers if you become brain damaged or die from vaccination. 15,16,17

As The Antichrist Preps His Appearance, Over 300 Denominations (Including Baptists, Protestants and Evangelicals) Join The Pope In Push Toward One World Church

Some 1,700 Christians from around 300 denominations have met in Munich for a 'Together in Europe' gathering of the Ecumenical Congress promoting unity between Catholics, Protestants and Evangelicals.

In a meeting supported by Pope Francis and Orthodox Patriarch Bartholomew I, leaders of the Catholic Church, the Anglican Church, several Orthodox Churches, Protestant denominations and free evangelical denominations including some Baptists and Pentecostals debated for three days about how to walk towards "encounter, reconciliation and hope in a better future."

Among the speakers were the German Catholic Cardinal Walter Kasper, Evangelical Protestant Bishop Heinrich Bedford-Strohm and German Evangelical Alliance Secretary General Hartmut Steeb. Pope Francis and Orthodox Patriarch Bartholomew I of Constantinople sent video messages to the meeting.

"We want to contribute towards reconciliation of Christians and of Churches," the organizers said on their website. "Through our witness of unity and reconciliation we also hope to impact on society as a whole. We want to encourage all people of our time to respond with a decisive and hopeful yes for going ahead together and overcoming barriers among people, nations, social and cultural groups."

The Congress finished with an open air rally attended by around 5,000 people under the banner: "500 years of division is enough – unity is possible". German YMCA leader Gerhard Pross said: "The division amongst Christians in Europe is a wound, but it does not have to be open forever...500 years are enough."

DARPA Investing Tens-Of-Millions For Mind-Control Microchips; NBC News Says "Chipping" Of Children By States Will Be "As Normal As Bar Codes" Starting In 2017

The Defense Advanced Research Projects Agency (DARPA) is in the process of making a neural-coding device capable of controlling artificial limbs when seeded in the brain. The device has had success in animal studies and the first human trials are set

for 2017. The Pentagon has subsidized the institution \$62 million to help foster this mind-control technology. Meanwhile, the mainstream media is pushing for the micochipping of children sooner rather than later.

During a recent televised report by *NBC News*, the news station purported the micro-chipping of children by the state was as normal as bar codes for consumers: "When barcodes first came out in the late 1960s, people were appalled. They were wary of them and did not understand the concept. Today, it is so commonplace, we don't even notice it. A microchip would work much in the same way."

This declaration is a reflection of the mentality of the mainstream media, which sees people as objects fit for labeling rather than persons with intrinsic moral value. Although DARPA touts the brain chips as a way to protect children, in actuality, this sort of technology has more to do with control than it does public safety.

Whenever the establishment wants to control the masses, they assemble a list of cheap talking points to scare the population into abiding by its agenda. Whenever the mainstream media <u>pushes for vaccines</u>, for instance, they list all the possible ways a person may become very sick and die if they don't get the shot. And whenever the government wishes to corrode privacy rights, they do so in the name of "protecting" the public from would be "terrorists."

Several pet owners have already microchiped their dogs to keep tabs on their pets. Therefore, microchip proponents argue, it is not too much of a stretch to start micro chipping children at birth for similar purposes. The problem is most people are not aware of the dangers this reasoning poses, which is why mind-control technology is not being more widely opposed.

According to a statement made by DARPA, the brain chip would:

"[Enable] data-transfer bandwidth between the human brain and the digital world, feeding digital auditory or visual information into the brain." and thereby "open the channel between the human brain and modern electronics."

In short: They are developing mind control chips that can be inserted into the brains of babies from the cradle.

As the *Waking Times* explains, the military deploys a term known as "mission creep," which refers to the expansion of a military project beyond its original goals that has yet to foster public support. If the military wants to invade a country, for example, they will first take over nearby regions and establish a military base around the desired country in an effort to boost the likelihood of winning. In the same way the public has been coerced into a number of unjustifiable wars, DARPA is now trying to coerce the public into submitting to mind control.

Last year, <u>CEO of Google</u>, Eric Schmidt, attended a Bilderberg conference with former DARPA employee and Google executive Regina Dugan, where he voiced support of DARPA's technology.

"If you have something that you don't want anybody to know, maybe you shouldn't be doing it in the first place," Schmidt said.

"We don't need you to type at all because we know here you are, with your permission, we know where you've been, with your permission, we can more or less guess what you're thinking about," he continued.

Without doubt, the mainstream media and DARPA will continue to tout the benefits of this technology without noting all the risks. Due to this, it is on the shoulders of the alternative media to ensure the public isn't trolled by mind control.

Moscow "Designer Babies And Human Enhancement Forum" Says Half Of All Children Will Soon Be Genetically Engineered... Same-Sex Couples Will Have Offspring Made Of Both Partners DNA... Single Persons Will Have Eggs & Sperm Created From Their Skin Cells Enabling Them To Be Both Mother And Father Of GMO "Children"...

Moscow - The InLiberty.ru classical liberal think thank invited me to lecture on the topic of Designer Babies and the Ethics of Human Enhancement. The lecture took place in July at the DI Telegraph building in central Moscow and was attended by around 300 people. I began by describing the techniques such as pre-implantation genetic diagnosis used now to test and select IVF embryos that are free of specified genetic diseases.



I moved on to describe how Stanford University bioethicist Henry **Greely believes that in** about 40 years half of all American babies will born using what he calls Easy PGD. **Basically, Greely** argues in his new book The End of Sex and the Future of **Human Reproduction** that most people will use gametes produced from their skin cells to

create scores of IVF embryos that will each have his or her entire genomes sequenced. Prospective parents will then choose among the embryos based on which combination of genetic traits they would prefer. Presumably they would tend avoid those embryos afflicted with debilitating genetic diseases.

Greely believes that Easy PGD will be extremely cheap, e.g., whole genome testing should fall to around \$10 by the beginning of the next decade. Easy PGD would also make it possible for same sex couples to have offspring genetically related to both parents and it might even be possible for a person to have both

sperm and eggs created from their skin cells, enabling them to be both mother and father of their child.

Interestingly, biologist Craig Venter, the leader of the group that raced the government to a tie in sequencing the human genome, and now founder of the life extension company Human Longevity, Inc. can <u>sequence a fetal genome</u> and give the mother "a picture of what her future child will look like at 18."

Further in the future, I discussed the possibilities of new whole genome editing techniques like CRISPR to generate transplant organs for people inside of animals and the cure of diseases. And with regard to radical life extension, I noted that Harvard biologist George Church has suggested that it might be possible to reverse the aging process in the next five years or so. Then I looked at a number of companies that are already working on treatments that they hope will slow and perhaps stop aging.

Something More Than They've Admitted? NASA's New "MINION" DNA Sequencer On The International Space Station Was Created TO WORK ON ALIENS (Note: In Ancient Times A "MINION" Was Something Under Satan's Influence Or A "Little Creature" You Could Summon)

The regular resupply missions to the International Space Station include the basics like food, but all sorts of new science toys as well. In the Dragon capsule that docked with the station several days ago, there was one particularly interesting device — a DNA sequencer. It's called the MinION, and it's tiny at just 120 grams. That's probably lighter than your smartphone, but it could do some big science up there.

The MinION operates a bit differently than DNA sequencers on Earth, but that's by design. NASA wants to be prepared for any kind of sample, even an alien one. NASA explains that any sufficiently large polymer could be analyzed by the MinION. If we did encounter some unknown life on Mars or some other planet, we don't know for sure they will have DNA. However, if it's something like DNA, the MinION should be able to provide some data on it. Physicists Weigh In On Dimensional Doorways, Warn CERN Stargate "Awake" Experiments Really Could Open Destructive (Demonic) Portals As Described In Best-Selling Book "On The Path Of The Immortals"

Two weeks ago, the first of a revolutionary series of experiments sent a proton beam hurtling through the Super Proton Synchrotron (SPS) and into an empty plasma cell. (Photo: video screenshot) On June 24, while scientists in Geneva were concentrating on a complex underground experiment in the world's largest physics lab, spectators outside the facility were shocked to see unusual cloud formations hovering above. The spectacular clouds were accompanied by lightning, adding to the dramatic effect.

This idea may not be so far-fetched, and actually has support in the scientific community. Even before the experiment began, there was speculation from the scientific sector about extreme and unanticipated side effects. Sergio Bertolucci, Director for Research and Scientific Computing at CERN, briefed reporters in 2009 about some of the possible implications of AWAKE. He speculated that the experiment could possibly open portals into the "unknown". "Out of this door might come something, or we might send something through it," Bertolucci was quoted as saying. Subject: Listener Comment: Fiber Optic Detection Ability of Big Brother

Hi Scott, This is something you can file away for when the topic comes up. I work for a large railway as a signals and communications maintainer. I ran into one of my colleagues and he told me he took one of our managers out high-railing (A high-rail is a modified truck that can drive on the rails). They met up with some fiber techs who were testing out a new detection system using the fiber optic cable. The right-of-way of rail lines is a good place to run utilities like fiber cable as it allows a really long run (miles and miles) without being interrupted.

This detection system uses the fiber cable itself to detect the location of a fiber break so it can be repaired quickly but my colleague told me it can do much more than that. He was told to walk 30 yards out and dig a small hole right over the fiber cable. Then walk another 30 yards and dig another hole. He did this 4 or 5 times. He told me when he was walking, he didn't go in a straight line over the fiber but in a zig-zag. When he got back to the techs he looked on the laptop that was doing the monitoring and he was amazed. It showed that a human (him) was walking and how far he was from the cable, how fast he was going, how hard his steps were. It then showed where he stopped to dig the holes and how deep they were. During the monitoring process a freight and then a passenger train went by. It showed both of those trains and it could tell what type of trains they were, as in freight and passenger, and how fast they were going. He said the techs told him that this monitoring system could detect a human walking almost a hundred yards from the fiber. In fact "It could be used to precisely detect hundreds of different things...." as my colleague was told by the fiber tech, "but right now it's in a testing phase".

Now think about all of the fiber that is running through not just our cities but out in the country as well. I use to be a signals tech in the rail traffic controller office and I've seen the fiber network maps running through the north east and Canada. There is a lot of it and that was almost 10 years ago. I can't imagine how much there is now. They want to ensnare us as many ways as they can. Too bad they can't have my soul as Jesus Christ owns mine.
