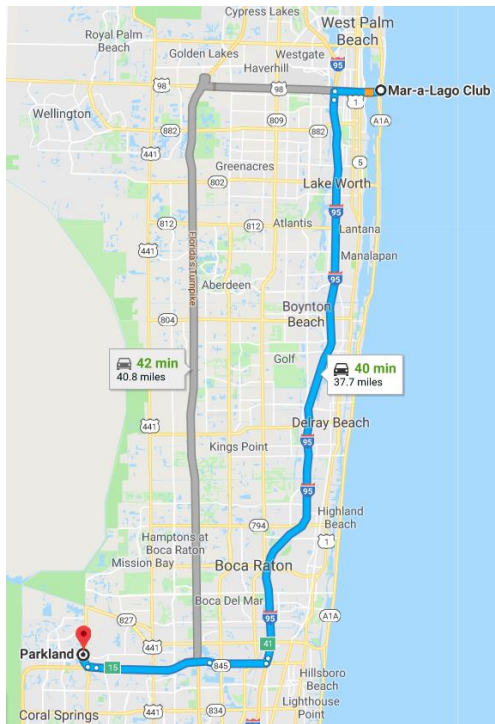

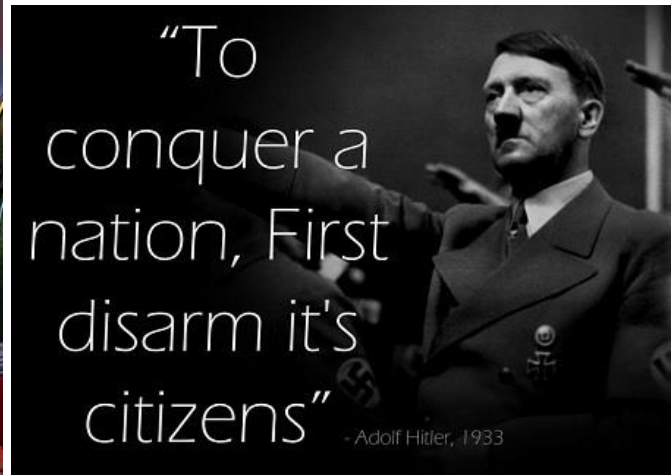

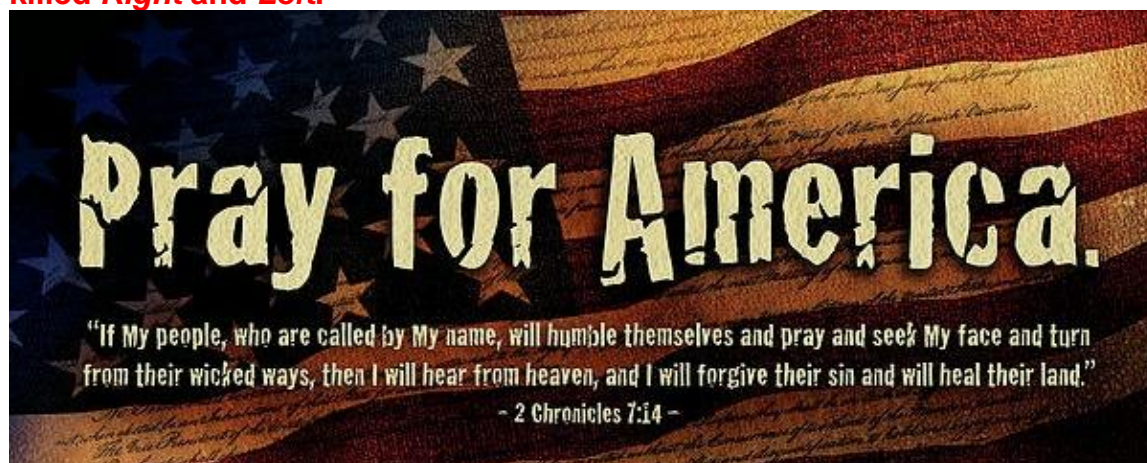

## Transforming Blood-Stained "Gun-Free-Zones" Into "Gun-Crime-Free Zones" by Letting Citizens Be Armed

I am always amazed by the enthusiastic attempts of liberals to outlaw guns in the hands of the innocent victims and law-abiding citizens whenever a murderer shoots people. Op-Ed pieces and Hollywood liberals are already claiming that the NRA and the prevalence of guns are one of the main reasons behind the murder of 33 students and professors at Virginia Tech.

On the contrary, the gun violence makes me even more dedicated to carrying my concealed weapon wherever I go and encouraging other good citizens to do the same. **Can anybody else see the connection between the shootings at Virginia Tech, the sniper attacks in D.C. and Baltimore, the Amish and Columbine massacres, and all of the public school shootings? They all occur at "gun-free zones." Even insane murderers aren't stupid. In June 2006, Virginia Tech's governing board approved a violence prevention policy that reaffirmed the school's ban of law-abiding students carrying the means to defend themselves against homicidal mass murderers.

### Myth: Gun Control Has Reduced The Crime Rates In Other Countries

1. Fact: The murder rates in many nations (such as England) were ALREADY LOW BEFORE enacting gun control. Thus, their restrictive laws cannot be credited with lowering their crime rates.<sup>1</sup>

2. Fact: Gun control has done nothing to keep crime rates from rising in many of the nations that have imposed severe firearms restrictions.

\* *Australia*: Readers of the *USA Today* newspaper discovered in 2002 that, "Since Australia's 1996 laws banning most guns and making it a crime to use a gun defensively, armed robberies rose by 51%, unarmed robberies by 37%, assaults by 24% and kidnappings by 43%. While murders fell by 3%, manslaughter rose by 16%."<sup>2</sup>

\* *Canada*: After enacting stringent gun control laws in 1991 and 1995, Canada has not made its citizens any safer. "The contrast between the criminal violence rates in the United States and in Canada is dramatic," says Canadian criminologist Gary Mauser in 2003. "Over the past decade, the rate of violent crime in Canada



has increased while in the United States the violent crime rate has plummeted." <sup>3</sup>

\* **England:** According to the *BBC News*, handgun crime in the United Kingdom rose by 40% in the two years after it passed its draconian gun ban in 1997.<sup>4</sup>

\* **Japan:** One newspaper headline says it all: Police say "Crime rising in Japan, while arrests at record low."<sup>5</sup>

3. Fact: British citizens are now more likely to become a victim of crime than are people in the United States:

\* In 1998, a study conducted jointly by statisticians from the U.S. Department of Justice and the University of Cambridge in England found that most crime is now worse in England than in the United States.

\* "You are more likely to be mugged in England than in the United States," stated the *Reuters* news agency in summarizing the study. "The rate of robbery is now 1.4 times higher in England and Wales than in the United States, and the British burglary rate is nearly double America's."<sup>6</sup> The murder rate in the United States is reportedly higher than in England, but according to the DOJ study, "the difference between the [murder rates in the] two countries has narrowed over the past 16 years."<sup>7</sup>

\* The United Nations confirmed these results in 2000 when it reported that the crime rate in England is higher than the crime rates of 16 other industrialized nations, including the United States.<sup>8</sup>

4. Fact: British authorities routinely underreport crime statistics. Comparing statistics between different nations can be quite difficult since foreign officials frequently use different standards in compiling crime statistics.

\* The British media has remained quite critical of authorities there for "fiddling" with crime data. Consider some of the headlines in their papers: "Crime figures a sham, say police,"<sup>9</sup> "Police are accused of fiddling crime data,"<sup>10</sup> and "Police figures under-record offences by 20 percent."<sup>11</sup>

\* British police have also criticized the system because of the "widespread manipulation" of crime data:

a. "Officers said that pressure to convince the public that police were winning the fight against crime had resulted in a long list of ruses to 'massage' statistics."<sup>12</sup>

b. Sgt. Mike Bennett says officers have become increasingly frustrated with the practice of manipulating statistics. "The crime figures are meaningless," he said. "Police everywhere know exactly what is going on."<sup>13</sup>

c. According to *The Electronic Telegraph*, "Officers said the recorded level of crime bore no resemblance to the actual amount of crime being committed."<sup>14</sup>

\* **Underreporting crime data:** "One former Scotland Yard officer told *The Telegraph* of a series of tricks that rendered crime figures 'a complete sham.' A classic example, he said, was where a series of homes in a block flats were burgled and were regularly recorded as one crime. Another involved pickpocketing, which was not recorded as a crime unless the victim had actually seen the item being stolen."<sup>15</sup>

\* **Underreporting murder data:** British crime reporting tactics keep murder rates artificially low. "Suppose that three men kill a woman during an argument outside a bar. They are arrested for murder, but because of problems with identification (the main witness is dead), charges are eventually dropped. In American crime

statistics, the event counts as a three-person homicide, but in British statistics it counts as nothing at all. 'With such differences in reporting criteria, comparisons of U.S. homicide rates with British homicide rates is a sham,' [a 2000 report from the Inspectorate of Constabulary] concludes."<sup>16</sup>

5. Fact: Many nations with stricter gun control laws have violence rates that are equal to, or greater than, that of the United States. Consider the following rates:

6. Fact: The United States has experienced far fewer TOTAL MURDERS than Europe does over the last 70 years. In trying to claim that gun-free Europe is more peaceful than America, gun control advocates routinely ignore the overwhelming number of murders that have been committed in Europe.

\* Over the last 70 years, Europe has averaged about 400,000 murders per year, when one includes the murders committed by governments against mostly unarmed people.<sup>17</sup> That murder rate is about 16 times higher than the murder rate in the U.S.<sup>18</sup>

\* Why hasn't the United States experienced this kind of government oppression? Many reasons could be cited, but the Founding Fathers indicated that an armed populace was the best way of preventing official brutality. Consider the words of James Madison in Federalist 46:

Let a regular army, fully equal to the resources of the country, be formed; and let it be entirely at the devotion of the federal government; still it would not be going too far to say, that the State governments, with the people on their side, would be able to repel the danger . . . a militia amounting to near half a million of citizens with arms in their hands.<sup>19</sup>

Our hearts and prayers truly go out to all of those affected by Cho Seung-Hui's evil actions. But not even senseless, brutal murder justifies taking away the God-given rights of the law-abiding.

It is also worthwhile to note that Virginia Tech is -- because of deliberate policies set by its administration -- a victim disarmament zone, where even those with a state-issued concealed carry permit are denied their right of self-defense.

**"When will we learn that being defenseless is a bad defense,"** asked Larry Pratt, Executive Director of Gun Owners of America?

"All the school shootings that have ended abruptly in the last ten years were stopped because a law-abiding citizen -- a potential victim -- had a gun," Pratt said.

"The latest school shooting demands an immediate end to the gun-free zone law **which leaves the nation's schools at the mercy of madmen.** It is irresponsibly dangerous to tell citizens that they may not have guns at schools. The Virginia Tech shooting **shows that killers have no concern about a gun ban when murder is in their hearts.**

"Not far from Virginia Tech, a killer was stopped at the Appalachian School of Law **when two students were able to go off campus to their vehicles and get their guns which they used to subdue the killer.** Sadly, not even that awkward defense was available at Virginia Tech.

"Isn't it interesting that Utah and Oregon are the only two states that allows faculty to carry guns on campus. **And isn't it interesting that you haven't read about any school or university shootings in Utah or Oregon? Why not? Because criminals don't like having their victims shoot back at them,**" Pratt said. "That's why the American people want an end to this ineffective gun ban."

Pollsters have found that 85% of Americans would find it appropriate for a principal or teacher to use "a gun at school to defend the lives of students" to stop a school massacre (Research 2000 poll).

The words of Virginia Tech spokesman, Larry Hincker, should be haunting him in the wake of the massacre at his school. **Last year, a bill was killed in the Virginia legislature to enable those with concealed weapons permits to carry their guns at schools.** Hincker said that "I'm sure the university community is appreciative of the General Assembly's actions because this will help parents, students, faculty



and visitors **feel safe on our campus.**"

"Gun Owners of America has called on Congress to repeal its deadly law requiring gun free school zones," said Pratt. "Likewise, the call has been made to state legislatures to enact legislation enabling people with concealed carry permits to be able to have their weapons with them in schools."

## **AS USUAL, NOBODY HAD A GUN**

So far, 33 people are dead and another 29 wounded in the attack launched by one gunman reportedly armed with two 9mm pistols and extra magazines at the campus of Virginia Tech on 4/16/07.

Virginia is one of the many states with "Shall Issue" concealed gun laws, which means that if a citizen who has not been convicted of a felony or domestic violence, and they are not judged mentally unstable, the law requires they be issued a concealed gun permit upon request.

But nobody in range of the gunman, other than late-arriving police, had a gun. To make it even more senseless and inexcusable, this is the **SECOND** recent firearms attack at Virginia Tech.

The gunman in the incident is dead, and I suspect he got tired of waiting for the cops so he did it himself.

I don't know the policy at Virginia Tech, but I'll bet there is a no-gun policy on

campus, which means everybody there were just sitting ducks, fleeing for their lives or hiding. It is reported some students jumped from second story windows and ran to safety.

To be certain, there will be yet another call for gun control over this incident, which translates as follows: The citizens who are afraid of guns and don't want to have them, will try to impose their will on everybody else, making us all sitting ducks for the next gunman to slaughter.

In their mindless quest for non-violence, these well-meaning folks actually envision a nation with such stringent gun bans that nobody will have a gun. But that is never going to happen in the United States, because there are too many guns and there is absolutely no way to vacuum them all up by passing laws to make them go away. We can't make even the slightest dent in the amount of illegal drugs smuggled into this nation, so there is no way we'll ever completely eliminate the availability of guns to people who should not have them.

In the world of reality and clear thinking, the only way to fight fire in the hands of criminals, is to have equal fire to stop them with.

I was recently talking to a Chicago Police Captain on other business, and Chicago, like the District of Columbia and New York City, have virtual bans on possessing handguns. I asked this 25-year veteran Captain if there was any shortage of handguns on Chicago streets, and he laughed at the absurdity of my question. In the case of Chicago, the law-abiding generally don't have handguns, while the violent criminals mostly do.

The United States District Court, which has jurisdiction in the District of Columbia, recently ruled the D.C. handgun ban unconstitutional on the basis that it clearly violates the citizens right to bear arms under Article II of the Bill of Rights. Of course, that decision is being appealed to the full court on the laughable basis that the ruling will increase violent crime. There are few places in the United States that have a higher violent crime rate involving handguns than the District of Columbia, so it is doubtful it could get much worse.

And what excuse does the anti-gun crowd come up with to explain why their gun ban doesn't work? They blame guns coming in from neighboring states with more liberal gun laws. If the entire United States enacted a strict gun ban, the same people would blame guns being smuggled in from other nations. Again, we can't seem to stem the flow of illegal drugs into this nation, but these bright thinkers will still insist a complete gun ban would reduce gun violence. It follows the same line of thinking of committed Communists, who insist Communism and Socialism will work, but it just hasn't been done right yet.

The problem is human nature, which is and always has been a constant we have to deal with, but these âprogressive• thinkers always seem to leave that out of

the equation.

So getting back to this tragedy in Virginia in which 22 students died and another 21 were injured, many of those undoubtedly in critical condition, the one thing the anti-gun crowd will never admit is that one student with a concealed handgun in the right place at the right time could have saved some -- or all of them.

But as usual, nobody but the responding cops had guns. The only option the students trapped on that campus could do was run, hide, jump and/or get shot. Women carry the guns primarily in their purse, and the men often have the gun concealed out in the glove compartment of their car.

In the real world, if you need a gun to defend yourself and others, you'll need to access it immediately. A gun in your car parked outside is about as useless as a broken leg.

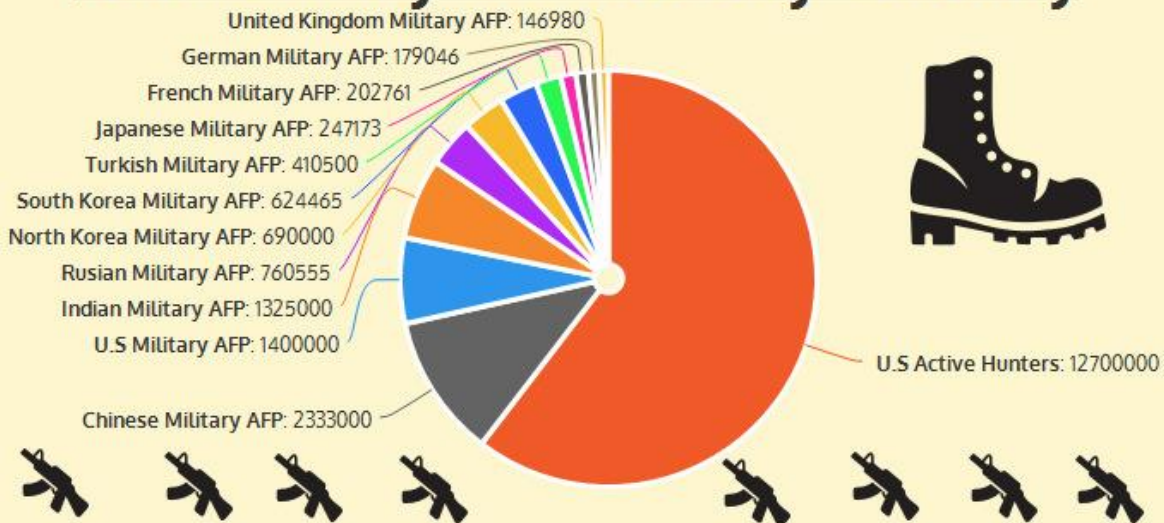

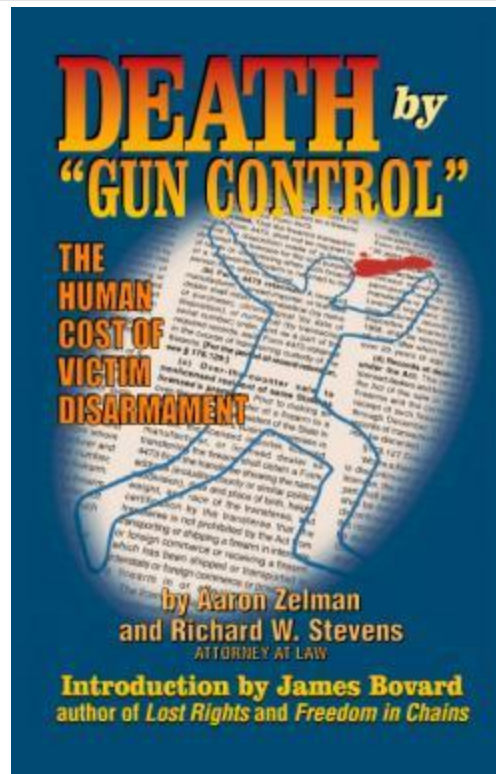
