A quick read on how they make it and you'll realize why it's so toxic. Instead of a "WARNING" on food labels, most products just say 'sugar free'.

**In May 1992, the official U.S. Air Force Magazine, Flying Safety explained: "In pregnancy the effects of aspartame can be passed directly to the fetus, even in very small doses. People have suffered aspartame-related disorders with doses as small as that carried in a single stick of chewing gum. This could mean a pilot who drinks diet sodas is more susceptible to flicker vertigo or to flicker-induced epileptic activity. It also means that all pilots are potential victims of sudden memory loss, dizziness during instrument flight and gradual loss of vision."**

**Pilots have experienced grand mal seizures in the cockpits of commercial airline flights and have lost their medical certification to fly, and three have died this year (1994) from aspartame. FDA has received more than 10,000 consumer complaints on NutraPoison, that's 80% of all complaints about food additives.**

**Still FDA remains comatose and has done nothing to alert the public, who assume that since it's so highly advertised, it must be as safe as mother's milk. The FDA consistently approves killer drugs as OMNI Magazine reported: "51% of FDA approved drugs have serious risks and could cause adverse reactions that lead to severe or permanent disability of death" [MAY '94]**

**The CDC, Johns Hopkins University and the New Jersey School of Medicine estimates that 80-120,000 Americans die from prescription drugs each year. This atrocity has everything to do with money and nothing to do with public health. Monsanto reaps at least a billion annually from its Aspartame toxic bonanza. For the fraudulent tests they used get this poison approved, but Sam switched sides and went to work for Searle's lawyers and the case died when the feds let the statute of limitations run out. **2. GMO CROPS-** Since these crops are patented; no one really knows exactly what types of genes are spliced into their DNA. They call them terminator seeds, meaning they do not produce seeds for future planting and must be purchased by farmers every year.

The original theory was to blend **Monsanto's herbicide Round-Up into the gene of the plant so the crops could be sprayed with Monsanto's Round-up without killing the plant. Way back in the 1980's president G.H.W. Bush declared that if Genetically Modified crops looked like regular foods, then they were foods, and the government would not spend federal money on testing or researching their safety or efficacy.**

As a result it has since been a battle royal for independent scientists to show that these foods are indeed questionable as to their safety for human or animal consumption.

Obvious evidence from around the world **shows that farm animals consuming GMO's, as well as mice and hamsters in laboratory tests, have a high incidence of death and deformity in second and third generation offspring, spontaneous abortion and sterility.**

## **Biotech's Dirty Tricks Exposed in New Documentary *Scientists Under Attack***

"One question means one's career." This was the harsh warning of UC Berkeley Professor Ignacio Chapela for those daring to conduct independent research on genetically engineered foods and crops. "You ask one question, you get the answer and you might or might not be able to publish it; **but that is the end of your career.**" Both he and biologist Arpad Pusztai dared to ask questions and do the research. And then all (you know what) broke loose.

Using stunning visuals filmed on three continents, veteran German filmmaker Bertram Verhaag tracks the fate of **these two scientists at the hands of a multi-billion dollar industry that is desperate to hide the dangers of their genetically modified organisms (GMOs).**

*BR Online* says of the film, "Belief in noble and incorrupt research and science is reduced to absurdity." *Arthouse* says the "movie shows how purchased truth becomes the currency in the perfidious business between science and multinationals." And *GMWatch* writes, "Original research showing problems with GM crops is buried under a deluge of smears and follow up studies are not done."

When Dr. Pusztai voiced his concerns about the health risks of genetically modified (GM) foods during a nationally televised interview in August 1998, his was not simply just another voice in a contentious debate. **Pusztai was the world leader in his field, and he had received major government funding to come up with the official method for testing the safety of GM foods. His protocols were supposed to become the required tests before any new GMO entered the European market. Pusztai was an insider, and an advocate of GM foods—that is until he actually ran those tests on supposedly harmless GM potatoes.**

The high-tech spuds were engineered to produce their own pesticide. "The point of the whole genetic modification experiment was to protect the potato against aphids, which are one of the major pests in Scotland," he said. His team inserted a gene from the snowdrop plant into the potatoes, which did in fact protect the GM crop from the insects. **As part of his safety studies, he fed that insecticide producing GM potato to rats, along with a complete and balanced diet. Another group of rats ate natural potatoes. A third was fed not only the natural potatoes, but they also received a dose of the same insecticide that the GM potato produced. This way, if the insecticide was harmful, he**

would see the same health problems in both the group that ate the GM potatoes, and those that ate the diet spiked with the insecticide. To his surprise, only those that ate the GM potato had severe problems—in every organ and every system he looked at. "After the animals were killed and dissected," Pusztai recalled, "we found out that in comparison with the non-genetically modified potatoes, **their internal organs developed differently.** The intestines and stomach lining, for example, increased in size, the liver and kidneys were smaller, and the overall rate of growth was retarded. And the immune system suffered. Pusztai emphasized, "They found in those data 36 – 36! – very highly significant differences between the GM-fed animals and the non-GM fed animals."

Since the rats that ate the natural potatoes plus the insecticide did not have these issues, there was one obvious conclusion—the *process* of genetically engineering the potatoes caused unpredicted side effects, turning a harmless food into a dangerous one.

**CDC now calling U.S. households and demanding child immunization records as part of vaccine surveillance and tracking program**

by Mike Adams, the Health Ranger, NaturalNews Editor (NaturalNews) **The U.S. Centers for Disease Control, which has been comprehensively exposed as a vaccine propaganda organization promoting the interests of drug companies, is now engaged in a household surveillance program that involves calling U.S. households and intimidating parents into producing child immunization records.** As part of what it deems a *National Immunization Survey* (NIS), the CDC is sending letters to U.S. households, alerting them that they will be called by "NORC at the University of Chicago" and that households should "have your child's immunization records handy when answering our questions." (See copies of the letter, below.)

This NIS vaccine compliance program is revealed in a letter being sent to U.S. households by Edward J. Sondik, PhD, the director of the *National Center for Health Statistics* at the CDC. The CDC, you may recall, was instrumental in pushing the false swine flu pandemic scare and encouraging governments to order billions of dollars worth of vaccines from drug companies. Following this marketing fraud, the former head of the CDC, Dr. Julie Gerberding, went on to accept the lucrative job as the president of Merck's global vaccine division ([http://www.naturalnews.com/027789\\_D...](http://www.naturalnews.com/027789_D...)). One of the CDC's top researchers who worked under Gerberding, Dr. Poul Thorsen, was later indicted by a federal grand jury for allegedly stealing grant money and using it to buy

luxury cars and motorcycles ([http://www.naturalnews.com/032216\\_T...](http://www.naturalnews.com/032216_T...)).

Now the CDC is bullying parents across the USA to **comply with child immunization surveillance programs** by calling their home phones and asking them to produce child immunization records.

"Your phone number was chosen randomly by computer," explains the letter, which goes on to say that the CDC will use your information to generate a map of **vaccine compliance** -- no doubt to later target low-compliance areas with increased vaccination propaganda or even court-ordered immunization mandates like the one we witnessed in Maryland ([http://www.naturalnews.com/022242\\_m...](http://www.naturalnews.com/022242_m...)).

"It is important for us to interview every household we call to get a complete picture of your area's immunization rates," the CDC letter explains. "Your answers to the NIS will provide information to help improve the nation's health now and in the years ahead," it continues. **Which means, of course, that this information will be used to push more vaccines onto more infants** by targeting areas with low vaccine compliance rates, such as African American neighborhoods which are rightly skeptical of government's claims about vaccines.

Note that in this letter, the CDC admits it is using this information to **track vaccine compliance** at the local level. On top of that, the NORC.org website openly admits this is all about **public health surveillance**, saying: "the NIS is one of the largest telephone surveys in the nation and its data are considered the gold standard for public **health surveillance** on immunization rates."

Ever notice how these organizations are so aggressive at tracking vaccination rates but they care nothing about tracking **rates of autism**? Have you wondered why they aren't calling U.S. households and asking parents whether their children became autistic after receiving vaccines? for the sole purpose of obtaining immunization records, providing an important supplement to the household report," NORC explains. **Yes, once you answer the interrogation questions on the phone, they will then go straight to your doctor to acquire vaccine records there *in order to determine whether you were lying on the phone.***

"NORC then sends an Immunization History Questionnaire via mail to these health providers," it says. And once the data are compiled: "These data are used by the CDC and state and local public health agencies to monitor the potential for disease outbreaks at the community level and to allocate resources for the Vaccines for Children (VFC) Program, which ensures that all children in the U.S. have access to vaccinations **regardless of financial status.**"

Under a heading called "Advances in Survey Research," NORC adds something that should raise some red flags among privacy advocates, saying "In collaboration with CDC, NORC has spearheaded an ambitious research program to identify best practices for sampling landline and cell telephones and develop valid statistical approaches for weighting and estimation."

Cell phones? Ambitious research programs?
