By contrast, here's how RT described what Jobar was like five years ago:


Before the conflict in Syria erupted in 2011, the neighborhood was home to some 300,000 residents, most of whom were Sunni Muslims. The suburb contained a number of ancient landmarks, most notably the Green Synagogue, the oldest Jewish synagogue in the world. It also contained the Grand Jobar Mosque in addition to the tomb of the Prophet Elijah. The clashes continue in Jobar between the Syrian Army and rebel forces aiming to oust Syrian President Bashar Assad. The suburb is now in the hands of rebels.

“The great counterfeit religion was Roman Catholicism, called ‘Mystery, Babylon the Great, the Mother of Harlots and Abominations of the Earth’- Revelation 17:5. “What I’m going to tell you is what I learned in secret briefings in the Vatican when I was a Jesuit priest, under oath and induction. A Jesuit cardinal named Augustine Bea showed us how desperately the Roman Catholics wanted Jerusalem at the end of the third century. Because of its religious history and its strategic location, the Holy City was considered a priceless treasure. A scheme had to be developed to make Jerusalem a Roman Catholic city.



“The great untapped source of manpower that could do this job was the children of Ishmael. The Arabs fell victim to one of the most clever plans ever devised by the powers of darkness. Early Christians went everywhere with the gospel setting up small churches, but they met heavy opposition. Both the Jews and the Roman government persecuted the believers in Christ to stop their spread. But the Jews rebelled against Rome, and in 70 AD, Roman armies under General Titus smashed Jerusalem and destroyed the great Jewish temple which was the heart of Jewish worship...in fulfillment of Christ’s prophecy in Matthew 24:2.


But Corruption, apathy, greed, cruelty, perversion and rebellion were eating at the Roman Empire, and it was ready to collapse. The persecution against Christians was useless as they continued to lay down their lives for the gospel of Christ.

“The only way Satan could stop this thrust was to create a counterfeit “Christian” religion to destroy the work of God. The solution was in Rome. Their religion had come from ancient Babylon and all it needed was a face-lift. This didn’t happen overnight, but began in the writings of the ‘early church fathers’ (The corrupt ones).

“It was through their writings that a new religion would take shape. The statue of Jupiter in Rome was eventually called St. Peter, and the statue of Venus was changed to the Virgin Mary. The site chosen for its headquarters was on one of the seven hills called ‘Vaticanus’, the place of the diving serpent where the Satanic temple of Janus stood.

“The great counterfeit religion was Roman Catholicism, called ‘Mystery, Babylon the Great, the Mother of Harlots and Abominations of the Earth’- Revelation 17:5. She was raised up to block the gospel, slaughter the believers in Christ, establish religions, create wars and make the nations drunk with the wine of her fornication as we will see.

“Three of the major religions have one thing in common – each has a holy place where they look for guidance. Roman Catholicism looks to the Vatican as the Holy City. The Jews look to the wailing wall in Jerusalem, and the Muslims look to Mecca as their Holy City. Each group believes that they receive certain types of blessings for the rest of their lives for visiting their holy place. In the beginning, Arab visitors would bring gifts to the ‘House of God’, and the keepers of the Kaaba were



gracious to all who came. Some brought their idols and, not wanting to offend these people, their idols were placed inside the sanctuary. << The Kaaba, Mecca

“In a tribal contention over a well the treasure of the Kaaba and the offerings that pilgrims had given were dumped down the well and it was filled with sand –so it disappeared. Many years later Adb Al-Muttalib was given visions telling him where to find

the well and its treasure. He became the hero of Mecca, and he was destined to become the grandfather of Muhammad. Before this time, Augustine became the bishop of North Africa and was effective in winning Arabs to Roman Catholicism, including whole tribes. It was among these Arab converts to Catholicism that the concept of looking for an Arab prophet developed.

“Muhammad’s father died from illness so sons born to great Arab families in places like Mecca were sent into the desert to be suckled and weaned and spend some of their childhood with Bedouin tribes for training and to avoid the plagues in the cities.

“After his mother and grandfather also died, Muhammad was with his uncle when a Roman Catholic monk learned of his identity and said, “Take your brother’s son back to his country and guard him against the Jews, for by god, if they see him and know of him that which I know, they will construe evil against him. Great things are in store for this brother’s son of yours.”

“The Roman Catholic monk had fanned the flames for future Jewish persecutions at the hands of the followers of Muhammad. The Vatican desperately wanted Jerusalem because of its religious significance, but was blocked by the Jews.

“Another problem was the true Christians in North Africa who preached the gospel. Roman Catholicism was growing in power, but would not tolerate opposition. Somehow the Vatican had to create a weapon to eliminate both the Jews and the true Christian believers who refused to accept Roman Catholicism. Looking to North Africa, they saw the multitudes of Arabs as a source of manpower to do their dirty work. Some Arabs had become Roman Catholic, and could be used in reporting information to leaders in Rome. Others were used in an

underground spy network to carry out Rome's master plan to control the great multitudes of Arabs who rejected Catholicism. When 'St Augustine' appeared on the scene, he knew what was going on. His monasteries served as bases to seek out and destroy Bible manuscripts owned by the true Christians.

"The Vatican wanted to create a messiah for the Arabs, someone they could raise up as a great leader, a man with charisma whom they could train, and eventually unite all the non-Catholic Arabs behind him, creating a mighty army that would ultimately capture Jerusalem for the pope." In the Vatican briefing, Cardinal Bea told us this story:

'A wealthy Arabian lady who was a faithful follower of the pope played a tremendous part in this drama. She was a widow named Khadijah. She gave her wealth to the church and retired to a convent, but was given an assignment. She was to find a brilliant young man who could be used by the Vatican to create a new religion and become the messiah for the children of Ishmael. Khadijah had a cousin named Waraquah,, who was also a very faithful Roman Catholic and the Vatican placed him in a critical role as Muhammad's advisor. He had tremendous influence on Muhammad.

'Teachers were sent to young Muhammad and he had intensive training. Muhammad studied the works of St. Augustine which prepared him for his "great calling." The Vatican had Catholic Arabs across North Africa spread the story of a great one who was about to rise up among the people and be the chosen one of their God.

'While Muhammad was being prepared, he was told that his enemies were the Jews and that the only true Christians were Roman Catholic. He was taught that others calling themselves Christians were actually wicked impostors and should be destroyed. Many Muslims believe this.

'Muhammad began receiving "divine revelations" and his wife's Catholic cousin Waraquah helped interpret them. From this came the Koran. In the fifth year of Muhammad's mission, persecution came against his followers because they refused to worship the idols in the Kaaba.

'Muhammad instructed some of them to flee to Abyssinia where Negus, the Roman Catholic king accepted them because Muhammad's views on the virgin Mary were so close to Roman Catholic doctrine. These Muslims received protection from Catholic kings because of Muhammad's revelations.

'Muhammad later conquered Mecca and the Kaaba was cleared of idols. History proves that before Islam came into existence, the Sabeans in Arabia worshiped the moon-god who was married to the sun-god. They gave birth to three goddesses who were worshipped throughout the Arab world as "Daughters of Allah" An idol excavated at Hazor in Palestine in 1950's shows Allah sitting on a throne with the crescent moon on his chest.

'Muhammad claimed he had a vision from Allah and was told, "You are the messenger of Allah." This began his career as a prophet and he received many messages. By the time Muhammad died, the religion of Islam was exploding. The nomadic Arab tribes were joining forces in the name of Allah and his prophet, Muhammad.

‘Some of Muhammad’s writings were placed in the Koran, others were never published. They are now in the hands of high ranking holy men (Ayatollahs) in the Islamic faith.’

“When Cardinal Bea shared with us in the Vatican, he said, these writings are guarded because they contain information that links the Vatican to the creation of Islam. Both sides have so much information on each other, that if exposed, it could create such a scandal that it would be a disaster for both religions.

“In their “holy” book, the Koran, Christ is regarded as only a prophet. If the pope was His representative on earth, then he also must be a prophet of God. This caused the followers of Muhammad to fear and respect the pope as another “holy man.”

So going back to previous information we covered: “The pope moved quickly and issued bulls granting the Arab generals permission to invade and conquer the nations of North Africa. The Vatican helped to finance the building of these massive Islamic armies in exchange for three favors:

1. Eliminate the Jews and Christians (true believers, which they called infidels).
2. Protect the Augustinian Monks and Roman Catholics.

“Under Waraquah’s direction, Muhammad wrote that Abraham offered Ishmael as a sacrifice. The Bible says that Isaac was the sacrifice, but Muhammad removed Isaac’s name and inserted Ishmael’s name. As a result of this and Muhammad’s vision, the faithful Muslims built a mosque, the Dome of the Rock, in Ishmael’s honor on the site of the Jewish temple that was destroyed in 70 AD. This made Jerusalem the 2nd most holy place in the Islam faith. How could they give such a sacred shrine to the pope without causing a revolt?



“The pope realized what they had created was out of control when he heard they were calling “His Holiness” an infidel. The Muslim generals were determined to conquer the world for Allah and now they turned toward Europe. Islamic ambassadors approached the pope and asked for papal bulls to give them permission to invade European countries.

“The Vatican was outraged; war was inevitable. Temporal power and control of the world was considered the basic

right of the pope. He wouldn’t think of sharing it with those whom he considered heathens.

"The pope raised up his armies and called them crusades to hold back the children of Ishmael from grabbing Catholic Europe. The crusades lasted centuries and Jerusalem slipped out of the pope's hands.

"Turkey fell and Spain and Portugal were invaded by Islamic forces. In Portugal, they called a mountain village "Fatima" in honor of Muhammad's daughter, never dreaming it would become world famous.

"Years later when the Muslim armies were poised on the islands of Sardinia and Corsica, to invade Italy, there was a serious problem. The Islamic generals realized they were too far extended. It was time for peace talks. One of the negotiators was Francis of Assisi. "As a result, the Muslims were allowed to occupy Turkey in a "Christian" world, and the Catholics were allowed to occupy Lebanon in the Arab world. It was also agreed that the Muslims could build mosques in Catholic countries without interference as long as Roman Catholicism could flourish Arab countries.

"Cardinal Bea told us in Vatican briefings that both the Muslims and Roman Catholics agreed to block and destroy the efforts of their common enemy: the Bible-believing Christian missionaries.

"A light control was kept on Muslims from the Ayatollah down through the Islamic friendly priests, nuns and monks. The Vatican also engineered a campaign of hatred between the Muslim Arabs and the Jews. Before this, they had co-existed peacefully. The true Christians were demonized as well: "The Islamic community looks on the Bible-believing missionary as a devil who brings poison to the children of Allah. This explains years of ministry in those countries with little results.

"The next plan was for the RCC to control Islam. In 1910, Portugal was going Socialistic. Red flags were appearing and the Catholic Church was facing a major problem. Increasing numbers were against the church.

"The Jesuits wanted Russia involved, and **the location of this vision at Fatima could play a key part in pulling Islam to the Mother Church.**

"In 1917, the Virgin appeared in Fatima. "The Mother of God" was a smashing success, playing to overflow crowds. As a result, the Socialists of Portugal suffered a major defeat.

"Roman Catholics world-wide began praying for the conversion of Russia; and the Jesuits invented the Novenas to Fatima which they could perform throughout North Africa, spreading good public relations to the Muslim world. **Note: A novena is an act of pious Roman Catholic devotion^[1] often consisting of private or public prayers repeated for nine successive days in belief of obtaining special intercessory graces.^[2] The Arabs thought they were honoring the daughter of Muhammad, which is what the Jesuits wanted them to believe.**



NYC COMMISSION ON HUMAN RIGHTS
Legal Enforcement Guidance on the
Discrimination on the Basis of Gender Identity or Expression:
Local Law No. 3 (2002); N.Y.C. Admin. Code § 8-102(23)

Violations of the law in the City of New York now include:

Failing to use an individual's preferred name or pronoun, such as calling a biological male "she" when requested. It's also illegal to require proof of a legal name change or of "sex-change" medical procedures.

Restricting same-sex facilities, such as restrooms, locker rooms, and showers, to the persons of the biological sex. People's "gender identity or expression" must be the indicator.

Limiting a person's options to only "male" and "female." How this works was not completely explained.

Sex stereotyping. A company allows women to wear wigs, makeup, skirts, and jewelry – it must also allow men to do so. It also prohibits any conversation about a person's non-conformity to gender norms.

Imposing different dress codes based on sex. Similar to sex stereotyping. For example, if a restaurant requires waitresses to wear skirts and high heels, it must also require male waiters do so. The Commission's manual is very emphatic about this Transgender-inclusive health insurance. All employers must cover medical procedures for "transitioning" to the opposite sex and include other special "transgender" health care. The manual elaborates: To be non-discriminatory with respect to gender, health benefit plans must cover transgender care, also known as transition-related care or gender-affirming care ... Transgender care includes a range of treatments, including, for example, hormone replacement therapy, voice training, or surgery. Treating cross-dressers differently in any way. Treating cross-dressers differently in the workplace or at a public accommodation, even in a minor way, is strictly illegal. Also, reacting negatively to a person's demands that their "transgender rights" be enforced is also illegal. Penalties. Violators can be fined up to \$250,000 per violation. This can include employers, employees, and even members of the public at a public accommodation. In addition, the "victims" can be awarded "back and front pay, along with other compensatory and punitive damages." Potential victims have one year to file a complaint with the Commission and three years to file with the court system.



<<Coming to your state? In New York City you could be fined for even making a comment at work about these these guys' "gender non-conformity."

In order to justify the imposition of such a ridiculous set of laws, they employ a tactic known as "inversion of reality." The Left claims it is not only necessary but absolutely critical. Here's what the New York' Commission on Human Rights states [as part of its](#)

Administrative Code: *In the City of New York, with its great cosmopolitan population, there is no greater danger to the health, morals, safety and welfare of the city and its inhabitants **than the existence of groups prejudiced against one another and antagonistic to each other because of their actual or perceived differences ...***

The council hereby finds and declares that prejudice, intolerance, bigotry, and discrimination and disorder occasioned thereby threaten the rights and proper privileges of its inhabitants and menace the institutions and foundation of a free democratic state.

Most people might see dangers to modern society as crime, the murder rate, terrorism, or even terrible public schools, **not the intolerance of perversions. But this is how the Left actually sees reality. (The perceiver of true reality is now the criminal.)**

Even a few years ago, this would be considered science fiction, a complete inversion of normalcy. Actually, it would have been too absurd for even fiction. (Not even the "Twilight Zone"!)

But now because of these laws it must be considered not only normal, but mandatory. And no one (that we know of) fought back when they needed to.

As we've said in the past, it's less stressful for pro-family people to simply label these as just "bathroom bills". But avoiding the transgender issue does not confront the larger lunacy being forced on people, and gives the LGBT movement a free pass on its real intent.

Sesame Street rolls out autistic muppet to 'normalize' vaccine injuries... follows Elmo push for mass vaccinations of children

(NaturalNews) In yet another sickening example of the absolute mental derangement of modern society, Sesame Street has rolled out its first autistic muppet named "Julia," says the Sesame Street website

The rollout of autistic Julia is Sesame Street's attempt to "normalize" vaccine



injuries and depict those victimized by vaccines as happy, "amazing" children rather than admitting the truth that vaccines cause autism in children.

The fact that vaccines are linked to autism was openly admitted by a top CDC scientist named Dr. William Thompson, who admitted to taking part in a scientific fraud scheme

involving numerous CDC officials. In the name of "vaccine science," they actively altered data to eliminate the statistical link between vaccines and autism.

Another Sesame Street character, Elmo, has been exploited as a literal puppet by the vaccine industry to push a pro-vaccine message alongside the U.S. Surgeon General. It is instructive to realize that even though the vaccine industry claims its vaccines are based on scientifically validated safety claims, it must use social engineering tactics on children to attempt to portray vaccines as being recommended by their favorite muppet characters from Sesame Street. The tactic smacks of the same kind of exploitive propaganda programming used by sugary breakfast cereal makers to influence children with Saturday morning cartoon ads. Former Merck virologists, by the way, have filed a False Claims Act with the federal government, saying they were ordered by Merck management to falsify vaccine research data in order to trick the FDA into approving MMR vaccines even though they didn't work. These virologists even wrote that they believed such vaccines would cause the spread of contagious disease among those who were vaccinated, which is what always happens.

The CDC does not dispute the fact that vaccines are still made with mercury, MSG, aluminum, formaldehyde and other toxic additives.

But there is no safety margin established in the scientific literature for injecting such

items into the body of a child. But it is propagated by the vaccine establishment that such toxins are present in quantities so small that they don't matter to human biology.

Yet, as Natural News has established using ICP-MS laboratory instrumentation, the concentration of mercury in a flu shot is over 50,000 ppb, making it hundreds of times higher than the concentration of mercury in tuna fish, for example. It also happens to be 25,000 times the concentration allowed in drinking water by the EPA.

Further, the adjudicated settlements report from the national Vaccine Injury Compensation Program reveals that flu shots containing mercury cause more vaccine injuries and financial payouts from the government than any other type of vaccine.

The federal government has desperately tried to delete this data from websites so that the public is denied access to this information. As [reported by investigative journalist Sharyl Attkisson](#):

In March, the federal government removed the latest vaccine injury court statistics—more than a year's worth of data—from one of its publicly reported charts. It was an abrupt departure from the normal practice of updating the figures monthly.

Wiping the latest data means the "adjudication categories by alleged vaccine" chart on a government website no longer reflects the recent, sharp rise in court victories for plaintiffs who claimed their children were seriously injured or killed by one or more vaccines.

Since January of 2014, the number of flu vaccine cases conceded by the government is more than double the previous eight years combined. The adjudication chart only reflects half of the current number.

The flu business is big business, generating \$1.6 billion revenues for vaccine makers. That's a large motivation to cover up vaccine injuries and keep pushing vaccine obedience at any cost.

Rather than seeking to find and eliminate the root cause of skyrocketing rates of autism across America's children, Sesame Street seems to believe that "normalizing" autism is the answer.

If this trend continues, we may soon have a Sesame Street "chemo boy" muppet who loves chemotherapy, and even an aborted fetus muppet that talks about how its tissues are being used to "advance scientific discoveries!"

After all, it's never too early to start propagandizing children and demand their absolute obedience to a medical police state dominated by corporate interests.
