**Fort Hood Soldiers Told That Christians, Tea Partiers a Radical Terror Threat**

**During a pre-deployment briefing, Fort Hood soldiers were told that Christians, Tea Party supporters and anti-abortion activists were a radical terror threat, enemies of America, and that anyone found to be supporting these groups would be subject to discipline under the Uniform Code of Military Justice.**

**That's the explosive claim from a soldier who attended the half-hour briefing which took place on October 17 and was devoted to how so-called "radical" groups were "tearing the country apart," the soldier told Fox News, adding that the threat of Islamic terrorism was barely even mentioned.**

**Despite the fact that another soldier confirmed that threats of punishment were made during the meeting, an official Fort Hood representative denied the allegations.**

**"I was very shocked and couldn't believe what I was hearing," the soldier said. "I felt like my religious liberties, that I risk my life and sacrifice time away from family to fight for, were being taken away."**

**According to the soldiers, the counter-intelligence agent who conducted the briefing also said that Christians who protest against abortion were planning to bomb family planning clinics and that the pro-life movement was an example of "radicalization."**

**"The American public should be outraged that the U.S. Army is teaching our troops that evangelical Christians and tea party members are enemies of America and that they can be punished for supporting or participating in those groups," Liberty Institute Attorney Mike Berry told Fox News. "These statements about evangelicals being domestic enemies are a serious charge."**

“Our community is still healing from the act of terrorism brought on by (Muslim Jihadist) Nidal Hasan – who really is a terrorist,” the unnamed soldier added. “This is a slap in the face. “The military is supposed to defend freedom and to classify the vast majority of the military that claim to be Christian as terrorists is sick.”

**This is by no means the first time that US Army top brass as well as sectors of the federal government have identified Christians and other conservatives as terrorists.**

Earlier this month, it emerged that several dozen active duty and reserve troops at Camp Shelby in Mississippi were taught that the American Family Association, a credible Christian ministry, was a “domestic hate group.”

The 2001 documentary film “9/11: The Road to Tyranny” featured footage from a FEMA symposium given to firefighters and other emergency personnel in Kansas City in which it was stated that the founding fathers, Christians and homeschoolers were terrorists and should be treated with the utmost suspicion and brutality in times of national emergency.

**A Department of Defense manual that was leaked in August revealed how the DoD was teaching that the founding fathers were “extremists” and would not have been welcome in today’s military.**

A 2011 study funded by the Department of Homeland Security also characterized Americans who are “suspicious of centralized federal authority,” and “reverent of individual liberty” as “extreme right-wing” terrorists.

The recent firing of top military commanders Navy Vice Adm. Tim Giardina and Maj. Gen. Michael Carey has increased speculation that there are some very peculiar things happening within the U.S. military.

Earlier this week, former Navy SEAL Ben Smith warned that **the Obama administration is asking top brass in the military if they would be comfortable with disarming U.S. citizens, a litmus test that includes gauging whether they would be prepared to order non-commissioned officers to fire on Americans.**

**Leaked Video: FEMA Preparing Military Police For Gun Confiscations and Martial Law**

The video, shot in September 2013, shows an army commander briefing the MPs on their new command structure under the Federal Emergency Management Agency and the Department of Homeland Security for domestic operations with the National Guard.

The MP began recording the exchange after being shocked to hear that they were now under FEMA control.

In this video you can clearly hear the commander discuss the **suspension of the Constitution** for martial law and **gun confiscations** in America.

In essence, the military police is to provide security for FEMA while the agency confiscates our guns during a government-declared domestic crisis.

“They did that in Katrina, right,” the commander said. “They just go on and take away people’s guns.”

This is yet another piece of the larger pattern of demonization of gun owners, libertarians, conservatives, Christians and anyone who will not bow down to enslavement by a hijacked government occupied by ruthless tyrants who desire only total control.

The hijacked federal government has been meticulously preparing for martial law at a breakneck speed.

Last year, a leaked U.S. Army manual entitled FM 3-39.40 Internment and Resettlement Operations outlined the responsibilities of army “PSYOP” officers to indoctrinate “political

activists" into having an "appreciation of U.S. policies" while they are detained at detention camps within America.

Another training manual demonized Americans who embrace individual liberties as potential "extremists" and even referred to the Founding Fathers as examples of "extremists" in history.

The U.S. Army Civil Disturbance Operations manual from 2006 broke down how military assets on U.S. soil will be used to confiscate firearms, put down riots and even kill Americans.

This manual listed weapons to be used against American "dissidents," including "anti-riot" grenades, and emphasized that "warning shots will not be fired."

Earlier this year, Law Enforcement Targets, Inc., a provider of shooting targets to DHS and other federal agencies, sold a line of realistic-looking "non-traditional" targets of pregnant women, children and the elderly.

One target in particular depicted a pregnant woman standing inside a nursery. These targets are designed to condition law enforcement into shooting these American "threats" without hesitation.

In addition to buying shooting targets of Americans, DHS also bought two billion rounds of ammunition for domestic operations last year.

This excessive amount, enough to sustain the war in Iraq for 24 years, will ensure the rapid expansion of the police state during the civil chaos caused by the likely economic collapse of America.

We've already seen a similar paramilitary takeover after the Boston Bombings, when armored police went door-to-door to enter and search homes without a warrant.



"Buried deep within the over 1,000 pages of the massive US Health Care Bill (PDF) in a "non-discussed" section titled: Subtitle C-11 Sec. 2521— National Medical Device Registry, and which states its purpose as:

"The Secretary shall establish a national medical device registry (in this subsection referred to as the 'registry') to facilitate analysis of postmarket safety and outcomes data on each device that—“(A) is or has been used in or on a patient; and “(B) is a class III device; or “(ii) a class II device that is implantable.”

## ++Blood Donations are Potential Biohazard from Those Vaccinated with Gardasil

The huge wave of serious adverse conditions after receiving Gardasil vaccinations has caused deep concern across the world.

However, the suffering may not only be limited to those who are vaccinated. Blood donated from individuals vaccinated with Gardasil may have horrific consequences for the recipients' health.

Merck's Gardasil patient product insert originally stated that there was no viral DNA in the vaccine. After viral DNA was discovered by an independent lab, the statement mysteriously disappeared from US product inserts in April 2011.

SANE Vax Inc. believes that both the FDA and Merck were at least negligent and **perhaps fraudulent when claiming there was 'no HPV (viral) DNA' in the Gardasil vaccine.**

Dr. Lee, a pathologist on the medical staff at Connecticut's Milford Hospital, testified:

*"The finding of these **foreign DNA fragments** in the post-mortem samples six months after vaccination indicates that some of the residual DNA fragments from the viral gene or plasmid injected with Gardasil **may have been protected from degradation in the form of DNA-aluminum complexes in the macrophages; or via integration into the human genome.***

*Based on medical literature and **some of the FDA/Merck's own publications, & adventitious (coming from an outside source) **DNA in an injectable protein-based vaccine may increase the risk of autoimmune disorders and gene mutation which may lead to malignancies.***** [3]

If the Gardasil-vaccinated donate blood, these unanswered questions may apply both to the donors and to the recipients:

- Is the aluminum bound recombinant (genetically modified) HPV DNA a new chemical compound with untested toxicity?
- Does binding with aluminum prolong survival of the recombinant HPV DNA in the blood stream?
- If recombinant HPV DNA attached to aluminum adjuvant enters a person's blood, how long will it remain there?

- Which autoimmune-related disorders could result from this contamination?
- Which genetic changes (mutagenesis) could occur should the residual HPV DNA enter and begin reproducing in a human cell?
- Is it possible that the contamination will initiate gene mutations which may lead to cancer?

Information from the the UK National Health Service (NHS) explains **that after your blood has been collected for donation, it is sent for testing in a laboratory. Here, it is screened for viruses and infections such as HIV and hepatitis.**

If the blood passes this screening, it will usually be separated into different components. This means your blood donation can be used to help several different patients.

Once the blood has been separated, it is distributed to hospitals all over the country. [4]

**From this information, we may definitely deduce that blood will not be tested for genetically modified (recombinant) aluminium-bound HPV DNA. Blood from several donors may be mixed or pooled. Elements in blood from a Gardasil-vaccinated donor may be given to several recipients.**

**In some poor regions of the world the blood is not tested at all. The human consequences may be devastating. [5]**

**Guidelines for assessing blood donor suitability do not currently contain special restrictions regarding blood donation from Gardasil vaccinated. Comment: What about all the other plethora of vaccines that could be doing the exact same thing!!**

Here are some official guidelines from well-known organizations on assessing donor suitability for blood donation:

#### **WHO**

On page 64, **a list of vaccines is given, including the HPV vaccine & then this statement is made:**

***“These vaccines pose no risk to the recipients of blood; donors may be accepted provided they are well.” [6] Hosea 4:6!!***

#### **Australian Red Cross Blood Service**

*“Question: How long after I’ve had a vaccination (or flu shot, etc) can I donate?*

*Answer: **Those made from ‘killed/inactivated/recombinant’ material generally do not affect eligibility. These include diphtheria, influenza (both seasonal flu and H1N1 or ‘swine’ flu), hepatitis A, meningococcus, pertussis (whooping cough), pneumococcus, Q fever, tetanus, human papillomavirus (Gardasil) and others.**” [7]*

#### **UK National Health Service (NHS)**

***“People who cannot donate blood: You may not be able to donate blood if you have had certain immunizations within the last four weeks.” [8]***

This statement was followed up by sending a polite email message to Dr. David Salisbury, Director of Immunization, Department of Health:

*Dear Dr. Salisbury,*

*I understand that blood transfusion units maintain that blood donated from Gardasil-vaccinated poses no risk to the blood recipients. I found these guidelines. [9]*

*However, I have now read that fragments of gene-modified HPV DNA bound to aluminum have been found post-mortem from a girl who had been vaccinated with Gardasil six months previously.*

*My question is whether there may be harmful health consequences for the recipient of blood from a donor who has been vaccinated with Gardasil?*

Dear Ms. Lunoe,

**I fully endorse the advice of blood transfusion units to ignore receipt of Gardasil in blood donors as it poses no risk to recipients. The report of fragments of HPV DNA from a post-mortem specimen has been the subject of considerable criticism that I am sure you can find for yourself.**

**Dr. Salisbury did not refer to any evidence or studies to support his statement "... poses no risk to recipients."**

The same question was sent to **Centers for Disease Control and Prevention (CDC)**. Here is their prompt answer:

Thanks for your inquiry. **Vaccination with Gardasil provides no known risk to the blood recipients or the blood donor. The presence of DNA fragments is expected in Gardasil and not evidence of contamination. Based on the scientific information available to FDA, Gardasil continues to be safe and effective.** [10]


**But no evidence was given to support the statement: "Vaccination with Gardasil provides no known risk to the blood recipients or the blood donor."**

Before the HPV Vaccine, I was the most energetic child. I went to school for 8 hours, then went to 3 hours of gymnastics practice, finishing with homework at night. My weekends were filled with gymnastics meets. After gymnastics I went straight into competition cheerleading, which were the same hours. I basically lived in the gym and loved every second of it, I was blessed. Overall I was a healthy child.

I had **slight fatigue, and I would occasionally have a very sore throat. I couldn't stick my tongue out** and I just threw it off as an allergic reaction to chlorine because I was swimming a lot. The nightmare began on June, 2008. I received the second shot and I noticed it hurt a bit more than the first. I almost cried a bit which is very much unlike me. I got a little lightheaded at the checkout line. After 30 minutes I was fine (for the moment).

**The very next night I told my mom I was very sick. I was crying in pain with my pelvic and legs absolutely killing me. I was running a fever and I was very nauseous. So like a parent would, she took me to the emergency room. Of course, doctors only listen to one symptom and told me I had a stomach virus that they couldn't do anything and sent me home.**

**The next day I was so exhausted and slept till about 3 o'clock. My mom came home from work and I went outside and noticed I had some kind of rash all over my body. It looked like someone took a fine point purple permanent marker and dotted it all over me. My mom immediately took me to my regular pediatrician and he could not figure out what was on me. He ran a lot of blood work on me and we went home until we could receive the blood work news. My mom received a phone call around 9 O'clock. One of the scariest phone calls she has ever received.**

**My doctor told her I needed to get back to the ER ASAP. He told her that my blood work was CRITICAL, and the rash on me was called a petechial rash. My red blood cells and white blood cells were completely wiped out. They told me if I were to do a handstand my gums would start bleeding and I would bleed to death. If I caught a common cold my body would not be able to fight it off and I would die. Over the next 6 weeks I went through so many different rashes, EXTREME fatigue, joint pains, leg pains, shoulder pains, dizziness, and low blood pressure.**

**I finally went to an infectious disease specialist and he told me not to get the third shot or I wouldn't be here.**

I finally started feeling like I was getting better **but at the age of 15 I still had not received my menstrual cycle.** I went to an OB/GYN and he put me on birth control to start my period. **That should have been a sign then but we didn't think about it. I never gained my energy back.** My senior year things started acting up again. **I got a hemangioma on my lip which is very strange because it is mostly babies that will get a hemangioma, not adults. After that happened, I started getting very sick. I missed weeks of school at a time.**

I kept getting severe bronchitis and I just couldn't shake it off. I also had to go to the doctor because I was very depressed. I was then put on Zoloft. Luckily my teachers worked with me and I graduated with A's and B's.

Throughout the 5 years after I received the shot I always slept, never had energy, and kept getting what I thought was growing pains. In June of 2012 my growing pains were getting worse in my knees/legs. So my mom took me to the doctor and they couldn't really figure out what was wrong. They put me in a knee brace and gave me medicine and sent me off. I also just did not feel good at all and my doctor ran some more blood work on me. We then found out I had Hypothyroidism, I am now on medicine for that. **Comment: This is what "they"/Satan wants: A sterilized, sickly, DNA defiled, medically dependant population with a very low life expectancy, who cannot function in society anymore and most importantly could do very little for God if they were saved!!!**

I had 8 epidural steroid injections, none of which worked. I also was just diagnosed with fibromyalgia. But the fibromyalgia is still being researched on me. My Epstein Barr igG is 544.0 and the normal is 16.0 and below. And my blood clotting time is critical. They could not get it to clot so they finally had to put pressure to it. I also tested positive to atypical anca.

From June 2012-now (August 2013), I face every day with severe pain. My pain is in my lower back, pelvic, hips, back of leg, and knee. My legs will also turn a dark purple almost black and it will travel all the way down to my feet. I had an MRI for my back and found out that I am missing an ovary and have a mass on my uterus. Of course, when I went to the OBGYN for it, he did a sonogram and couldn't find the mass nor my ovary. He threw me off like it was no big deal. I am now lost on whether I have an ovary or a mass. I have discovered in this situation that doctors really will not try to help you. They just don't believe you or throw you off to another doctor if they can't figure it out.

I also have lost family members because of this problem. Not everyone will believe you or know what you are going through, but I am here to telling about what happened to me, so no girl or boy will have to go through the misery that I am going through.

I want to create something good out of something terrible.

**Sadly, Ashley is just one of countless young women and men who are harmed by Gardasil. Comment: And this is just one of the many death vaccines!!!** It's time to end the **vaccine holocaust** that is devastating our youth.

### **Are polio vaccines safe?**

When national immunization campaigns were initiated in the 1950s, the number of reported cases of polio following mass inoculations with the killed-virus vaccine was significantly greater than before mass inoculations, and may have more than doubled in the U.S. as a whole. ## The Danger of GMO Vitamins



Medical Tyranny— 09 August 2013

It is crucial to avoid GMO sources of any kind. Highly toxic, GMOs are associated with the development of deadly diseases in animals, including endocrine disorders, digestive diseases, immune dysfunction, and cancer. Most of the studies showing poisonous effects have been feeding studies in animals, where the test animals were fed

either GMO-tainted corn or soy, usually from Monsanto. In some cases such toxins induced the visible growth of tumors, often of monstrous size. In others infertility was the result, including permanent sterility of the generations.

So are GMOs a means of population control? Well Bill Gates is a major proponent of genocidal policies and is a major buyer of Monsanto stock. He further supports vaccinations which are also horrific.

It can be readily seen that most supplements contain such additives, fillers, sugars, and

vitamins. These components are just as toxic as the GMOs in foods and in some cases more toxic because they act as concentrates.

Regarding the source of vitamin C (ascorbic acid) and vitamin E (alpha tocopherol) see the following:

“Nearly 90% of all the vitamin C is made in China from GMO corn. In fact China is now the world’s leader in Vitamin C production.”

IIRC, the same article also mentioned that most vitamin E is also now manufactured from GMO sources.

**The toxicity is undeniable.**

**The following case histories demonstrate the harm that is being caused by these noxious supplement components:**

#### **Case History**

Ms. G. is a 30-year old woman who suffers from a variety of disorders caused by root canals. She was under care of a nutritionist for various health issues, who put her exclusively on non-GMO supplements (made by North American Herb & Spice). Her dentist insisted that she take ascorbic acid and also taking high-dose ascorbic acid by IV. The nutritionist warned her against this because of his experience with the toxicity of GMOs. She succumbed to the dentist’s commands and took the GMO ascorbic acid therapy. As a result, she broke out rapidly thereafter with massive amounts of highly painful canker sores all throughout mouth and throat, even extending onto the lips. | <u>Act 15:28</u> | For it seemed good to the Holy Ghost, and to us, to lay upon you no greater burden than these necessary things;   |
| <u>Act 15:29</u> | That ye abstain from meats offered to idols, and from blood, and from things strangled, and from fornication: from which if ye keep yourselves, ye shall do well. Fare ye well.   |
| <u>Act 21:25</u> | As touching the Gentiles which believe, we have written [and] concluded that they observe no such thing, save only that they keep themselves from [things] offered to idols, and from blood, and from strangled, and from fornication.        |
| <u>Rev 2:14</u>  | But I have a few things against thee, because thou hast there them that hold the doctrine of Balaam, who taught Balac to cast a stumblingblock before the children of Israel, to eat things sacrificed unto idols, and to commit fornication. |

This also doesn't seem like this is a good practice based on the verses below:

1Cr 8:9

But take heed lest by any means **this liberty of yours become a stumblingblock to them that are weak.**

1Cr 8:10

For if any man see thee which hast knowledge sit at meat in the idol's temple, shall not the conscience of him which is weak be emboldened to eat those things which are offered to idols;

1Cr 8:11

And through thy knowledge shall the weak brother perish, for whom Christ died?

1Cr 8:12

But when ye sin so against the brethren, and wound their weak conscience, ye sin against Christ.

1Cr 8:13

Wherefore, if meat make my brother to offend, I will eat no flesh while the world standeth, lest I make my brother to offend.

1Cr 10:27

If any of them that believe not bid you [to a feast], and ye be disposed to go; whatsoever is set before you, eat, asking no question for conscience sake.

1Cr 10:28

But if any man say unto you, This is offered in sacrifice unto idols, eat not for his sake that shewed it, and for conscience sake: for the earth [is] the Lord's, and the fulness thereof:
