Unless you've been hidden under a rock for the past twenty years, you are probably familiar with the development of radio-frequency identification (rfid) technology that under certain applications is forecast to be connected to future Grin technologies, especially neurosciences, brain-machine interfacing, and cybernetics. RFID chips employ tiny integrated circuits for storing and processing information using an antenna for receiving and transmitting the related data. This technology is most commonly applied as a "tag" for tracking inventory with radio waves at companies like Walmart, where consumer goods are embedded with "smart tags" that are read by hand-held scanners for supply chain management.

In recent years, rfid technology has been expanding within public and private firms as a method for verifying and tracking people as well. We first became aware of this trend a while back when chief of police Jack Schmidig of Bergen County, New Jersey, a member of the police force for more than thirty years, received a VeriChip (rfid chip) implant as part of Applied Digital Solution's strategy of enlisting key regional leaders to accelerate adoption of its product.

Kevin H. McLaughlin, VeriChip Corp.'s chief executive officer at the time, said of the event that **"high-profile regional leaders are accepting the VeriChip, representing an excellent example of our approach to gaining adoption of the technology"** (note that VeriChip Corp. was renamed to PositiveID Corp. on November 10, 2009, through the merger of VeriChip Corp. and Steel Vault Corp.). Through a new and aggressive indoctrination program called "Thought and Opinion Leaders to Play Key Role in Adoption of VeriChip," the company set out to create exponential adoption of its fda-cleared, **human-implantable rfid tag**. According to information released by the company, the implantable transceiver **"sends and receives data and can be continuously tracked by gps (Global Positioning Satellite) technology."** The transceiver's power supply and actuation system are unlike anything ever created. **When implanted within a body, the device is powered electromechanically through the movement of muscles and can be activated either by the "wearer" or by the monitoring facility.** In the wake of the terrorist attacks in New York and Washington, an information technology report highlighted the company's additional plans to study implantable chips as a method of tracking terrorists. "We've changed our thinking since September 11 [2001]," a company spokesman said. "Now there's more of a need to monitor evil activities." As a result, PositiveID has been offering the company's current incarnation of implantable rfid as **"a tamper-proof means of identification for enhanced e-business security...tracking, locating lost or missing individuals, tracking the location of valuable property [this includes humans], and monitoring the medical conditions of at-risk patients."** While PositiveID offers testimony that safeguards have been implemented to ensure privacy in connection with its implantable microchips, some believe privacy is the last thing internal radio

transmitters will protect—that in fact the plan to microchip humanity smacks of the biblical mark of the Beast. Has an end-times spirit indeed been pushing for adoption of this technology this generation?

Consider the following:

- In 1973 Senior Scholastics began introducing school kids to the idea of buying and selling in the future using numbers inserted in their foreheads. In the September 20, 1973, feature “Who Is Watching You?” the secular high school journal speculated: All buying and selling in the program will be done by computer. No currency, no change, no checks. **In the program, people would receive a number that had been assigned them tattooed in their wrist or forehead.** The number is put on by laser beam and cannot be felt. The number in the body is not seen with the naked eye and is as permanent as your fingerprints. All items of consumer goods will be marked with a computer mark. The computer outlet in the store which picks up the number on the items at the checkstand will also pick up the number in the person’s body and automatically total the price and deduct the amount from the person’s “Special Drawing Rights” account.
- The following year, the 1974 article, “The Specter of Eugenics,” had Charles Frankel documenting Nobel Prize winner Linus Pauling’s suggestions that a **mark be tattooed on the foot or forehead of every young person.** Pauling envisioned a mark denoting genotype.
- In 1980, U.S. News and World Report revealed how the federal government was plotting “National Identity Cards” without which no one could work or conduct business.
- The Denver Post Sun followed up in 1981, claiming that **chip implants would replace the identification cards.** The June 21, 1981, story read in part, “The chip is placed in a needle which is affixed to a simple syringe containing an anti-bacterial solution. The needle is capped and ready to forever identify something—or somebody.”
- The May 7, 1996, Chicago Tribune questioned the technology, wondering aloud if we would be able to trust “Big Brother under our skin?”
- Then, in **1997, applications for patents of subcutaneous implant devices for “a person or an animal” were filed.**
- In August 1998, the bbc covered the first-known human microchip implantation.
- That same month, the Sunday Portland Oregonian warned that proposed medical identifiers might erode privacy rights by tracking individuals through alphanumeric health identifier technologies. The startling Oregonian feature **depicted humans with bar codes in their foreheads.**
- Millions of Today Show viewers then **watched in 2002 when an American family got “chipped” with Applied Digital Solution’s VeriChip live from a doctor’s office in Boca Raton, Florida.**
- In November of the same year, ibm’s patent application for “identification and tracking of persons using rfid-tagged items” was recorded.

- Three years later, **former secretary of the Health and Human Services department, Tommy Thompson, forged a lucrative partnership with VeriChip Corp. and began encouraging Americans “to get chipped” so that their medical records would be “inside them” in case of emergencies.**
- The state of Wisconsin—where Thompson was governor before coming to Washington—promptly drew a line in the sand, passing a law prohibiting employers from mandating that their employees get “chipped.” Other states since have passed or are considering similar legislation.
- Despite this, in the last decade, **an expanding number of companies and government agencies have started requiring the use of rfid for people identification.** Unity Infraprojects, for example, one of the largest civil contractors in India, tracks its employees with rfid, as does the U.S. Department of Homeland Security for workers involved in baggage handling at airports.
- Since September 11, 2001, the U.S. government has proposed several versions of a national id card that would use rfid technology.
- Starting in **2006, the U.S. government began requiring passports to include rfid chips.**
- **Hundreds of Alzheimer’s patients have been injected with implantable versions of rfid tags** in recent years.
- **Rfid bracelets are now being placed on newborns at a growing list of hospitals.**
- Students are being required in some schools and universities to use biometric id employing rfid for electronic monitoring.
- **Thousands of celebrities and government officials around the world have had rfid radio chips implanted in them so that they can be identified—**either for entry at secure sites or for identification if they are kidnapped or killed.
- Others, like Prof. Kevin Warwick (discussed earlier), have been microchipped for purposes of controlling keypads and external devices with the wave of a hand.
- Besides providing internal storage for individual-specific information like health records, banking and industry, this technology envisions a cashless society in the near future where all buying and selling could transpire using a version of the subdermal chips and wireless authentication. Time magazine, in its feature story, “The Big Bank Theory and What It Says about the Future of Money,” recognized how this type of banking and currency exchange would not require a laser tattoo. Rather, the writer said, “Your daughter can store the money any way she wants—on her laptop, on a debit card, **even (in the not-too-distant future) on a chip implanted under her skin.**”<sup>[i]</sup>
- In 2007, PositiveID, which owns the Food and Drug Administration approved VeriChip that electronically transmits patients’ health information whenever a scanner is passed over the body, **ominously launched “Xmark” as its corporate identity for implantable healthcare products.**

- And now the Department of Homeland Security is working out how to implement the “Real id Act,” with the goal of codifying an international biometric id system.

The list above continues to accumulate, causing a growing number to wonder if rfid adoption will, for all practical purposes, result in every man, woman, boy, and girl in the developed world having an id chip inside them (like animals worldwide already do) sometime this century. Students of eschatology (the study of end-times events) find it increasingly difficult to dismiss how this all looks and feels like movement toward fulfilling Revelation 13:16–17: “And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads: And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name.”

As newer versions of rfid-like transmitters become even more sophisticated—adding other “prophetic” components such as merging human biological matter with transistors to create living, implantable machines—the authors believe the possibility that the mark of the Beast could arrive through a version of this technology. That is one reason we found the recent Discovery News report, “**Part-Human, Part Machine Transistor Devised,**” particularly disturbing: **Man and machine can now be linked more intimately than ever. Scientists have embedded a nano-sized transistor inside a cell-like membrane and powered it using the cell’s own fuel. The research could lead to new types of man-machine interactions where embedded devices could relay information about the inner workings of proteins inside the cell membrane, and eventually lead to new ways to read, and even influence, brain or nerve cells.**

“This device is as close to the seamless marriage of biological and electronic structures as anything else that people did before,” said Aleksandr Noy, a scientist at the University of California, Merced, who is a co-author on the recent ACS Nano Letters. “We can take proteins, real biological machines, and make them part of a working microelectronic circuit.”[ii]

A similar story (“Dna Logic Gates Herald Injectable Computers”) was published by New Scientist magazine the same month as the story above, and a few weeks earlier, an article by the Daily Mail (“Meet the Nano-Spiders: The dna Robots that Could One Day Be Walking through Your Body”) which reported the creation of **microscopic robots made of dna molecules that can walk, turn, and even create tiny products of their own on a nano-scale assembly line.**

**^Amazing Documentary on Chemtrails (but somewhat New Age)--Watch What in the World are They Spraying!**

**What In The World Are They Spraying?** is an investigation into all aspects of the phenomenon of chemtrails. Over the past decade and more, long white trails emanating from jet planes have been seen lingering in the skies all over the planet, often expanding and merging to form vast swathes of artificial cloud cover.

These trails are clearly not water vapour contrails, which evaporate after several minutes. They remain overhead for long extended periods of time, often culminating in strange grid like formations. Now they have people asking some serious questions.

What are these trails, who is spraying them into our atmosphere and for what purpose?

This film, produced by G. Edward Griffin, Michael Murphy and Paul Wittenberger sets out to answer those questions and discovers some disturbing answers.


Research indicates that the trails are part of a **geoengineering program** that may already be in its initial implementation phase.

Scientists at the Carnegie Institution are using taxpayer money to lay the groundwork for injecting the atmosphere with materials they believe will artificially cool the planet, in a bid to stave off what we are told is modern civilization's greatest threat to date, anthropogenic global warming.

Playing God with the atmosphere is having severe consequences, **particularly given that the compounds these scientists are testing are known to cause debilitating health problems and could lead to massive droughts and famines.**

Based around the madcap method of “injecting aerosols of sulfate into the stratosphere” to produce “a global sunshade,” researchers at the Carnegie Institution’s Department of Global Ecology have been running advanced trials on how to distribute artificially added sulfates to the atmosphere in the name of cooling the planet.

One of the main authors of the study was Ken Caldeira, the man who told a conference of fellow warmists earlier this year that **it would be a good idea to make the emission of CO2 an illegal act.** Presumably, that would include the very process of breathing



since all humans exhale carbon dioxide. That's right – the man tasked with playing God with the environment thinks breathing should be criminalized.

But it gets worse – **Caldeira is an advisor for and is being funded by Bill Gates** – the man who **thinks that old people should be killed to save teaching jobs**, and the man who says that vaccines which his foundation bankrolls to the tune of billions **should be used to lower population** and bring CO2 emissions down to a level approaching zero.

But the Carnegie study is just one recent example of a research program that has been ongoing for up to 20 years.

Experiments similar to Caldeira's proposal are already being carried out by U.S. government -backed scientists, such as those at the U.S. Department of Energy's (DOE) Savannah River National Laboratory in Aiken, S.C, **who last year began conducting studies** which involved shooting huge amounts of particulate matter into the stratosphere.

The science of geoengineering through chemtrails is **also vehemently backed by John P. Holdren**, the White House science czar, who in his **1977 book Ecoscience** advocated poisoning the water supply to involuntarily sterilize humans as part of a “planetary regime” that would control every aspect of our existence. The fact that such eugenicists are now in control of geoengineering programs that will have a direct impact on our health is beyond alarming.

Would you let Ted Bundy take your teenage daughter out on a date? Would you allow Ian Brady and Myra Hindley to baby sit your children? **And yet here we have a gang of elitists who have publicly stated their intent to use the threat of global warming and overpopulation as a justification for killing and sterilizing people, and we're giving them free reign with taxpayer money to play God with planet Earth? What is wrong with this picture?**

Geoengineering programs have also been **promoted by the Council on Foreign Relations**, which is one of the main steering committees behind the implementation of global governance.

In a document entitled **Geoengineering: Workshop on Unilateral Planetary Scale Geoengineering**, the CFR proposes different methods of “reflecting sunlight back into space,” which include adding “small reflecting particles in the upper part of the atmosphere,” adding “more clouds in the lower part of the atmosphere...”

**The proposals in the CFR document match exactly the atmospheric effects observed in the aftermath of chemtrail spraying.**

A recent **report issued by the UK government** also calls for the UN to exclusively regulate world wide geoengineering of the planet in order to stave off man made global warming.

Discussion of geoengineering technology is often framed as a future consideration, yet governments are already conducting such programs at an advanced stage.

The Atmospheric Radiation Measurement (ARM) Program was created in 1989 with funding from the U.S. Department of Energy (DOE) and is sponsored by the DOE's Office of Science and managed by the Office of Biological and Environmental Research.

The DOE website states that, "The current focus of the program is *aerosol radiative forcing of climate*: aerosol formation and evolution and aerosol properties that affect direct and indirect influences on climate and climate change."

U.S. government scientists are already bombarding the skies with the acid-rain causing pollutant sulphur dioxide in an attempt to fight global warming by "geo-engineering" the planet, despite the fact that injecting aerosols into the upper atmosphere carries with it a host of both known and unknown dangers.

Such programs merely scratch the surface of what is likely to be a gargantuan and overarching black-budget funded project to geo-engineer the planet, with little or no care for the unknown environmental consequences this could and are engendering.

Injecting the atmosphere with sulfate aerosols is a completely insane, untested and dangerous proposal.

Rutgers University professor Alan Robock has warned that such experiments "could create disasters," damaging the ozone layer and potentially altering the stratosphere by eliminating weather patterns such as the annual Asian monsoon rain season, which 2 billion people rely upon to water their crops and feed the population.

"Imagine if we triggered a drought and famine while trying to cool the planet," **Robock told a geo-engineering conference last year.**

However, when you consider the fact that the **global warming mantra is a thin veil for eugenics and population control**, it's unlikely that the world's elite care about one third of the planet's population being unable to eat, in fact they would probably see that as a bonus.

The known facts about what happens when the environment is loaded with sulphur dioxide are bad enough, since the compound is the main component of acid rain, **which according to the EPA** "Causes acidification of lakes and streams and contributes to the damage of trees at high elevations (for example, red spruce trees above 2,000 feet) and many sensitive forest soils. In addition, acid rain accelerates the decay of building materials and paints, including irreplaceable buildings, statues, and sculptures that are part of our nation's cultural heritage."

The health effects of bombarding the skies with sulphur dioxide alone are enough to raise serious questions about whether such programs should even be allowed to proceed.

The following health effects are linked with exposure to sulphur.

- Neurological effects and behavioral changes
- Disturbance of blood circulation
- Heart damage

- Effects on eyes and eyesight
- Reproductive failure
- Damage to immune systems
- Stomach and gastrointestinal disorder
- Damage to liver and kidney functions
- Hearing defects
- Disturbance of the hormonal metabolism
- Dermatological effects
- Suffocation and lung embolism



This graphic proposes, “Spraying aluminum powder and barium oxide into high levels of the atmosphere, again delivered by aircraft, to increase planetary reflectance (albedo) and cloud cover.” High levels of barium have been found in substances associated with chemtrails.

Reports of chemtrails have increased dramatically over the last 10 years. Many have speculated that they are part of a government program to alter climate, inoculate

humans against certain pathogens, or even to toxify humans as part of a population reduction agenda.

In 2008, a [KSLA news investigation](#) found that a substance that fell to earth from a high altitude chemtrail contained high levels of Barium (6.8 ppm) and Lead (8.2 ppm) as well as trace amounts of other chemicals including arsenic, cadmium, etc.. Of these, all but one are metals, some are toxic while several are rarely or never found in nature.

This newscast focuses on Barium, which its research shows is a “hallmark of chemtrails.” KSLA found Barium levels in its samples at 6.8 ppm or “more than six times the toxic level set by the EPA.” The Louisiana Department of Environmental Quality confirmed that the high levels of Barium were “very unusual,” but commented that “proving the source was a whole other matter” in its discussion with KSLA.

KSLA also asked Mark Ryan, Director of the Poison Control Center, about the effects of Barium on the human body. Ryan commented that “short term exposure can lead to anything from stomach to chest pains and that long term exposure causes blood pressure problems.” The Poison Control Center further reported that long-term exposure, as with any harmful substance, would contribute to weakening the immune system, which many speculate is the purpose of such man-made chemical trails.

One of the accepted truisms of scientific study is the fact that if scientists are proposing an idea, then those scientists with access to the bottomless pit of black-budget secret government funding are already doing it.

It is highly likely that chemtrails are merely one manifestation of “geo-engineering” that is taking place without proper debate, notification or any form of legality, and with a callous disregard for the potential dangers to both our health and our environment.

On the face of it, the idea of artificially poisoning the atmosphere with substances known to cause massive health problems and one that many environmentalists say will lead to crippling droughts and famines, is a complete over-reaction to combating climate change which has naturally occurred for thousands of years. **Add to that the fact that the people proposing, funding, and researching the issue are all avowed eugenicists who have been vocal in their mission to enact draconian measures of population control and the true scope of what we're dealing with is clear – an effort by control freaks whose sole interest is not about caring for the planet, but hijacking concerns about the environment as a vehicle through which to enforce their putrid cocktail of death and tyranny.**

Springfield, MO — An [article](#) by Tim Ross and Martin Beckford for the UK Telegraph this week cites a study published by the Church of England concluding that people "born after 1982 - known as 'Generation Y' - have only a 'faded cultural memory' of Christianity."

Most young people today define themselves by a "secular trinity of family, friends and the reflexive self", the study found, giving them an "immanent faith" based on

In contrast to the Church of England study, here in the United States the pagan-driven occult Burning Man Festival 2010 held a few weeks ago was bigger than ever, surpassing last year's tens of thousands of participants as the number of earth-worshipping pagans swelled the ranks of party-goers from across Canada, Brazil, Germany, Russia, and 25 other countries to an isolated corner of Black Rock Desert in Nevada.



### Massive stretches of weathered oil spotted in Gulf of Mexico

**Bob Marshall**--The Times-Picayune --Just three days after the U.S. Coast Guard admiral in charge of the BP oil spill cleanup declared little recoverable surface oil remained in the Gulf of Mexico, Louisiana fishers Friday found miles-long strings of weathered oil floating toward fragile marshes on the Mississippi River delta.

The discovery, which comes as millions of birds begin moving toward the region in the fall migration, gave ammunition to groups that have insisted the government has overstated clean-up progress, and could force reclosure of key fishing areas only recently reopened.

The oil was sighted in West Bay, which covers approximately 35 square miles of open water between Southwest Pass, the main shipping channel of the river, and Tiger Pass near Venice. Boat captains working the BP clean-up effort said they have been reporting large areas of surface oil off the delta for more than a week but have seen little response from BP or the Coast Guard, which is in charge of the clean-up.

The H1N1 swine flu virus may be starting to mutate, and a slightly new form has begun to predominate in Australia, New Zealand and Singapore, researchers reported on Thursday.

More study is needed to tell whether the new strain is more likely to kill patients and **whether the current vaccine can protect against it completely**, said Ian Barr of the World Health Organisation Collaborating Centre for Reference and Research on Influenza in Melbourne, Australia and colleagues.

"However, it may represent the start of more dramatic antigenic drift of the pandemic influenza A(H1N1) viruses **that may require a vaccine update sooner than might have been expected**," they wrote in the online publication Eurosurveillance.

It is possible it is both more deadly and also able to infect people **who have been vaccinated**, they said.

**Patients' anger after they are unable to opt out of swine flu vaccine despite fears of side effects**

Patients' groups have expressed anger over this year's seasonal flu jab programme **because people are unable to opt out of having the swine flu vaccine.** The H1N1 vaccine will be the dominant of three flu strains included in the shot, **meaning millions of elderly and vulnerable patients will get it automatically.** Yet many people refused to have the swine flu vaccine when it was offered last year because of fears it may cause serious side effects.

There does not seem to be any patient choice involved here – either patients have both vaccines or no vaccine.' Each year the World Health Organisation considers which strains of flu will be dominant in winter. This year **they ruled** H1N1 would be a dominant strain. The annual seasonal flu jab is being offered to about 12 million people. **For the first time, pregnant women are included because of the dangers posed by the swine flu virus.** However, some patients are fearful of having this year's jab.

There really should be a choice.' The Medicines and Healthcare products Regulatory Agency received nearly 8,600 suspected adverse reactions to the swine flu jab during the pandemic last winter. Most involved pain or swelling at the site of the jab, vomiting and headaches.

The MHRA also received 15 reports of patients developing Guillain-Barre Syndrome. It is not known if the cases are linked to the vaccine, although a swine flu jab in the US in 1976 led to 25 deaths from the condition. **Please remember these numbers are severely understated**

## **Gestapo government orders family farm to commit financial suicide by destroying 50,000 pounds of cheese**

Huff, staff writer (NaturalNews) The United States of America is currently in the midst of a hostile takeover by a rogue government hellbent on controlling the nation's food supply. And in one of its latest acts of domestic terrorism, federal and state officials recently decided to go after Morningland Dairy, a family-owned dairy farm in Missouri, ordering it to destroy 50,000 pounds of raw, artisan cheese -- worth roughly \$250,000 -- for no legitimate reason.

The incident dates back to June 2010 when federal and state officials raided Rawesome Foods, a private food buying club in Venice, Calif., for alleged code violations.

According to testimony, the agents confiscated Morningland's cheese from Rawesome as part of their sweep and put it in un-iced coolers for later testing. Even though California state law mandates that confiscated food be tested immediately, it took officials **seven weeks** to conduct the tests, and nobody knows where the cheese was or how it was handled during that time -- **other than that it was not properly refrigerated from the moment it left Rawesome.**

When the tests were finally completed almost two months later, they allegedly came up positive for bacterial contamination, which prompted immediate action by officials back in Missouri where Morningland dairy is located. Both the Missouri Milk Board and the U.S. Food and Drug Administration (FDA) showed up at Morningland on August 26 and "embargoed" the dairy from making or selling any product because of the alleged contamination.

So for a month and a half, Morningland was forced to dump all of its milk and avoid all production, even though no official and properly conducted tests had proven there to be anything wrong with the cheese stock in the first place. The dairy was also forced to recall and destroy all cheese sold since January 1, 2010.

A month later, officials came back to Morningland Dairy and verbally demanded that it destroy its entire stock of cheese, even though an official FDA-conducted swab of the entire dairy plant and farm found no contamination whatsoever. The FDA did not, however, take any official samples of the dairy's cheese for testing, which makes the demand to destroy it all even more bizarre.

Morningland immediately contested the outlandish demands, pointing to "lack of scientific evidence, lack of transparent protocol and complete lack of any illness associated with [its] cheese." And as of this writing, the dairy is awaiting a proper response from authorities.
