Russian activist disappears after exposing vaccination plans for Russia, Ukraine and Belarus

Alexander Goncharov, a Russian activist who has been exposing the globalists eugenics program and in particular a vaccination program set to begin in 2011 has disappeared after recently receiving a serious threat to his life.

He has been missing since the night of October 30th, 2010, at approximately 22:00 hours when he was last seen leaving his office at the Russian Benevolent Society and did not return home as expected.

Alexander Goncharov had sworn an oath to disseminate as much information as possible about the globalists eugenics program to medical professionals and the public. He had uncovered a plan to sterilize women through vaccination programs in Russia, Ukraine and Belarus.

The same day threats were made on his life Alexander had asked for protection from paratrooper friends, but unfortunately it seems he did not get this additional security on time, as he disappeared that very night.

Below is the last statement of Alexander Goncharov made on 22nd October, 2010.

I, Alexander Goncharov, President of the Russian Benevolent Society, received information from honest doctors who do not wish to take part in KILLING their own people, about preparations for the mass DESTRUCTION OF OUR CHILDREN in the guise of a “new vaccination” scheduled for early 2011.

I cannot confirm or deny this information or vouch for the credibility of it, but I ask everyone to check it for themselves. “Someone” found out that I had this information and I was first offered a bribe for non-disclosure and secondly threatened with death if I continued disseminating information about the upcoming KILLING of our children. I rejected their “proposal” and will never accept the deliberate destruction of my own people – I have a holy duty to the motherland, in accordance with the Constitution of Russia and knowing the power of the enemies of our people, I have sworn to disseminate information about the impending MURDER OF ALL OUR CHILDREN IN RUSSIA and I will circulate this information by all possible means.

I specifically appeal to the staff of the Ministry and FEDERAL SECURITY SERVICE, to listen to my calls and read my correspondence – **THEY WANT TO KILL YOUR CHILDREN. Therefore, you have a choice: either to help the survival of your people or procure small coffins for your own grandchildren.**

THE FOLLOWING WILL TAKE YOU TWO MINUTES TO READ AND SAVE THE LIVES OF YOUR CHILDREN.

Subject: [Contending for Truth:] About your x-ray comments

It really struck a cord with me when you said you don't do x-ray any more as you feel they are not safe. I couldn't agree more, i am an x-ray tech and now do Lithotripsy busting kidney stones. We use fluoroscopy to see the stone and make sure they break. We use maybe 2 mins of fluoro during the entire exam. So we try to keep the dose as low as possible. But i use to do Cat Scans and it just struck me in what you said. **I can no longer do CT scans knowing how many people are getting mega doses of radiation. The amount of radiation being pump out by CT scans is just mind blowing.** I was working on a GE 64 slice and we would use almost 700 mAs to do the 3D heart scans and the scan last around 10 to 15 seconds. And that is not counting the scout scans taken to set up the heart scan. A normal chest xray is done at 85-100 kvp at maybe 2-8 mAs. **So we were really pumping out some serious radiation.** I did so many unnecessary scans just so the ER doctors would not get sued. Anyone with a **headache coming to the ER would get a head CT with huge amounts or radiation going straight to the brain and eyes.** Maybe 1 in 2000 scans would be positive for a bleed or mass. Just about anyone with abdominal pain would have an abdominal pelvic CT scan. So now the **groin is getting massive amounts of radiation.** It just sickens me and i can not bring myself to do CT scans ever again.

Peak kilovoltage (kVp) is the maximum [voltage](#) applied across an [X-ray tube](#). It determines the [kinetic energy](#) of the [electrons](#) accelerated in the X-ray tube and the peak energy of the [X-ray emission spectrum](#). Increasing **mAs** causes more photons (radiation) of the particular kVp energy, to be produced.

Atheist Ministers Struggle With Leading the Faithful

Jack said that his secret left him feeling isolated but that he would certainly lose a lot of friends when he professed to no longer being a Christian. His wife doesn't know and he said it was possible he could lose her as well.

"It's going to be very confusing for her," Jack said. "It's going to be very devastating and it's going to take us a while to work through it."

Adam said his wife knew that he was struggling with his faith but not that he had lost it completely.

"It's a very tough situation to be in," he said. "I can't think of another **career** that is so dramatically affected by a change in one's opinions or thoughts."

Here are some basic tips to always keep in mind:

1: What you can dehydrate and how you can use the ingredients once dehydrated, is limited only by your imagination. If you're a great cook, you'll still produce the same high quality meals. If you can only boil water, then at least you'll eat well at very reasonable prices.

2: Learn how to shop intelligently. Just because it's being sold by Amazon rather than Macy's, doesn't mean it's a good buy. Learn how to use the internet & especially eBay effectively. Most people don't know how.

3: If you're serious about serving only healthy food to your family you **MUST** learn how to read labels. If you typically consume junk food, & buy things like frozen sausage & egg breakfast muffins, and know what poisons you're putting into your bodies and are cool with it, then you can skip the rest of this section.

The big killer is trans fats. Trans fats may be the single most deadly poison that Americans consume. You've heard about them and are probably used to seeing foods with "No Trans Fats" labels on them in your markets. Learning how to spot food labels that lie, is really quite simple.

A huge number of food companies, even many of those who put "No Trans Fats" labels on their products use trans fats in pretty large quantities in what they sell. How do they get away with this you ask? Once again it's our government screwing us with trick language. In collusion I'm sure with giant food conglomerates, they've ruled that as long as there's less than 1 gram of trans fat "per serving" in what you're buying, the manufacturer can legally say they aren't using any. So a package of snacks with 10 servings of some processed crap, can have 9 grams of trans fats in it while denying they use any at all, because

that's only 9/10's of a gram per serving. The tip off is in the ingredients list. They have to tell you what's in it. Hydrogenated or partially hydrogenated oils etc, are trans fats by another name. It's just like the way they say Quantitative Easing instead of Devaluation. It's all BS folks.

Note: Don't be at all surprised, if this makes you stop buying lots of stuff that you buy all the time!

Trans fats are certainly not the only poison we consume, but in general, you'll be safe if you avoid purchasing any food items that have the words "hydrogenated", "partially hydrogenated" or "hydrolyzed" HVP, TVP, MSG or yeast extract in their list of ingredients.

4: Buy ingredients, not meals. Pre-made bags of dehydrated beef stew are OK if you're on a long camping trip, and aren't creative enough to bring better food to eat. As emergency survival items I guess they're fine, but they're terribly expensive.

Whenever you see one of these MLM (Multi Level Marketing) schemes, run for the hills. In order to pay all the middle-men they have to charge very high prices.

Look on their website. They sell 13.2 lbs of instant rice (yeachhh) for \$56.59

Now check out Honeyville grains @
<http://store.honeyvillegrain.com/riceproducts.aspx> and you'll see that they sell 50 lbs of rice for \$52.99.. No contest. \$4.29lb Vs \$1.06lb.

Check out their prices for beans vs Honeyville's

Kidney Beans 28.2lbs \$62.68 Vs 25lbs \$39.99
Pinto Beans 27.78lbs \$50.35 Vs 50lbs \$59.99
Small red beans 30lbs \$62.59 Vs 25lbs \$38.99
Small white Navy beans 30lbs \$59.89 Vs 25lbs \$36.99

Others have mentioned other such companies, such as Mountain House, and Wise Food Storage, and Wise Food Storage www.wisefoodstorage.com and there are dozens of others. While most of these companies are not MLM's, they're all selling meals, rather than simple healthy ingredients from which you can easily make your own meals. Unless you're willing to survive on what is basically mediocre quality cafeteria type food, which happens to cost an arm & a leg, these companies are all to be avoided.

Living (exclusively) on dehydrated foods certainly somewhat limits in terms of

what you have on your table. You can make great apple pies, but you won't want to eat the apples raw. Some fruits on the other hand, such as banana chips, are great as is.
