
According to my sources, Obama will ultimately implement the following gun control regulations, mostly through a series of Executive Orders.

1. Tax ammunition into oblivion and encourage the prosecution of gun manufacturers and bullet producers for shootings that used their products. This is a given and will be rolled out very early in the form of an Executive Order.
2. The Federal government will purchase as much ammunition as possible in order to create shortages, thus, driving up the price of ammunition.
3. The prohibition of purchasing a gun in one state and transporting that same gun across state lines.
4. New Federal regulations which will permit, without a warrant, any civil authority to enter a home of a registered gun owner to check for gun safety when it comes to the "proper" storage of guns. Said gun can be confiscated and the owner will be subject to arrest and fines if a gun does not meet governmental storage regulations. The new regulations will be devised to prevent one from using the gun in a moment's notice.


5. There is discussion among DoJ officials about limiting how many guns, in the aggregate, that can be stored in one geographic area. This will amount to gun rationing.
6. Gun owners will eventually be required to attend and pass gun safety courses in the same manner as one renews their drivers license. This will, again, drive up the cost of owning a gun.
7. At some point, no doubt following a false flag event, an Executive Order will be issued to overturn all conceal and carry laws currently in place in several states.
8. With regard to Child Protective Services investigations, any gun-owning parent will receive a negative score when it comes to investigation of child abuse and welfare cases.
9. No veteran will be allowed to own a gun for an unspecified period of time following their discharge from the service. As part of the VA reform there is serious discussion about mandating outplacement counseling for all veterans and gun prohibitions will be a part of this. I was told that this is, in part, is why all the Federal attention is being placed on streamlining the VA process for veteran access.
10. The scope of gun free zones will be expanded. The IRS will be given policing powers on new gun control regulations. Bank accounts and homes can be seized for failure to comply. Further, RICO statutes can be utilized among the non-compliant. It was stressed to me that examples will be made of protesters and non-compliant people.
11. Obama will wait for the next false flag, & then will announce a ban on all assault rifles.



In the text of the H.R. 4269 we see the following section title "SEC. 3. RESTRICTIONS ON ASSAULT WEAPONS AND LARGE CAPACITY AMMUNITION FEEDING DEVICES."

It states:

"(v) (1) It shall be unlawful for a person to import, sell, manufacture, transfer, or possess, in or affecting interstate or foreign commerce, a semiautomatic assault weapon.

[...]

(w) (1) It shall be unlawful for a person to import, sell, manufacture, transfer, or possess, in or affecting interstate or foreign commerce, a large capacity ammunition feeding device.

In section 2, they define the term "semiautomatic pistol" as (A) utilizes a portion of the energy of a firing cartridge to extract the fired cartridge case and chamber the next round; and (B) requires a separate pull of the trigger to fire each cartridge. They also define the term "semiautomatic shotgun" as (A) utilizes a portion of the energy of a firing cartridge to extract the fired cartridge case and chamber the next round; and (B) requires a separate pull of the trigger to fire each cartridge.

They offer other definitions in the text for those that wish to read them and then they list what weapons would be included in their "Assault Weapons Ban of 2015"



As stated in section three, this bill does not apply to the U.S. government and law enforcement:

(4) Paragraph (1) shall not apply to—

“(A) the importation for, manufacture for, sale to, transfer to, or possession by the

United States or a department or agency of the United States or a State or a department, agency, or political subdivision of a State, or a sale or transfer to or possession by a qualified law enforcement officer employed by the United States or a department or agency of the United States or a State or a department, agency, or political subdivision of a State, for purposes of law enforcement (whether on or off duty), or a sale or transfer to or possession by a campus law enforcement officer for purposes of law enforcement (whether on or off duty);



BOTTOM LINE

Many ANP readers have been concerned over the latest attempt on the part of [Democrats in Congress to strip away more of Americans' Second Amendment rights with their "Assualt Weapon Ban of 2015"](#) introduced in the US House of Representatives with the stated purpose being "To regulate assault weapons, to ensure that the right to keep and bear arms is not unlimited, and for other purposes."

What slipped through the cracks while our attention was focused on the introduction of the U.S. congressional bill was another (on a state level in Illinois) that was filed with the Illinois House clerk on November 6, 2015, sponsored by three Democratic State Representenatives, Emanuel Welch, Rep. Pamela Reaves-Harris and Jaime Andrade, which directly challenges the Supreme Court ruling in [DISTRICT OF COLUMBIA... vs.](#)

HELLER, which held "that the Second Amendment protects an individual's right to possess firearms and that the city's total ban on handguns, as well as its requirement that firearms in the home be kept nonfunctional (even when necessary for self-defense), violated that right."

The Illinois bill [HR0855](#), titled "**2ND AMEND-NOT INDIVIDUAL RIGHT**," is far more dangerous in language and intent than the Assault Weapon Ban of 2015 because there is little chance the Weapon Ban will pass, and has a higher likelihood that the Illinois state bill will pass considering the composition of the Illinois House stands at **71 Democrats with only 47 Republicans**.

The danger in this bill is that they are going after private ownership of guns, for if they can ban private ownership, they can take the next step and confiscate weapons legally owned now by making it illegal for private citizens to possess a firearm.

Text of HR0855 - 2ND AMEND-NOT INDIVIDUAL RIGHT, below and can be found at <http://www.ilga.gov/legislation/99/HR/09900HR0855.htm>:

WHEREAS, Gun violence is an ever present problem in the State, as well as nationwide; an example of which is 8 persons dying in Chicago in one week in October due to gun violence; and

*WHEREAS, In the past few years, court rulings, including the United States Supreme Court in District of Columbia V.Heller, in interpreting the Second Amendment to the United States Constitution have overturned long standing precedent, which had **supported state and local authority to deny gun possession** when necessary to promote and protect public safety; in order to reach its decision, the 5 member majority of the United States Supreme Court either ignored or misinterpreted much of the clear and plain wording of the Second Amendment; and*

WHEREAS, As stated by U.S. Supreme Court Justice Stevens in his well-thought out dissent on behalf of 4 Justices in Heller: "The Second Amendment was adopted to protect the right of the people of each of the several States to maintain a well-regulated militia. It was a response to concerns raised during ratification of the Constitution that the power of Congress to disarm the state militias and create a national standing army posed an intolerable threat to the sovereignty of the several States. Neither the text of the Amendment nor the arguments advanced by its proponents evidenced the slightest interest in limiting any legislature's authority to regulate private civilian uses of firearms. Specifically, there is no indication that the Framers of the Amendment intended to enshrine the common-law right of self-defense in the Constitution."; rather the Second Amendment's original purpose was to act as a check on federal gun-making policy, not to prevent individual states from creating gun policy as they saw fit; and

WHEREAS, The legal view of the Second Amendment as a collective, militia right, and not an individual right, held for over 200 years until the Heller decision in 2008, which invalidated a law barring individuals from possessing a handgun not registered before the law took effect and annual registrations for the remaining handguns; and

WHEREAS, The Heller decision and other pro-firearm industry court rulings have resulted in a proliferation of guns in numerous communities and have diminished the security and freedom of our citizens to enjoy a life free of gun violence; living with the fear of gun violence is contrary to living in a free society; high levels of gun violence are a threat to the security of whole communities; and

WHEREAS, The cost of gun violence has been pushed onto everyone except the people and companies that produce and sell firearms; the firearms industry benefits financially when more guns are sold; more firearms in circulation leads to more gun crimes, homicides, and suicides to the extent that gun-related deaths will soon exceed the number of deaths in automotive crashes; but the Heller decision effectively said that most of the Second Amendment should be disregarded in favor of the part that is most profitable to the firearms industry, "the right of the people to keep and bear arms shall not be infringed"; and

WHEREAS, Throughout the history of the United States, federal and state laws **have regularly placed restrictions on who can legally own, possess, and use firearms**; even prior to the ratification of the U.S. Constitution, gun control laws were enacted; therefore laws restricting gun access are not anomalous to American law; and

WHEREAS, Before these court decisions, **state legislatures had been able to pass laws restricting gun access** if it was in the best interests of public safety; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the courts, especially the United States Supreme Court, to restore interpretation of the Second Amendment as a right afforded to state-sponsored militias that as Justice Stevens stated in his Heller dissent, " ... it does not curtail the Legislature's power to

regulate the non-military use and ownership of weapons ... ".

BOTTOM LINE

The whole resolution is about restricting access of private citizens to legally own weapons.... they aren't going after specific weapons as the introduction of the Assault Weapon Ban of 2015 in the U.S. House of Representatives.... this bill is going after all privately owned guns.

This is a beta test but this is also the end

goal of the Obama administration and Democratic politicians.

Once they have banned private ownership, they will have given the state of Illinois the right to confiscate weapons from citizens that refuse to hand them over.

For those that have been waiting for the next volley in the governments attempt to disarm Americans.... this beta test is it.

Bloodthirsty Daesh Islamists posted notes through the doors of dozens of random neighbors in several cities across Sweden, including the capital Stockholm, threatening to murder “non-believers” in a terrifying campaign of violence.

Sweden is now on lockdown after the chilling letters pledged to behead innocent civilians and then “bomb your rotten corpses afterwards”.

Intelligence officials confirmed they are investigating the horrifying threats – which were signed by “ISIS” – as a state of fear gripped the nation. The notes, written in Swedish, order people to convert to Islam or pay a religious tax, known as the jizya, warning that the police “will not save you from being murdered”.



The letter, posted on Facebook, features the flag of ISIS

It warns Swedes they must convert to Islam or face being beheaded

It states:

“In the name of Allah, the merciful, full of grace. You who are not believers will be decapitated in three days in your own house. We will bomb your rotten corpses afterwards.” You must choose between these three choices: 1. Convert to Islam. 2. Pay the jizya [religious tax] for protection. 3. Or else, you will be decapitated. “The police will not prevent or save you from you being murdered. (Death comes to all of you).”

Swedish police said these death notices were posted through residents’ doors in a number of prominent Swedish cities including the capital Stockholm, earlier this week.

Muslim Inbreeding: Impacts on intelligence, sanity, health and society

Massive inbreeding within the Muslim culture during the last 1.400 years has done catastrophic damage to their gene pool. The consequences of intermarriage between first cousins often has serious impacts on the offspring’s intelligence, sanity, health and on their surroundings.

The most famous example of inbreeding is in ancient Egypt, where several Pharonic dynasties collapsed after a couple of hundred years. In order to keep wealth and power within the family, **the Pharaohs often married their own sister or half-sister and after a handful of generations the offspring were mentally and physically unfit to rule.** Another historical example is the royal houses of Europe where royal families often married among each other because tradition did not allow them to marry people of non-royal class.

The high amount of mentally retarded and handicapped royalties throughout European history shows the unhealthy consequences of this practice.

The Muslim culture still practices inbreeding and has been doing so for longer than any Egyptian dynasty. **A rough estimate shows that close to half of all Muslims in the world are inbred: In Pakistan, 70 percent of all marriages are between first cousins (so-called “consanguinity”) and in Turkey the amount is between 25-30 percent** (Jyllands-Posten, 27/2 2009 [More stillbirths among immigrants](#))

Statistical research on Arabic countries shows that up to 34 percent of all marriages in Algiers are consanguine (blood related), 46 percent in Bahrain, 33 percent in Egypt, 80 percent in Nubia (southern area in Egypt), 60 percent in Iraq, 64 percent in Jordan, 64 percent in Kuwait, 42 percent in Lebanon, 48 percent in Libya, 47 percent in Mauritania, 54 percent in Qatar, 67 percent in Saudi Arabia, 63 percent in Sudan, 40 percent in Syria, 39 percent in Tunisia, 54 percent in the United Arab Emirates and 45 percent in Yemen (Reproductive Health Journal, 2009 [Consanguinity and reproductive health among Arabs.](#)).

A large part of inbred Muslims are born from parents who are themselves inbred – which increase the risks of negative mental and physical consequences greatly. (Jyllands-Posten, 27/2 2009 [More stillbirths among immigrants](#)).

More than half of Pakistani immigrants living in Britain are intermarried: The research, conducted by the BBC and broadcast to a shocked nation on Tuesday, found that at least 55% of the community was married to a first cousin. This is thought to be linked to the probability that a British Pakistani family is at least 13 times more likely than the general population to have children with recessive genetic disorders.” (Times of India, 17/11 2005 [Ban UK Pakistanis from marrying cousins](#)).

Several studies show that children of consanguineous marriages have lower intelligence than children of non-related parents. Research shows that the IQ is 10-16 points lower in children born from related parents and that abilities related to social behavior develops slower in inbred babies:

The article “Effects of inbreeding on Raven Matrices” concludes that “Indian Muslim school boys, ages 13 to 15 years, whose parents are first cousins, were compared with classmates whose parents are genetically unrelated on the Raven Standard Progressive Matrices, a nonverbal test of intelligence. The inbred group scored significantly lower and had significantly greater variance than the non-inbred group, both on raw scores and on scores statistically adjusted to control for age and socioeconomic status.” ([Behaviour Genetics, 1984](#)).

Another study shows that the risk of having an IQ lower than 70 goes up 400 percent from 1.2 percent in children from normal parents to 6.2 percent in inbred children.” (Proceedings of the National Academy of Science, 1978 [Effect of inbreeding](#))

[on IQ and mental retardation](#)"). The study [A study of possible deleterious effects of consanguinity](#) concludes, that **"The occurrence of malignancies, congenital abnormalities, mental retardation and physical handicap was significantly higher in offspring of consanguineous than non-consanguineous marriages."**

The risk of stillbirth doubles when parents are first cousins (Jyllands-Posten, 27/2 2009 [More stillbirths among immigrants](#)).

Deaths due to autosomal recessive disorders were 18 times more common in the Pakistani children. Similarly, deaths due to multiple malformations, which may be part of unrecognized autosomal recessive syndromes, were 10 times more common.

(BMJ, 1994 [Infant death and consanguineous marriage](#)).

Another study focused on the relationship between intermarriage and schizophrenia:

"The closer the blood relative, the more likely was there to be a schizophrenic illness."

(American Psychiatric Press, 1982 [The role of genetic factors in the etiology of the schizophrenic disorders](#)).

The increased risk of insanity among children of marriages between cousins might explain why immigrant patients are stressing the psychiatric system and are strongly overrepresented among insane criminals:

"In Sct. Hans Hospital, which has the biggest ward for clinically insane criminals in Denmark, **more than 40 percent of the patients have an immigrant background.**" (Kristeligt Dagblad, 26/6 2007 [Ethnic minorities overrepresented among the criminal insane](#)).

Implications for the Western and the Muslim World

The consequences for offspring of consanguineous marriages are unpleasantly clear: Death, low intelligence or even mental retardation, handicaps and diseases often leading to a slow and painful death. Other consequences are:

Limited social skills and understanding, limited ability to manage education and work procedures. The negative cognitive consequences also influence the executive functions. The impairment of concentration and emotional control most often leads to anti-social behavior.

The economic costs and consequences for society of inbreeding are also enormous.

However, inbreeding among Muslims has severe implications for both the Western societies and the Muslim world.

Expenses related to mentally and physically handicapped Muslim immigrants drains the budget for other public services:

"When cousins have children together, they are twice as likely to have a disabled child – it costs municipal funds dearly. Disabled immigrant children costs Danish municipalities millions.. Comment: All by design..." (BT, 10/11 2003 [Immigrants inbreeding costing one million](#)).

On top come the expenses for Muslim immigrants who – because of different consequences of being born from blood related parents – are not able to live up to the challenges of our Western work market: **Muslim immigrants and their descendants in Europe have a very high rate of unemployment. Comment so what do they do then: They blame society and become militant Islamic Jihadists that want revenge and love to kill!!**

The same goes for Muslims in USA, where the Gallup Institute made a study involving 300.000 people concluding "The majority of Muslims in USA have a lower income, are less educated and have worse jobs than the population as a whole." (Berlingske Tidende, d. 3. marts 2009: [Muslims thrive in USA](#)).

The cognitive consequences of Muslim inbreeding might explain why non-Western Muslim immigrants are more than 300 percent more likely to fail the Danish army's intelligence test than native Danes: "(TV 2 Nyhederne, 13/6 2007 [Immigrants flunk army test](#)).

It probably also explains – at least partly – why two thirds of all immigrant school children with Arabic backgrounds are illiterate after 10 years in the Danish school system: "Those who speak Arabic with their parents have an extreme tendency to lack reading abilities – 64 percent are illiterate. ... No matter if it concerns reading abilities, mathematics or science, the pattern is the same: The bilingual (largely Muslim) immigrants' skills are exceedingly poor compared to their Danish classmates."

(Rockwool Foundation Research Unit, May 2007: [Ethnic students does not make Danish children worse](#)).

The high expenses on special education for slow learners consumes one third of the budget for the Danish schools. "Immigrant children are clearly overrepresented on Copenhagen's schools for retarded children and children with physical handicaps. ... 51 percent of the children on the three schools in Copenhagen for children with physical and mental handicaps have immigrant back ground and on one of the schools the amount is 70 percent. ... The many handicapped children are a clear evidence that there are many intermarried parents in the immigrant families." (Jydske Vestkysten, 4/4 2009 [Tosprogede i overtal på handicapskoler](#)).

Our high level of education may also make it harder for inbred students to follow and finish their studies: "Young people with minority backgrounds have a significantly higher dropout rate at secondary schools than youth with a Danish background. For trade school education, the dropout rate among immigrants is 60 percent, twice as high among adolescents with a Danish background...."

The limited ability to understand, appreciate and produce knowledge following a limited IQ is probably also partly the reason why Muslim countries produce 1/10 of the World average when it comes to scientific research: The lack of interest in science and human development in the Muslim World is also clear in the UN Arab Human Development Reports (AHDR). AHDR **concludes that there have been fewer books translated into Arabic in the last thousand years, than the amount of books translated within the country of Spain every year:**

Conclusion

There is no doubt that the wide spread tradition of first cousin marriages among Muslims has harmed the gene pool among Muslims. Because Muslims' religious beliefs prohibit marrying non-Muslims, and thus preventing them from adding fresh genetic material to their population, the genetic damage done to their gene pool since their pedophile prophet Mohammad allowed first cousin marriages 1,400 years ago, are most likely massive. The overwhelming direct and indirect human and societal consequences have been explained above.

Compassion for the health of future generations should be enough to ban intermarriage among first cousins. **The economic and societal consequences are also very important.**

A legislative ban on first cousin marriages is a logical and compassionate imperative for both the Muslim world, for EU and our Western national governments.
