ANP readers have since added their own [warnings to this map](#) and as we see in the maps below ([via WND](#)), **the flow of refugees into America has continued unabated.**


**Keep in mind this map shows only the refugees coming here from Somalia and doesn't include other countries.** As we've also since learned, something very suspicious is



In a new video purportedly released by the Islamic State titled “A Message to America From the Islamic State Caliphate Supporters,” **an ISIS executioner directs a message at President Obama before beheading Syrian Arab Army soldiers. The video was released on March 7, 2016.**

**This will lead to a brokered convention, in which unbound delegates, like Haugland stated, could play a significant swing role on the first ballot to choose a nominee.**

It has been estimated that 10-30 million Americans could have received an SV40 contaminated dose of the vaccine.**

Michele Carbone, Assistant Professor of Pathology at Loyola University in Chicago, **has recently isolated fragments of the SV-40 virus in human bone cancers and in a lethal form of lung cancer called mesothelioma. 

Average two people per vehicle and over eighty million (80,000,000) people were looking out their car windows...

And, the campaigns are just getting rolling. Already, California State Health Department sociopaths are/were fear screeching after similar billboards were placed around this year's football Super Bowl location. Read this article in the [San Jose Mercury News](#). In part, it said:

*"Billboards questioning the safety of vaccines have popped up over the past couple of months from Berkeley and San Francisco to North Fair Oaks, a largely Latino community in southern San Mateo County. More went up in January in the San Jose area to coincide with Super Bowl 50, which has drawn tens of thousands of visitors to the South Bay."*

Groups are gathering money all over California for more billboards. And more of everything. The war for California is on.

Oh yeah...It has just started. What's next? The sky is the limit.

My suggestion to some of the "No on SB277" groups is to get right in the face of authority over vaccine damage issues. How?

For One Thing - A Tee Shirt Campaign...

The biggest official cover-up, in the vaccine issue, is the actual amount of vaccine damage that has been caused. One in six US children have been

neurologically damaged in recent years. One in 45 US children now have Autism. ADD/ADHD levels are over the top. Asthma is so prevalent now, it seems almost normal. Of course it is all from childhood vaccines. Forty-nine (49) vaccines, are required, from zero to three years old?

So, why hide those children? Go public in a big way. Get a group together, design a common tee-shirt color and message (This Child Is Vaccine Damaged) and make plans for public demonstrations that the groups will then video for FaceBook.

Examples:

(1) A hundred children, with parents, showing up at any Shopping Mall on a Saturday, wearing those Tee-shirts, with message, will put a CLEAR, STRONG MESSAGE into the hearts and minds of EVERY mother there shopping for their own children. Make sure they get seen. Have your videographers capture the looks on the those mother's faces. Video the Mall Security Guards reactions. Hopefully, some Mall Management Nazi will demand that the children be removed. Bring the media. Even if they don't show up - send them video. They all have ways to receive clips.

(2) The California Medical Board has four public meetings a year, all over the State. Take two hundred Tee-shirted vaccine damaged children there and TURN THEM LOOSE during the meeting. Plan on doing all four meetings. Every parent can demand their three minutes to speak to the Board. What about? Ask the Board to (a) officially ban the Pediatrician's "Well Baby Program," pointing out that these children are the direct result of that program. (b) Ask the Board to adopt a policy to immediately suspend the license of any MD that does not carefully explain to parents what damage each vaccine has been known to cause (package inserts) for a first offense, and permanent termination of license, and felony arrest, for a second offense.

Of course the Board will not properly respond the FIRST time they get confronted. The Board Staff will tell you to leave. Don't do that. Video them telling you that - then complain to the Department of Consumer Affairs and your legislators about that - and that will not happen again. Demand to be on the Board's regular Agenda with your issues - and then prepare with details. The fur will fly. Why? Doctors are kept in the dark about vaccine damage too. These Medical Board Members will walk out of that meeting, and go back to their normal world with an entirely different view of vaccines, because of what they saw in front of them that day. And, all of those Medical Board members were appointed by the Governor, or others, because they are leaders in various facets of the MD community. Word of that action in front of the Board will spread like wildfire throughout the medical community. ALL doctors know how dangerous drugs really are. It will be a surprise to most of them that vaccines are exempt (but not really) from harm disclosure.

(3) Take a hundred children, in Tee-shirts, to every School Board meeting in the State. Demand to be on the Agenda FIRST. Scream at them that "this is what your forced vaccination program is causing..." Do not sit in the back. Don't let them make you wait until the end of the meeting. Walk the children up front for everyone to see. Get everyone's attention. Video, video, video...

(4) New children's movie in town? Line up in front at peak movie time. Video, video, video...

(5) Officially ask Disneyland, in Anaheim, to sponsor a "Vaccine Damaged Children's Day" with FREE entry for those children and accompanying parents. Wear Tee-Shirts. And, if "Disneyland says "No...." They'll have a Public Relations nightmare... We'll make sure they do... since, that stupid, fake, story about measles started with them.

(6) Anyplace where parents and children gather for an event. Be there. Make everyone SEE WHAT IS REALLY GOING ON.

### California rapidly turning into medical police state: Mandatory vaccines and genetic discrimination now routinely harming children

California health authorities are increasingly applying police state measures by forcing vaccinations and practicing genetic discrimination – violating constitutional principles and privacy rights.

The state's schools are now being penalized financially for not enforcing mandatory vaccinations; meanwhile children are being expelled for having a genetic predisposition to certain diseases – even when they don't actually have the diseases in question.

California has some of the strictest mandatory vaccination laws in the country. "In this way, U.S. doctors, vaccine patent holders (such as Paul Offit), legislators and health regulators are marching America right down the path of medical crimes against humanity -- the very same thing we once witnessed carried out by scientists operating under the Nazi regime in Germany."

Schools in California are now being threatened with financial penalties for admitting "kindergartners who were overdue for their second dose of the measles vaccine."

From Southern [California](#) Public Radio:

"The state acted because its data analysis indicates that many schools are erroneously enrolling kindergartners who are overdue for one or more vaccinations and by law should be excluded from class until they're up to date with their shots. ...

"If children entered school with only one of two required measles shots and had not received their second shot within three months, as required by state law, the guidelines require auditors to verify the students were excluded from class."

If the students were not excluded from classes, auditors were instructed "disallow

**the [average daily attendance payment]** for any days after three calendar months and ten days from the first dose until the date of the second dose."

**So, either the kids whose parents don't want to take chances on unsafe vaccines get expelled, or the schools lose funding, creating a no-win situation for everyone involved – except for the state and Big Pharma, of course.**

Equally as disturbing as the mandatory vaccination agenda in California, **is the growing trend towards 'genetic discrimination.'**"

**The recent case of sixth-grader Colman Chadam – who was kicked out of school because of his DNA profile – has raised grave concerns regarding privacy, medical ethics and the extent of the government's increasingly meddling role in regulating health.**

As reported by *Wired*:

"The situation, odd as it may sound, played out like this. **Colman has genetic markers for cystic fibrosis, and kids with the inherited lung disease can't be near each other because they're vulnerable to contagious infections. Two siblings with cystic fibrosis also attended Colman's middle school in Palo Alto, California in 2012. So Colman was out, even though he didn't actually have the disease, according to a lawsuit that his parents filed against the school district. The allegation? Genetic discrimination.**"

**As unbelievable as that case may sound, the article warns that genetic discrimination is a term that we'll be hearing a lot more of in the future.**

According to bioethics expert Michelle Lewis: "As we do more screening earlier and earlier in life, **there's potential for misuse of information in ways that are harmful, that could potentially discourage parents from seeking genetic testing even if it's medically indicated.**"

**The corporate-owned state seeks to control every aspect of our existence – what we eat, what we think and how we raise our children. It's aim is to keep us sick, uninformed and utterly dependent.**

### **Medical tyranny comes to Colorado: Law would demand names and addresses of unvaccinated children be registered with the state**

(NaturalNews) On the heels of California's gross violation of human rights, medical ethics and parental choice with SB 277 (the vaccine mandate), **Colorado is looking to bring the medical police state to the Rocky Mountains. House Bill 1164 was just passed by committee on its way to a state congressional vote. It would demand that the names and addresses of all unvaccinated children be tracked on secret lists maintained by the state government.**

**Over the last few years, the for-profit vaccine industry has increasingly turned to state coercion to intimidate and criminalize parents who seek to protect their children from vaccines. Even as vaccines have been proven to cause widespread brain damage in children as openly admitted by the UK government last year -- and now the American College of Pediatricians is warning about the harmful side effects of Gardasil -- some Colorado lawmakers think the state government**

should force these toxic injections onto children in total defiance of the preferences and beliefs of their parents.

The CDC openly admits that vaccines contain multiple brain-damaging chemical adjuvants and preservatives, including neurotoxic mercury, aluminum, MSG and formaldehyde. My own laboratory tests on flu shots showed they contained over 50,000 ppb mercury, which is 25,000 times the mercury limit in drinking water set by the EPA. Perhaps this helps explain why so many young girls die after receiving HPV vaccine shots.

Colorado government, like California government, essentially believes that the state owns your children and can therefore do anything it wants to them. The march toward medical tyranny is a rapid one, and immediately after the passage of SB 277 in California, the state's Secretary of Health and Human Services, Diana S. Dooley, announced that all California children should be injected with mercury vaccines because the state ran out of mercury-free vaccines.

Many Colorado citizens are up in arms over this latest attempt and government-run medical tyranny. "House Bill 1164 is designed to circumvent the law protecting privacy and bully people into every vaccine on the market," said Colorado mom Pam Long as reported by [CBS Denver](#).

**Forced Vaccination for all Hospital Workers Passes Indiana Senate Unanimously**

**URGENT WARNING FOR INDIANA HOSPITAL EMPLOYEES-Forced Vaccination for all Passes Senate Unanimously-OPPOSITION NEEDED IMMEDIATELY IN HOUSE**

We contacted you a couple of weeks ago to ask for your help to oppose a bad bill, **SB 162**, which implements vaccine mandates for all hospital employees having patient contact starting in 2017. There have been some very concerning developments with this bill requiring your immediate communication with your legislators.

**SB 162 unfortunately passed the full senate on 2/2/16 completely unopposed with a vote of 50 yes and 0 no. The bill was amended to become a much worse bill.**

While the introduced version of the bill prohibited a hospital from ultimately requiring an employee to receive a vaccine if the "employee refuses to permit the immunization after being fully informed of the health risks" **the final version sent to the House was significantly adversely altered to force vaccination as a condition of employment and to grant liability protection for hospitals firing employees.**

**SB 162 should be OPPOSED because it:**

**1. Requires a minimum of 8 vaccines for hospital employees as a condition of employment: Influenza, Varicella, Measles, Mumps, Rubella, Tetanus, Diphtheria, and Pertussis (page 2 lines 13-16).**

- **There is no crisis warranting government forced vaccination of hospital employees.**
- **These vaccines are already available to the employees who want them.**
- **Many labor unions oppose mandatory flu vaccination for health care workers.**

- There is no guarantee an employee will even respond to vaccination as [vaccines fail sometimes](#) where even fully vaccinated people become infected.
  - According to the CDC, the 2014-2015 [flu shot was only approximately 19% effective](#).
  - Individuals vaccinated with an acellular pertussis vaccine may show no symptoms yet [still become infected and spread pertussis](#) to others including infants.
  - The [Cochrane Collaboration concluded](#), “There is no evidence that only vaccinating healthcare workers prevents laboratory-proven influenza or its complications (lower respiratory tract infection, hospitalization or death due to lower respiratory tract infection) in individuals aged 60 or over in LTCIs and thus no evidence to mandate compulsory vaccination of healthcare workers.”
2. **Does not prohibit hospitals to also require (as a condition of employment) any number of other vaccines recommended by the [Advisory Committee on Immunization Practices](#). (page 2 lines 29-37).**
- While this bill requires the 8 above listed vaccines, individual hospitals could add any number of vaccines approved for adults as a requirement. Nothing in this bill prohibits that. This could include the additional vaccines of Hepatitis A, Hepatitis B, Haemophilus Influenzae type B, Meningococcal, Pneumococcal, Human papillomavirus, and Zoster which are currently on the [ACIP Adult Immunization Schedule](#).
  - There are [several thousand vaccine clinical trials being conducted](#), including for infectious and non-infectious diseases such as gonorrhea, syphilis, chlamydia, HIV/AIDS, genital herpes, RSV, strep B, cytomegalovirus, hepatitis C, tuberculosis, e-coli, salmonella, asthma, diabetes, obesity, anti-cocaine and heroin use. Many of these will be added to the adult schedule leaving hospital employees with an endless potential for mandates in the future.
3. **Allows hospitals to fire employees who don't receive the required vaccines (page 2 lines 38-42) and protects the hospital or agent from any liability for firing an individual over vaccination compliance (page 3 lines (9-13)).**
- Many good health care workers who want to delay or decline any or all doses specified in this bill will lose their jobs and the employee will have no legal recourse for being discriminated against and bullied over their informed vaccination decision. Vaccines manufacturers and the doctors who administer vaccines are already [completely shielded from liability for vaccine injuries and deaths](#).
  - [Indiana workman's compensation programs](#) will have to pay for employees who are injured as a result of vaccine requirements for their jobs.
  - The [current fiscal note for SB 162](#) already says this bill could “cause a county hospital's expenses to exceed its revenues”, and workman's compensation claims responsible by the state is not even a cost to the state included in the fiscal note for the bill.

4. **Removes the personal belief exemption from introduced version.** ([page 2 lines 39-40 of introduced version](#) is deleted from [final senate amended version](#))

- This violates the informed consent rights of hospital employees who have concerns that vaccines carry the risk of injury and death.
- The [United States Government has paid out more than \\$3.3 billion dollars to vaccine victims.](#)
- Many [more people have adverse reactions.](#)
- The [flu vaccine is the most compensated vaccine](#) in the [National Vaccine Injury Compensation Program.](#)

5. **Restricts the religious exemption from the introduced version** “receiving the immunization is against the employee’s religious beliefs” ([page 2 line 37-38](#)) by allowing a hospital instead to establish a discriminatory and unconstitutional process for determining whether the tenets of the religion relied upon by an individual for purposes of a religious exemption would prohibit the individual from receiving an immunization ([page 3 lines 36-39](#)).

6. Restricts the medical exemption to “medically contraindicated” instead of permitting the professional medical opinion of the employee’s physician.

- There are many health reasons outside of the [extremely narrow CDC defined contraindications](#) why a doctor may want to medically exempt their patient.
- SB 162 doesn’t allow for an exemption granted for natural immunity. Varicella, Measles, Mumps, Rubella, and Influenza are all viruses that the employee could have contracted in the past to which they already have immunity. Vaccination is not only unnecessary and redundant, but it puts the health and safety of the employee at risk.

#### **ACTION NEEDED:**

1) Contact your own Indiana State Representative and ask him/her to oppose SB 162, state mandated vaccines for hospital employees. Use the points above that mean something to you and personalize your request.

Click on your senator to display his/her contact information.

Prioritize your communication method: In-Person communications are the most effective. Make an appointment to meet with your legislators or their staff in person ASAP. If you can’t meet in person, make a phone appointment right away to discuss with your legislator or their staff assigned to these bills why your family is opposed to them. EVERYONE should be directly visiting or talking to their legislators or staff on the phone. Additionally, everyone needs to send an email voicing their opposition. If this issue is important to your family, please make the time for personal direct communication in addition to emailing. It is far more effective and we will need those personal connections and personal stories to stop a bill like this.

2) Contact [Mike Pence](#) and ask him to oppose SB 162, state mandated vaccines for hospital employees. Use the points above to personalize why you want him to oppose this bill. **Seven bills have been introduced in Hawaii that combined could turn Hawaii into America's only FORCED vaccination state.**

**The following bills need to be vigorously opposed:**

**HB 1946 and SB 2393** would require that the state director of health, implement rules for vaccine requirements for the state of Hawaii that codify federal recommendations by the ACIP (Advisory Committee on Immunization Practices) within 90 days of the recommendation. SB 2393 is scheduled for a hearing Feb. 4, 2016 at 9:00 AM in the Senate Committee on Commerce, Consumer Protection, and Health in conference

room 229.

**HB 1910** and **SB 2316** would mandate that all students entering 7th grade in Hawaii receive at least one dose of HPV (human papillomavirus/Gardasil vaccine). These bills would also allow pharmacists to administer HPV Vaccines to children between the ages of 11 and 17 and require all insurance policies to cover 3 visits for HPV Vaccine. SB 2316 is scheduled for a hearing on Feb. 2, 2016 at 9:45 AM in conference room 229. This is a joint committee hearing with the Senate Committee on Commerce, Consumer Protection and Health and the Senate Committee on Education.

**HB 1945** and **SB 2394** would mandate health care workers receive a yearly flu vaccine. "Health care worker" means all persons, whether paid or unpaid, working or delivering services in a health care facility, including contractors and their employees whose occupational activities involve direct or indirect contact with patients or contaminated material in a health care, hospital, or clinical laboratory setting. SB 2394 is scheduled for a hearing Feb. 4, 2016 at 9:00 AM in the Senate Committee on Commerce, Consumer Protection, and Health in conference room 229.

**HB 1722** would eliminate the religious belief exemption to vaccination for public school students. This bill prohibits a parent from exercising their freedom of conscience that applies to their religious beliefs and obtaining a religious exemption for their child for one or more state required vaccinations. The bill is sponsored by [Rep. John Mizuno](#) and has been referred to the

House [Health](#), [Education](#) and [Finance](#) Committees. Even though this bill has been referred to three committees, it is not yet scheduled for a public hearing.

It is far more effective and we will need those personal connections and personal stories to stop a bill like this.
