In January, [The Royal Society](#), the national academy of science of the UK and the Commonwealth hosted representatives from **NASA, the European Space Agency and the UN Office for Outer Space Affairs**, during its 350th anniversary celebration. The event offered some dizzying intellects in the featured discussion, "The Detection Of Extraterrestrial Life and the Consequences for Science and Society." Lord Martin Rees, President of the Royal Society and Astronomer Royal, announced that aliens may be **"staring us in the face"** in a form humans are unable to recognize. Other speakers used words like "overwhelming evidence" and "unprecedented proof" to signify how close we are to making irrefutable discovery of alien life. Some, like Simon Conway Morris, professor of evolutionary paleobiology at Cambridge University, worried that contact with these unknowns might not be a good thing. **"Extra-terrestrials might not only resemble us but have our foibles, such as greed, violence and a tendency to exploit others' resources,"** he said. **"And while aliens could come in peace** they are quite as likely to be searching for somewhere to live, and to help themselves to water, minerals and fuel."



Vatican astronomers likewise weighed in on this question, "Are we alone in the Universe," and their top scholars hinted that discovery of alien life, including intelligent life, might be made in the near future. Father Jose Gabriel Funes in a long interview with the L'Osservatore Romano newspaper said there is a certain possibility of intelligent life elsewhere in the universe, and that such notion **"doesn't contradict our faith."** Another Vatican astronomer, Guy Consolmagno concluded that chances are better than not, that mankind is facing a near-future discovery of extraterrestrial intelligence (Monsignor Corrado Balducci even went so far a few years ago to suggest that aliens were already interacting with earth and that **some of the Vatican's leaders are aware of it**).

"How can we rule out that life may have developed elsewhere," asked Funes. "Just as we consider earthly creatures as 'a brother,' and 'sister,' why should we not talk about an

'extraterrestrial brother'? It would still be part of creation."

Muslim and Jewish leaders joined Funes to say **their religion could accommodate an ET reality**, while a scholar for the Russian Orthodoxy excluded the possibility of extraterrestrial intelligence.

The question of how the world's political and **religious communities would respond if suddenly faced with visitors from beyond is something world religions** and even the US Government has studied. Paul Davies of The Atlantic Monthly wrote in 2003 that the discovery of [even a single bacterium somewhere beyond Earth could force mankind to revise its understanding of who we are](#) and where we fit into the cosmic scheme of things. Davies speculated that such a find could throw the human race into a spiritual identity crisis that could leave some gasping for faith in God.

Evidently things have changed since 2003. Recent polls show a majority of people believe ET disclosure would not challenge their faith in God, findings supported by a [study at the University of California, Berkeley](#) in 2008. A Reuters Ipsos poll of 23,000 adults in 22 countries taken in April, 2010 found similar responses, adding that more than 40 percent of people from India and China believe [aliens are already here](#) and are walking among us disguised as humans.

In a related CCN article, Sayyid Syeed of the Islamic Society of North America said, "Most Muslims would also welcome the discovery of life off of Earth." The Koran refers to Allah as the God of 'worlds,' he said, not just one world.

Rabbi James Ruden of the American Jewish Committee says most Jews also leave open the possibility of life on other planets in their interpretation of Genesis.

But not everybody in the faith community agrees. Many conservative evangelicals in particular take a more suspicious view of aliens, stating that they could be [demonic manifestations](#) or play a role in a future great delusion that gives rise to the appearance of Antichrist.

"I have become thoroughly convinced that UFOs are real," popular Christian writer Hal Lindsey wrote. "I believe these beings are not only extraterrestrial but supernatural in origin. To be blunt, I think they are demons."

Associate professor of psychology Elizabeth L. Hillstrom in her book [Testing the Spirits](#) documented a growing number of scholars who support Lindsey's conclusions that UFOonauts are synonymous with historical demons.

"From a Christian perspective," she wrote, "Vallee's explanation of UFOs is the most striking because of its parallels with demonic activity. Vallee himself, drawing from extrabiblical literature on demonic activities, establishes a number of parallels between UFOonauts and demons.... Pierre Guerin, a UFO researcher and a scientist associated with the French National Council for Scientific Research, is not so cautious: 'The modern UFOonauts and the demons of past days are probably identical.' Veteran researcher John Keel, who wrote *UFOs: Operation Trojan Horse* and other books on the subject, comes to the same conclusion: 'The UFO manifestations seem to be, by and large, merely minor variations of the age-old demonological phenomenon.'"

In addition to extrasolar planet discovery or the sudden appearance of a **UFO armada** (you mean like "V"), some believe contact with alien intelligence could eventually happen as a result of **man-made super technology that opens new dimensions or discovers parallel worlds**. (Like **CERN is purported to do and shows like Flash Forward and Fringe heavily promote**) Sergio Bertolucci, a top scientist at CERN, surprised reporters for the British newspaper 'The Register' recently by saying the Large Hadron Collider may create "an extra dimension" and that **"out of this door might come something."**

Fayyad: Next Year Jerusalem Will Be Capital Of Our New Palestinian State

The Palestinian people will celebrate the Holy Fire vigil next year in Jerusalem, the "eternal capital" of the Palestinian state, Palestinian Authority Prime Minister Salam Fayyad said Saturday night. "Next year, Inshallah (God willing), we shall celebrate in the Church of the Holy Sepulchre **in east Jerusalem, the capital of the Palestinian state**". "Our people, joined by all humanity, will celebrate the creation of the Palestinian independent state according to 1967 borders, **a state whose capital shall be Jerusalem.**" He said the Palestinian Liberation Organization was the trusted body to declare a state, in coordination with the international community. Meanwhile, Hamas called on Fayyad to stand trial for telling *Ha'aretz* in remarks published at the weekend that he intends to declare a Palestinian state in the summer of 2011 and to build infrastructure to absorb Palestinian refugees into the state.

Meshal: All Options Against Israel Are Open, Including War

Hamas political leader Khaled Meshal said on Saturday that all options against Israel remain open, including war. "We will do everything to obtain the rights stolen from us, including confrontation with the enemy," he told journalists. Meshal was meeting with senior members of Palestinian terrorist organizations, including Ahmed Jibril, the head of the Popular Front for the Liberation of Palestine.

The principles of the Hamas are stated in their Covenant or Charter, given in full below. Following are highlights.

"Israel will exist and will continue to exist until Islam will obliterate it, just as it obliterated others before it." (The Martyr, Imam Hassan al-Banna, of blessed memory).

"The Islamic Resistance Movement believes that the land of Palestine is...consecrated for future Muslim generations until Judgement Day. It, or any part of it, should not be squandered: it, or any part of it, should not be given up. "

"There is no solution for the Palestinian question except through Jihad (Holy War on the Jews and infidels). Initiatives, proposals and international conferences are all a waste of time and vain endeavors."

Unprecedented: Instead Of Acting As Intermediary, Obama Administration 'Assuming All PA Positions'

In an unprecedented move, the U.S. has been conducting negotiations with Israel on behalf of the Palestinian Authority, according to a senior PA negotiator and sources in the Israeli government. The U.S. has been calling for the resumption of indirect talks, with Obama administration officials publicly proposing to serve as a go-between to facilitate dialogue between Israel and the PA. Sources in both the PA and Israeli government told WND talks are underway on a number of issues, including future borders and security controls for a Palestinian state. A senior PA negotiator, speaking on condition of anonymity, said rather than act as an intermediary, the U.S. has been negotiating with Israel on behalf of the PA, assuming all Palestinian positions and bargaining with Israel from the Palestinian side. The account was confirmed with sources in the Israeli government, who said such behavior by the U.S. government is unprecedented.

US Military Analyst: Obama Is First Anti-Israeli President

Lt.-Col. (ret.) Ralph Peters, military analyst and author of a book on Middle East politics, says Obama apparently has a chip on his shoulder against Israel – and it's not "helpful to our civilization." Peters, who wrote "Endless War: Middle Eastern Islam vs. Western Civilization," was asked to explain why he felt American-Israeli friendship appears to have been derailed so dramatically. "The answer is two words," he said. "President Obama." "Obama's treatment of

[Prime Minister Binyamin] Netanyahu [during their recent meeting in Washington] was disgraceful and shameful," Peters told FoxNews. "We treat our enemies with greater courtesy! In addition, it was counter-productive – because this vendetta on the part of the White House against Israel - all it does is encourage the Palestinians and their Arab backers to make ever wilder demands that Israel cannot possibly fulfill. This is not a peace process; this is something about a chip on the President's shoulder." Peters says that Obama's approach is "absolutely" a departure from past American policy.

Kenyan officials affirm: Obama 'son of this soil'

U.S. agrees to time table for UN Gun Ban

Once the UN Gun Ban is passed by the General Assembly of the United Nations it must be ratified by each nation, including the United States.



Gold and Silver Being Artificially Manipulated

By MICHAEL GRAY--April 11, 2010--There is no silver lining to the activities of JPMorgan Chase and HSBC banks in the precious-metals market here and in London, says a 40-year veteran of the metal pits.

The banks, which do the Federal Reserve's bidding in the metals markets, have long been the government's lead actors in keeping down the prices of gold and silver, according to a former Goldman Sachs trader working at the London Bullion Market Association.

Maguire was scheduled to testify last week before the Commodities Futures Trade Commission, which is looking into the activities of large banks in the metals market, but was knocked off the list at the last moment. So, he went public.

"JPMorgan acts as an agent for the Federal Reserve; they act to halt the rise of gold and silver against the US dollar. JPMorgan is insulated from potential losses [on their short positions] by the Fed and/or the US taxpayer," Maguire said.

In the gold pits, Maguire sees HSBC betting against the precious metal's price & says:"HSBC conducts an ongoing manipulative concentrated naked short position in gold. Silver is much easier to manipulate due to its much smaller [market] size," Maguire added.

HSBC declined to comment.

Also during the CFTC hearing, Jeff Christian, founder of the commodities firm CPM Group, said that the LBMA, **the physical delivery market for gold and silver in the UK, has been using leverage (just like the banking industry), which is another way to depress the price of gold and silver.**

Christian said that the LBMA -- the same market Maguire trades in -- has leverage of about 100-1 on the gold bars settled on the exchange. In layman's terms, that means if 100 clients requested their bullion bars be delivered, the exchange could only give one client the precious metal.

The remaining requests would have to be settled for cash equivalent. "That is tantamount to a default on the trade," says Bill Murphy, chairman of the Gold Antitrust Action committee.

Maguire goes further and calls it a fraud: **"If you sell something you do not own, then that is fraud."**

Back in 2007, Morgan Stanley agreed to settle a \$4.4-million lawsuit brought by precious-metal clients, who alleged that **Morgan offered to buy gold and silver and store it for the investors, but never purchased any metal and still charged them storage fees.**

Despite gold's rise each of the last 10 years, Murphy believes the price of gold today would be closer to **\$2,300 an ounce** if the price just moved with inflation.

According to the e-mails Maguire sent to [Commodity Futures Trading Commission \(CFTC\)](#) regulators, he was spot-on in his expectations of how the precious metals would trade on release of the January jobs report.

This message is to "confirm that the silver manipulation was a great success and played out exactly to plan as predicted yesterday. How would this be possible if the silver market was not in the full control of the parties we discussed in our phone interview," Maguire wrote to a staff investigator after the trading day.

Vaccine Contamination: Pig Virus DNA Found in Rotarix

by Barbara Loe Fisher--On March 22, 2010, Food and Drug Administration (FDA) officials adhering to the precautionary principle advised American doctors to suspend use of Rotarix vaccine until the agency finds out **why DNA from a swine virus (porcine circovirus 1 or PCV1) was found in the live rotavirus vaccine. One million U.S. children, and about 30 million worldwide, have already received GlaxoSmithKline's Rotarix vaccine.** Now a research team has discovered it is contaminated with "a substantial amount" of DNA from a pig virus. The discovery that viral DNA is contaminating Rotarix vaccine was made by a team of scientists at an independent research lab in San Fransisco, California, where they used new technology to detect fragments of viral genetic material in vaccines using genetic sequencing.

More testing confirmed that many copies of DNA from the pig virus were present in all Rotarix vaccine lots released since the vaccine was licensed in 2008 because the pig virus DNA also contaminated the working cell bank and the original viral "seed" stock, from which Rotarix

vaccine was first produced.

In addition to pig viral DNA found in Rotarix vaccine, **low levels of DNA fragments from avian (bird) leukosis virus was found in measles vaccine and DNA fragments of a virus similar to simian (monkey) retrovirus was found in RotaTeg vaccine.**

Rotarix is a genetically engineered vaccine that GSK created by isolating human rotavirus strain infecting a child in Cincinnati and using African Green monkey kidney cells to produce the original viral seed stock from which all Rotarix vaccine has been made. In the FDA licensing process, Rotarix had to meet certain FDA standards, that included demonstrating the vaccine was not contaminated with "mad cow" disease or with cow viruses because bovine (cow) serum was used to prepare the original viral seed stock. Porcine trypsin, an enzyme in the pancreatic juice of a pig, was also used to make the viral seed stock.

RotaTeg is a genetically engineered vaccine containing **five human-cow reassortment strains of rotavirus** that were created at the Children's Hospital of Pennsylvania (CHOP), where strains of rotavirus that give cows diarrhea were combined with strains of rotavirus that cause diarrhea in humans. **The reassortment viruses were transported to Merck, where master seeds were produced using African Green Monkey kidney cell cultures. Fetal bovine (cow) serum and porcine trypsin was used to make the "seed" stock.** There are small amounts of bovine serum and cell culture media (monkey viral DNA) that remain in RotaTeg vaccine....
