Boston Bomber Controlled by FBI

April 19, 2013--Zubeidat K. Tsarnaeva, [the mother of Boston bombing suspects Dzhokar and Tamerlan Tsarnaev](#), [said Friday that her eldest son Tamerlan was under the control of the FBI.](#)

"He was controlled by the FBI, like for three, five years," she told Russia Today during an interview. **"They knew what my son was doing, they knew what actions and what sites on the Internet he was going [to], they used to come...and talk to me...they were telling me that he was really a serious leader and they were afraid of him."**

"How could this happen?...They were controlling every step of him, and they are telling today that this is a terrorist attack," she added.

The FBI is notorious for recruiting and framing terrorist patsies. A report compiled by [Mother Jones and the Investigative Reporting Program at the University of California-Berkley](#) found that of the 158 prosecutions carried out on terrorism charges since 9/11, 49 defendants participated in plots that were arranged by FBI agent provocateurs.

"They're creating crimes to solve crimes so they can claim a victory in the war on terror," explained Martin Stolar, a lawyer who represented a suspect involved in a New York City bombing plot contrived by FBI agents.

FBI Casting Set Stage for Boston Marathon Bombing, Shootout, Charade

Father Of Boston Suspects: US Security Services Set Up My Sons

[A report from the Russian agency Interfax](#) says that a correspondent spoke with Anzor Tsarnaev, who resides in the southern Russian republic of Dagestan. Reports on Twitter also claim that Anzor has said that "[all hell will break loose](#)," if his remaining son is killed. **"They were set up, they were set up!" he exclaimed. "I saw it on television; they killed my older son Tamerlan."**

The father is then said to have become more agitated and abruptly ended the call angrily, saying, "Leave me alone, my son's been killed."

"Contractors" at Boston Marathon Stood Near Bomb, Left Before Detonation

April 19, 2013--What appear to be private contractors, wearing unmarked, matching uniforms and operating an unmarked SUV affixed with communication equipment near the finish line of the Boston Marathon shortly after the bomb blasts – can be seen beforehand, standing and waiting just meters away from where the first bomb was detonated.

The contractor-types had moved away from the bomb's location before it detonated, and could be seen just across the street using communication equipment and waiting for similar dressed and equipped individuals to show up after the blasts.



Image: An already widely distributed photo showing the contractor-types on the bottom left, just left of where the bomb was placed and detonated. The men are wearing matching, unmarked uniforms, large black bags, and appear to be waiting, separately, and “behind” the rest of the crowd. In the upper left corner, a wooden structure forming one half of a temporary photography “bridge” over the finish line can be seen and serves as a useful reference when establishing the contractor-types’ position in other photos.



It should be noted, **with the exception of the contractor-types**, all other responders at the scene, including the FBI agent, **can be clearly identified**, from police to the fire department, to medics and even individuals wearing vests with “B.A.A. Physician” written on them. **These men were unidentified, professional contractors apparently augmenting the public servants at the Boston Marathon, present before and after the bomb blasts in the direct vicinity of the incident. After the blasts, whether it was their intended function or not, they appeared to be searching for something under the bleachers before being joined by what appears to be the FBI bomb squad. The FBI and the city of Boston has so far categorically failed to provide any information on these highly suspicious individuals.**

Questions That Must be Answered

Several questions must be answered by the FBI, leading the investigation on behalf of we, the American people. **The first question is who these men were, with large, black bags in the direct vicinity of where a bomb would detonate, moving away before the blast, and appearing directly across the road afterward. Who hired them and what was their function? Why were they moving amongst the crowd in a semi-covert fashion when all other public servants present were wearing proper uniforms and clearly identified? Did police, firefighters, event organizers, and medics know these men were present and what they were doing? Why did it appear that the FBI was fully aware of their presence, and in fact working with them, specifically with what looks like a bomb squad unit? Were**

these contractors specialists in explosives, and if so, what is the significance that at least two of them were spotted just meters from where the blast occurred?

Why These Questions Demand Answers

The checkered, frightening history ([see: FBI's History of Handing "Terror Suspects" Live Explosives](#)) of the FBI's involvement in fomenting false terror attacks, and even presiding over attacks that succeeded in maiming and killing innocent people, should call into question their presence or involvement at any public event, especially when seen associating with unidentified, semi-clandestine organizations that appear to be private contractors.

Private contractors as well, do not answer or work for the public, but rather the highest bidder. Private contractors, most notably Blackwater and its various incarnations have operated both domestically and abroad, committing obscene crimes and atrocities with seemingly absolute impunity. The term "defense contractor" is in fact a euphemism for mercenary, and has no place in a civilized, democratic world, no matter what their alleged mission statement may claim.

An alarming suspicion is raised when the FBI makes no mention of an organization it was clearly coordinating with, particularly in terms of bombs and explosives before and after the incident, considering the nature of the attack. When an already dubious organization attempts to hide the facts of any given event, it is the right and responsibility of legitimate law enforcement, public representatives and the citizenry itself to demand and get answers. If we are not persistent, with the FBI's bizarre behavior over the past few days, including inexplicably cancelled and suspiciously rushed press conferences, and now what appears to be a Hollywood ending for the case, we may never get those answers.

The FBI and other agencies have a long and well documented history of staging terror events to get more power. It's also suspicious they told us only to observe photos and information they provided, after postponing a press conference set to take place earlier this week, and an awkward media bumbling in misreporting the capture of a lone suspect (who every liberal news source was just begging to be a white, male, tea party conservative)

Emergency Treatment for Ricin Exposure and Other Chemical Agents

Because no antidote exists for ricin, the most important factor is avoiding ricin exposure in the first place. If exposure cannot be avoided, the most important factor is then getting the ricin off or out of the body as quickly as possible. The types of supportive care would depend on several factors, such as the route by which victims were poisoned (that is, whether poisoning was by inhalation, ingestion, or skin or eye exposure). Care could include such measures as helping victims breathe, giving them intravenous fluids, **flushing their stomachs with activated charcoal (if the ricin has been very recently ingested)**, or washing out their eyes with water if their eyes are irritated.

How you can know whether you have been exposed to ricin

- If we suspect that people have inhaled ricin, a potential clue would be that a large **number of people who had been close to each other suddenly developed fever, cough, and excess fluid in their lungs. These symptoms could be followed by severe breathing problems and possibly death.**
- No widely available, reliable test exists to confirm that a person has been exposed to ricin.

How you can protect yourself, and what to do if you are exposed to ricin

- **Cover your nose and mouth with a wet piece of fabric as soon after the attack as possible. If this is not possible you can try breathing through your shirt.** By doing this, some of the poisonous spores will be eliminated and you will not breathe them in.
- Leave the area that was attacked as soon as possible. Prolonged exposure to the harmful chemical will lessen your chances of survival. If you can escape to an area where water is flowing, immerse yourself in the water to wash off the immediate effects of the ricin.
- Hold your breathe if you can until you are out of the attack area. If you are unable to do this, take short, shallow breathes until you are away from the area. This will lessen the number of poisonous spores you inhale through your mouth or nose.
- **If you think you may have been exposed to ricin, you should remove your clothing, rapidly wash your entire body with soap and water.**
- Removing your clothing:
 - **Quickly take off clothing that may have ricin on it. Any clothing that has to be pulled over the head should be cut off the body instead of pulled over the head.**
 - **If you are helping other people remove their clothing, try to avoid touching any contaminated areas, and remove the clothing as quickly as possible.**
- Washing yourself:

- As quickly as possible, wash any ricin from your skin with large amounts of soap and water. Washing with soap and water will help protect people from any chemicals on their bodies.
 - If your eyes are burning or your vision is blurred, rinse your eyes with plain water for 10 to 15 minutes. If you wear contacts, remove them and put them with the contaminated clothing. Do not put the contacts back in your eyes (even if they are not disposable contacts). If you wear eyeglasses, wash them with soap and water. You can put your eyeglasses back on after you wash them.
 - Disposing of your clothes:
 - After you have washed yourself, place your clothing inside a plastic bag. **Avoid touching contaminated areas of the clothing.** If you can't avoid touching contaminated areas, or you aren't sure where the contaminated areas are, wear rubber gloves, turn the bag inside out and use it to pick up the clothing, or put the clothing in the bag using tongs, tool handles, sticks, or similar objects. Anything that touches the contaminated clothing should also be placed in the bag. If you wear contacts, put them in the plastic bag, too.
 - **Seal the bag, and then seal that bag inside another plastic bag.** Disposing of your clothing in this way will help protect you and other people from any chemicals that might be on your clothes.

April 19th-a Special Occult Day Leading up to Walpurgis Night & May 1st Beltane

By Tom Gambill--Satanists and followers of Lucifer prepare for April 19th and the days afterward leading up to Beltane May 1st. Watch on these days for major occurrences, as well as situations of "Manchurian monarch ops".

APRIL

Easter Week-end: **Black mass/black sabbath. To mock the death of Jesus Christ, a man is sacrificed on Good Friday. On Easter Sunday, known to satanists as unholy sunday, a woman or man is sacrificed followed by three days of fasting and chanting.**

April 19 – May 1 is a very important time period to Satanists, Lucifer's followers and the Illuminati. Blood Sacrifice to the Beast Moloch begins this most critical 13-day period. Four six-foot alternating red and white ribbons were connected to the pole; the men would dance counterclockwise, while the ladies danced clockwise. The union of the intertwining red and white ribbons symbolized the act of copulation — remember, this is a “fertility” celebration day!

Some of the very important historic dates that were staged according to this blood sacrifice day are:

April 19, 1775 — Battle of Lexington & Concord, which made the Revolutionary War inevitable but which led to independence for the colonies. Revolution begins- Lexington Common, shot “heard round the world” American Revolutionary War: The Battle of Lexington and Concord – British General Thomas Gage attempts to confiscate American colonists’ firearms. Captain John Parker orders his band of minutemen to not fire unless fired upon. Random shots rang out among the British soldiers. The minutemen promptly fired back. This was the “shot heard round the world.” The British are driven back to Boston, Massachusetts, thus beginning the American Revolutionary War

April 19, 1861 – Baltimore Riot Considered first bloodshed of civil war. A clash between pro-South civilians and Union troops in Maryland’s largest city resulted in what is commonly accepted to be the first bloodshed of the Civil War. American Civil War: Lincoln orders blockade of Confederate ports (Civil War)

April 19, 1904 – The Great Fire of Toronto –

April 19, 1943 — After trapping the last Jewish Resistance Fighters in a storm drain in Warsaw, and holding them for several days, Nazi Storm Troopers began to pour fire into each end of the storm drain, using flame-throwers. The Nazi Storm Troopers continued pouring the fire into the drain until all resisters were dead. Blood sacrifice brought about by a fiery conflagration was rumored to have been ordered by those in Nazi High Command or even Hitler himself who demanded blood on April 19, 1943.

April 19, 1989 – A gun turret explodes on the USS Iowa, killing 47 sailors.

April 19, 1993 – The 51-day siege of the Branch Davidian building outside Waco, Texas, USA, ends when a fire breaks out. Eighty-one people die. Secret Delta Force soldiers, combat armed government troops from a multitude of agencies led by the FBI, Army tanks, and other military equipment stormed the compound of David Koresh and his followers at Waco, Texas. **Certainly, this operation fulfilled the basic**

Two senior students, Eric Harris and Dylan Klebold, **murdered a total of 12 students and one teacher.** They injured 21 additional students, with three other people being injured while attempting to escape the school. **The pair then committed suicide.** **The Columbine High School massacre is the deadliest mass murder committed on an American high school campus, and is noted as one of the first and most serious of a series of high profile spree shootings which have since occurred.** The massacre sparked debate over gun control laws, the availability of firearms within the United States and gun violence involving youths.

April 20, 2010 – A suspicious explosion on the Deepwater Horizon offshore drilling rig, operating in the Gulf of Mexico off the coast of Louisiana occurred on April 20, 2010. by Tom Gambill.



An obelisk is a tall, four-sided stone pillar tapering toward a pyramidal top.
