Using a battery of small planes based out of Del Rio, Texas recently dropped 1.8 million edible vaccine packets over 7,700 square miles of rural Texas.



The packets contain edible rabies vaccines dipped in fish oil and coated with fish meal to entice foxes and coyotes to eat them. Once consumed, the animal is "vaccinated" against rabies, researchers claim.

For example, in 2009 Baxter Pharmaceuticals was caught red-handed shipping out live avian flu viruses to 18 countries (<http://www.naturalnews.com/025760.html>).

What Texas Dept. of State Health Services workers probably don't yet grasp is that vaccine manufacturers routinely use vaccines to spread the very disease they claim to be preventing. By injecting live rabies strains into a small percentage of the vaccines dropped on Texas (say, one percent), they are effectively engaging in a DNA

Vaccine For Rabies and their Diabolical Ingredients

Imovax, produced by Aventis Pasteur, **harvested from infected human diploid cells**, MRC-5 strain;

Rabies Vaccine Adsorbed SmithKline Beecham Pharmaceuticals Produced using **betapropiolactone** (See below), **aluminum** phosphate, sodium ethyl**mercur**ithiosalicyate (**thimerosol**),* and phenol red. **Medium: fetal rhesus monkey lung cells.**

BetaPropiolactone is one of 13 "**OSHA-regulated carcinogens**," **chemicals regarded occupational carcinogens** by the **Occupational Safety and Health Administration**, despite not having an established **permissible exposure limit**.^[3] It was once widely used in the manufacture of **acrylic acid** and its **esters**, but its use has been mostly phased out **in favor of safer** and less expensive alternatives.

WEST NILE VIRUS SPRAYING

In 2006 Michael Greenwood wrote an article for the Yale School of Public Health entitled, "**Aerial Spraying Effectively Reduces Incidence of West Nile Virus (WNV) in Humans.**" The article stated that **the incidence of human West Nile virus cases can be significantly reduced through large-scale aerial spraying that targets adult mosquitoes**, according to research by the Yale School of Public Health and the California Department of Public Health.



Under the mandate for aerial spraying for specific vectors that pose a threat to human health, aerial vaccines known as DNA Vaccine Enhancements and Recombinant Vaccines against West Nile Virus may be tested or used to “protect” the people from vector infection exposures. DNA vaccine enhancements specifically use Epstein-Barr viral capsids with multi human complement class II activators

to neutralize antibodies. The recombinant vaccines against West Nile Virus use Rabbit Beta-globulin or the poly (A) signal of the SV40 virus. In early studies of DNA vaccines it was found that the negative results obtained in the studies would force these DNA vaccines into the category of future developmental research projects in gene therapy.

CALIFORNIA AERIAL SPRAYING for WNV and SV40

In February 2009 to present date, aerial spraying for the WNV occurred in major cities within the State of California. During spraying of Anaheim, CA a Caucasian female (age 50) was exposed to heavy spraying, while doing her daily exercise of walking several miles. Heavy helicopter activity occurred for several days in this area. After spraying, she experienced light headedness, nausea, muscle aches and increased low back pain. She was evaluated for toxicological mechanisms that were associated with pesticide exposure due to aerial spraying utilizing advanced biological monitoring testing. The test results which included protein band testing utilizing Protein Coupled Response (PCR) methods were positive for KD-45. KD-45 is the protein band for SV-40 Simian Green Monkey virus that causes cancer (remember the polio vaccines). Additional tests were performed for Epstein-Barr virus and Cytomegalia virus which are used in bioengineering for gene delivery systems through viral protein envelope and adenoviral protein envelope technology. The individual was positive for both; indicating a highly probable exposure to a DNA vaccination delivery system through nasal inhalation!!!!

Pentagon Document Revealed Aerial Vaccination Plans

In the Quarterly FunVax Review in June, 2007, the report lists the objective of a project listed as ID: 149AZ2 as a preparation of a viral vector that will inhibit/decrease the expression of a specific disruption gene (VMAT2) within a human population. It further indicates in the abstract that six methods of virus dispersal were tested including high altitude release, water supply release, insect transmission, and various methods of diffusion.

++ How a jab plunged my life into madness--BBC newsman Malcolm Brabant says yellow-fever vaccination led him to believe he was the Devil



28 Feb 2015--Malcolm Brabant's face – round, ruddy, full-featured, and crowned by a bald dome – is immediately recognisable. **For 30 years he has been an award-winning member of the BBC's team of foreign correspondents, bringing wars, natural disasters, political stand-offs**

and occasionally something a bit more cheerful into our living rooms on the evening news.

But he is not doing so anymore. The reason is the biggest personal story of Brabant's 58 years. As he puts it with what I quickly learn with his characteristic bluntness: "I went bonkers."

In April 2011, he attended an Athens clinic for a routine vaccination against yellow fever before an assignment in the Ivory Coast. His reaction to the vaccine, however, was anything but routine. "It fried my brain," he states simply. Overnight a previously sane man developed severe psychosis. An agnostic, Brabant became so convinced he was the Messiah that he telephoned his bemused fellow correspondent, Allan Little, to appoint him "first disciple" and ask him to record his words of wisdom.

One minute he was announcing that the Queen was aware of his divine status, the next he was claiming to be able to stop the traffic just by thinking about it, and control all technology. To prove the point, he flushed his Kindle down the lavatory.

It was utterly bewildering for those around him, especially when he switched into the persona of Winston Churchill, and then the Devil. Yet, because he had no insight into how strangely he was acting, Brabant also attempted to carry on reporting, with results that horrified previously admiring editors at the BBC.

With the corporation's support, he was sent to hospital in Athens, then released, but shortly afterwards he experienced a second mental breakdown. Unable to work, broke and broken, he returned to his childhood home in Suffolk where he tried and failed to get the help he needed from the NHS. While there, and out of control mentally, he presented himself, clad only in cycling gear but minus a bike, at BBC Television Centre in West London, which was being picketed in a pay dispute. He demanded to see senior managers and generally caused such a scene that the police were called.

"I was the man in Lycra, come to solve the strike," he recalls without flinching. "I really thought in my madness that I could do it but, of course, I was away with the fairies. That will have been the last time many of those people at the BBC saw me face to face."

Perched on the sofa beside her husband in their typically Scandinavian white-walled apartment in the Danish capital, Villemann grimaces when she recalls just what a state he was in. "I have been around mental illness before [her father hanged himself], but I have never seen someone so gone before. Malcolm was clawing around in the deepest, darkest parts of his mind," she says. "It would have killed a lesser human being."

She pauses as she pushes her long blonde hair back from her face. "I am ashamed to remember them now, but there were even times when I thought it would be better if he died because his suffering was so great.

"I have this nagging image in my head that won't ever go away of Malcolm, sitting on his bed in the hospital, with his arms folded. He was rocking backwards and forwards, saying, 'I'm the Devil, I'm the Devil'. Whatever anger I'd felt about the situation we were in evaporated in that moment."

The Danish health professionals who **slowly and painstakingly (via pharmakeia) brought Brabant back to sanity** told him that he would have to spend the rest of his life on medication. He decided otherwise.

“I was determined this wasn’t going to beat me. **When I finally left hospital in 2012, I would rattle as I walked around because I was carrying so many pills. I was a one-man chemist’s shop. It took me another year and a half to reduce my medication.** I stopped taking it in January of last year, and since then I have gradually been getting stronger and stronger.”

Picking up the threads of his career and of his reputation is one part of his life today in Copenhagen. **But Brabant and his wife are also pouring their considerable energies into spearheading a campaign that they hope will prevent others suffering as a result of vaccinations.**

“My husband had absolutely no previous history of mental illness,” says Villemann. “There was nothing latent in him. I have no doubt at all that his severe psychosis was brought on by the yellow fever vaccine.”

Brabant adds: **“I was not a one-in-a-million case. We are determined to make the manufacturers, Sanofi Pasteur, investigate what is happening. I have provided them with open access to all the doctors who treated me so they can hear what their vaccine did to me, but they haven’t been in touch. They are refusing to engage.”**

Faced with this silence, **the couple have been collecting reports from many others around the globe who suffered similar consequences to Brabant. And it is not just a question of a few individuals sounding the alarm bells.** In 2005, Dr Thomas Monath, a world expert on yellow fever, who sits on various World Health Organisation committees, confirmed publicly that the vaccine in question can cause **“really severe and significant, serious adverse events”**.

Even the manufacturer seems to be aware that all may not be well. In 2013 its head of vaccine innovation, Dr Ronald Neeleman, **admitted to a conference that the vaccine in question had not been reviewed in many years.** “[It serves] a small market, with very low returns, **and there is not really an incentive to redevelop,**” he said.

If Dr Neeleman was hinting that it is past its sell-by date, then, as Brabant points out, it remains a product **“routinely available in high street chemists. It is given to British soldiers who are going overseas. And it is used widely in Africa, where there are few channels for reporting when people go mad after taking it”**.

They are seeking financial compensation and they are prepared for it to be a bruising fight. To which end they have bared all in a book, “Malcolm is a Little Unwell”. They are also working on a documentary film, using some footage they shot during the most gruelling chapters of Brabant’s illness.

Aren’t they tempted to draw a veil and just get on with their careers?

“Even if we wanted to,” Brabant replies, “we couldn’t. It’s out there anyway because of how I behaved.” “No one rolls out the red carpet to welcome back people who have suffered a mental illness,” says Villemann. “That cannot go unchallenged.”

Former Air Force Officer Gives A Stern Warning



To a very great extent, America is fighting several wars – some on foreign soil, one on our own. **Aside from disrupting or eliminating the flow of items key to survival (clean water, nourishment, sanitary living conditions, etc.), governments (federal and state) are executing plans for complete disruption of our usual means of communication. This includes telephony in all of its forms (land-lines, cellular, VOiP) and the internet. You are already acutely aware of the "blackout" of the major news organizations, all of which are owned and controlled by major corporations or "banksters".**

I am a former USAF electronics/communications officer and a licensed amateur radio operator. Several years ago, as I began to learn more of what at the time seemed to be literally unbelievable, I thought about the need for an emergency communications network that would reach beyond our shores and borders and to which every American could have access for a nominal cost in equipment and without a license from the now DHS dominated Federal Communications Commission. Several colleagues across the United States are attempting to do the same thing at the state level. For example, in my own state, it is fellow Oath Keepers who have stepped forward to assist in this undertaking. In other states, it is their militias who have accepted this important responsibility. Though I wish I could

report that all states have in place an emergency communications network, for various reasons, I cannot. Some of those reasons include lethargy, fear, the infamous "somebody else will do it" syndrome, and religious precepts, among others.

My first active duty assignment was at **Vandenberg AFB, California with the First Strategic Aerospace Division**. As a young "shave-tail" from the mid-west, I soon came to love California and many of the people I met while stationed there. It has been painful for me to follow the drought situation that affects so many people in so many different ways. **It has been equally painful to come to understand the reasons behind that drought.**



The completely engineered California drought is far from over in spite of the most powerful El Niño event ever.

By now, you are certainly aware **of the nationwide airborne aerosol spraying program which is, and has been for years, conducted by the U.S. Air Force, the U.S. Navy and the U.S. Coast Guard. KC-135 (and perhaps other) aircraft, which were originally designed and built as "tankers" to permit in-flight refueling, have been converted to carry payloads of a wide variety of chemical and biological "payloads". Fitted with nozzles, they have dispersed and are dispersing tons of these agents over all of the "lower 48" states, plus Alaska and Hawaii. This project is not limited to the United States or North America. It is part of a world plan.** At first, many Americans thought that these were the familiar "contrails" that follow jet engines at altitude. As a B-52 and, ironically, a KC-135 electronics officer, **I can tell you with absolute certainty that these are not contrails. Contrails are created when very hot, burned jet fuel vapors combine with cooler, humid air. The interaction of the two causes a cloud-like contrail. Typically, contrails are fairly short in length, and they dissipate after only a few seconds (thought they continue to follow the aircraft during its flight) so long as ambient air is cool and**

humid. They do not grow in width as a function of time. **Very few Americans have not noticed what have come to be known as "chemtrails" (chemical trails) which may run in parallel lines or perpendicular patterns in our skies. To my knowledge, no portion of the United States has been spared. There is a great deal of useful and helpful information on "chemtrails"(geoengineering) on the internet. As always, be selective in what you read, and think critically.**

Many reasons have been given in regard to the purposes of these flights. Reasons have included such things as reduction in global warming, redirection of violent weather patterns to safer locations, an aid to military communications, a defense against enemy radar and satellite surveillance/reconnaissance, etc. Another frequently cited reason has to do with controlling the weather of other countries, particularly those in which we have troops involved in conflicts. **Despite their unmistakable presence and coverage patterns, no viable or credible reasons have been given for them. Reasons that have been given are at variance from one another and seem to skirt the facts that these chemical and biological agents are demonstrably and extremely dangerous to the health of humans, animals and plants. The effects on animal life (fish, birds, perhaps the mysterious, drastic decline in the bee population, etc.) and agriculture have been nothing short of disastrous. Perhaps you have seen some of the photographs of thousands upon thousands of dead fish lining a coastline, or dead birds covering fields, roads, homes and yards. To me, this is an example of the military-industrial-government complex that we have been forewarned about repeatedly for decades operating at its best and most efficient with no interruptions, interference or objections from the people that this affects most profoundly – American citizens.** I believe that, regardless of one's theological beliefs (and I am certainly no Biblical scholar), Scripture asks questions that seem particularly salient now: "Do you have ears, but do not hear; do you have eyes, but do not see?" In my field, we make a distinction between listening and looking (passive behaviors) and hearing and seeing (active behaviors, often requiring hard work). **We have been warned repeatedly by several Presidents over the decades about this unholy alliance, however, for whatever reasons, we have failed to pay attention to these alerts, and we certainly failed, as citizens living in a Republic, to act on them. Now, we are seeing the consequences of our inattention and lack of involvement in our governments, and no one is more guilty than I.**

So rather than being allowed to express our wills by means of the "Initiative" or the "Referendum" as provided by the Constitution on such significant issues as the construction of over 800 FEMA camps (some equipped with recently expanded crematoriums), the conversion of closed military installations into detention centers, passage of the "Patriot Act" and the "National Defense Authorization Act", the formation of an out-of-control DHS and its purchase of over two-billion rounds of "hollow point" or anti-personnel ammunition (which, contrary to what DHS told us, is not for "target practice"), construction of underground, multi-level interstate highways which run from Denver International Airport to Washington, D.C. to Maine with multiple diverging routes between these points, a high-speed underground railroad and over one-hundred underground cities complete with ample, long-term supplies of food, water, medical supplies (even operating suites), etc., we passively allowed these things

to come into being. We and our Congress were effectively by-passed or short-circuited by a President who unilaterally enacted a series of illegal "Executive Orders" (which no one questioned), a President who, in all likelihood, does not meet the criteria specified in our Constitution for someone to hold that office legally, a President who, when not self-constrained, exhibits unmistakable symptoms of megalomania. The ability of the people to be able to vote on these kinds of issues takes on additional importance when one considers that our elected representatives in Washington are no longer there to represent us or our best interests. My personal opinion is that they are motivated principally by greed for wealth and power.

The effect, then, is that there is, in reality, no longer a "Republican" or a "Democratic" party. There is one party, and it is not accountable to the people. It operates entirely in concert with the stated goals of U.N. "Agenda 21" and the illuminati's fundamental tenets which include a one-world government and religion (a/k/a "The New World Order"), and massive depopulation. Their fundamental "commandments" are inscribed on the vertical stone tablets placed in Georgia. Their goal calls for a world population that does not exceed 500,000,000 people. In order to achieve that goal, a reduction will be required in the current world population on the order of six billion human beings. The beginning point for this process of depopulation is the United States, followed quickly by Canada and Mexico to create the NWO's "North American Command Center". Hence, the observations of foreign military personnel at or near several of our military bases. Those foreign troops are not limited to Russian soldiers. They include U.N. These foreign soldiers have been training beside American military personnel in such areas as "riot control", inmate management and forcibly disarming Americans of weapons. Hence, the "forced retirement" of the largest number of senior military officers in our Nation's history. It is referred to as Obama's "litmus test". For them, that would constitute (and is) an unlawful order according to the "Uniform Code of Military Justice" which (if Martial Law is declared) will be modified, set aside or superseded; as will the Constitution. At the same time, Obama is expected to deploy more American troops to foreign countries (like Iraq). Meanwhile, these other non-American troops will be used to arrest and transport Americans to pre-designated FEMA "resettlement" or "re-location" or "internment" camps and, depending on the American citizen's status as determined by DHS, incarcerated or executed. It is important to note that each of these FEMA camps is currently staffed and ready for operation despite the absence of detainees. You are also probably aware of the hundreds of thousands of "casket liners" stored at various locations around the country – most, but not all, at military installations. Numbers reported vary from 500,000 to a million or more.

Perhaps you have seen one of the 2-3 mile long freight trains, consisting solely of 80' flat cars, fully loaded with APCs (armored personnel carriers), tanks, MRAPs (mine-resistant ambush protected) vehicles and even field artillery pieces.

I cannot stress strongly enough the importance of thinking, planning, preparing and behaving more aggressively (but still peacefully) in each of your own communities. Someone once said, "The most dangerous item in your home is your recliner", to which I would add, your computer. "Their" safety, and that of their families has been provided for underground. If you do not know your neighbors, make it a point to get to know them. For as long as they will work, create phone "call lists". A principle use of a call list is not only emergency communication, but the transfer of "intel" or intelligence on such things as the movements of enemy forces, the influx of armored vehicles, etc. As a long-time friend, an active duty Lt. Col. told me recently, "I cannot say much, but I will tell you that the fuse is very short". At this writing, my understanding from an active duty senior NCO is that Chinook (many of them black and unmarked, therefore FEMA) helicopters, C-130, Boeing 727, 737 and 747 fixed-wing aircraft **are being fitted with wide-range radio jamming equipment. The purpose is to neutralize civilian cellular, survivalist or militia communications. Initially, **the Chinooks will be used to transport detained American citizens to nearby FEMA camps. If a detainee is to be held at a more distant FEMA camp location, he or she will be transported by one of the aforementioned aircraft.** The senior NCO with whom I spoke did not know**

whether these jamming devices were being installed on other military vehicles, ships or base locations, **however, given that the President has the authority to control the airwaves (all of them), it seems likely that taking away the ability for us to communicate would answer that question.**

Until we learn otherwise, we have several communicative options currently at our disposal. Many of you remember the days when CB (Citizens Band) radios were popular, and some of you may still own one. **Well, they are popular again. If you own one, you may wish to consider dusting it off, installing an antenna (preferably outdoor) and providing it with 12 volt D.C. power from a power supply, a boat or car battery or your solar power system. Channel 3 has been designated as the national CB emergency frequency. If your radio has single side-band capability, channel 36 LSB (lower side-band) is also available as an emergency frequency. Single side-band signals use a narrower slice of the radio spectrum, travel greater distances than other modes of communication, and are slightly less affected by man-made or naturally occurring noise.**



<< Communications will be essential once the coming collapse commences.

In recent years, a relatively new radio service which uses hand-held, low power radios has become very popular among campers, boaters, hunters and others. These radio utilize the "Family Radio Service" or FRS. An FCC license is not required to use this service. These radios have a range, depending upon terrain, obstacles and weather, of about 2-6

miles (despite inordinate claims of greater ranges by manufacturers). **As with CB frequencies or channels, channel 3 has been designated as an emergency or calling frequency for FRS radios.** FRS radios share several frequencies or channels with another, older radio service, The General Mobile Radio Service or GMRS. These radios are a more powerful alternative as they are typically installed in vehicles. **However, just as with CB radios, providing them with a 12 volt D.C. power source will allow them to work in any location.** Their output power, and therefore their range, are greater than either CB or FRS radios and varies by model. Technically, a license is required to operate on GMRS frequencies, **however, according to the FCC, an individual can operate on any frequency, with or without a license, in an emergency.** The radios used by highway (and other) construction personnel (e.g. who rotate signs that read "Stop" or "Proceed with caution" (or whatever) use radios that operate **in yet another unlicensed band or service, the Multi-Use Radio Service or MURS.** These radios are available in five frequencies and do not require a license. Their range is greater than FRS radios, however they are more costly. As with CB and FRS radios, **both GMRS and MURS radios use channel 3 and the primary calling frequency.** FRS radios should have no less than 50 channels, some of which communicate with GMRS radios. **An excellent portable, lightweight and durable radio manufactured in China by a company called Baofeng has become extremely popular**

across the United States. I have provided first responders who fight wild fires in California with these radios, and they have performed admirably. They produce either 5 watts (Baofeng UV-5R series) or 8 watts (Baofeng BF-F8HP series) of power. These are referred to as "dual-band" radios, not unlike traditional commercial "AM" and "FM" radios. They also receive all 10 NOAA weather frequencies. In many communities, they will receive local Public Safety transmissions (police, fire, EMS, state police, etc.). They are available from Amazon or on eBay. Shipping origin for some eBay sellers is China and requires considerably longer delivery time. Radios from Amazon, though a few dollars more, are shipped from within the United States. **I strongly recommend purchasing at least one spare heavy-duty battery and an optional, longer Nagoya NA-771 antenna (greater length equals greater range).** If you become active with radio communications, please educate yourself on "comsec" or communications security. Learn commonly used code words used in all radio communications, **keep transmissions as brief as possible, never reveal any information pertaining to yourself or your location and try to verify with whom you are talking (e.g. using pre-determined passwords, etc.).** **As a matter of course, we use two-person teams – one as the radio operator, the other as a spotter or lookout. Both are armed.**

The mainstay and bedrock of reliable, long-distance radio communication is amateur radio. Amateur radio operators and experimenters have contributed significantly to the body of knowledge surrounding electronic human audio and video communications for decades, and have earned many of their operating privileges from the FCC because of their efforts, particularly during major wars. Because of their power capability (up to 1,500 watts) and the wide range of frequencies on which they can operate, only amateur radio stations participate in the emergency communications networks themselves. **Just as there are ways to interfere with signal propagation (e.g. "jamming"), there are effective technique for circumventing jamming.** Part of my initial goal was to make emergency communication available to as many Americans as possible. **Fortunately, many amateur radios are able to transmit and receive all of the frequencies utilized by the various unlicensed services mentioned above: CB, FRS, GMRS and MURS.** In an emergency, establishing contact with an amateur net control operator would be your first task, keeping in mind safety considerations such as location, brevity of transmissions, etc.

I cannot urge you **strongly enough to educate yourselves now with current and accurate information regarding what the military-industrial-corporate complex is doing in and to our Country, your state, county and community for they have penetrated to those levels.** You are already probably **aware of the incredibly deleterious effects that over-spraying our Country with tons of toxic and potentially toxic elemental, chemical and biological agents has done, and is doing.** **My concern is that, if allowed to proceed unchecked, the cost in terms of suffering and human lives during the creation of the New World Order will surpass the Holocaust many times over.** Of major concern to anyone involved in civil **defense is the possible loss of mains power (120 or 240 volts A.C. house current) from our major power grids, and the horrendous ramifications that that would entail, particularly as far as nutrition is concerned.** **While people have petitioned Congress for years to "harden" our power grids as most major nations of the world have, they have consistently refused to do so.** **Whereas this process would have cost upwards of 500 million dollars ten years**

ago, today, it would cost approximately 50 billion dollars. And still, Congress has refused to take any action – on our behalf – to provide this additional protection not only to those of us who can fend for ourselves, but for those children and adults who are hospitalized, using medical appliances as part of their home health program, or our sick and elderly residents of long-term care facilities. At present, our understanding is that two electro-magnetic pulse (EMP) devices detonated at an altitude of 50 miles in the eastern and western portions of our Country would completely eliminate all electrical power in the United States. Furthermore, all unprotected electronic equipment, including on-board computers in vehicles and aircraft, would be destroyed. What follows, in terms of human behavior, you can imagine, particularly if you remember hurricane Katrina: looting, theft, and civilian casualties as food and water sources grew scarce and hunger and thirst increased. Some New Orleans law enforcement officers chose, instead of reporting to work, to loot stores, pharmacies and the abandoned (or occupied) homes of flood victims. As an aside, amateur radio operators provided communications for Coast Guard and other agencies who, for whatever reasons, were unable to communicate with each other. This could be monitored by most amateur radio operators across the Country.

Horowitz says: "Micoplasma is not really a fungus, it's not really a bacteria, it's not really a virus. It has no cell wall. It goes deep into the cell nuclei thereby making it very difficult to mount an immune response against it. It's a man-made biological weapon. The patent report explains how it causes chronic upper respiratory infections that are virtually identical to what's going on right now."

"I believe the chemtrails are responsible for a chemical intoxication of the public, which would then cause a general immune suppression, low grade to high grade, depending on exposure. The immune dysfunction allows people to become susceptible to opportunistic infections, such as this micoplasma and other opportunistic infections", says Dr. Horowitz.

"I first began to investigate chemtrails when some were sprayed over my home in Northern Idaho. I took pictures of them, and then contacted the Environmental Protection Agency of the state who were clueless and referred me to the Air Force. They got me in touch with Centers for Disease Control Toxicology, and after about a week I received a letter from one of their chief toxicologists saying, indeed there was some amount of ethylene dibromide in the jet fuel.

Ethylene dibromide is a known human chemical carcinogen that was removed from unleaded gasoline because of its cancer-causing effects. Now suddenly it has appeared in the jet fuel that high-altitude military aircraft are emitting!"

Ethylene dibromide is in chemtrails and that (in part) is causing immune suppression and weakening people's immune system. Then you've got a micoplasma microbe or a fungus that causes an upper respiratory illness. Suddenly you develop a secondary bacterial infection. Then you get hit with ANTIBIOTICS, and the antibiotics cause your immune system is further suppressed, so now you get rashes and other things, your liver gets full of toxins and comes out through your skin in



rashes and they get hyperallergenic reactions associated with the other chemicals. I've got colleagues in the Bahamas, Bermuda, Toronto, British Columbia all reporting the same bizarre seeding of the atmosphere. What is going on is just despicable.

All of a sudden now you've got human beings completely out of balance and infected by two, three or four microbial co-factors as well as intoxicated by a variety of different chemicals...

and you've got somebody who's going to be chronically ill.

"The Frank Church Congressional Hearings of 1975 exposed the Central Intelligence Agency biological weapons contracting firms – Litton Bionetics and the Army Corp of Engineers who were developing and utilizing various biological weapons on populations. And this is all done under black operations, covert operations, where they get funding and congressional people are never informed really where this money is going. It's the black budget", says Horowitz.

“And in the contemporary warfare arena (where experts in biological chemical warfare convene and discuss the ways that are ideal to conduct warfare today), they want to produce people who are chronically ill and become dependent on the state and totally sap the resources of the country. And then you can move in with your military-medical-industrial complex and your international medical-pharmaceutical cartel. Then you sell these defeated countries all of the pharmaceuticals and chemicals that they need to maintain any semblance of healthy function.

“What I’m relating to you now is not speculation. If you were to read the top experts analysis of military warfare, including The Report From Iron Mountain – **the Rockefeller family is one of the major players in this conspiracy. They are one of the major players in world genocide, world population reduction. That’s no mystery anymore.**

When you examine **who owns the chemtrail companies, who are the company directors, suddenly you enter into the realm of the Rockefeller family and the royal families – Standard Oil and British Petroleum. For **lung infections** nebulize 100ppm Invive Mild Silver Protien directly into the lung fields for 3-4 minute intervals several times per day. If you want to make a 100ppm solution (and you have a 5000ppm bottle) just divide 5000 by 100 to get: 50. So you would add 50 parts distilled water to 1 part 5000ppm to make a 100ppm solution.

Now with a **sinus infection** the best way to directly go after this is to get any nasal spray atomizer bottle (**Like this one:** <http://sparknaturals.com/index.php/accessories/1oz-blue-glass-nasal-sprayer.html>) and add 500ppm silver to the bottle. Now to make the 500ppm just add 10 parts distilled water to one part 5000ppm. This will be the strength you use in a nasal spray bottle. One drop of eucalyptus oil to this 500ppm solution is also very good for nasal use. Colloidal Silver (Definition) - A distilled water medium (preferably) containing minute silver particles held in suspension, where the particles carry a slight electrical charge known as a zeta potential. In a true colloidal silver, there is less than 5% ionic content.

What kind of silver does electrolysis (via electric silver generators) produce? This discussion of electrolysis assumes two silver electrodes are placed in deionized water a small distance apart. The electrodes are connected to a low voltage DC power source (9-30 VDC). The electrode connected to the positive (+) terminal is referred to as the anode, the electrode connected to the negative (-) terminal is referred to as the cathode.

1. When electric current passes through silver, some silver atoms interface with the water and release an electron changing the atom into an ion. Whereas true particulate/colloidal silver is not water soluble, silver ions are water soluble, so the silver ions simply dissolve in the water producing an ionic silver solution. This is the electrolysis process. With the electrolysis process, some of the ions in close proximity to the anode will take on an electron from the current passing through and be changed from an ion back into an atom. These atoms are attracted by other similar atoms by van der Waal's force of attraction and thus form small metallic particles. This is how both ions and particles are produced by the electrolysis process. But typically 90-99%% of the silver leaving the anode stays in the ionic form while about 1-10% forms into particles. This ionic solution

is also very unstable because the solution of silver ions is missing an electron in the outer shell and therefore will readily combine with other elements in the bloodstream which reduces ionic silver's useful half life in the body to approximately 7 seconds before it becomes inert and useless.

2. Also because "ionic silver" is so unstable, it has a short shelf life before it will start to precipitate out of solution and fall to the bottom of the container. That is why some unscrupulous manufacturers actually tell you to shake your bottle, because they do not want you to return your ionic silver bottle to them to refund it.
3. Some widely available "ionic silvers" actually have NO actual silver particles in them at all.

The way the "ionic" silver producers fool you, is that ionic solutions "do" have effectiveness "TOPICALLY" when they are used on the surface of the dermis (skin) and work topically because they cannot not combine with the chloride elements in the blood. What happens when ionic silver is ingested as opposed to true colloidal/particulate silver? What the ionic silver producers "don't" tell you is that: Upon sublingual (held under the tongue) absorption ionic silver will combine with the chloride molecules in the blood stream within 7 seconds and quickly be converted into silver chloride which is an inferior, inert, insoluble form of silver. This happens because ionic silver is missing an electron in the outer shell, causing it to immediately combine with the chlorides in the blood rendering the "ionic silver" useless and inert. Whereas true colloidal/particulate silver will be unaffected by the chlorides in the blood stream allowing colloidal/particulate silver to circulate freely to eradicate anything of a viral, bacterial or fungal origin.

Upon ingestion, the ionic silver present in most colloidal silver solutions will immediately come into contact with the hydrochloric acid (HCl) that normally exists in the stomach to digest food. Once again the chloride ions from the hydrochloric acid immediately combine with the silver ions to form silver chloride, an insoluble, inert, inferior silver compound. Since hydrochloric acid does not dissolve metallic/particulate silver (AKA true colloidal silver), the silver particles remain unaffected by the stomach acid. The remaining silver particles will pass easily through the lining of the gastro-intestinal tract and will be absorbed into the bloodstream where they will circulate and come in contact with pathogens which will be killed on contact. The silver chloride (formed as a byproduct of the ionic silver) that precipitates in the stomach consists of large molecules that flocculate to become even larger particles of inert, insoluble silver chloride.

Why is it important to know how much of the silver total is ionic? The benefits of colloidal/particulate silver in the human body are produced by the micron sized (not nanometer) sized metallic silver particles and not the ions. In most liquid silver products a large quantity of ionic silver is produced as a by-product of generating a small amount of silver particles. The prominent methods of production are electrochemical processes using either low voltage DC current or high voltage AC. Both the AC and DC process may employ a constant voltage or a constant current source. Both the DC and the high voltage AC produce a significant percentage of the total silver as ionic. Typically, 75 - 99% of total silver is ionic depending on process variables. In some products claiming very high concentration levels, almost the entire silver content is ionic. To state the silver concentration in ppm without specifying what percentage is

ionic is misleading to say the least. Therefore, it is important to know what percentage of the silver concentration is junk ionic to properly evaluate the quality and effectiveness of the product. Invive Mild Silver Protein (MSP) is virtually 100% true colloidal particulate silver without any useless and toxic ions at all.

What is the highest concentration of ionic silver that pure water will keep in solution? If no other contamination anions are present, the maximum concentration of silver ions that pure water can hold at room temperature in an unsaturated solution is 13.3 parts per million (ppm). 13.3ppm is far too weak to be of any real therapeutic value. Weak (20 ppm ((parts per million))) silver solutions were "never" ever used orally (internally) by the Medical Journals to address serious diseases.

The Medical Journal Silver strengths that produced the results in Medical Journals in the 1940's against 650 disease pathogens were:

- 1.) a 50% solution at 10,000 ppm (derived from a 20,000 ppm Laboratory mother solution).
- 2.) a 10% solution at 2,000 ppm (derived from the 20,000 ppm Laboratory mother solution).
- 3.) a 5% solution at 1,000 ppm (derived from the 20,000 ppm Laboratory mother solution).

Is there a simple way to demonstrate the ionic silver present? To demonstrate ionic silver content, all that is needed, is a chloride ion source to be added to a small amount of colloidal silver. Normal table salt is sodium chloride (NaCl). When table salt is dissolved in water it decomposes into sodium ions and chloride ions. To demonstrate: Place a small amount (1-2 ounces) of colloidal silver in a clear glass. Add a few grains of table salt. Observe that as the salt dissolves a white cloud of silver chloride forms in the solution. Eventually, the entire solution will turn cloudy. If more salt is added, the white silver chloride will become denser until all the silver ions have combined with the available chloride ions. If no silver ions are present then no white cloud will form so in other words if you try this with true particulate/colloidal silver you will not elicit this reaction.
