OBAMA says to Planned parenthood: ABORTION FOES WANT TO RETURN YOU TO THE 1950'S

WASHINGTON (AP) -- **President Barack Obama vowed Friday to join Planned Parenthood in fighting against what he said are efforts by states to turn women's health back to the 1950s, before the Supreme Court legalized abortion nationwide, and singled out the GOP-governed states of North Dakota and Mississippi for criticism.**

"When politicians try to turn Planned Parenthood into a punching bag, they're not just talking about you," Obama said. "They're talking about the millions of women who you serve." **Correction: They serve Satan!!!**

Obama asserted that **"an assault on women's rights"** is underway across the country, with bills introduced in more than 40 states to limit or ban abortion or restrict access to birth control or other services.

"The fact is, after decades of progress, there are still those who want to turn back the clock to policies more suited to the 1950s than the 21st century," he said.

"And they've been involved in an orchestrated and historic effort to roll back basic rights when it comes to women's health."

Last month, North Dakota Republican Gov. Jack Dalrymple signed a law that bans abortions as early as six weeks, or when a fetal heartbeat is detected, making the state the most restrictive in the nation in which to get the procedure.

Obama said "a woman may not even know that she's pregnant at six weeks."

More than a year ago in Mississippi, a "personhood" ballot initiative that would have defined life as beginning at fertilization was defeated by 58 percent of voters in November 2011, the same election in which staunch abortion opponent Phil Bryant, a

Republican, was elected governor. Bryant had campaigned for the initiative. **Abortion opponents are expected to soon begin a signature-drive to get a similar initiative on the ballot in 2014 or 2015.**

The president lauded Planned Parenthood's nearly 100 years of providing cancer screenings, contraception and other health services for women and assured those fighting to protect abortion rights that they have an ally in him.

"You've also got a president who's going to be right there with you, fighting every step of the way," Obama said.

Obama to Planned Parenthood: 'You're making me blush'... 'Planned Parenthood isn't going anywhere'

During a speech this morning at the Planned Parenthood gala, **President Obama vowed he would never allow Republicans to cut taxpayer funds for the abortion provider.**

"If there's one thing the past few years have shown is that Planned Parenthood isn't going anywhere," Obama said as the crowd cheered. "It's not going anywhere today, it's not going anywhere tomorrow."

Obama was wildly received by the audience when he entered the room - the first sitting president to address the nation's largest abortion provider.

"Everybody sit down," Obama said sheepishly. "You're making me blush."

In its [latest annual report](#) for fiscal year 2011 to 2012, **Planned Parenthood revealed that it performed 333,964 abortions in 2011 – a record year for the organization.**

In full view of public television cameras, Gosnell brought 15 low income, Chicago women to Philadelphia to undergo second-trimester abortions induced by inserting a mass of razor-sharp plastic coils into their wombs.

The so-called “super coil” method was the invention of Harvey Karman, an ex-con with a diploma-mill Ph.D., who was a darling of International Planned Parenthood.

That Gosnell was able to participate in a highly publicized event that left nine of its 15 “subjects” with major medical complications and suffer no penalty was a harbinger of the path he would take over four decades.

It was revealed in the murder trial of abortionist Kermit Gosnell that a late-term baby survived a botched abortion and was “swimming” in a toilet and “trying to get out.” An assistant killer then took the very large baby out and “snipped the back of its neck while the mother was still in the room.” **The bloody barbarian baby butcher sarcastically said that the baby “was big enough that it could walk to the store or the bus stop.” I’d like to see that doctor in his white jacket with his stethoscope dangling from his neck walk up the 13 steps of a gallows--literally.**

There was testimony that the abortionist had snipped the spinal cords of about 10 babies who survived the abortion procedure. **As I reconsider my previous statement, I would like to see him walk up the steps to a gallows ten different times!**

That abortion clinic went 17 years without an inspection! Does anyone think the Christian schools and day cares could be treated so gently? Surely, only a mentally and morally challenged Planned Parenthood person would suggest that there is a moral equivalence to a Christian school and an abortion clinic.

Congresswoman Marsha Blackburn, Republican of Tennessee, has submitted a bill to stop funding Planned Parenthood, the biggest provider of abortions in America. **She reports that every 94 seconds Planned Parenthood performs an abortion, and in that amount of time they take in over \$1,600 in federal taxpayer money. That’s your money and mine. That makes us enablers of white-coated killers.**

One of the shocking things about this whole mess is that the mass media refused to cover the story! In my opinion, everyone in this sorry, sordid, sinful mess is complicit to murder—not manslaughter, not accidental death, not wrongful death, but murder. And any society that permits such atrocities is violent, vile, and vicious. No one can defend such heartless slaughter but they try. **In fact, some people tell us abortion is an “act of compassion” since an unnecessary and unwanted child will also grow up unloved. Well, I’d rather be “unwanted” and “unloved” than “unalive.”**

Michigan abortionist: 'It's too late for me, I'm possessed'

ANN ARBOR, MI, February 21, 2013, ([LifeSiteNews.com](#)) – The sidewalk counselor watched with concern as the abortionist escorted his patient out of the clinic. The woman didn’t seem ready to go. Still woozy from the effects of anesthesia and seemingly in pain, she wobbled to and fro, barely able to walk. The woman clung to the abortionist for support as they crossed the street in front of his abortion center. There was no one to take her home. **The abortionist left her alone on the sidewalk and returned to his grim work.**

Worried about the woman’s safety, the sidewalk counselor sent someone after her. They found her sitting on the pavement of a parking lot two blocks away next to a puddle of fresh vomit. When they asked if they could help, she couldn’t speak. **The police were called, and an ambulance took her away.**

When the sidewalk counselor called the abortionist the next day to tell him his patient had been taken to the hospital, **he said it was the woman’s own fault for not bringing a driver.**

This and other harrowing stories **comprise 17 pages of notarized affidavits filed against Michigan abortionist Robert Alexander with the Michigan Board of Medicine and obtained by LifeSiteNews.com.**

The complaint paints a picture of a troubled man, often under the influence of alcohol or other substances, behaving erratically and often dangerously, with stunning disregard for safety, ethics, and state law.

The carefully documented complaint levels serious accusations against Alexander, including:

- Running an unlicensed abortion clinic in violation of state law;
- Performing abortions in unsafe and unsanitary environments, at least one of which lacked running water;
- Lying to property owners about how he intended to use the spaces he would rent from them;
- Stealing from his patients;
- Routinely releasing post-abortive women who were still under the effects of sedation;
- Violating Michigan's informed consent laws; and
- Possible drug abuse.

The complaint covers a two-year period from 2004 to 2006, and contains testimony from witnesses, mostly sidewalk counselors, at two of Alexander's abortion clinics – one in Ann Arbor, which was closed down in 2005 after he was evicted for failure to pay rent, and another in neighboring Ypsilanti which closed down about two years ago for unknown reasons.

One sidewalk counselor took two-and-a-half pages to recount her often strange experiences at the Ann Arbor clinic. **She said that even when working, the abortionist frequently behaved as if he was drunk or on drugs, and that he once told them he was possessed.**

According to the counselor, in August of 2005, Alexander came out of the clinic to talk to the pro-life activists standing on the sidewalk. **"We approached him and told him to stop killing children, to leave the place,"** the counselor wrote.

We told him that we could help him. He answered that it was too late for that, he was possessed, and he proceeded to give us a number...50,000. We don't know what this number meant. He had a stack of cash, about four inches wide in his pocket, and his scrubs all dirty and stained in blood.

Jer. 2:34 Also in thy skirts is found the blood of the souls of the poor innocents: I have not found it by secret search, but upon all these.

Jer 19:4 Because they have forsaken me, and have estranged this place, and have burned incense in it unto other gods...and have filled this place with the blood of innocents;

Jer 19:5 They have built also the high places of Baal, to burn their sons with fire [for] burnt offerings unto Baal, which I commanded not, nor spake [it], neither came [it] into my mind:

Jer 19:6 Therefore, behold, the days come, saith the LORD, that this place shall no more be called Tophet, nor The valley of the son of Hinnom, but The valley of slaughter. Tophet = "place of fire" & Hinnom = "lamentation"

His speech was very slow, and not very clear. When walking, Alexander seemed not very coordinated, almost like if he had been drinking.

The counselor wrote that he often seemed to be in an altered state during their interactions. In October 2005, the abortionist invited the pro-lifers in to talk. They took him up on his offer. **“We talked for 30 minutes and then we prayed over him,”** the counselor wrote. **“After that, we had the opportunity to pray over him every Friday for the next couple of months, and interact with him more.** During these times, we always noticed how he walked slow and almost in a state of sleep, or confusion. His speech was also impaired and he would say things that were not clear.”

Another former clinic worker came to see the counselor right after quitting her job. “Women’s Choice was a busy and hostile clinic to do counseling at,” the counselor wrote. “There was a clinic worker, who we believe was the clinic coordinator...She was very hostile with us all the time. One day...a friend of mine who counsels with me went to the clinic, and this lady was in her car waiting for us. She said that she had just quit her job there. She said that Robert Alexander was particularly confused that day. **That he had asked her to sign false papers and she refused, and that he had tried to do an abortion on a 7 month old baby and charge \$3000 for it. She said she was getting out of there before it got too bad.**”

Not long after that, the Ann Arbor clinic closed because Alexander stopped paying the rent.

Monica Miller, who heads the group Citizens for a Pro-Life Society, **was able to enter the facility a few days after the eviction with a realtor and a few other pro-life activists. In her notarized affidavit, she describes the hastily abandoned facility as “exceptionally unkempt and dirty.”**

“Several piles of garbage bags occupied one room along with containers of blood-material,” she wrote. “There was a small area of blood spattering on the wall of this room...In another room I observed open syringes with exposed hypodermic needles.” Another affidavit from someone who searched the facility with Miller guessed the room was full of trash because the dumpster behind the facility had been removed a month prior. “Apparently, in the last month of business,” he wrote, **“Woman’s Choice received no garbage service; the garbage was being stored in a spare room.”**

Suspicious that Alexander may have left the remains of aborted babies in those bags, he opened one to look. He found a plastic bag with formalin **inside labeled “Abortion – 13 weeks.” The bag had been sliced open.** Elsewhere in the clinic, he found trash cans spattered with blood. One had an open cup set on top of it. The cup was filled with what appeared to be blood.

Over the next few weeks, as Alexander searched for a new location for his abortion mill, Miller and other pro-life activists called him several times posing as women seeking abortions to find out where he would set up shop next. Miller noted that each time they made an appointment, Alexander told them to print informed consent paperwork off the Michigan.gov website, sign it and bring it with them, **but to just “skip the right-to-life questions” and “go to the end of the form,” in clear violation of Michigan’s informed consent law.**

When Alexander offered to schedule an abortion for one of them at a small office suite in Ann Arbor, Miller met with the landlord and asked if he knew the space would be

used as an abortion mill. The landlord was surprised. Alexander had told him he would be running a medical referral service, not performing surgery.

“Both [the landlord and his assistant] told me that this space was not set up as a doctor’s office,” Miller wrote. “There was no sink or running water, for instance, of any kind on the premises.”

That landlord decided not to rent to Alexander after all, but another landlord, this one in Ypsilanti, had allowed Alexander to store abortion equipment and furniture on his property in a small office space after his eviction. **While the two were still negotiating over a possible lease arrangement, with no paperwork signed and no permits filed, Alexander began arranging abortion appointments at that makeshift ‘office,’ which also lacked running water or a toilet.** Again, Miller contacted the landlord, and once again Alexander was denied a lease.

Finally, Alexander managed to secure a space in Ypsilanti. City statutes require a building inspection to be performed and occupancy permits to be issued before business can take place on any property, **but she says Alexander started scheduling abortions before he ever asked for an inspection or applied for any permits.**

As for the woman taken by ambulance from the parking lot where sidewalk counselors found her, dazed and vomiting? She survived. She called the sidewalk counselor who had helped her later that same night and asked to be picked up from the hospital. She wanted a ride back to the parking lot to pick up her car. When the counselor picked her up, she told her a little about what had happened.

Dr. Alexander, she said, had told her an abortion would cost \$250. When she arrived at his office, **he raised the price.** She protested, telling him she had only \$270 in her wallet, but needed the last \$20 to buy gas for her car so she could get to work. **After the procedure, she checked her purse. The \$20 she had withheld from him was gone.** She confronted him about it, but he denied taking the money. Then he walked her across the street and left her there alone, **still drugged, with a wallet as empty as her womb.**

All of these troubling allegations are in 17 pages of notarized affidavits obtained by LifeSiteNews – but only after they were rejected out of hand by officials in the state of Michigan. **Because the evidence was collected by pro-life advocates, Michigan Board of Medicine chairman Dr. George Shade dismissed it, accusing the pro-lifers of a conspiracy to discredit his former protégé.**

Alexander, whose filthy Muskegon clinic was shut down by local authorities as a threat to public health in late 2012, has a long history of trouble with the law. His medical license was revoked in 1990 and he served time in federal prison for selling illegal prescriptions for controlled substances out of a weight loss clinic. **Dr. Shade was the one who helped Alexander get his license back upon his release, writing a letter on his behalf and hiring the ex-con into a training program under his supervision.** Shade is now facing tough questions about an investigation he blocked into botched abortions at Alexander’s Muskegon clinic in 2010, but the complaint obtained by LifeSiteNews indicates he may have been covering up Alexander’s misdeeds for a lot longer than that.

Alexander recently abruptly left his job at an abortion mill in Detroit and reportedly now works at a public STD clinic in the same city. An attempt by LifeSiteNews to reach Alexander for comment at his place of employment was unsuccessful.

Congressman Files Bill to Ban Abortions Based on Fetal Pain Science

Rep. Trent Franks, an Arizona Republican, is the sponsor of the D.C. Religious Groups Celebrate Day To Thank Abortion Doctors

In case you missed it, March 10 was National Abortion Provider Appreciation Day. Yes, a special day to celebrate the work done by our friendly neighborhood abortionists.

The Religious Coalition for Reproductive Choice (RCRC), which enjoys official, unqualified endorsements from a collection of liberal Protestant, Jewish, Unitarian Universalist, and atheist/humanist groups, marked the holiday by e-mailing supporters a statement entitled "The Religious Coalition for Reproductive Choice Thanks and Blesses Abortion Providers."

According to this church-endorsed, atheist-funded interfaith group, religious leaders should celebrate the "holy work" (which has claimed the lives of over 55 million American babies since 1973), by thanking, blessing, and offering prayers of gratitude for the work of "abortion providers around the world."

After all, performing abortions is driven by "equal parts compassion and courage," as well as, for many providers, "a deep religious faith," RCRC assures us.

RCRC's endorsers include four oldline Protestant denominations: the United Methodist Church, the Presbyterian Church (USA), the Episcopal Church, and the United Church of Christ.

Comment: Wow, I guess these wonderful "Christian" denominations could care less about murdering babies or these verses:

Jer 1:4 Then the word of the LORD came unto me, saying,

Jer 1:5 Before I formed thee in the belly I knew thee; and before thou camest forth out of the womb I sanctified thee, and I ordained thee a prophet unto the nations.

Eph 2:10 For we are his workmanship, created in Christ Jesus unto good works, which God hath before ordained that we should walk in them.

Psa 22:10 I was cast upon thee from the womb: thou art my God from my mother's belly.

Gen 4:9 And the LORD said unto Cain, Where [is] Abel thy brother? And he said, I know not: Am I my brother's keeper?

Gen 4:10 And he said, What hast thou done? the voice of thy brother's blood crieth unto me from the ground.

Gen 4:11 And now art thou cursed from the earth, which hath opened her mouth to receive thy brother's blood from thy hand;

Mat 18:6 But whoso shall offend one of these little ones which believe in me, it were better for him that a millstone were hanged about his neck, and that he were drowned in the depth of the sea.

While many members of each denomination have protested this affiliation, **RCRC enjoys strong support from the liberal factions and denominational elites in all four.** Liberals within the United Methodist Church openly celebrate how their Macchiavellian tactics **prevented a proposal to sever the UMC's ties with RCRC from ever coming to a vote at denomination's 2012 General Conference.**

Observers on both sides believe that this proposal would have passed if delegates had not been forcibly prevented from voting on it, even despite the way in which the United Methodist bishops (with a couple of notable exceptions) have chosen to abdicate their responsibility of moral leadership.

The RCRC e-mail **also promotes a video featuring an abortionist and RCRC board member, Dr. Willie Parker, accepting RCRC's inaugural "Moody-Patterson Award for Leadership in Reproductive Justice."**

As is typical for defenders of all abortions, there is disproportionate attention given to rare "hard cases" which account for only a tiny percentage of American abortions. But the award recipient makes clear that his abortion business also includes many cases of simply "unplanned or unwanted pregnancies."

Meanwhile, creative, non-violent solutions to such circumstances (including but not limited to adoption) are treated as unworthy of even a moment of consideration.

For the large portion of the human population whose conception was not planned, RCRC's implied message seems clear: **the value of your life is inherently massively lower than that of others. In fact, unplanned pregnancies being allowed to live is defined primarily as a "punishment" and a source of "untold hardships" for your family.**

The statement from the "religious" front group gushingly claims that in the video, **Parker "eloquently explained why providing abortion care is a part of his own spiritual life."** However, his speech actually makes no reference to God, scripture, or even to his personally adhering to any religion. **Comment: Man this is really reminiscent of Patricia Baird-Windle, Founder and owner of Aware Woman Center for Choice (AKA: abortion clinics) who was quoted saying: 'You practice your religion and let me practice mine.' My religion is a holy ritual child sacrifice'** The stated purpose of the Wiccan Religious Cooperative of Florida is to provide an umbrella organization for witch covens throughout the state of Florida. The incorporation papers **list two abortion clinic employees as directors of the Wiccan organization.** Shortly after the Wiccan Religious Cooperative of Florida was founded, Carol Ebbing, another Aware Woman abortion clinic employee procured the book entitled: **"The Sacrament of Abortion" by Ginnette Paris, a witch in France, who presents abortion as 'a sacred act' & 'A sacrifice to Artemis'.**

The most religious part of his speech is when Parker approvingly quotes a statement from the Clergy Consultative Service **praising abortionists for "living by the highest standards of religion and of the Hippocratic Oath".**

The citation of the Hippocratic Oath is beyond hypocritical, given how abortion is explicitly rejected in the classical version of that oath for doctors of Western medicine.

The Hippocratic Oath (orkos) is one of the most widely known of Greek medical texts. It requires a new physician **to swear upon a number of healing gods that he will uphold a number of professional ethical standards.**

Oath text--English Translation, version 1

Apollo Physician and Asclepius and Hygieia and Panacea and all the gods and goddesses, making them my witnesses, that I will fulfill according to my ability and judgment this oath and this covenant:

...I will neither give a deadly drug to anybody (Comment: Like the "Morning After Pill" is to the unborn baby The essence of this oath is where we get th term "First do no harm") if asked for it, nor will I make a suggestion to this effect. Similarly, I will not give to a woman an abortive remedy. In purity and holiness I will guard my life and my art.

Pharmakeia: Sorcery, Pharmaceuticals & the Roots of Modern Day Drug

Pharmakeia is a form of the Greek root word from which we get our English words: Pharmacy, Pharmacist, and Pharmaceutical. In the Bible, pharmakeia carried with it the idea of sorcery, occultism, and black magic. It is in this sense that Paul used the term in Galatians 5.20 as the word 'witchcraft'. In Rev. 9:21 & 18:23 it is translated 'sorceries'. Do you find it rather disturbing that approximately 60% of the population is taking at least one pharmaceutical drug every day? Some are taking up to fifteen and twenty! We are told that we are living during a time of the greatest medical breakthroughs in the history of the world yet, over one hundred million Americans suffer from various health problems. Why has such a large majority of the world become dependent on pharmaceutical drugs? Perhaps you're one of the hundreds of millions around the world that's ingesting a daily dose of pharmaceutical medicine? Is it possible that the pharmaceutical/medical cartel has 'disease treatment' and not 'disease cure' in mind? The most powerful German economic corporate emporium in the first half of this century was known as IG Farben, and was nothing more than a powerful cartel of BASF, Bayer, Hoechst, and other German chemical and pharmaceutical companies. IG Farben was the single largest donor to the election campaign of Adolph Hitler & the beginning of the modern day pharmaceutical industry. Zyklon-B, an extermination gas produced by Hoechst, was used to kill millions of innocent people in death camps. The U.S. government's investigation (of all the factors leading to WW2 in 1946) came to the conclusion that without IG Farben the Second World War would of not been possible.

As an apparently deliberate rhetorical strategy, the speech and RCRC text repeatedly connect abortion to the words "compassion" and "care," even framing the procedure itself as "abortion care."

In fact, Parker frames his work as so driven by compassion that his retort to questions about his comfort with personally performing abortions is that **he is "uncomfortable at the number of abortions [he] failed to provide for the first 12 years of [his] practice."**

Meanwhile, RCRC's on-screen text also notes common "reproductive rights" talking

points lamenting how the performance of abortion is not more widespread throughout the country.

Yet for all the talk of compassion and care, this abortion-appreciation presentation **includes no hint of acknowledgement that abortions involve another human being besides the woman and the abortionist, let alone acknowledgement of the scars abortion leaves on surviving mothers, fathers, and siblings.**

But in RCRC's dictionary, "compassion" and "care" are redefined to mean mercilessly drowning another human being in poison or cutting him to pieces, and taking great pains to avoid acknowledging he ever existed.
