

Worse, there are hints that the government uses this secret interpretation to gather what one Patriot-watcher calls a "dragnet" for massive amounts of information on private citizens; the government portrays its data-collection efforts much differently."

Senator Wyden attempts to further explain:

"We're getting to a gap between what the public thinks the law says and what the American government secretly thinks the law says', Wyden tells the 'Danger Room' in an interview in his Senate office ... That's why Wyden and his colleague Sen. Mark Udall offered an <u>amendment on Tuesday to the Patriot Act reauthorization</u>. The amendment, first reported by Marcy Wheeler, blasts the administration for "secretly reinterpret[ing] public laws and statutes." It would compel the Attorney General to "publicly disclose the United States Government's official interpretation of the USA Patriot Act."

Americans are in the situation where the government has far more authority over us than anyone can possibly know. Congress Proposes Bill to Allow Worldwide War ... Including INSIDE the U.S.

A couple of minutes past midnight, <u>Rep. John Garamendi</u> (D-Calif.) offered an amendment to strike Sec. 1034 — the new authorization for worldwide war provision — from the NDAA. Visibly angry that such a large sweeping provision had not yet had any public hearing whatsoever, he vigorously characterized it as a very broad declaration of war.

Rep. Garamendi was very concerned by the limitless geographic boundaries of the provision. Essentially, it would enable the U.S. to use military force anywhere in the world (**including within the U.S.**) in search of terrorists.

While a new authorization for worldwide war has had its first public debate, it unfortunately only lasted a hair over 10 minutes and occurred after midnight.

White House Adds New Position to Deal with Unfavorable Online Media

Top Mexican Drug Lord: I Trafficked Cocaine For The U.S. Government Paul Joseph Watson--Infowars.com--April 27, 2011

The "logistical coordinator" for a top Mexican drug-trafficking gang that was responsible for purchasing the CIA torture jet that crashed with four tons on cocaine on board back in 2007 has told the U.S. District Court for the Northern District of Illinois in Chicago that he has been working as a U.S. government asset for years.

Jesus Vicente Zambada is the son of Ismael Zambada, one of the top kingpins of the Sinaloa drug-trafficking organization. Niebla was arrested in Mexico in March 2009 and extradited to the United States to stand trial last February.

"The indictment pending against Zambada Niebla claims he served as the "logistical coordinator" for the "cartel," helping to oversee an operation that imported into the U.S. "multi-ton quantities of cocaine ... using various means, including but not limited to, Boeing 747 cargo aircraft, private aircraft ... buses, rail cars, tractor trailers, and automobiles," writes Narcosphere's Bill Conroy.

In a two page court pleading filed with the U.S. District Court for the Northern District of Illinois in Chicago, Niebla claims that he was working on behalf and with the authority of, "The U.S. Department of Justice, Drug Enforcement Administration ("DEA"); and the Federal Bureau of Investigation ("FBI"); and the Department of Homeland Security, Immigration and Customs Enforcement ("ICE")," since January 1, 2004.

Niebla is also connected to the <u>Gulfstream II jet that wrecked with four tons of cocaine</u> on board on September 24, 2007. European investigators linked the plane's tail number, N987SA, to past CIA "rendition" operations. The <u>bill of sale</u> for the Gulfstream jet, sold weeks before it crashed, listed the name of Greg Smith, a pilot who had previously worked for the FBI, DEA and CIA.

The plane was purchased by Niebla's Sinaloa drug-trafficking organization through a syndicate of Colombian drug-traffickers that included a CIA asset named Nelson Urrego, according to another undercover CIA operative, Baruch Vega, who was involved in the deal.

Sinaloa bought the jet by wiring money through the U.S. banking giant Wachovia, now a subsidiary of Wells Fargo. "In total, nearly \$13 million dollars went through correspondent bank accounts at Wachovia for the purchase of aircraft to be used in the illegal narcotics trade. From these aircraft, more than 20,000 kilograms of cocaine were seized," states Wachovia's deferred prosecution agreement with the U.S. Department of Justice. Wachovia was forced to pay a penalty of around \$160 million dollars for allowing the money to be laundered through its correspondent bank accounts.

In addition to smuggling narcotics into the United States, Niebla is also accused of obtaining weapons from the U.S. with the intent to use them to cause violence in Mexico City, leading to the murders of several innocent people. Despite the fact that the Obama administration has cited the flow of guns from the U.S. into Mexico as an excuse with which to attack the second amendment rights of Americans, it was recently revealed that the US Bureau of Alcohol, Tobacco, Firearms and Explosives deliberately allowed guns to be smuggled from the U.S. into the hands of Mexican drug lords under "Operation Fast and Furious". President Obama later denied that he had any knowledge of the program.

Niebla's assertion that he smuggled drugs from Mexico into the United States while working for the U.S. government adds further weight to the <u>already voluminous body of evidence</u> that confirms the CIA and U.S. banking giants are the top players in a global drug trade worth hundreds of billions of dollars a year, <u>information made public by the likes of Gary Webb</u>, who it was claimed committed suicide in 2004 despite the fact that he was found **with two gunshot wounds to the head** and after Webb himself had complained of death threats and "government people" stalking his home. According to a little noticed quote in the Washington Post earlier this month which has attracted virtually no media attention, President Obama told gun control advocate Sarah Brady that his administration is working "under the radar" to sneak attack the second amendment rights of American citizens.

During a March 30 meeting between Jim and Sarah Brady and White House Press Secretary Jay Carney, at which Obama "dropped in," the president reportedly told Brady, "I just want you to know that we are working on it (gun control)....We have to go through a few processes, but under the radar."

The quote appeared in an <u>April 11 Washington Post story</u> about Obama's gun control czar Steve Croley.

"What is truly startling about this story is the way it has been totally ignored by the rest of the media," <u>writes Jeff Knox</u>...."Even the folks at the Brady bunch are not spreading the news about the stunning reassurances from the president. There is nothing on their website discussing or even mentioning Obama's chat with Jim and Sarah."

The Obama administration has repeatedly invoked rhetoric about the flow of guns being smuggled from the U.S. into Mexico as a talking point with which to kill gun rights of American citizens.

Just months into his term in the Oval Office, Obama told Mexican President Felipe Calderon that the U.S. was to blame for much of Mexico's drug violence because of firearms that were purchased in America in spite of the fact it was recently revealed that the U.S. government itself was responsible for smuggling guns over the border which ended up directly in the hands of Mexican drug lords.

Mexican "Saint of Death" Cult: 'like fighting against Satan himself'

Apr 20, 2011 | by Jerry Pierce--LAREDO, Texas (BP)--They call her "La Santa Muerte," the Saint of Death, whose followers have multiplied rapidly over the last decade as violence has gripped Mexico and spilled across the border, according to missionaries who have witnessed the death cult's growing influence.

From Mexico City to border towns such as Laredo, and lately in large American cities such as Houston, Dallas, Los Angeles and Chicago, her cloaked, skeletal icon, usually depicted gripping the Grim Reaper with a scythe, is often seen hanging from the windows, entryways and sometimes on the tattoos of her disciples.

Her appeal lies in basic human desires -- especially those of the poor **and drug runners** who entreat her for protection and vengeance.

"Healing, money, protection, or they want power," said Orpha Ortega, who along with

her husband William serves as a Southern Baptist missionary in Mexico City.

The Santa Muerte cult is a growing concern for pastors in border towns such as Laredo, where a meeting hosted by Southern Baptist missionaries in January drew Spanish-speaking pastors, church leaders and at least one concerned police officer whose experiences at a local jail prompted him to attend. (Spanish-language video of the meeting is accessible at http://www.sbtexas.com/videos.)

The death cult figures **prominently in the surging violence by Mexican drug traffickers** known as narcos in interior Mexico and along the U.S.-Mexico border, William Ortega told those at the meeting.

For six of the 12 years they've been in Mexico City, the Ortegas have ministered in the Tepito neighborhood, which is notorious for its thriving black market. Poverty, drugs and violence are pervasive, and the largest shrine to Saint Death is an institution there.

Of the 28 million people in Mexico City, about **2 million** are estimated to be followers of Saint Death, Ortega said, with large numbers of them in Tepito.

The Ortegas welcomed the news in January that Mexican authorities had arrested the leader of the Tepito shrine and the closest thing the cult has to a high priest, David Romo, on kidnapping and money laundering charges.

Increasingly, the death cult has moved north, making inroads into border towns and American cities where Mexican immigrants find work.

Ortega said adherents largely form two groups: drug dealers and the poor, with the former seeking protection from authorities and vengeance on their enemies and the latter seeking healing, protection from the violence around them, and prosperity. The death saint, her followers claim, offers all of the above.

A Baptist worker in the Laredo area told the Southern Baptist TEXAN he hears testimonies of healing from cancer, AIDS and other ailments at the hands of Saint Death.

"But most of the time, their promise of healing or protection involves the killing of someone else in order to receive a miracle or in order to receive a protection," the worker said.

That was one of the points Ortega emphasized during the Laredo meeting. In the Texas border town and across the Rio Grande in Nuevo Laredo is the largest number of Saint Death followers along the Rio Grande, Ortega said.

Often, Christians are seen as enemies of the cult for winning converts and refusing to syncretize orthodox Christianity with the death cult.

"Pray for safety while I'm doing the work," the missionary said. "Pray for my integrity and

holiness. Pray the Lord will provide the right leaders to provide churches. The only way we will win the fight is to plant those churches that preach the truth." http://www.bpnews.net/BPnews.asp?ID=35100

February 01, 2010--By Drew Zahn--2011 WorldNetDaily--On a hill overlooking the Cadet Chapel and Visitor Center of the U.S. Air Force <u>Academy</u>, Tech. Sgt. Robert Longcrier is burning white sage, consecrating a circle of stones that will soon be used by cadets as a place to worship Mother Earth and the Horned God.

According to <u>an official release</u> from the Colorado Springs, Colo., <u>university</u> and air base wing, the chapel is adding this new worship area for followers of Earth-centered religions, including Paganism, Druidism and the form of witchcraft known as Wicca. The official dedication ceremony is tentatively scheduled for March 10.

Longcrier, who became Pagan shortly after arriving at the Academy in 2006, celebrates that the new worship circle represents an increasing level of acceptance of pagan religion:

"When I first arrived here, Earth-centered cadets didn't have anywhere to call home," he said. "Now, they meet every Monday night, they get to go on retreats and they have a stone circle. ... We have representation on the Cadet Interfaith Council, and I even meet with the chaplains at Peterson Air Force Base once a year to discuss religious climate."

The stone and earth circle is only the latest addition to a collection of worship spaces on the Academy <u>campus</u>, including Protestant, Catholic, Jewish, Muslim and Buddhist sacred spaces.

Longcrier attests that the Academy's chaplains have supported his efforts in every step of making a space for Pagans to worship:

"There really haven't been any obstacles for the new circle," he said. "The chaplain's office has been 100-percent supportive."

Yes see below for the full definition. Many Japanese business people wouldn't think of having a restaurant, store, bar, etc. without the presence of a beckoning cat ("Maneki Neko", also sometimes called a "Prosperity Cat"). Maneki Neko's always have at least one raised forepaw but otherwise they can take many forms. A white cat wearing a bib and a bell are typical sights in Chinese restaurants in this country. The cat is waving to us, asking us to come into the shop or asking good fortune to visit the establishment. Maneki Neko date back several centuries. The exact origins of Maneki Neko and the source of its power are explained with many tales. The most prevalent tale involves a poor temple in the woods: A traveler takes shelter under a nearby tree during a storm. A cat appears and beckons the traveler to follow it to avoid the storm in the temple. As



Maneki Neko or Beckoning Cat - Bank. soon as the traveler follows the cat, the tree and the spot he had been in are struck by lightning. Because the cat has saved him and brought him to the temple, the traveler and his family become patrons of the temple and bring it fame and wealth. Other sources hint that the raised paw might be a coded phallic symbol because the cats are first found around the time when common but more graphic phallic good luck symbols were banned from inns and gambling houses by western-influenced Japanese governments. There are many variations on the Maneki Neko and you may see the left paw or the right paw raised. Generally speaking, it is believed that the left paw beckons for people (customers) while the right attracts money or good fortune.

You may want a Beckoning Cat for your office or store to attract customers or in your place of business or house to attract good fortune. Placed near the front door of a store, it is said to attract new patrons. At home, you can put you Maneki Neko anywhere you want to attract good luck.

Why do people offer things such as food, wine, water, tea, incense, money and even cigarettes to statues of Buddha? What is the representation behind these items

Answer:

It's a form of ritual worship. These items represent desirable human objects, and are offered to the Buddha (or in other religions, the deity) as a show of respect and appeasement. These sorts of practices are a part of Buddhism, in that they arose in the course of Buddhist history, however they are not taught as Buddhist practices. Cigarettes, I had never heard of it before. So, I'm a Christian and I smoke...What's wrong with that?

Imagine for a moment The Lord Jesus stopping in at your house to visit with you personally. You have him sit in your most comfortable chair. In the course of your sharing together you offer him a cigarette. What do you think his response would be? To consider the Lord's response, we will take liberty with scripture passages found in Colossians 3:23 and 1 Corinthians 10:31 in light of the smoking questions: "When you smoke, smoke heartily as unto the Lord." "Whenever you smoke, smoke to the glory of God."

Probably, on the merit of only these two scripture passages you will agree cigarette smoking is not compatible with the Christian experience. Let's examine further to see what the Spirit of God reveals about tobacco and smoking...

We are responsible to God for the care of our body. When a person truly receives Jesus Christ as Savior, the Holy Spirit of God enters the human spirit making a new creature. 1 Corinthians 6:19 states that the body of the Believer is a Temple, a tabernacle or dwelling, abiding place of the very Holy Spirit of God. Our willing covenant or contract with God to receive eternal life through Jesus Christ puts us in a place of responsibility. As genuine Christians we are held responsible by God for the care and use of our physical body. 1 Corinthians 6:19 states: What? Know you not that your body is the Temple of the Holy Ghost which is in you, which you have of God, and you are not your own?

Beyond question--it is established both medically and scientifically--smoking adversely affects virtually every organic system of the human body and bodily function. The smoker opens the door to the spirit of self-destruction and commits "slow-suicide". The heart and blood are affected. The eyes and nasal passages are inflamed and burned. The respiratory system easily falls prey to emphysema and asthma. Tobacco, nicotine and smoking attack and break down immune systems so cancers can develop unrestricted. Common to smokers are lung cancer, throat cancer and lip cancer.

The "narcotic" property in the tobacco and nicotine attacks the nervous system of the smoker and works its breakdown process, see-sawing the smokers nerves between periods of Hypertension and Depression. Mental awareness, alertness and function come under a dulling, slowing effect. This hinders our mental ability in everyday activity and restricts or cuts off our mental fellowship with the Holy Spirit speaking to our mind from our spirit. A person who has the smoking habit, in honesty, must label themselves an "addict".

Smoking harms others. For the Christian it is to be especially noted that the smoker "forces" all these above mentioned plagues, diseases and problems on other "innocent" people in the smoker's presence. Co-workers, family and especially children are victims of the smoke from the smoker and cigarettes. Christians are definitely **not to be** "stumbling blocks" to others. Think how God views it when a Believer, by smoking, causes others, especially children, to have to endure burning eyes, clogged nasal passages, undue colds, flu, nervous disorders and hindrances to mind function! Even asthma and cancers! Yes, Christian smoker - You are guilty of these! Others are offended by smoking Believers yet most endure the offense silently. The children and infants tormented by tobacco smoke have no choice but to endure silently. Il Corinthians 6:3 is a command to followers of Christ to "give no offense in anything, that the ministry be not blamed".

The Smoking Believer's Question of Stewardship

We have seen above that the smoker buys misery, destruction & death when cigarettes are purchased. Most Christians desire to be seen of the Lord as "good stewards". How much financial resource is "going up in smoke" from Believer-smokers? What would Jesus say about this waste of funds that otherwise could go to evangelism, missionary work or the needy? Should a smoking Believer even pray for God's financial blessings? Most probably the smoking Believer causes a devouring spirit to come upon his or her finances, as described in Malachi 3:11.

The Smoking Believer's Question of Example

It has been well said: "You are the only Christian someone knows"; or, what would another person read in "The Gospel According to You"? Again, responsibility demands of the Christian we walk holy and unblamable in our behavior. Can there be any argument, smoking can in no way serve as a good example to a young Christian? How easy a matter it is for Satan to convince young boys and girls and teens it is certainly o.k. to smoke "modern" dope if parents and adults--especially Christian adults-smoke "old fashioned" tobacco?

Smoking has Spiritual Effects

God is Spirit and sees things spiritually. Believers are called to be spiritually-minded even though we are in the physical world. We note in Ephesians 6:12 our enemies are evil spirit beings in the spirit realm. We are each of us as a Believer called and commanded to do personal battle against the demons and overcome them in our lives. Satan and the unclean spirits (demons) know they have spiritual "legal right or ground" to successfully attack and harm (steal, kill, destroy) the smoking Believer! Spiritually speaking, (the way God sees it) cigarette smoking is "burning incense to other (demon) gods". Il Kings 22:17, Il Kings 23:5; Il Chronicles 28:25, 34:24, 34:25; Jeremiah 1:16, 7:9, 11:12, 19:4; Chapter 44, 48:35.

READ THIS!

Burning tobacco originated with ancient aboriginals. The modern world learned of the use of tobacco from the Indians. History reveals Columbus found the Indians smoking and watched with surprise and wonderment. The Grand Pipe or Pipe of Peace was first observed among the Indians of Upper Mississippi country by the French. They called these pipes "calumets". According to the Indians, the pipe possessed a supernatural power and a "charming" effect to compel the partakers of the smoke to a brotherly bond of peace (obviously not the peace of the Lord Jesus Christ).

Historically the calumet was considered a sacred pipe to offer smoke to the demon gods above and below. Tobacco was looked upon as a sacred plant and burning it brought favor in the eyes of the gods (demons). Even a member of an enemy tribe who entered a house and smoked with the host was guaranteed protection and safe conduct when he left.

Several Indian tribes burned incense for a purifying medium or an acceptable offering to the unseen. Some Eastern tribes did not smoke a pipe in a sacred ceremony but burned tobacco in a small fire. This smoke offering was believed to ascend to the power to whom they prayed.

As the use of tobacco as an offering to gods continued, it was rolled in corn husks, the predecessors of modern cigars and cigarettes. Inhaling the smoke was incorporated into the rituals and both the smoke and the aroma continued to have a serious place in the religious rituals and ceremonies.

Historical reference books also state the tobacco pipe was used by American Indians in ceremonies to ratify treaties. Also, some Indians smoked the tobacco pipes to their sungod and blew the smoke to him. Indians related many sources of illnesses to "witches who flew through the air disguised as owls to poison their victims". The protective practice against these witches was to cut their limbs and cleanse themselves of bad blood; and the use of "the old man's tobacco" was to avert spirits of the dead.

.These are processes of witchcraft prohibited by God!
