### **Bizarre Batman Connection Shows Up in Another Mass Shooting--Has Batman**


A recent shooting in Las Vegas appears to be the work of two crazed Batman fans. The Facebook pages of <u>Jerad</u> and <u>Amanda Miller</u>, the two accused shooters who killed two police officers inside a Cici's Pizza in

Las Vegas, as well as a Walmart patron, are littered with photos of the married couple dressed as Batman villain The Joker and his love interest and criminal accomplice Harley Quinn.

Similarly, on July 20, 2012, James Holmes walked into a theater in Aurora, Colorado, and threw smoke grenades into an audience before unloading a hail of bullets, killing 12 people. Patrons had flocked to watch the latest Batman flick, "The Dark Knight Rises," and many publications claimed Holmes painted his hair red as a reference to the Joker in a scene from "The Dark Knight."

After the shooting, <u>multiple witnesses claimed they saw accomplices aid Holmes</u>, and once incarcerated, an inmate housed with the accused shooter claimed Holmes complained about an <u>"evil" therapist who had "programmed" him to kill</u>.

Holmes was also <u>linked to DARPA-funded research</u> into neuroscience programs at the University of Colorado Anschutz Medical Campus in Denver, and while attending the Salk Institute of Biological Studies in San Diego, he <u>also designed a computer program using flicker fusion</u>, a science examining how light flicker rates affect human behavior. Following the Sandy Hook school shootings, which a <u>multitude of people perceive to have been staged</u>, the Batman theme was revisited after Internet sleuths found a map in "The Dark Knight Rises" <u>referenced the words "Sandy Hook."</u>



The rumors were confirmed and it was found that the map in question had been altered from previous versions appearing in the recent Christopher Nolan-directed Batman films to include Sandy Hook.

A section of map in "The Dark Knight Rises" was renamed Sandy Hook.

Further investigation found <u>46-year-old Scott Getzinger</u>, <u>listed as the prop master for "The Dark Knight Rises" film on IMDB</u>, **died in a head-on collision on April 6, 2012**, prior to the film's release. <u>In the film industry</u>, a prop master is responsible for all things props, including maps.

Besides the obvious Batman connection, <u>another running theme through some of these</u> past shootings seems to be Sandy Hook or Newtown, Conn. An additional anomaly is that <u>Getzinger was a resident of Newtown</u>.

Suzanne Collins, the author of the Hunger Games, is also a <u>famous Newtown resident</u>, and two weeks ago, Elliot Rodger, the son of the Assistant Director of the Hunger Games movie series (which is based off Collins' books) also <u>carried out a mass</u> shooting.

The frequent references to the Batman franchise, a fictional work designed to sympathize the masses to the plight of humanitarian billionaire playboys, like Bruce Wayne, and the odd Sandy Hook connections are similar to how several past assassins, including Lee Harvey Oswald, were found with copies of the novel The Catcher in the Rye.

### Media Links Las Vegas Shooters to Bundy Ranch

According to a report posted at the <u>Daily Mail</u>, the married couple suspected in the shootings and who executed a suicide pact following the rampage were "militant"

and "obsessed with conspiracy theories." They allegedly shouted at diners to "tell the police the revolution has begun."

The male suspect, named as Jared in media reports, claimed to have been involved in the standoff between Cliven Bundy, his supporters and the Bureau of Land Management, according to a neighbor.

Carol Bundy said the shooting in Las Vegas is not related to the standoff at the Bundy ranch. "I have not seen or heard anything from the militia and others who have came to our ranch that would, in any way, make me think they had an intent to kill or harm anyone," she told The Daily Mail.

Miller was a <a href="convicted felon">convicted felon</a>, so legally purchasing the firearms he allegedly used in last weekend's rampage is out of the question.

"It is illegal for a person who has been convicted of a felony then to possess a firearm in Nevada. Penalties include prison and high fines. People who have been convicted of a felony may not possess a firearm in Nevada unless they are granted an official pardon," states the <u>Las Vegas Defense Group</u>.

Dylan Scott, writing for <u>Talking Points Memo</u>, notes law enforcement in Nevada has yet to determine how Miller and his wife received firearms. "But in the weeks leading up to the attack, Jerad Miller posted multiple times on Facebook that he was looking for a gun and asked for help obtaining one," Scott writes.

Amanda Miller, however, did not have a criminal record and it was legally permissible for her to purchase firearms. Police in Nevada have yet to release any information indicating if she in fact bought the firearms allegedly used in the attack.

Mother Jones, formerly edited by anti-Second Amendment zealot Michael Moore, writes in a <u>screed implicating Infowars.com in the shooting</u> that Miller suffered from "decaying teeth, lack of health insurance, and inability to find work," in other words the supposed rightwing extremist likely did not have the funds available to buy a shotgun, handgun and hundreds of rounds of ammunition.

Moreover, photos of Miller at the Bundy ranch show him toting an AK-47, the very weapon he pined for on his Facebook page. He is outfitted in crisp new camos and a bulletproof vest.

AK-47 semiautomatic rifles are priced between \$450 and \$3,500, depending on manufacture origin and modifications. The price of AK-47 ammo, the 7.62×39, while relatively inexpensive, routinely costs over \$200 for a thousand rounds bought in bulk. A bulletproof vest can cost hundreds of dollars. The question is: how did an unemployed felon manage to buy this equipment?

This scenario is reminiscent of the behavior of the FBI agents during patsy frameups on terror charges.

Adding to the possibility that Miller was handled by the FBI is the fact he was ejected from the Bundy ranch. Ammon Bundy, the son of Cliven Bundy, said Jerad and Amanda Miller were told to leave the ranch. He said the couple were "very radical" and did not "align themselves" with the protest's main issues. This is classic agent provocateur behavior.

An **agent provocateur** (<u>French</u> for "inciting agent") is an undercover agent who acts to <u>entice another person to commit an illegal</u> or rash act or falsely implicate them in partaking in an illegal act. An agent provocateur may be employed by the <u>police</u> or other entity to discredit or harm another group (e.g., peaceful protest or demonstration) by provoking them to commit an act - thus, undermining the protest or demonstration as whole.

Raw Story, a liberal news blog, has placed Alex Jones at the center of the controversy. "Jerad Miller outlined his political views, which were largely based on conspiracy theories promoted by Fox News and Alex Jones, in his social media postings, and he posted frequently about firearms and violent revolution," writes <a href="Travis Gettys">Travis Gettys</a>.

Jones and the liberty movement will now be implicated in the murder of police officers by way of insinuation. This is a repeated pattern.

It was reported after the pair shot the police officers they draped their bodies with a Gadsden flag. The yellow flag depicting a rattlesnake coiled and ready to strike was adopted as a symbol of the Tea Party movement in 2009.

The mainstream media, which has spent the past day falsely blaming freedom loving Americans, the Tea Party, the Second Amendment and even Alex Jones for the Las Vegas Shooting, was slow to report on the third victim and hero of the tragedy: Joseph Robert Wilcox, the concealed handgun license holder who lost his life while confronting the shooters.

Wilcox, 31, was <u>armed with a concealed weapon and confronted Jerad Miller</u> after the Millers entered the Wal-Mart he was shopping at.

Unfortunately, as Wilcox approached Miller, Amanda Miller came from behind and shot him several times, killing Wilcox almost instantly. Comment: This is also when Amanda killed Jerad and then killed herself. In other words their MK Ultra CIA/FBI suicide programs kicked in when confronted with another gunman which most likely saved untold lives.

Nevertheless, his bravery in the face of danger was under-reported in the mainstream media and only came to prominence through alternative media sites.

News reports added a further lurid detail by saying a neighbor described the pair as users of methamphetamine.

The shooting follows the announcement on June 3 by the Justice Department it will investigate groups and individuals it deems to be terrorists. It will reorganize a task force originally formed in the wake of the 1995 Oklahoma City bombing but disbanded after the 9/11 attacks as law enforcement agencies concentrated on threats from foreign terrorists.

"We must also concern ourselves with the continued danger we face from individuals within our own borders who may be motivated by a variety of other causes from anti-government animus to racial prejudice," Attorney General Eric Holder said.

The incident is custom-made to demonize the patriot movement. The Southern Poverty Law Center has consistently attempted to forge a link between white supremacists and members of the patriot and constitutional movements. The murder of two police officers will undoubtedly further polarize law enforcement and turn many of them against the patriot movement. For a large

number of police officers, the Gadsden flag will now represent the murder of law enforcement officers.

#### Addendum

"As I've noted before when writing about the militia movement, violence on the far right often comes from hotheads who have been kicked out of the more mainstream militias," writes Jesse Walker for Reason.com.

Feinstein and Boxer Introduce Bill to Rat Out a Family Member with a Firearm Exploiting Isla Vista shooting in new bid to confiscate firearms from American citizens

California Democrat Senators Dianne Feinstein and Barbara Boxer are exploiting the Isla Vista shooting in a new bid to confiscate firearms from American citizens.

The Pause for Safety Act will allow "families and others" to seek a "gun violence prevention order" in court. The order will allow police to confiscate firearms from people who have not committed a crime and may not necessarily pose a threat. Senator Feinstein added. "I'm pleased to work with Senator Boxer on this bill, which creates a new grant program to encourage states to allow family members and others to seek court orders to temporarily prohibit dangerous individuals from possessing a firearm. The bill would allow those who know the most about the condition of someone who poses a risk of committing violence to take steps to remove firearms from that individual's possession."

# **Every mass shooting over last 20 years has one thing in common... and it's not guns**

Nearly every mass shooting incident in the last twenty years, and multiple other instances of suicide and isolated shootings all share one thing in common, and its not the weapons used.

The overwhelming evidence points to the signal largest common factor in all of these incidents is the fact that all of the perpetrators were either actively taking powerful psychotropic drugs or had been at some point in the immediate past before they committed their crimes.

The following list of mass shooting perpetrators and the drugs they were taking or had been taking shortly before their horrific actions was compiled and published to Facebook by John Noveske, founder and owner of Noveske Rifleworks just days before he was mysteriously killed in a single car accident. Is there a link between Noveske's death and his "outting" of information numerous disparate parties would prefer to suppress, for a variety of reasons?

I leave that to the individual readers to decide. But there is most certainly a documented history of people who "knew too much" or were considered a "threat" dying under extraordinarily suspicious circumstances.

On to the list of mass shooters and the stark link to psychotropic drugs.

- Eric Harris age 17 (first on Zoloft then Luvox) and Dylan Klebold aged 18 (Columbine school shooting in Littleton, Colorado), killed 12 students and 1 teacher, and wounded 23 others, before killing themselves. Klebold's medical records have never been made available to the public.
- Jeff Weise, age 16, had been prescribed 60 mg/day of Prozac (three times the average starting dose for adults!) when he shot his grandfather, his grandfather's girlfriend and many fellow students at Red Lake, Minnesota. He then shot himself. 10 dead, 12 wounded.
- Cory Baadsgaard, age 16, Wahluke (Washington state) High School, was on Paxil

(which caused him to have hallucinations) when he took a rifle to his high school and held 23 classmates hostage. He has no memory of the event.

- Chris Fetters, age 13, killed his favorite aunt while taking Prozac.
- Christopher Pittman, age 12, murdered both his grandparents while taking Zoloft.
- Mathew Miller, age 13, hung himself in his bedroom closet after taking Zoloft for 6 days.
- Kip Kinkel, age 15, (on Prozac and Ritalin) shot his parents while they slept then went to school and opened fire killing 2 classmates and injuring 22 shortly after beginning Prozac treatment.
- Luke Woodham, age 16 (Prozac) killed his mother and then killed two students, wounding six others.
- A boy in Pocatello, ID (Zoloft) in 1998 had a Zoloft-induced seizure that caused an armed stand off at his school.
- Michael Carneal (Ritalin), age 14, opened fire on students at a high school prayer meeting in West Paducah, Kentucky. Three teenagers were killed, five others were wounded..
- A young man in Huntsville, Alabama (Ritalin) went psychotic chopping up his parents with an ax and also killing one sibling and almost murdering another.
- Andrew Golden, age 11, (Ritalin) and Mitchell Johnson, aged 14, (Ritalin) shot 15 people, killing four students, one teacher, and wounding 10 others.
- TJ Solomon, age 15, (Ritalin) high school student in Conyers, Georgia opened fire on and wounded six of his class mates.
- Rod Mathews, age 14, (Ritalin) beat a classmate to death with a bat.
- James Wilson, age 19, (various psychiatric drugs) from Breenwood, South Carolina, took a .22 caliber revolver into an elementary school killing two young girls, and wounding seven other children and two teachers.
- Elizabeth Bush, age 13, (Paxil) was responsible for a school shooting in Pennsylvania
- Jason Hoffman (Effexor and Celexa) school shooting in El Cajon, California
- Jarred Viktor, age 15, (Paxil), after five days on Paxil he stabbed his grandmother 61 times.
- Chris Shanahan, age 15 (Paxil) in Rigby, ID who out of the blue killed a woman.
- Jeff Franklin (Prozac and Ritalin), Huntsville, AL, killed his parents as they came home from work using a sledge hammer, hatchet, butcher knife and mechanic's file, then attacked his younger brothers and sister.
- Neal Furrow (Prozac) in LA Jewish school shooting reported to have been courtordered to be on Prozac along with several other medications.
- Kevin Rider, age 14, was withdrawing from Prozac when he died from a gunshot wound to his head. Initially it was ruled a suicide, but two years later, the investigation into his death was opened as a possible homicide. The prime suspect, also age 14, had been taking Zoloft and other SSRI antidepressants.
- Alex Kim, age 13, hung himself shortly after his Lexapro prescription had been doubled.
- Diane Routhier was prescribed Welbutrin for gallstone problems. Six days later, after suffering many adverse effects of the drug, she shot herself.
- Billy Willkomm, an accomplished wrestler and a University of Florida student, was prescribed Prozac at the age of 17. His family found him dead of suicide hanging from

a tall ladder at the family's Gulf Shore Boulevard home in July 2002.

- Kara Jaye Anne Fuller-Otter, age 12, was on Paxil when she hung herself from a hook in her closet. Kara's parents said ".... the damn doctor wouldn't take her off it and I asked him to when we went in on the second visit. I told him I thought she was having some sort of reaction to Paxil...")
- Gareth Christian, Vancouver, age 18, was on Paxil when he committed suicide in 2002, (Gareth's father could not accept his son's death and killed himself.)
- Julie Woodward, age 17, was on Zoloft when she hung herself in her family's detached garage.
- Matthew Miller was 13 when he saw a psychiatrist because he was having difficulty at school. The psychiatrist gave him samples of Zoloft. Seven days later his mother found him dead, hanging by a belt from a laundry hook in his closet.
- Kurt Danysh, age 18, and on Prozac, killed his father with a shotgun. He is now behind prison bars, and writes letters, trying to warn the world that SSRI drugs can kill.
- Woody \_\_\_, age 37, committed suicide while in his 5th week of taking Zoloft. Shortly before his death his physician suggested doubling the dose of the drug. He had seen his physician only for insomnia. He had never been depressed, nor did he have any history of any mental illness symptoms.
- A boy from Houston, age 10, shot and killed his father after his Prozac dosage was increased.
- Hammad Memon, age 15, shot and killed a fellow middle school student. He had been diagnosed with ADHD and depression and was taking Zoloft and "other drugs for the conditions."
- Matti Saari, a 22-year-old culinary student, shot and killed 9 students and a teacher, and wounded another student, before killing himself. Saari was taking an SSRI and a benzodiazapine.
- Steven Kazmierczak, age 27, shot and killed five people and wounded 21 others before killing himself in a Northern Illinois University auditorium. According to his girlfriend, he had recently been taking Prozac, Xanax and Ambien. Toxicology results showed that he still had trace amounts of Xanax in his system.
- Finnish gunman Pekka-Eric Auvinen, age 18, had been taking antidepressants before he killed eight people and wounded a dozen more at Jokela High School then he committed suicide.
- Asa Coon from Cleveland, age 14, shot and wounded four before taking his own life. Court records show Coon was on Trazodone.
- Jon Romano, age 16, on medication for depression, fired a shotgun at a teacher in his New York high school.



Weier told police that Slender Man is the "leader" of Creepypasta, and in the hierarchy of that world, one must kill to show dedication. Weier said that Geyser told her they should become "proxies" of Slender Man — a paranormal figure known for his ability to create tendrils from his fingers and back — and kill their friend to prove themselves worthy of him. Weier said she was surprised by Geyser's suggestion, but also excited to prove skeptics wrong and show that Slender Man really did exist.[1] What prompts such devotion? Slenderman is a foreboding, faceless phantom in a dark suit known to haunt children.

According to Jesus Christ, demons and evil spirits are absolutely real and have names (Mark 5:9).

But when he saw Jesus afar off, he ran and worshipped him,

And cried with a loud voice, and said, What have I to do with thee, Jesus, thou Son of the most high God? I adjure thee by God, that thou torment me not.

For he said unto him, Come out of the man, thou unclean spirit.

And he asked him, What *is* thy name? And he answered, saying, My 5:9 name *is* Legion: for we are many.

However, devils seem flexible with their identities. Scripture does not call many by name but they do seem to morph by adopting new names. For example, "They have as



king over them the angel of the bottomless pit. His name in Hebrew is <u>Abaddon</u>, and in Greek he is called Apollyon" (Re 9:11). Abaddon is the place of destruction, the really bad side of the underworld Sheol. Accordingly, in Proverbs 15:11; 27:20 and Job 26:6 we find it in paralleled with Destruction. In in Job 28:22, abaddon is personified along with death. This is the biblical starting point for speculations about abaddon as a separate entity. When we arrive at the book of Revelation abaddon is a full-fledged fallen angel king over the bottomless pit known as Apollyon in the Greek which means the "Destroyer", and is a play on the name Apollo. The point of this exercise is to show that scripture supports the notion that demonic names

morph from other concepts over time.

### << Angra Mainyu

Other cultures have similar destroyer gods Angra Mainyu in Zoroastrianism, Shiva in Hinduism, Erra the Akkadian plague god, Malsumis the malevolent god in Abenaki mythology, and many others. My point in citing these is to suggest that the fallen angelic rulers, authorities and cosmic powers likely assume many names as they function in various historical eras and geographic areas. Rather than creating these

identities, they promote an archetype like "the destroyer" that gets recast in various cultural contexts. In other words, evil entities are more than happy to bring life to idols.

The Apostle Paul connects the dots between manmade idols and demons:



But I say, that the things which the Gentiles sacrifice, to devils, and not to God: and I would not that ye should have fellowship with devils.

ТООLS 10:21

Ye cannot drink the cup of the Lord, and the cup of devils: ye cannot be partakers of the Lord's table, and of the table of devils.

Paul implies that devils empower and use man-made idols of wood and stone.

Comment: When a person worships or sacrifices to these evil beings they are having fellowship with that devil (or devils), & are empowering that devil and are becoming more demon infested the more they worship these idols. This practice is carried on all over the world everyday in various pagan religions. But also in our era, increasingly phantomlike figures like the SlenderMan are also being worshipped and sacrificed to as evidence by the actions of these two 12 year old girls.

If that is the case, might an actual evil spirit have adopted the Slenderman character to satisfy its malevolent agenda against children? I suggest the two twelve year old girls were enticed by more than a website.

That's right; I am suggesting that Slenderman has become *real* or rather that the character has a real malevolent spirit empowering him, one that was able to reach out of the online horror fantasy world to the real world in order to entice two twelve year old girls to murderous mischief.

Comment: This thing has been around for a long time and is not fictional character created in 2009: The Slender Man is an alleged paranormal figure purported to have been in existence for centuries, covering a large geographic area. Believers in the Slender Man tie his appearances in with many other legends around the world, including; Fear Dubh (or, The Dark Man) in Scotland, the Dutch Takkenmann (Branch Man), and the German legend of Der Grosse Mann (the Tall Man). One of the main issues facing Slender Man investigators in the fact that "his" appearance seems to be subjective, with reports varying largely from area to area. This is often put down to cultural bias, with the observer projecting his fears into the sighting and recollections being blurred. However, it is generally agreed that it's appearance is that of a pale, emaciated male figure, with an apparent height of between 7 and 9 feet tall. The figure is often described as wearing a black suit, although it seems to be a relatively recent addition to the mythology.
