Despite Jerry Sandusky's conviction who will pursue the trail of bigger devils? The accusations against hailed coach Jerry Sandusky shocked the world & now a jury has found him guilty of 45 of 48 counts related to sexual abuse with children he had promised to help through his

organization. He is convicted. His sentence is effectively prison for life. But does this close the Penn State investigation? Coach Joe Paterno passed away just months after stepping down as coach in the fallout over 'looking the other way' in the scandal. Whatever he may have known about the powerful donor types that could have been involved, he will bring this case no further information. **It seems the claims that children had been 'pimped out to rich donors' seem all but forgotten. Will those people continue their crimes, unstoppable and unpunished? Sadly, history shows us a pattern of criminal decadence among many of the most powerful leaders of the world, who assume immunity and only rarely face accountability.**

## Homosexual prostitution inquiry ensnares VIPs with Reagan, Bush

### 'Call boys' took midnight tour of White House

A homosexual prostitution ring is under investigation by federal and District authorities and includes among its clients key officials of the Reagan and Bush administrations, military officers, congressional aides and U.S. and foreign businessmen with close social ties to Washington's political elite, documents obtained by The Washington Times reveal.

One of the ring's high profile clients was so well-connected, in fact, that he could arrange a middle-of-the-night tour of the White House for his friends on Sunday, July 3, of last year. Among the six persons on the extraordinary 1 a.m. tour were two male prostitutes.

Federal authorities, including the Secret Service, are investigating criminal aspects of the ring and have told male prostitutes and their homosexual clients that a grand jury will deliberate over the evidence throughout the summer, The Times learned.

Reporters for this newspaper examined hundreds of credit card vouchers, drawn on both corporate and personal cards and made payable to the escort service operated by the homosexual ring. Many of the vouchers were run through a so-called "sub-merchant" account of the Chambers Funeral Home by a son of the owner, without the company's knowledge.

Among the client names contained in the vouchers — and identified by prostitutes and escort operators — are government officials, locally based U.S. military officers, businessmen, lawyers, bankers, congressional aides and other professionals.

Editors of The Times said the newspaper would print only the names of those found to be in sensitive government posts or positions of influence. "There is no intention of publishing names or facts about the operation merely for titillation," said Wesley Proden, managing editor of The Times.

The office of U.S. Attorney Jay B. Stephens, former deputy White House counsel to President Reagan, is coordinating federal aspects of the inquiry but refused to discuss the investigation or grand jury action.


Several former White House colleagues of Mr. Stephens are listed among clients of the homosexual prostitution ring, according to the credit card records, and those persons have confirmed that the charges were theirs.

Mr. Stephens' office, after first saying it would cooperate with The Times' inquiry, withdrew the offer late yesterday and also declined to say whether Mr. Stephens would excuse himself from the case because of possible conflict of interest.

At least one highly placed Bush administration official and a wealthy businessman who procured homosexual prostitutes from the escort services operated by the ring are cooperating with the investigation, several sources said.

Among clients who charged homosexual prostitute services on major credit cards over the past 18 months are Charles K. Dulcher, former associate director of presidential personnel in the Reagan administration, and Paul R. Babach, Labor Secretary Elizabeth Dole's political personnel liaison to the White House.

In the 1970s, Mr. Dulcher was a congressional aide to former Rep. Robert Bauman, Maryland Republican who resigned from the House after he admitted having engaged in sexual liaisons with teen-age male

The purpose of the event is to commemorate June Pride Month, while also marking "a year of significant progress for DHS Pride and for the LGBT community."



According to [the Federal Emergency Management Agency \(FEMA\) web site](#), DHS Pride, the group behind the event, is an employee association that represents gays, lesbians, bisexual and transgendered individuals working within DHS's ranks. The organization

seeks to showcase how these individuals work diligently to secure the U.S. Here are [some of the goals](#) the group works towards, as per its web site:

- Identify and address issues particularly affecting Gay, Lesbian, Bisexual and Transgender employees of the Department.
- Support and guide the Department in the development and implementation of effective policies and **practices for the elimination of discrimination on the basis of sexual orientation and gender identity in all Departmental activities.**
- Serve as a resource and point of contact for its members, for those seeking or considering employment with the Department, and for other interested individuals or groups regarding LGBT issues and activities at DHS.



Aside from Napolitano, who will receive the DHS Pride Award for Service, Amanda Simpson, special assistant to the Army Acquisition Executive, DOD, will deliver the keynote address.

**Simpson is the first openly transgendered woman to be appointed to the U.S. government.** Following the speeches, there will be a reception.

### **Pentagon to salute gay troops - Washington Times**

WASHINGTON — Last summer, gays in the military dared not admit their sexual orientation.

**This summer, the Pentagon will salute them, marking gay pride month just as it marks other celebrations honoring racial or ethnic groups.**

Officials said Thursday that they're planning the first-ever event to recognize gay and lesbian troops. They declined to give details about what the event will be, but officials said **Defense Secretary Leon Panetta feels it's important to recognize the service of gays in the armed forces.** June is gay pride month in the U.S. This is the first time the [Pentagon](#) could participate, since September's repeal of "don't ask, don't tell."

### **Gay Marriage Ceremony on Louisiana Military Base Sparks Uproar**

June 7, 2012 The continued debate over homosexuality in the military is never ceasing, but a recent matrimonial ceremony held at Fork Polk, an army base in Louisiana, is sparking an intensified level of controversy.



Fox News' Todd Starnes [reports more](#) about the lesbian nuptials that are creating an intense stir among politicians and traditional marriage advocates:

**The ceremony was conducted about three weeks ago by a chaplain for the Disciples of Christ,** according to Ron Crews, executive director for the Chaplain Alliance for Religious Liberty. "It was kept quiet," Crews told Fox News Radio. He said **the service was conducted in the military chapel, under the authorization of the chaplain's denomination.**

So if the same-sex ceremony was approved by the military – why the outrage?

"It raises the issue that Louisiana is a state that has a clear definition of marriage," Crews said. "By allowing this on military installations, this means that chaplains in Afghanistan, Pakistan and Iraq could conduct same sex ceremonies like this. How will this look to our coalition partners who do not approve of same sex unions?"

Last September, [The Blaze covered](#) **the Pentagon's decision to allow gay marriages by military chaplains both inside and outside of chapels.**

"The liberal social experiment with our military continues," Rep. John Fleming (R-LA) said in an interview with Fox News Radio. **"A same-sex marriage-like ceremony should not have occurred at Fort Polk, especially since the people of Louisiana have made it abundantly clear that our state does not recognize same-sex marriages or civil unions."**

Others, like Rep. Todd Akin (R-MO), who created legislation that would ban gay marriages on military bases, agree.

**"It's outrageous and illegal," Akin said. "This appears to be a case where political agenda has trumped the rule of law, which is absolutely unacceptable."**

Rep. Tim Huelskamp (R-KS) accused the Dept. of Defense of lying to the American people. "This happened despite last year's assurances from the Department of Defense that state law recognized only traditional marriage would be respected and upheld," Huelskamp said in a statement. **"They clearly lied."**

Fleming said the repeal of "Don't Ask, Don't Tell" has made incidents "like this inevitable."

At the heart of this ruling is the Thought Control Bill Obama signed into law his first year in office; a bill Public Advocate fought tooth-and-nail to stop.

### **Target Selling Pride Shirts to Help Pro-Gay Marriage Group — and Reportedly Blocking Emails From Those Complaining**

**Target Corp. is selling gay pride T-shirts to raise money for a group working to defeat a same-sex marriage ban in Minnesota — and is reportedly blocking emails from one group complaining about it.**

**The Minneapolis-based retailer — which came under fire two years ago for a \$150,000 campaign donation in support of a gay marriage proponent — is currently selling special shirts with all proceeds benefiting the Family Equality Council.**

**In response, the American Family Association mobilized its supporters to urge Target to pull the shirts, but has since said the corporation is blocking emails sent through the organization's internal system.**

"I hope you will not let Target silence your voice. I encourage you to call their corporate office and share your personal thoughts," the group told supporters.

Target has pledged up to \$120,000 to the Washington, D.C.-based Family Equality Council, which is working against a state constitutional ban on same-sex marriage slated for the November ballot. Target started selling the shirts in late May and will continue through the end of June. Available only on the retailer's website, the \$12.99 apiece shirts come in four designs with words including "pride" and "harmony." One, designed by singer Gwen Stefani, features the phrase "love is love."


