'Sit down,' President Barack Obama begged – not 'get out' – after two Hispanic hecklers interrupted his economic speech on Thursday with shouts about illegal immigration.

Then, for the first time in his presidency, the Secret Service stood down and Obama promised to meet with them before he left.

'I'm sorry, what are you yelling about now?' Obama said amid the sudden yelling. 'Sit down, guys. I'm almost done.'

'Come on, sit down. I'll talk to you afterwards, I promise. I'll bring you back. I'm wrapping things up here.'

Obama spoke to a cheering, partisan crowd on Thursday in Austin, Texas, begging immigration protesters at one point to meet with him privately instead of interrupting his remarks

The White House's transcript of his remarks in the liberal enclave of Austin, Texas omits what the protesters said, but Obama replied, 'I understand. See, everybody is going to start – I'm on your side, man. Sit down, guys, we'll talk about it later, I promise.'

Before returning to his teleprompter, the president told his security force to take a step back.

'You don't have to escort them out,' he ordered. 'They'll sit down.'

And then, again directed at his hecklers: 'I promise I'll talk to you afterwards.'

Obama had just wrapped up a section of his speech, partially cribbed from earlier fundraising addresses, in which he ripped into Republicans for slow-walking his demands for immigration reform measures.

"Make no mistake about it, we have to keep fighting as hard as we can on immigration," the first lady/man said. "As my husband has said, he's going to do whatever administrative action he can to fix this broken system."

[GANGS USING PROCESSING CENTER AS RECRUITMENT HUB...](#) According to Border Patrol sources, violent MS-13 gang members are using the Nogales processing center in Arizona as a recruitment hub and as a transfer point for gang members to get into the United States.

The Red Cross has set up phone banks inside the processing center so unaccompanied minors can make phone calls to family members inside the United States and back home in Central America. According to sources, those phones are also being used by MS-13 members to communicate with gang members already in the United States and operating in cities like Atlanta, New York and Chicago. Further, many teenaged males inside the facility have approached Border Patrol agents and have said gang members have tried to recruit them from shared cells. According to the FBI, MS-13 regularly targets middle and high school students for recruitment.

"The National Border Patrol Council believes there to be serious security issues at the Nogales Processing Center. Agents' hands are tied due to the policies governing the care and lodging of juveniles and this has allowed gang recruitment and activity to flourish amongst those being detained," vice president of the National Border Patrol Council Shawn Moran tells *Townhall*. "

[Earlier this week](#) an internal Border Patrol summary confirmed at least 16 MS-13 gang members from El Salvador, Honduras and Guatemala are being housed in the processing center after graffiti was found on bathroom walls. These same gang members admitted to acts of torture and murder in their home countries before heading north to the United States.

[TSA ALLOWING ILLEGALS ON PLANES WITHOUT ID](#)

Illegal aliens are being allowed to fly on commercial airliners without valid identification, according to the National Border Patrol Council (NBPC). "The aliens who are getting released on their own recognizance are being allowed to board and travel commercial airliners by simply showing their Notice to Appear forms," NBPC's Local Spokesman, Hector Garza, told *Breitbart Texas*.

"This is not the CBP [Customs and Border Protection] or another federal agency renting or leasing an aircraft, these are the same planes that the American public uses for domestic travel," said Garza.

"This just adds insult to injury. Not only are we releasing unknown illegal aliens onto American streets, but we are allowing them to travel commercially using paperwork that could easily be reproduced or manipulated on any home computer. The Notice to Appear form has no photo, anyone can make one and manipulate one. They do not have any security features, no watermark, nothing. They are simply printed on standard copy paper based on the information the illegal alien says is the truth."

Spokesman Garza continued, "We do not know who these people are, we often have to solely rely on who they say they are, where they say they came from, and the history they say they have. We know nothing about most of them, ICE releases them into the American public, and now they are boarding aircraft at will with a simple paper document that anyone can easily alter or reproduce themselves."

He discussed the importance of agents being relieved in place when tracking an individual or group.

**Daily Mail:** Both centres, at Brownsville and nearby Fort Brown, were today on lockdown as border officials scrambled to contain a potential outbreak, placing some 120 people who came in contact with the juveniles in isolation.

It comes days after Texas officials renewed demands that the federal government take further steps to secure the border as waves of illegal immigrants are turning military bases into makeshift settlements.



## Congress Knows About Government Sponsored Child Trafficking & Its Relationship to the Present Immigration Crisis

Today was the day that I was going to produce the final chapter on the present immigration crisis. What a difference 24 hours can make. It is with a heavy heart that I am compelled to state that there is so much new information surfacing about the current government planned and sponsored immigration crisis, that the end is no longer in sight.

With regard to the welfare of our children there is no good news to report today, all I can offer is the lesser of two evils. Here are your choices: **(1) Congress is fully aware that the amount of child sex trafficking is prolific and it is taking place inside of the United States. Further, the present immigration crisis is greatly exacerbating the amount of**



**child sex trafficking that is taking place and it is going to increase exponentially; Or, (2) Agencies of the federal government are now planning for a pandemic resulting from the present immigration crisis and anyone caught talking about this could go to prison.**

Yesterday, the Senate heard testimony, from among others, a San Diego high school Assistant Principal and a journalist from Reuters who have firsthand knowledge of child sex trafficking operations within the United States.

Please note the title of the proceedings attempts to minimize the problem with the use of the phrase “Falling Through Cracks...”, in the title of the Senate Subcommittee hearing on Health, Education, Labor and Pensions. By the end of this article, you will see that the referenced descriptive term, “cracks”, could be more adequately described as the Grand Canyon.

### **Subcommittee Hearing – Falling Through the Cracks: The Challenges of Prevention and Identification in Child Trafficking and Private Re-homing**

**Committee:** Subcommittee on Children and Families

**Date:** Tuesday, July 08 2014, 10:00 AM

**Place:**430 Dirksen Senate Office Building

In the televised hearing, **Ms. Jenee’ Littrell, Assistant Principal, in the Grossmont Union High School District, testified that child sex trafficking has reached the point where children are being trafficked from high school campuses in San Diego.** I can understand that if you have been out of school for a while you may be doing a double take. However, this is exactly what she said, but it pales in comparison to what was said by Ms. Megan Twohey, an investigative reporter for Reuters, **who investigated how children “drop out of the foster care system” and end up being child sex trafficked.** Some, who criticized investigative reporters for daring **to state that the 50 CPS networks, directly or inadvertently provide children for sex trafficking,** will soon be apologizing for their scathing attacks on the legitimate work of investigators who have been making these claims for years. **CPS oversees a corrupt and sinister system where children just disappear and all too often, according to Twohey, they disappear into child sex trafficking rings.**

**Briefly, these future child sex trafficking victims disappear into a system where the foster parents sell the child online. Twohey found that most states do not prevent the transfer of custody of a foster child from the foster parent to unknown private parties through the use of internet based custody transfer agreements. The whole process can take place in most jurisdictions without the oversight of the court system and the involvement of a judge.**

If we are unwilling to tear down this corrupt system and replace it with a system of child welfare that has judicial oversight, then we deserve to perish as a nation. Any nation that is unwilling to protect its children deserves to disappear from the face of the earth.

**Before the naysayers reach their computer keyboard and bluntly ask me what does this have to do with illegal immigration and child sex trafficking? Child sex trafficking is being done under the watchful eyes of an impotent Congress, armed with its 7% approval rating.** At least not everyone is Congress is impotent or corrupt. Here is another case in point, please read the following about exploits of Representative Jim Bridenstine (R., Okla.).

For some time now, I have been in possession of information from reliable, but confidential sources who have told me that **many immigrant and American children are being sex trafficked to the Sinola Mexican Drug Cartel. The Mexican drug cartels [5] have been long been linked with the terrorist organizations of Hamas and Hezbollah. The partner in crime of the cartels is none other than the CIA in what is a very similar operation to the infamous Iran-Contra scandal. Only in this case, both drug and child sex trafficking money are being skimmed to support the**

**off-the-books operations of supplying money for gun running to al-Qaeda to promote regime change. This same strategy is presently being applied to ISIS and their activities as well.**

Congressman Jim Bridenstine recently stuck his nose in the middle of this situation as he unsuccessfully attempted to gain access to the illegal immigrant center at Ft. Sill, OK. Human Health Services [6] officials refused to allow a member of Congress to enter a facility in his district where some of the unaccompanied immigrant children [7] are being housed. There are 1,200 immigrant children being kept at Ft. Sill; & Ft. Sill is within Bridenstine's district. The American people are supposed to be able to depend on Congress to protect the American public from the excesses of the executive branch of government and in the fulfillment of this duty, **the Congressman was denied entry by a guard hired by Human, Health Services.** He was told to return after July 21st to "make an appointment [8]".

Bridenstine subsequently stated, **"Do they not want the children to speak with Members of Congress? As a Navy pilot, I have been involved in operations countering illicit human trafficking. I would like to know to whom these children are being released."** The Congressman may not be familiar with the work of Megan Twohey or Dave Hodges, but it is a safe bet that the Congressman probably knows what we both already know.

After the encounter with HHS, Bridenstine stated, **"There is no excuse for denying a federal representative from Oklahoma access to a federal facility in Oklahoma where unaccompanied children are being held... Any Member of Congress should have the legal authority to visit a federal youth detention facility without waiting three weeks.** Bridenstine expressed additional concern [9] **that Human Health Service are releasing illegal immigrant children to a "sponsor" within the United States.**

On July 17, 2012, the Senate released a 1200 page report which implicated HSBC bank, banking regulators and chastised various law enforcement agencies for not doing their job related to money laundering from illicit sources of income, mostly involving the Mexican drug cartels. The report was released under the following title:

**U.S. Vulnerabilities to Money Laundering, Drugs, and Terrorist Financing: HSBC Case History**

This report barely saw the light of day, yet its revelations are stunning. **In the appendix section of this article, the entire report and downloadable witness testimony is provided.**

The report's title speaks for itself. Don't be deceived by the fact that you do not see the term child sex trafficking mentioned in the title. **The monies derived from drug running and sex trafficking are commingled and no Senate report is going to directly accuse the Department of Homeland Security, the FBI, the Manhattan District Attorney's office, the New York Port Authority for either facilitating or turning a blind eye to the practice of child sex trafficking.**

**After reading as many reports as I have, I have concluded that when one finds drug operations to support gun running, one will always find child sex trafficking operating hand in glove as a result.**

I have interviewed former HSBC Vice President, John Cruz, three times. John tried to expose these heinous crimes to all of the above mentioned federal and local law enforcement agencies. **According to Cruz, every agency refused to look at this issue, although some acknowledged that he did uncover criminal activity. If banking regulators refuse to look at this issue brought forth from a Vice President of the bank, then it is likely that the trail runs all the way to the top of the Federal Reserve Board.**

**In conclusion it is apparent that no child is safe, particularly the immigrant children.** If the haters at LaRaza would put away the race card long enough, they would clearly see that the children they claim to support are being victimized in the thousands.

## Is Your Church Part of the New World Order?

With a scant few exceptions the church has been invaded in the same manner that our Constitution has been obliterated.

As the country struggles to come to grips with the illegal alien invasion, which threatens our economy, our collective health and our national sovereignty, we are unable to look to our churches to provide the leadership needed in this time of crisis. I have previously documented how several of the recent unscreened illegal aliens have very serious illnesses, some of which have been caught by the Border Patrol, and nothing is being done except for the federal government's threatening the whistleblowers with prison. I have also documented how some of the illegal immigrants are members of MS-13 who have decided ties to the

Mexican drug cartels and ultimately to the most dangerous terrorist organizations on the face of the earth. **Instead of heeding these well documented warnings, many of our churches are not condemning the evil. Instead, they are embracing the evil.**

Most of the disciples of Jesus Christ were martyred for their uncompromising views towards corrupt civilian authority, except for John, who died of extreme old age and Judas, who committed suicide after betraying Jesus. Many of Jesus' followers met an untimely end. For example, Peter was crucified, head downward, during the persecution of Nero. James, was thrown from a pinnacle of the Temple, and then beaten to death with a club. Thomas, the doubter, was run through the body with a lance at Coromandel, in the east Indies. **Yet, today, most of our 501 C3 tax exempt churches have embraced the suicidal course of Judas as they have made a deal with the devil by espousing government doctrine even when it violates the word of God.**

**In opposition to the early founders of the church and in opposition to the teachings of Jesus Christ, today's church capitulates in the face of evil. It acquiesces to the evil and drags its followers with it by demanding compliance to the illegitimate authority and decidedly non-Christian forces which are subjugating this country.** Today's pastors are doing so under the guise of Romans 13.

### Case In Point

Two San Bernardino-area churches; Fontana's St. Josephs Catholic Church and St. Catherine of Siena Parish in Rialto. **These churches have provided travel cash and bus tickets to recent illegal immigrants as they are permanently embedded into the mainstream of our country. Many of these immigrants come from countries who have virulent outbreaks of very serious diseases and viruses for**

which the average American has no immunity. Yet, the Catholic Diocese of San Bernardino spokesman John Andrews told NBC Los Angeles[2] that we will serve these people for as long as need to (even when it threatens the existing population). Why don't these churches just hand out blankets on the street corners laced with small pox?

**First, I would like to point out to these "benevolent" churches that we have homeless Vietnam veterans on seemingly every street corner begging for their next meal. Where is their compassion for these people? Charity begins at home and these two churches are examples on why I do cannot find a church worthy of trusting.** If you want to feed today's illegal immigrants, that is a noble cause. **However, to pay to embed them illegally into our society with no health screening or naturalization period is the height of social irresponsibility.**

**I recently condemned pastors who support and lead churches who "enjoy" the 501-C-3 tax exempt status offered by the IRS. Does your pastor command you to follow the will of the government because it is your Christian duty to do so under Romans 13? If so, your pastor is likely a traitor to the Word of God.**

The modern interpretation of Romans 13 is pure blasphemy. This scripture has been morphed into a doctrine espousing the "Divine Right of Kings" **in which God has somehow chosen all kings to ruthlessly rule over a people and it is incumbent upon the people to accept their "God-given fate". The flock are commanded to "...submit himself to the governing authorities, for there is no authority except that which God has established."** This false interpretation is nothing but a divine coronation of a ruthless, self-serving government and Christians are expected to **capitulate and honor the same kind of thievery, lawlessness and murder which inspired Jesus to expel the moneychangers from the Temple.**

**Comment: From the description of the teaching I posted above on Romans 13:**

**Do Christians who use Romans 13 to teach that we should not oppose our President or any other political leader, really believe that civil magistrates have unlimited authority to do anything they want without opposition? For example, what if our President decided to resurrect the old monarchical custom of Jus Primae Noctis (Law of First Night)? That was the old medieval custom when the king claimed the right to sleep with a subject's bride on the first night of their marriage. Would our sincere Christian brethren sheepishly say, 'Romans Chapter 13 says we must submit to the government'? I think not. And would any of us respect any man who would submit to such a law? So, there are limits to authority. All human authority is limited in nature. No man has unlimited authority over the lives of other men. (Lordship and Sovereignty is the exclusive domain of Jesus Christ.) Did John the Baptist violate God's principle of submission to authority when he publicly scolded King Herod for his infidelity? Did Simon Peter and the other Apostles violate God's principle of submission to authority when they refused to stop preaching on the streets of Jerusalem? Act 5:29: "Then Peter and the other apostles answered and said, We ought to obey God rather than men." So, even the great prophets, apostles, and writers of the Bible (including the writer of Romans Chapter 13) understood that human authority—even civil authority—is limited.**

If you didn't have to get across right away you might try your luck at catching the train a few times and see if you could get in for free.**

## Low Iron Symptoms in Children

++There are many reasons for children to suffer with iron deficiency. Apart from a poor diet and **the inability to absorb iron from foods, iron deficiency in children may also occur due to long-term slow, blood loss and rapid growth. Children absorb only 10% of iron through their food intake.** Therefore, it is necessary for them to receive 8-10mg of iron a day. Children with iron deficiency may suffer with symptoms such as,

- Extreme fussiness
- Have a short attention span
- Grow slowly than other children
- May develop their motor skills slower than others

## Low Iron Symptoms in Adult

Iron deficiency can occur in children and adults. Adults experience different symptoms than children with lack of iron in the blood. **Women are at a 7 times higher risk of developing iron deficiency anemia than men. Women lose more blood than men because of their monthly period and**

**also during child birth. They may also lose iron during pregnancy and breastfeeding as these nutrients are transferred to the baby.** Young women, aged 14 to 18, require at least 15mg of iron per day. Women over the age of 19 through 50 require 18mg while pregnant women may require approximately 27mg of iron. **Adult men, however, only require approximately 8mg of iron per day.** However, men too suffer with the symptoms of iron deficiency.

**Common symptoms for adult men and women with iron deficiency include**

- **Fatigue**--Oxygen is used in the body for energy. As it is reactive it is used to help break the bonds in glucose and release the energy that we need, and likewise it is used to break down fat. This is why during cardiovascular exercise we pant and draw deeper breaths as we are using that to break down glucose and glycogen stores in order to use them for energy and fuel our activities. When you have low iron this then means that you can't as easily get the oxygen around your body and that in turn will result in your feeling like you have less energy and are less able to get up and go.
- **Dizziness**
- **Pale skin color**
- **Poor appetite**
- **Pica** is a condition in which you get unusual and intense cravings – often for things that are not edible such as dirt, grout, metal etc. This is often your body's way of telling you that you lack something crucial in your diet. If you find yourself craving metal in particular then of course this could be a sign of low iron.
- **Light stool color**
- **Burning sensation in tongue**
- **Altered sense of touch**
- **Angina**
- **Brittle nails**
- **Rapid heartbeat**
- **Feeling cold**

- Irritability
- Headache
- Shortness of breath
- Restless leg syndrome

**++ Warning--** Iron supplements should never be taken in the absence of a deficiency **since iron is a pro-oxidant and too much of it may increase the risk of cancer and heart disease.** The best way to check for low iron stores and iron deficiency anemia is to have your doctor check a complete blood count and an iron panel. The iron panel includes a ferritin level, a measure of how much iron you have stored in your body. <http://healthmad.com/nutrition/signs-that-you-have-a-low-iron-level/#ixzz36ebLdEJi>
