While millions of Americans struggle to keep their homes and jobs, President Barack Obama can't give your tax dollars away fast enough.



Less than 100 feet from where a hijacked airplane slammed into the Pentagon, Muslim military personnel bring prayer rugs on weekday afternoons for group worship. On Fridays, **a local imam conducts a service in the Pentagon Memorial Chapel built after the September 11, 2001 attacks that killed 184 people at the U.S. military headquarters.**

Ailing 9/11 responders slammed President Obama on Tuesday for sounding off on the Ground Zero mosque while keeping silent on a \$7.2 billion health care bill. One of the thousands who worked at The Pile after the World Trade Center attacks, Feal heads the Fealgood Foundation supporting the responders. In response to the accusations that Obama is not a Christian more than 70 pastors and other Christian leaders signed a letter saying the personal faith of public leaders should not be up for public debate.

Some of the names on the list include Bishop T.D. Jakes, Dr. Joel Hunter, and Rev. Samuel Rodriguez.

"President Obama has been unwavering in confessing Christ as Lord and has spoken often about the importance of his Christian faith," the leaders wrote. "Many of the signees on this letter have prayed and worshipped with this president."

"We believe that questioning, and especially misrepresenting, the faith of a confessing believer goes too far," they continued.

The leaders urged the media, public officials, and other faith leaders "to offer no further support or airtime" to those who question Obama's faith.

Texas Man Stages Pig Races to Protest Islamic Neighbor's Plans to Build Mosque

Friday, January 05, 2007--KATY, Texas — When an Islamic group moved in next door and told Craig Baker the pigs on his family's 200-year-old Texas farm had to go, he and his swine decided to fight back.

In protest of being asked to move, Davis began staging elaborate pig races on Friday afternoons — one of the Islamic world's most holy days.

Craig's neighbors, the Katy Islamic Association, have plans to build a mosque and community compound on the 11 acres they purchased alongside his farm.

Baker, 46, a stone-shop owner whose family has owned the farm for two centuries, says the association knew about the pigs when they bought the property, and it's not fair for them to ask him to get rid of the animals.

"I am just defending my rights and my property," Baker said. "They totally disrespected me and my family."

Initially Baker and Kamel Fotouh, the president of the 500-member Islamic Association, were on good terms. But things turned sour at a town meeting, where Baker says Fotouh insulted him by asking him to move.

"That was the last straw for me ... calling me a liar, especially in front of three or four hundred people at that meeting," Baker said. "Mr. Fotouh said it would be a good idea if I considered packing up my stuff and moving out further to the country."

The Return of the Mahdi Is Nigh

Iran may be days away from going nuclear—in the full sense of the word. On Saturday, Iran began commissioning its first nuclear power plant. Barring a full-scale invasion, it may now be impossible to stop Iran from building nuclear weapons (if it hasn't already). With Russian-supplied uranium in its reactors, any aerial bombing risks spreading nuclear fallout far beyond the Persian Gulf region.

Who would take such a risk? **Israel might have previously, but American handcuffing purposefully postponed military options until the risk of fallout made them possibly non-options.**

America does not have the will to stop Iran either. It has proven great at talking, at negotiating, at pleading. And at being told what it can do with all its empty rhetoric.

Iran just doesn't care!

On Friday, the day before it began loading its radioactive uranium rods, Iranian Defense Minister, Brig. Gen. Vahidi announced the launch of a special new upgraded surface-to-surface missile. **Written on the side of the missile was a very specific and literal**

message for President Obama, the world, and anyone who would oppose Iran.

“Ya Mahdi.”

Ya Mahdi—also known as the 12th imam—is the most important Shiite personage after Mohammad. The belief of a returning Mahdi, or 12th imam, is a defining doctrine within the most populous group of Shiite Muslims (known as the “Twelvers”), to which Iranian President Mahmoud Ahmadinejad is a devout adherent.

Why is this important?

Twelvers believe that the 12th imam will *emerge from hiding during a time of world chaos* to bring order and exalt Shiite believers to their rightful place. Ahmadinejad belongs to this sect, which believes it is their job to pave the way for the Mahdi’s return. Ahmadinejad claims that Ya Mahdi has communicated with him personally and that it is within his ability to hasten the Mahdi’s return.

The televised viewing of the missile’s launch, which was accompanied by shouts of “Allah Akbar” (meaning, our God is greatest) and timed to coincide with the arrival of nuclear fuel to the Bushehr reactor, sent an unmistakable message.

And if the world didn’t get it, Iran sent it another memo on Sunday, the day after the nuclear reactor got the fuel.

On Sunday, Ahmadinejad announced the completion of Iran’s very first unmanned aerial vehicle (UAV) capable of delivering weapon payloads. Named the Karrar, Ahmadinejad said the new weapon would be an “ambassador of death” for Iran’s enemies.

In the past, American officials have scoffed at Iran’s UAV technology, noting that past models were small drones, only capable of monitoring. This new model has a range of 1,000 kilometers and can carry two bombs weighing 250 pounds each. Analysts say Iran’s rapid advances are due to Russian technology.

In the same Sunday victory speech, Ahmadinejad also announced that Iran would begin mass production of the Bladerunner 51, a boat often referred to as the world’s fastest. Ahmadinejad christened the more heavily armed Iranian version of the Bladerunner “Zolfaqar.” *Zolfaqar was the name of Shiite Imam Ali’s famous sword. Imam Ali, the first imam, was known as “Allah’s Lion” for his aggressive wars against unbelievers.* Earlier, in June, Iran announced that it would no longer accept UN-approved cargo inspections on Iran-bound ships. From now on, Iran would use its burgeoning navy to retaliate by searching foreign vessels of offending nations.

So with Iran growing stronger and more radicalized, who is going to stop it from speeding the return of Ya Mahdi?

It may not be the United States. Remember the famous 2007 National Intelligence Estimate (NIE) released by the U.S. government claiming that Iran actually gave up its nuclear weapons program way back in 2003. That report also claimed that Iran was a “rational actor” not motivated by religion and that it could be coerced into giving up its civilian nuclear program by conventional means such as economic sanctions and political pressure. Most Americans prefer to live in a *fantasy world*—like the one portrayed in the NIE.

A fantasy world is one in which someone tells you he is going to do everything he can to wipe you off the face of the map and *you don't believe* him. A fantasy world is one in which a country labels you as “the Great Satan” but at the same time wants to form a partnership with you. And a fantasy world is one in which a country with the world's third-largest oil and natural gas resources builds a nuclear power station because it needs more electricity.

Unfortunately, when you are dealing with nuclear weapons, living in a fantasy world can lead to a nightmare.

Iran has sent a clear message to the world: We are going nuclear and there is nothing you can do about it. And even if you try, we will actually welcome that because you are just doing us a favor. *Long live the 12th imam and hasten his return.* . •

EPA Surrenders to NRA on Gun Control Issue

EPA rejects attempt to regulate lead in bullets after NRA protests

By [PAUL BEDARD](#)--August 27, 2010--In a swift and unexpected decision, the [Environmental Protection Agency](#) today rejected a petition from environmental groups to ban the use of lead in bullets and shotgun shells, claiming it doesn't have jurisdiction to weigh on the controversial [Second Amendment](#) issue. The decision came just hours after the Drudge Report posted stories from [Washington Whispers](#) and the *Weekly Standard* about how gun groups were fighting the lead bullet ban.

The EPA had planned to solicit public responses to the petition for two months, but this afternoon issued a statement rejecting a 100-page request from the Center for Biological Diversity, the American Bird Conservancy, and three other groups for a ban on lead bullets, shot, and fishing sinkers. The agency is still considering what to do about sinkers.

The decision was a huge victory for the National Rifle Association which just seven days ago asked that the EPA reject the petition, suggesting that it was a back door attempt to

limit hunting and impose gun control. It also was a politically savvy move to take gun control off the table as the [Democrats](#) ready for a very difficult midterm election.



RFID Trash Cans To Monitor Your Recycling Habits

<http://blog.cleveland.com/> It would be a stretch to say that Big Brother will hang out in Clevelanders' trash cans, but the city plans to sort through curbside trash to make sure residents are recycling -- and fine them \$100 if they don't.

The move is part of a high-tech collection system the city will roll out next year with new trash and recycling carts embedded with radio frequency identification chips and bar codes.

The chips will allow city workers to monitor how often residents roll carts to the curb for collection. If a chip show a recyclable cart hasn't been brought to the curb in weeks, a trash supervisor will sort through the trash for recyclables.

Trash carts containing more than 10 percent recyclable material could lead to a \$100 fine, according to Waste Collection Commissioner Ronnie Owens. Recyclables include glass, metal cans, plastic bottles, paper and cardboard.

City Council on Wednesday approved spending \$2.5 million on high-tech carts for 25,000 households across the city, expanding a pilot program that began in 2007 with 15,000 households.

The expansion will continue at 25,000 households a year until nearly all of the city's 150,000 residences are included. Existing carts might be retrofitted with the microchips.

The chip-embedded carts are just starting to catch on elsewhere. The Washington, D.C. suburb of Alexandria, Va., earlier this year announced it would issue carts to check whether people are recycling.

Some cities in England have used the high-tech trash carts for several years to weigh how much garbage people throw out. People are charged extra for exceeding allotted limits.

Full-Body Scan Technology Deployed In Street-Roving Vans

By ANDY GREENBERG-- Aug. 24 2010--As the privacy controversy around full-body security scans begins to simmer, it's worth noting that courthouses and airport security checkpoints aren't the only places where backscatter x-ray vision is being deployed.

The same technology, capable of seeing through clothes and walls, has also been rolling out on U.S. streets.

American Science & Engineering, a company based in Billerica, Massachusetts, has sold **U.S. and foreign government agencies more than 500 backscatter x-ray scanners mounted in vans that can be driven past neighboring vehicles to see their contents**, Joe Reiss, a vice president of marketing at the company told me in an interview. While the biggest buyer of AS&E's machines over the last seven years has been the Department of Defense operations in Afghanistan and Iraq, Reiss says law enforcement agencies have also deployed the vans to search for vehicle-based bombs in the U.S.

"This product is now the largest selling cargo and vehicle inspection system ever," says Reiss.

Here's a video of the vans in action.

The Z Backscatter Vans, or ZBVs, as the company calls them, bounce a narrow stream of x-rays off and through nearby objects, and read which ones come back. Absorbed rays indicate dense material such as steel. Scattered rays indicate less-dense objects that can include explosives, drugs, or human bodies.

It would also seem to make the vans mobile versions of the same scanning technique that's riled privacy advocates as it's been deployed in airports around the country. The Electronic Privacy Information Center (EPIC) is **currently suing** the DHS to stop airport deployments of the backscatter scanners, which can reveal detailed images of human bodies.

"It's no surprise that governments and vendors are very enthusiastic about [the vans]," says Marc Rotenberg, executive director of EPIC. **"But from a privacy perspective, it's one of the most intrusive technologies conceivable."**

Congressman Takes On Invasive Vans That Peer Into Homes

(KSL) – Utah Congressman Jason Chaffetz is speaking out against vans that carry scanning technology inside them that allows people to see through the walls of cars, trucks, and even into homes.

"These vans essentially can look through the walls of your home, look through the walls of a vehicle or a container and they can tell what's inside. They can see through

people's clothes and give you some great detail about people's bodies, much like they do at the airport. That's pretty scary," Chaffetz tells KSL Newsradio.

Chaffetz says there are a few legitimate uses for the vans during a hostage situation or on the border to inspect trucks coming into the country, but he says other uses of the technology are an invasion of privacy that must be limited.

"To think that a van can drive down the street and literally look through the walls of a home and see who is inside and what they are doing. It was cute and funny when we thought about it in the context of Superman but when you realize they have already sold 500 of these vans, I've got real concerns about how and where we are using these," says Chaffetz.

The congressman says he's already working on legislation aimed at limiting what circumstances these Z Backscatter Vans, or ZBV's as they are called, could be used for.

So we cannot preach in churches across the nation – even though that is exactly what they have let me in to do before. This is the first time I have ever been denied entry to do that very thing. **And now we are all – very evidently – “criminals”. Never to darken the door again.**

My family and I naturally came home from this pretty distraught and devastated. My daughter was crying in the car. Six hours is a long time to be detained like that.



"With little fanfare, the Pentagon is putting the finishing touches on a new strategy that will treat cyberspace as a domain of potential warfare -- and apply instant "active defense" to counter attacks that, in theory, could shut down the nation's transportation and commerce. America's closest allies would be drawn into an early-warning network of collective cybersecurity; private industry would be mobilized in a kind of civil defense against attackers; and military commanders would be given authority to respond automatically to electronic invaders."

The public rhetoric states that the purpose of all this is to make "America's infrastructure robust and redundant enough to survive any attack".

But, the powers granted the government on the basis of any type of cyber attack far outweigh the threat. Whenever you see this kind of action occur, you know you are looking at the excuse by which the government intends to impose its coming dictatorship.

"William J. WKRG News 5 in Alabama reports that [the Attorney General of Alabama has filed charges against BP and Transocean for covering up the BP Gulf Oil Spill and using a dangerous and highly toxic choice of chemical dispersants](#) among other things. Alabama's attorney general is suing BP and others over the Gulf oil spill saying the oil giant has broken too many promises.

Attorney General Troy King filed two [lawsuits](#) in federal court in Montgomery late Thursday afternoon. One suit is against BP, the other against Transocean.

In a statement released Friday, King said "their history of saying one thing and doing another, and now, new information that they have been secretly working to gain a legal advantage, can only further damage our people."

The lawsuit claims "defendants were slow and incompetent, if not dishonest, in their announcements and warnings to the state of Alabama and its citizens and businesses," referring to the drastic difference in the initial oil flow estimate of 1,000 barrels per day and the latest estimate of as much as 60,000 barrels per day.

The lawsuit, which seeks unspecified money damages plus punitive damages, also references BP's choice of a "highly toxic chemical used to disperse oil in the ocean."

Perhaps the United States is not as close as we think in surrendering its sovereignty to the United Nations, as Senators take a stand against the world body's encroachment upon our children's rights!

"Thirty-one Republican senators have agreed to oppose the United Nations' "Convention on the Rights of the Child" treaty, and critics of the international plan to vest children with a long list of rights – such as a right to seek government review of parental decisions – [are looking for three more names](#). "

"The campaign by supporters of ParentalRights.org opposes an effort to put the U.N. advocacy plan into operation in the United States ... The resolution states the U.N. Convention on the Rights of the Child should not even be presented to the Senate for a

vote, which would require two-thirds approval for ratification, because it 'is contrary to the principles of self-government and federalism, and ... because the United Nations Convention on the Rights of the Child undermines traditional principles of law in the United States regarding parents and children'."

The Russian Communist system realized that parental attitudes and values were so powerful as to throw a huge obstacle to the government system of molding the minds of the children into the atheistic Communist model. Russian Premier, Nikita Khrushchev, was asked one day why the Russian government was having trouble indoctrinating the Communist philosophy into young children. Parents of 50 Million U.S. Children May Soon Lose Parental Rights



"THE 'ERA of clerical immunity' has to end in Ireland ... US lawyer and former Benedictine monk Patrick Wall acknowledged the special position of the Catholic Church had been removed from the Irish Constitution in 1973, but 'it has not been removed from the soul of Ireland'."
