## **Evangelicals Left Off National (Pagan) Cathedral 9/11 Program**

A weekend of religious-themed observances at Washington National Cathedral marking the tenth anniversary of the September 11 terrorist attacks **will include a Buddhist nun** and an **Islamic Imam**, **but not an evangelical Christian**, leading the head of the [Southern Baptist Convention](#) to ask President Obama to reconsider attending the event.

**2Cr 6:14** Be ye not unequally yoked together with unbelievers: for what fellowship hath righteousness with unrighteousness? and what communion hath light with darkness?  
**2Cr 6:15** And what concord hath Christ with Belial? or what part hath he that believeth with an infidel?

"A Call to Compassion" will include an interfaith prayer vigil on Sept. 11. It will feature the dean of the Cathedral, the Bishop of Washington, **a rabbi**, **Buddhist nun** and **incarnate lama**, a **Hindu priest**, the **president of the Islamic Society** of North America and **a Muslim musician**.

However, Southern Baptists, representing the nation's largest Protestant denomination, were not invited to participate – **and neither were leaders from any evangelical Christian organization.**

"It's not surprising," said Frank Page, president of the [Southern Baptist](#) Convention Executive Committee. "There is a tragic intolerance toward Protestants and particularly toward evangelicals and I wish the president would refuse to speak unless it was more representative."

Richard Weinberg, the Cathedral's director of communications, confirmed that Southern Baptists were not extended an invitation to participate.

"The goal was to have interfaith representation," he told Fox News Radio. **"The Cathedral itself is an Episcopal church and it stands to reason that our own clergy serve as Christian representatives."**

He said the Washington National Cathedral serves as the **"spiritual home for the nation"** and as such, he said that **"diversity was first and foremost"** a factor in the planning.

“We certainly aim to appeal to as many in the country as possible and feel that our events are not any one slice that could ever represent the entire country -- but that we are doing our best commemorate the events as it fits with our mission,” Weinberg said.

Luk 16:15 And he said unto them, **Ye are they which justify yourselves before men; but God knoweth your hearts: for that which is highly esteemed among men is abomination in the sight of God.**

On Sunday night the Cathedral will host President Obama as he delivers remarks in a program called, “A Concert of Hope.” **At least five faith leaders will deliver prayers but those individuals have not been identified.**

Weinberg said the president’s event will be a “secular service,” but said given the setting it will include an interfaith benediction.

The White House referred questions about the services to the Cathedral.

“First and foremost, the breadth of the programming aims to honor those who were most affected by the tragedy of 9/11,” Weinberg said. “We also recognize as a Cathedral that this country has been engaged in two wars abroad (Comment: Creating these wars were one of the main purposes of the government ordered 911attacks with a side benefit to the elite of incrementally stripping all Americans of their personal freedoms. ### **[Crane topples at National Cathedral, comes down 'like thunder'](#)**

A crane toppled at the National Cathedral this morning, sending its operator to the hospital, damaging two out-buildings and crushing four vehicles that belonged to contractors.

The crane was lifting supplies to the top of the cathedral at 3101 Wisconsin Ave. as part of the [ongoing earthquake repair](#) when it collapsed without warning at 10:55 a.m.

**“We don’t know why it collapsed,”** DC Fire/EMS Battalion Chief John Donnelly said. Wind gusts of 40 to 50 mph were reported in the area at the time of accident.

The building that sustained the most damage was Herb Cottage, which is next to Church House on the east side. Its roof was clipped by the falling crane, Donnelly said. **The building was already closed to the public and one of a handful of buildings on the grounds surrounded by a protective fence after the earthquake.**

Herb Cottage is one of the oldest buildings on the cathedral grounds and was originally built as a baptistry. **Most recently it was a gift shop that sold gift cards, spices and home decor, with the proceeds supporting the cathedral.**

The cathedral, put out of commission by the Aug. 23 earthquake, is supposed to reopen Friday to be the venue for [a number of weekend events](#) around the 10th anniversary of the 9/11 terror attacks, with President Obama scheduled to speak there Sunday night.

### [Petition seeks 9/11 ceremony invites for NYC first responders](#)

The first responders to the World Trade Center on September 11, 2001, weren’t stopped by falling buildings and deadly debris. Ten years later, they’re not letting the New York City mayor’s office stop them from trying to attend the tenth anniversary ceremony at Ground Zero.

An explosive [petition at Change.org](#) is calling on Mayor Michael Bloomberg to invite the first responders to the ceremony. **If he doesn’t, this will be the first year New York City police officers, firemen, and EMS workers are not be allowed to attend.**

As of Wednesday morning, the petition had about 1,900 signatures.

When Bloomberg's office announced the ceremony would be limited to the victims' families, they cited limited space.

But Jack Dewan, a fourth generation firefighter whose uncle, Gerard "Gerry" Dewan, lost his life on 9/11 as part of FDNY Ladder Company #3, doesn't quite buy it.

"I just can't wrap my head around the idea of why you would keep cops, firefighters, and EMS away," Dewan told The Daily Caller. "That doesn't make any sense to me."

Dewan, who helped launch the petition, told TheDC that to him, it would be like World War II veterans being told they can't go back to the site of Pearl Harbor.

## India scans 2.4 billion eyes to see end to poverty

*Mind-boggling database being created to give all an identity and chance for better life*

By LYDIA POLGREEN **The New York Times** 9/2/2011 [KALDARI, India](#) — Ankaji Bhai Gangar, a 49-year-old subsistence farmer, stood in line in this remote village until, for the first time in his life, he squinted into the soft glow of a computer screen.

The fingerprints of a migrant farm worker are scanned in New Delhi for a national identity system linking her to benefits.

His name, year of birth and address were recorded. A worker guided Mr. Gangar's rough fingers to the glowing green surface of a scanner to record his fingerprints. He peered into an iris scanner shaped like binoculars that captured the unique patterns of his eyes.

With that, Mr. Gangar would be **assigned a 12-digit number, the first official proof that he exists.**

**He can use the number, along with a thumbprint, to identify himself anywhere in the country.** It will allow him to gain access to welfare benefits, open a bank account or get a cellphone far from his home village, something that is still impossible for many people in India.

Across this sprawling, chaotic nation, workers **are creating what will be the world's largest biometric database, a mind-bogglingly complex collection of 1.2 billion identities.** But even more radical than its size is the scale of its ambition: to reduce the inequality corroding India's economic rise **by digitally linking every one of India's people to the country's growth juggernaut.**



### Electronic 'tattoo' could monitor vital organ functions

Forget those old, bulky electrodes of the past. **Researchers have created a device that can track your heart, brain and muscle activity as effectively as conventional monitoring systems — and is thin enough to be laminated onto the skin like a temporary tattoo.** Down the line, such electronic patches could be used to monitor vital functions, aid in physical rehabilitation or perhaps be deployed in covert military operations.

### Hospital patients now being microchipped with "electronic tattoos"

by Christina Luisa (NaturalNews) **Being microchipped is now being spun as a method of protecting the health of hospital patients. To help mask the practice of this bodily invasion with a trendy, high-tech appearance, microchipping sensors are being referred to as "electronic tattoos" that can attach to human skin and stretch and move without breaking.**

Supposedly the comparisons of this hair-thin electronic patch-like chip to an electronic tattoo are being made because of how it adheres to the skin like a temporary tattoo using only water.

The small chip is less than 50 micrometers thick, which is thinner in diameter than a human hair. It is being marketed as a "safe" and easy way to temporarily monitor the heart and brain in patients while replacing bulky medical equipment currently being used in hospitals.

This device uses micro-electronics technology called an epidermal electronic system (EES) and

is said to be a development that will "transform" medical sensing technology, computer gaming and even spy operations, according to a study published last week.

Pet microchips have become increasingly common over the past few years. These chips are marked with a small barcode that can be scanned just like the tags on grocery items.

This seems to suggest that microchips are meant to turn the wearer into an object that can be tracked and catalogued. Once inserted in an animal, the chip stays there for the entirety of its lifetime and can be used to identify the pet if it should be found on the street or turned into a shelter. The subdermal chips are often recommended by vets and animal care experts as a way to ensure lost pets find their way home again.

**But research suggests that despite their proclaimed usefulness, pet microchips may cause cancer. Multiple studies have clearly linked pet microchips with increased incidence of cancer and tumors in mice and rats.**

In the past, public disclosure of these suggested links between microchipping and cancer in animals stirred widespread concern over the safety of implantable microchips in living beings. The animal microchip study findings that created such an uproar were so persuasive that Dr. Robert Benezra, head of the Cancer Biology Genetics Program at the Memorial Sloan-Kettering Cancer Center in New York, was quoted in an article about microchipping as saying, **"There's no way in the world, having read this information, that I would have one of those chips implanted in my skin, or in one of my family members."**

At least a dozen animal studies have been done between 1990 and 2007 and most concluded that microchips significantly increased the risk of cancer at the microchip site.

All the electronic parts of the new EES chip are built out of wavy, snake-like components which allow them to be stretched and squeezed. **They also contain tiny solar cells which can generate power or get energy from electromagnetic radiation.** The sensor is mounted on to a water-soluble sheet of plastic and attached to the body by brushing the surface with water - hence the comparison to a temporary tattoo.

This new device being implanted in hospital patients certainly looks and acts like a microchip - yet it is persistently being referred to as an "electronic tattoo" in order to make the concept appear harmless, friendly - even trendy!

## The future of America: Microchipped Zombies

Researchers believe the technology could be used to replace traditional wires and cables, but this sounds remarkably like an excuse used to cover up the real truth: that this new microchipping method is a way to ensure all of us are eventually microchipped and able to be tracked and monitored. Soon, everyone may be required to wear chips or "tattoos" that prove they got their vaccinations, to link to health records, credit history and social security records.

## **Homeland Security surveillance detected on Christian website--Blogger noted for opposing homosexual lifestyle choice**

The U.S. Department of Homeland Security has begun watching a blog posted **by a Christian who was forced to flee Brazil because of the conflict between that nation's pro-homosexual "hate crimes" agenda and his advocacy for traditional marriage.**

Exactly why the U.S. government, which several times has linked Christians and conservatives with terrorism, is watching Julio Severo's unabashedly Christian [Last Days Watchman](#) blog isn't clear.

A WND request to the DHS for comment did not generate a response.

The website's records reveal the DHS visited the site yesterday. A different computer, also at the DHS, was on the site again today.

[WND reported in 2009, shortly after Obama took office,](#) that a [Department of Homeland Security report](#) warned of the possibility of violence by unnamed "right-wing extremists" – **people**

**concerned about illegal immigration, increasing federal power, restrictions on firearms, abortion and the loss of U.S. sovereignty.** The report pointed to returning war veterans as particular threats. The report from the DHS Office of Intelligence and Analysis defined right-wing extremism in the U.S. as "divided into those groups, movements and adherents that are primarily hate-oriented (based on hatred of particular religious, racial or ethnic groups) and

those that are mainly anti-government, rejecting federal authority in favor of state or local authority, or rejecting government authority entirely. It may include groups and individuals that are dedicated to a single issue, **such as opposition to abortion** or immigration."

It was followed by a report from the Missouri Information Analysis **Center that linked conservative groups to domestic terrorism.**

The Missouri report warned law enforcement agencies to watch for **suspicious individuals who may have bumper stickers for third-party political candidates such as Ron Paul, Bob Barr and Chuck Baldwin. It further warned law enforcement to watch out for individuals with "radical" ideologies based on Christian views, such as opposing illegal immigration, abortion and federal taxes.**

### **Verdict! "Christians" Convict Pastor For 'Giving Out Bibles'**

The pastor of a Wichita, Kan., church who has been vocal in speaking out on homosexuality on public streets, the influence of abortion interests in his state and other biblical issues says he has been **convicted on charges relating to his decision to hand out Bibles at a Muslim mosque – in a courtroom staffed and filled with Christians.** The counts against Pastor Mark Holick of Spirit One Christian Center, known as the church "without walls," technically were two counts of loitering and one count of disrupting a business. He was convicted by a 6-member jury in Wichita District Court and today was sentenced to a \$300 fine, a year of probation and ordered not to be within **1,000 feet of the Islamic center where last fall he was caught handing out pamphlets containing portions of the Bible.** What is startling, he told the judge and courtroom during a 15-minute statement in court, is that the conviction came about through Christians. He told the court and judge: Wichita, you are confused, I am not your enemy, Islam is. 'Thou shalt have no other gods before me.'

Islamists believe that it is okay to lie if it is to help in the cause of Allah.

My own government called a foreign Islamist to testify for them against me, a born American, Christian peacefully handing out free Bibles.

How sad, how incredibly sad.

**The arresting officer said he is Christian.**

**The court/judge says it/he is Christian.**

**The prosecutor says he is Christian.**

**The city attorney says he is Christian.**

**Four of the six jurors say they are Christian.**

**And I have been convicted for handing out free Bibles.**

[WND previously reported on the dispute that brought Holick into court again.](#) At the time of his arrest, he warned that Islamic law, Shariah, is creeping into America through preferential treatment provided by law enforcement and the courts.

Today, he told WND that he was handing out a book containing English and Arabic versions of the biblical books of John and Romans, as well as a DVD containing testimony from former Muslims.

**He said he was able to make the accusation against the court and jurors because of information he's gotten from those who know the arresting officer and the judge and the prosecutor's statement about attending church. Holick said he has dealt with the city attorney in previous cases, and during jury selection four of the six jurors affirmed that they attend a regular Christian service.**

Holick had been handing out the Bible portions on a sidewalk adjacent to the Wichita mosque. He also went into the driveway where it crossed the sidewalk to do the same. It apparently was that action that the police cited for their counts of loitering and obstructing a business. Holick noted, **however, there was no testimony that he had obstructed anyone.**

[According to the report in the Wichita Eagle,](#) Sedgwick County District Judge [Phil Journey](#) handed down the sentence to Holick.

"The only reason you were the one arrested is because you were the only one who disobeyed the police orders," the newspaper reported the judge said.

The report also said Journey discussed how the First Amendment assured Holick's right to express his religious beliefs but also allowed laws that would regulate how he practices his faith. A WND message requesting comment from the court left after hours was not returned.

**Holick told WND he was a little surprised that the judge let him make a 15-minute statement (Comment: God arrested the judge) but noted that the judge later stated his disagreement with the pastor's testimony.**

Holick said, "This is about an idolatrous government that has rejected the Lord God Jesus. This is about a government that has turned from the Lord God to the many gods of pluralism.

"Listen to the 911 call by the mosque. Not one reference to any traffic problems, no[t] one indication of cars being blocked. No, it is clear that the reason they called was because – we were there peacefully offering free Bibles," he said. "To which the police, city attorney, and courts were all too willing to act with expediency and malice to silence the Gospel of our Lord Jesus."

He continued, "Rest assured, your actions will have a great chilling effect on the Gospel of our Lord, but I suspect you know that and are glad. Rest assured that this conviction is already running through the Wichita Islamic social network like an August Texas grass fire. Because I use the public sidewalk to offer Bibles to those driving out, I stand here before this magistrate today."

**[Bill Approved To Create Massive Surveillance Database Of Internet Users](#)**

Legislation **that will force Internet providers to store information on all their customers and share it with the federal government and law enforcement agencies was significantly beefed at the last minute yesterday and approved by a U.S. House of Representatives committee.**

**Under the guise of protecting children from internet pornographers, the House Judiciary committee voted 19-10 to approve a bill that will require Internet Service Providers to store temporarily assigned IP addresses for future government use.**

**In addition, the bill was re-written yesterday to also include the enforced retention of customers' names, addresses, phone numbers, credit card numbers and bank account numbers.**

As [Declan McCullagh of CNet reports](#), the panel rejected an amendment that would have clarified that only IP addresses must be stored.

"The bill is mislabeled," said Rep. John Conyers of Michigan, the senior Democrat on the panel. "This is not protecting children from Internet pornography. It's creating a database for everybody in this country for a lot of other purposes."

It represents "a data bank of every digital act by every American" that would "let us find out where every single American visited Web sites," said Rep. Zoe Lofgren, who led Democratic opposition to the bill. The Californian Representative described the legislation as a "mess of a bill" and a "stalking horse for a massive expansion of federal power".

Rep. Darrell Issa, R-Calif., noted that the bill would open a Pandora's box of government abuse. "This is not about child porn. It never has been and never will be," Issa said. "This is a convenient way for law enforcement to get what they couldn't get in the PATRIOT Act."

Advocates for the legislation include the National Sheriffs' Association, which has said it "strongly supports" mandatory data retention. The bill has also attracted endorsements from the National Center for Missing and Exploited Children, as well as the FBI.

In a last ditch effort to derail the bill, the ACLU, along with dozens of other privacy watchdog groups penned a letter ([PDF](#)) to House Judiciary Committee Chairman Lamar Smith earlier this week, noting that "any data retention mandate is a direct assault on bedrock privacy principles."

"The data retention mandate in this bill would treat every Internet user like a criminal and threaten the online privacy and free speech rights of every American, as lawmakers on both sides of the aisle have recognized," Senior Staff Attorney Kevin Bankston of the [Electronic Frontier Foundation](#) said.

"This is China-style law enforcement, treating everyone as a potential suspect and requiring the collection of personal information just in case it might later be useful to the government," said Greg Nojeim, senior counsel for the Washington based Center for Democracy and Technology,

in an [interview with Bloomberg](#). The legislation, with all its privacy stripping measures intact, will now be scheduled for a full House debate.

## Study finds abortion raises risk of mental health problems by 81%

Researchers behind a new study on abortion have discovered **that women who have abortions experience an astonishing 81% increase in the risk of mental health problems.**

## **Pedophile Predators with Ph.D.s**

The latest offensive against morality, decency, and sanity in America has been launched by a pro-pedophilia group and several academics who openly advocate for the normalization and legalization of pedophilia. Referring to Christian moral principles and values as "cultural baggage of wrongfulness" and an adult's desire to sexually molest a child as "normative," these predators with Ph.D.s are hell-bent on destroying key moral boundaries and critical societal norms that protect innocent children from pathological and dangerous adults.

On August 17 of this year, the pro-pedophilia group [B4U-ACT](#) sponsored an event in Baltimore attended by researchers, professors, mental health professionals, and "minor-attracted persons" (MAP, a euphemism for "adults who crave sex with children"). These individuals endorse the adult molestation of children, consider this sexual perversion as normal, and advocate for the declassification of pedophilia as a mental illness by the American Psychiatric Association (APA).

The academic panelists who presented at this "pedophilia-friendly" scientific symposium came from such distinguished institutions as Johns Hopkins University, Albert Einstein College of Medicine, Harvard Medical School, and the London School of Economics and Political Science. According to a press release issued by Matt Barber, vice president of Liberty Counsel Action, and Dr. Judith Reisman, visiting law professor at Liberty University School of Law, who attended the event, several admitted pedophiles were in attendance, in addition to many academics and university professors. The keynote address was given by Dr. Fred Berlin of Johns Hopkins University, who proclaimed that he wants to "completely support the goal of B4U-ACT."

Key highlights from the conference include these disturbing assertions (more disturbing excerpts available at the end of this article):

- Pedophiles are "unfairly stigmatized and demonized" by society.
- "The majority of pedophiles are gentle and rational."
- There was concern about the "cultural baggage of wrongfulness."
- "We are not required to interfere with or inhibit our child's sexuality."
- "Children are inherently able to consent" to sex with an adult.
- An adult's desire to have sex with children is "normative."
- Our society should "maximize individual liberty. ... We have a highly moralistic society that is not consistent with liberty."
- "Anglo-American standard on age of consent is new [and 'Puritanical']. In Europe it was always set at 10 or 12. Ages of consent beyond that are relatively new and very strange, especially for boys. They've always been able to have sex at any age."
- A consensus belief by both speakers and pedophiles in attendance was that, because it vilifies MAPs, pedophilia should be removed as a mental disorder from the American Psychiatric Association's (APA) Diagnostic and Statistical Manual of Mental Disorders (DSM), in the same manner homosexuality was removed in 1973.

There is no greater moral imperative than the protection of the innocent, and especially defenseless children. These timeless and universal truths are embedded in the Christian principles and moral precepts upon which American society and legal system are based. Any adult -- especially a university professor or medical doctor -- who cannot grasp such elementary morality has no business teaching, counseling, or treating anyone, especially dangerous predators with an appetite for children.

**What these academics are doing -- i.e., providing comfort and support for child-rapists and molesters -- is unconscionable and unethical. Instead of condemning these abusers' sick desires, these professionals sympathize with these monsters and minimize the evil they perpetrate. Rather than working to expose the abomination in these pedophiles' minds and souls, these academics stoke these warped passions with the fuel of justification, rationalization, and normalization.**

And their treachery doesn't stop there. Academics like Fred Berlin, M.D., Ph.D.; Nancy Nyquist Potter, Ph.D.; and others **are also attempting to destroy societal protections of children by pushing to declassify this dangerous perversion as a mental illness and decriminalize the behavior. In essence, they advocate the elimination of statutory rape and sexual offender registration laws designed to protect minors from being sexually exploited by adults, thus removing the ability of the state to punish and incarcerate these monsters. How many other potential predators -- who previously suppressed their lusts for fear of incarceration, societal rebuke, and sexual predator registration laws -- will now be encouraged to succumb to their perverse impulses, cheered on and defended by credentialed academics and fully protected by a neutered legal system?**

What do the leadership of John Hopkins University, Harvard Medical School, and the University of Louisville have to say about their professors attending a pro-pedophile conference and advocating for the "normalization" of adults having sex with children? What about the donors, supporters, and alumni who support these institutions? Are they aware that their donations pay for these professors' salaries and help promote these kinds of "academic" activities? Is this an indication of the level of "scholarship" and "intellectual discourse" we expect to see in the future from these acclaimed institutions? **What's next? A conference on how to de-stigmatize and normalize producers, distributors, and users of child porn?**

### **U.K. Judge Tells Teacher Sex-Offender Busted with Child Pornography: 'I Don't Criticize You for Being...Attracted to Children'**

Well this is abhorrent to say the least. A school teacher who escaped jail with a suspended sentence after owning up to **possessing literally 4,500 pornographic images, some of children as young as two years old**, was told by his presiding judge **that she did not criticize him “for being a teacher who’s attracted to children.”**

63-year old substitute teacher David Armstrong was reportedly caught after a colleague noticed files on Armstrong’s laptop with names such as **“rape wife,” “nude model” and “gay alligator.”** Disturbed by the obviously deviant behavior that was at play, the teaching assistant immediately reported Armstrong to the police.

But it gets worse. After finding a shocking 4,500 indecent images and videos on two laptops and an external hard drive, police arrested Armstrong. What is perhaps most repugnant, is that more than **300 of the images were reportedly of the “worst kind,” some involving children as young as two.**

But despite the overwhelming evidence, **Armstrong was somehow allowed to walk free**, after Judge Mary Jane Mowat reportedly told him, **“I don’t criticise you for being a teacher who’s attracted to children.”**

**“Many teachers are but they keep their urges under control both when it comes to children and when it comes to images of children,”** the judge reportedly told Armstrong.

**As if she were condoning Armstrong’s urges while commending other deviants who just haven’t managed to get caught yet.**

Needless to say child abuse advocates are reportedly enraged by the judge’s wildly inappropriate comments — comments that have been cited as an “insult” to child victims. Teachers were also reportedly up-in-arms over the judge’s outrageous comments, saying the incident cast a shadow over the teaching profession while **sending the wrong message to pedophiles.** [The Telegraph](#) reports:

Peter Bradley, deputy director of the children’s charity Kidscape, said: **“Children who have been sexually abused would be horrified to read this judges remarks.**

But even though Judge Mowat admitted that Armstrong’s “was by any standards a substantial collection, with some 300 of the worst kind,” **she only handed the sexual deviant a 12-month prison sentence, suspended for two years.**

It might not come as shock then, that this is not the first time Judge Mowat has caused controversy over sentencing sex-offenders:

In 2008, she allowed former headmaster Phillip Carmichael to walk free from court **after accepting that medication for Parkinson’s disease had turned him into a paedophile.**

**Sentencing a bus driver to ten-months in jail in 2006 for abusing a 12-year-old girl, the judge acknowledged that she felt "obliged" to lock him up because of "current views about sentences".**

"I have a record of trying to suspend sentences in cases like this and them ending up in the Court of Appeal," she told Robert Prout, following a public outcry over the brevity of prison sentences for sex offenders.

**It is the judge who should be the one on trial over perpetuating such gross injustices. Why no one has investigated her or taken action to suspend her from the bench is still unclear.**



# Guided by Resurrection, and a dose of insurrection

**RED ROCKS EASTER:** The Rev. Nadia Bolz-Weber turns heads and minds by blending tradition and irreverence.

Lutheran pastor Nadia Bolz-Weber is a dichotomy wrapped in a paradox covered in tattoos.

Creation, Advent, Christmas, Lent, Good Friday, Easter and Pentecost — practically the entire liturgical year — unfurl in technicolor ink from her shoulder to her wrist.

That's just her left arm. Mary Magdalene and Lazarus rising from the dead are on the long right arm of this 6-foot-4 Christian billboard.

The 42-year-old came to Jesus later in life but then pursued a vocation in Christ full throttle. In a state where Focus on the Family and other strands of evangelical Christianity have long grabbed most headlines, a progressive Lutheran is now stealing the marquee.

On the strength of her preaching, Bolz-Weber received the invitation to sermonize Sunday at Easter sunrise services for roughly 10,000 people at Red Rocks Amphitheatre.

In the few years since ordination in late 2008, she has become famous within her denomination, the Evangelical Lutheran
