Operation Mountain Guardian is a terrorism-based, full-scale emergency exercise scheduled to take place in numerous locations in the Denver metro area on Friday, September 23, 2011.

A Infowars.com reporter reported today outside Denver’s Mile High Stadium that the facility would be used for “processing activities,” according to a handout.

The handout is a [news advisory](#) distributed to press by authorities in Colorado. It states that a “terrorist-driven catastrophic situation” **will include the “processing” of students: Catholic Charities and Sports Authority Field at Mile High will participate in an administrative fashion to test student/teacher processing activities.**

“In terms of the drill or even real events, **the goal is to get everybody here to reunify with their parents,**” Scott Snow, director of the Victims Assistance Unit of the Denver Police, told Infowars.com.

Darrin McBreen talked with a Denver firefighter on a security detail who admitted that she was playing the role of a mother who was at the stadium to pick up fictitious children. She had a print-out of fifth or sixth grade kids, according to McBreen. The woman said she was instructed not to talk with the media and her comments were off the record.

An employee confirmed that the south entrance and tunnel of the stadium would be **used to bus children in for processing.** Buses were spotted at the location with digital destination banners reading “Special,” according to Aaron Dykes.

As documented in the film, *Camp FEMA*, the supposed disaster response agency has the authority to round up people and relocate them to designated facilities, including sports stadiums, under a number of executive orders.

Federal exercises have specifically targeted children on a number of occasions, most infamously in Muskegon, Michigan. In 2004, a Michigan county concocted a scenario in which public school children were threatened by a fictitious radical group that believed everyone should be home-schooled, [WorldNetDaily](#) reported. The exercise was funded by homeland security grants to area school districts and Muskegon county.

Want some torture with your peanuts?

Just when you thought you’ve heard it all...A senior government official with the U.S. Department of Homeland Security (DHS) has expressed great interest in a so-called safety bracelet that **would serve as a stun device, similar to that of a police Taser®.** According to this promotional video found at the Lamperd Less Lethal, Inc. website, the bracelet would be worn by all airline passengers (video at the link below).

This bracelet would:

- Take the place of an airline boarding pass
- Contain personal information about the traveler
- Be able to monitor the whereabouts of each passenger and his/her luggage

• Shock the wearer on command, completely immobilizing him/her for several minutes

The Electronic ID Bracelet, as it's referred to, would be worn by every traveler "until they disembark the flight at their destination." **Yes, you read that correctly. Every airline passenger would be tracked by a government-funded GPS, containing personal, private and confidential information, and would shock the customer worse than an electronic dog collar if the passenger got out of line.**

Clearly the Electronic ID Bracelet is a euphemism for the EMD Safety Bracelet. EMD stands for **Electro-Musclar Disruption**. Again, according to the promotional video, the bracelet can completely immobilize the wearer for several minutes. So is the government really that interested in this bracelet? Apparently so.

According to [this letter](#) from DHS official, **Paul S. Ruwaldt** of the Science and Technology Directorate, office of Research and Development, which was written to the inventor whom he had previously met with, Ruwaldt wrote, **"To make it clear, we [the federal government] are interested in . . . the immobilizing security bracelet, and look forward to receiving a written proposal."**

The letterhead, in case you were wondering, is **from a U.S. Department of Homeland Security** office at the [William J. Hughes Technical Center](#) at the Atlantic City International Airport, or the Federal Aviation Administration headquarters.

In another part of the letter, Mr. Ruwaldt confirmed, **"In addition, it is conceivable to envision a use to improve air security, on passenger planes."**

Would every paying airline passenger flying on a commercial airplane be mandated to wear one of these devices? I cringe at the thought. **Not only could it be used as a physical restraining device, but also as a method of interrogation**, according to the same aforementioned letter from Mr. Ruwaldt.

So would you let them put one of those on your wrist? Would you allow the airline employees, which would be mandated by the government, to place such a bracelet on any member of your family?

**Why are tax dollars being spent on something like this?
Is this a police state or is this America?**

UPDATE: Lamperd [Less Lethal Inc.](#), the Canadian company that designed the EMD Safety Bracelet, has [responded](#) to the controversy as follows:

We wish to clear up any misconceptions regarding the EMD Safety Bracelet for Airline Security.

The bracelets remain inactive *until a hijacking situation has been identified*. At such time a designated crew member will activate the bracelets making them *capable of delivering the punitive measure - but only to those that need to be restrained*. **We believe that all passengers will welcome deliverance from a hijacking, as will the families, carriers, insurance providers etc.** *The F-16 on the wing-tip is not to reassure the passengers during a hijacking, but rather to shoot them down.* Besides activation using the grid screen, the steward / stewardess will have a laser activator that can activate any bracelet as needed by simply pointing the laser at the bracelet - that laser dot only needs to be within 10 inches of the bracelet to activate it. **Comment: If you're on one of these flights just pray the stewardesses aim is good.**

Shocking Info on US Government Automobile Surveillance

I live in Texas, and was at a family gathering at which one of the extended family present is a Texas Ranger.

We were all sitting outside enjoying the cool of the evening and having drinks and talking. The subject got around to the **uptick in "No refusal" checkpoints in the state at which they draw blood (whether or not the person is willing) from suspected driving while intoxicated people who refuse to blow into breathalyzer**. Family members were voicing their ignorance of their rights while spewing their position on the matter. I could not let an opportunity to "educate" such a large group on the correct and Constitutional way to frame this issue and what is wrong with it. Some of the family members were getting upset by what I said, as my position of illegal detention for those who have done nothing wrong except driving thru the wrong street at the wrong time and what about the 5th Amendment and the right to not self incriminate.

To dissuade the tension, my Texas Ranger relative tried to change the subject. He said he had to admit that some rights were being stepped on, but that "some" good was coming out of it. Then he blurted out **"That he was actively using something in the course of his duties and liking it even though he felt in his gut that it was not right"**. He then asked if any of us had heard about **the new cruisers being outfitted with cameras that can read 5000 car license plates per hour**. Only a couple of hands

went up (I was one). He then explained what it is for those who had not heard of it. After this, he said this "new tool" was proving to make his job much easier.

Cruisers (and I guess unscrupulous government contractors), **drive anywhere and everywhere logging two things about each plate. First the plate and who owns it and secondly the GPS location of the plate pictured and the time of day. According to him, this all goes into a database and is stored for mining later, as needed, as well as constantly being updated. Later, if a situation arises in which they are looking for John Q Public, they access the database and to see that at 8 am a car with a certain tag is at this place, 12 noon it goes to this place, and this tag spends its nights at this place. So he is able to ascertain a person's daily routine and when they will probably be at a particular location. He said it makes his job much easier.**

So again, even if you are doing nothing wrong, your personal routine is now part of a database. This will only get worse I fear as more cruisers (and more unscrupulous contractors I suppose) will be outfitted with this Orwellian apparatus **which means the database will get more and more all encompassing and complete.**

Perhaps there is an opportunity here to sell some sort of license plate cover to mask your plate while car turned off.

He confirmed that the scanners provide images of vehicles, GPS location and times of day. This is all put into a database to be used in conjunction with the FBI or DHS if needed.**

He even went so far to include a website for law enforcement to obtain access to the database. He listed it as **nvlslpr.com** which is a restricted access website to be used only by law enforcement. He did confirm that law enforcement has been able to track a person's location pattern to ultimately make arrests. The officers in the room just loved

this. As for me....I was grieved at knowing more of our freedoms have been taken away as they track our every move.

Big Brother OnStar Begins Spying On Customers' GPS Location For Profit

I canceled the OnStar subscription on my new GMC vehicle today after receiving an email from the company about their new terms and conditions. While most people, I imagine, would hit the delete button when receiving something as exciting as new terms and conditions, being the nerd sort, I decided to read it instead. I'm glad I did. OnStar's latest T&C has some very unsettling updates to it, **which include the ability to now collect your GPS location information and speed "for any purpose, at any time". They also have apparently granted themselves the ability to sell this personal information, and other information to third parties, including law enforcement. To add insult to a slap in the face, the company insists they will continue collecting and selling this personal information even after you cancel your service, unless you specifically shut down the data connection to the vehicle after canceling. This could mean that if you buy a used car with OnStar, or even a new one that already has been activated by the dealer, your location and other information may get tracked by OnStar without your knowledge, even if you've never done business with OnStar.**

The complete update can be [found here](#). The first section explains the information that's collected from the vehicle. No big deal. Sounds rather innocuous and boring. I imagine most people close the window by the time they get this far. Your contact information, billing information, etc. is collected. Toward the end, you'll read about how GPS data is collected, including vehicle speed and seat belt status. Again, in an emergency, this is very useful and most customers want an emergency services business to collect this information - *when necessary*. And the old 2010 terms and conditions only allowed OnStar to collect this information for legitimate purposes, such as recovering a stolen vehicle, or when needed to provide other OnStar services to customers on demand. As you scroll down the list of information collected, you see that once you get past important *emergency services* (what we pay OnStar for), **OnStar now has given themselves the right to also use this information for seemingly profitable purposes. OnStar has granted themselves the right to collect this information "for any purpose, at any time, provided that following collection of such location and speed information identifiable to your Vehicle, it is shared only on an anonymized basis."** – This provides carte blanche authority for OnStar to now track and collect information about your current GPS position and speed any time and anywhere, instead of only in the rare, limited circumstances the old contract outlined.

Anonymized GPS data? There's no such thing! We've all seen this before – anonymized searches, for example, that were not-so-quite anonymized. But in this case, it's impossible to anonymize GPS data! If your vehicle is consistently parked at your home, driving down your driveway, or taking a left or right turn onto your street every single day, it's pretty obvious that this is where you live! What's unique even more so to OnStar is that the data they claim they sell as part of their business model is specific; that is, not diluted to the nearest 10 mile radius, for example. This combination of analytics, and their **prospective customers (law enforcement, marketers, etc) requires the data be disturbingly precise. Anyone armed with Google can easily do a phone book**

or public records search to find the name and address that resides at any given GPS coordinate.

So the GPS location of your vehicle and your vehicle's speed are likely going to be collected by OnStar and sold to third parties. What kind of companies are interested in this data? OnStar would have you believe that respectable agencies, like departments of transportation and various law enforcement agencies (for purposes of "*public safety or traffic services*"). TomTom recently had a run-in with so-called "public safety" and "traffic services" use when their data was used by the police to create a number of speed traps. I can imagine this data COULD be used for good, to create traffic based analytics to improve future road construction or even emergency response. But given that those types of decisions are only made once a decade in most cities, OnStar isn't likely to benefit much financially from "respectable" companies.

What is more profitable to OnStar than what your personal GPS data could be used for? As it would be extremely profitable to be able to identify all vehicles within OnStar's network that frequently speed, and provide law enforcement "traffic services" the ability to trace them back to their homes or businesses, as well as tell them where to set up speed traps. Or perhaps insurance companies who want to check and make sure you're wearing your seat belt, or automatically give you rate increases if you speed, even if you're never in an accident? How about employers who purchase these records from these third parties to see where their employees (or prospective employees) travel to, or sleazy bag lawyers who want to subpoena these records to use against you if you're ever sued, or government agencies who want to monitor you, or marketing firms who want to spam you, and a long list of other not-so-squeaky-clean people who use (and abuse) existing online, credit card, financial, credit, and other analytics to destroy our privacy?

Add to this OnStar's use policy of your personal information – the stuff that does identify who you are and ties it to your GPS records. OnStar also uses my information to "*allow us, and our affiliates, your Vehicle Maker, and Vehicle dealers, to offer you new or additional products or services; and for other purposes*". So not only is OnStar now able to sell my vehicle's GPS location data to a number of third parties, but they're also able to use it and my personal information for marketing purposes. Imagine your personal data being sold to any number of their "affiliates", and a few months later, you start to receive targeted, location-specific advertising based on where you've traveled. Go to Weight Watchers every week? Expect an increase in the amount of weight loss advertising phone calls. Go to the bar frequently? Anticipate a number of sleazy liquor ads to show up in your mailbox. OnStar's new T&C continues, explaining that part of the company may at some point be sold, and all of your information with it. It sounds as though OnStar is poising part of their analytics department to be purchased by a large data warehousing or analytics company. Or at least, perhaps they're throwing the hook out there for anyone interested. Do you trust such companies with unfettered access to the entire GPS history of your vehicle?

To make matters even more insulting, it was difficult to ensure the data connection was shut down after canceling. I still have no guarantee OnStar did what they were supposed to. I had to request the data connection be shut down repeatedly, after the OnStar rep attempted to leave it on and ignore my requests.

These terms don't go into effect until December 2011, and it takes up to 10 days to have the account fully cancel, and another 14 days for the data connection to be shut down... so if you want to get out of these new terms and conditions, you'll need to do it soon.

Update:

Since writing this article, OnStar has reportedly told a few individuals that the contract requires them to obtain the customer's consent in order to provide this information to anyone. **Not true. In fact, the only mention of the word consent in their updated T&C is below:**

We will comply with all laws regarding notifying you and obtaining your consent before we collect, use or share information about you or your Vehicle in any other way than has been described in this privacy statement.

Two points to make: first, this clause *only applies* to collecting and sharing information in any way *that is not described in the privacy statement*. All of the nefarious uses for your personal data are, quite clearly, described in the privacy statement, **and so no consent would be required**. Secondly, this paragraph makes it clear that they will only *comply with all laws* requiring consent, *not* that they will actually obtain your consent. I'm not a lawyer, but as far as I know, there are no such laws on the books in most (if not all) states that protect the consumer from having their private information shared or sold to third parties, especially when such sharing is disclosed in a contract. In other words, the above paragraph seems to do nothing to require OnStar to obtain your consent to do any of this – and it's my firm belief that OnStar's only real interest is in OnStar.

As one poster said in a discussion, you don't create a weapon you don't intend to use.

Big Sis Ordered NFL Grope Downs--Guilty until proven innocent – the decline and fall of America accelerates

The NFL's new policy to conduct full pat downs of all people entering stadiums nationwide is a consequence of the organization's partnership with Homeland Security, the federal agency that has come to resemble an occupying army enforcing the notion that Americans are guilty until proven innocent.



“The NFL wants all fans patted down from the ankles up this season to improve fan safety,” [reports USA Today](#).

“Under the new “enhanced” pat-down procedures, the NFL wants all 32 clubs to search fans from the ankles to the knees as well as the waist up. Previously, security guards only patted down fans from the waist up while looking for booze, weapons or other banned items.”

The Buffalo Bills and the Indianapolis Colts have already announced the new measures will be in place for this weekend's games.

The policy arrives following the **NFL's partnership with the Department of Homeland Security, who back in January for the Super Bowl recommended that fans entering the Dallas Cowboys stadium be subjected to airport-style metal detectors as well as pat downs. The NFL is following orders as it gets on board with the plan to litter the United States with checkpoints at public places where Americans will be forced not just to show their papers, but to assume the position for perverts to conduct invasive pat downs of themselves and their children.**

But this only marks the beginning of the role DHS sees itself in assuming as part of its occupation of the country.

Homeland Security is also developing technology to be used at “security events” which purports to monitor “malintent” on behalf of an individual who passes through a checkpoint. The [promotional video for the program](#) explains how “Future Attribute Screening Technology” (FAST) checkpoints will conduct “physiological” and “behavioral” tests in order to weed out suspected terrorists and criminals.

The clip shows individuals who attend “security events” being led into trailers before they are interrogated as to whether they are terrorists while lie detector-style computer programs analyze their physiological responses. The subjects are asked about their whereabouts, and if they are attempting to smuggle bombs or recording devices into the “expo,” proving that the technology is intended to be used at public events and not just airports. Individuals who do not satisfy the first lie detector-style test are then asked “additional questions”.



[Tests for the program were carried out by the DHS back in May](#), suggesting its implementation is close to fruition. Forget pat downs – the next step for entering NFL stadiums, shopping malls or any public place where crowds gather will be a behavioral interrogation and a radiation body scan.

The NFL policy was enacted following the arrest of a man for using a stun gun at the New York Jets-Dallas Cowboys game last weekend. **Using that logic, any time a gun is used in a shopping mall, on a highway or in any building or at any event, everyone will be treated as a criminal and subjected to a pat down as a routine response.**

It is estimated that over **16 million people will undergo the grope downs over the course of the football season, acclimatizing them to accept the notion that the 4th amendment is completely null and void.
