



Services up for bid include catering, temporary fencing and barricades, laundry and medical services, power generation, refuse collection, and other services **required for temporary “emergency environment” camps located in five regions of the United States.** At first glance, this may seem like no big deal. 

Fed Interest in Food Storage Facility Connected to FEMA Executive Order 10999

On Thursday, [Stewart Rhodes](#) of Oath Keepers posted a bulletin on the organization's blog reporting on **federal agents demanding a food storage cannery in Tennessee turn over customer lists so they might discover who is purchasing bulk storable foods and storing it** at the facility owned by Mormons.

He then speculates as to why the feds would demand customer lists. **"DHS/FEMA wants to know which Americans have food storage so the federal government can at some future point confiscate that food. Just as with lists of gun owners, compiling such lists is the first step toward future confiscation,"** he writes.

In fact, **the government codified the concept of food confiscation and redistribution when President Kennedy issued Executive Order 10999 on February 16, 1962.**

10999 was one of several executive orders signed by Kennedy under the rubric of "national emergency" that extended extrajudicial power to FEMA, including the ability to control communications, energy, food, fuel, farms, transportation, highways, railroads, inland waterways and seaports, health, education and welfare. The EO also allows FEMA to organize citizen work brigades under government control and undertake the relocation of the population.

10999 also gives FEMA the authority to control all public storage facilities.

On June 3, 1994, President Clinton consolidated all previous FEMA executive orders into one all-encompassing order, #12919.

As many have noted, FEMA is not an emergency agency. **It is a martial law agency. It is often referred to as the "secret government" of the United States.**

"It is not an elected body, it does not involve itself in public disclosures, and it even has a quasi-secret budget in the billions of dollars," writes [Harry V. Martin](#). **"This government organization has more power than the President of the United States or the Congress, it has the power to suspend laws, move entire populations, arrest and detain citizens without a warrant and hold them without trial, it can seize property, food supplies, transportation systems, and can suspend the Constitution."**

If we take the above into consideration, it makes sense that the feds would be interested in keeping track of facilities storing food supplies.

Government censors document revealing plans to wage war on Americans

The government-linked document we posted was marked 'Source Selection Sensitive' but not considered classified. Further, it was listed publicly on a government website that was soliciting bids for government contracts. However, despite its public classification, it contains information that clearly is NOT intended to gain wide publicity.

These new FEMA documents confirm information received from DoD sources that show military involvement in a FEMA-led takeover within the United States under partially-classified Continuity of Government (COG) plans. It involves not only operations for the relocation of COG personnel and key officials, population management, emergency communications and alerts but the designation of the American people as 'enemies' under a live military tracking system known as Blue Force Situational Awareness (BFSA).

1.0 GENERAL

1.1 SCOPE

The Federal Emergency Management Agency (FEMA) has a requirement for Contractor support to assist FEMA's National Continuity Programs (NCP) with program and mission support services. Work to be performed by the Contractor will be in support of the NCP programs identified in Section 1.2 Background, and may fall within one or more of the following Task Areas, which are further defined in Section 4.0 of this Statement of Work:

- Administrative Support
- Test, Training and Exercise Programs
- Software, Systems, and Telecommunications Engineering and Support
- First Responder Partnership Initiative
- Audit Support
- Financial and Internal Controls
- Property Management Support
- OMB 300 Support
- Acquisition Support
- Outreach Support
- Professional Support/Subject Matter Expertise

The Contractor's performance under this contract shall be in an advisory and assistance capacity to the Government, and shall not include any inherently governmental functions. The Contractor shall submit all work products in draft for review and approval by appropriate Government personnel prior to preparation and issuance in final, in accordance with the contract. The Government will make all final determinations and decisions after a critical and close review of the Contractor's work product and reasons/basis for the Contractor's recommendations. The Contractor shall not represent itself as FEMA to outside parties. To maintain public trust, Contractor employees shall identify themselves as FEMA Contractors at the onset of any communications with internal and external parties.

DHS Officers Armed With Semiautomatics Set Up Unannounced ID Checkpoint


That damage translates into lifelong patients (and thus life-long profit) for the pharmaceutical industry making the vaccines and he says doesn't appear to be accidental.







Warning: Flu Shots Are Coming to Your Church--If You Go to Church, Heed This Warning

Recently the [White House Office of Faith-Based and Neighborhood Partnerships](#), held an invitation-only call.

The call was co-sponsored by the [U.S. Health and Human Services](#), the [Office of Minority Health](#), and [CDC](#).

Conspicuously, the end of the invitation read:

"This call is off the record and is not for press purposes" -- but it became public when it showed up [on the HHS website](#).

Fortunately one of our staff was able to get on the call.

The focus of the call was on **getting faith-based organizations to sponsor flu clinics with Walgreens.**

Basically, they want to move inside your church, mosque or synagogue, and set up shop, with your pastor, priest, imam and rabbi on hand to convince you to get a flu shot. As an example, they cited a priest who stopped in the middle of mass to roll up his sleeve and get vaccinated, inspiring the rest of his parish to line up behind him.

The idea of holding out your arm and getting a shot in the middle of a worship service, with your pastoral leader urging you on is horrific. The reason they're doing this, health officials said on the phone, **is that they've found that non-traditional settings such as worship services can be highly effective in influencing people's decisions.**

Speaking directly to church leaders, Joshua DuBois, executive director of the White House Faith-Based and Neighborhood Partnership, said:

"As trusted messengers, you're able to spread messages and help get people vaccinated."

Zeroing in on minorities, particularly older adults, blacks and Latinos, health officials said churches, mosques and schools are places where barriers to vaccinations can be taken down, and these minorities can be convinced to get vaccinated.

Besides hosting flu shot clinics, churches can also help by putting reminders in their bulletins, and by church members personally reminding others to get their shots, officials said.

They even went so far as to encourage the churches to pay people's insurance co-pays so they'd be more inclined to get the shots. For those who simply can't pay anything, there'll be 300,000 free shots given out as part of the flu vaccine crusade.

The original concept of Faith-Based and Neighborhood Partnerships, developed in 2001, was [to help community leaders](#) enhance the 1998 Initiative to Eliminate Racial and Ethnic Disparities in Health.

The partnership targets cancer screening, cardiovascular disease, diabetes, infant mortality, HIV/AIDS and vaccinations.

For at least 10 years, this collaboration of community-based volunteers, nonprofit organizations and faith-based groups worked at a grassroots level in their respective neighborhoods, funded by Congress through various health care grants.

However, in 2010 **the initiative took a turn with the Patient Protection and Affordable Care Act, which moved the initiative's management to the Center for Faith-Based and Neighborhood Partnerships, paving the way for the federal government to fund and run projects like flu clinics right in your church.**

It's no surprise that flu shots were already covered by most insurance plans, Medicare and the Vaccines for Children (VFC) program.

But for some reason health officials have decided it's OK to push the government into places of worship, mid-service, to sell and administer vaccines – and this no-press-allowed phone call reiterated that over and over again. I can only wonder which vaccine they'll move into your church next, all in the name of "community health."

In February 2011, [new research showed](#) that 76 percent of white seniors get flu vaccines, with 68 percent of English-speaking Hispanic seniors getting them, and 64 percent of Spanish-speaking Hispanic seniors doing so. [In the phone conference, officials emphasized that they want to increase flu vaccine coverage beyond those numbers.](#)

But unfortunately, they neglected to mention the shocking lack of evidence supporting flu vaccines.

Start up dosage for the Mild Silver Protein if a high amount of infection or yeast is suspected
