

## ++ Vaccinated vs. Unvaccinated: Guess who is Sicker?

It's never been done before. [The first-of-its-kind study](#) of vaccinated vs. unvaccinated American homeschooled children shows who is really ailing...and parents should be worried

Something is wrong with America's children. They are sick – allergic, asthmatic, anxious, autoimmune, autistic, hyperactive, distracted and learning disabled. Thirty-two million American children – a full 43% of them – suffer from at least one of 20 chronic illnesses not including obesity. Across the board, once rare pediatric disorders from autism and ADD to Type 1 diabetes and Tourette's syndrome is soaring, though few studies pool the data. Compared to their parents, children today are four times more likely to have a chronic illness. And while their grandparents might never have swallowed a pill as children, the current generation of kids is a pharmaceutical sales rep's dream come true: More than one million American children under five years old takes a psychiatric drug. More than 8.3 million kids under 17 have consumed psychiatric drugs, and in any given month one in four is taking at least one prescription drug for something.



Fast food, bad genes, too much TV, video games, pesticides, plastics – name the environmental factor and it has been implicated in the surge of sickness, although none adequately explains the scale or scope of the epidemic. There is one exposure, however, that has conveniently evaded the search, despite that children have received it by direct injection (in steadily accumulating doses far beyond anything past generations ever saw): 50 doses of 14 vaccines by age six, 69 doses of 16 pharmaceutical

vaccines containing powerfully immune-altering ingredients by age 18.

We're assured vaccines are "safe and effective" even though public health officials acknowledge they sometimes have serious side-effects including death and despite the troubling fact that no long-term study of their effects on overall health has ever been conducted. Remarkably, not a single published study has ever compared vaccinated kids to unvaccinated kids to see who is healthier years after the shots. Until now.

A pilot study of 666 homeschooled six to 12-year-olds from four American states published on April 27th in the [Journal of Translational Sciences](#), compared 261 unvaccinated children with 405 partially or fully vaccinated children, and assessed their overall health based on their mothers' reports of vaccinations and physician-diagnosed illnesses. What it found about increases in immune-mediated diseases like allergies and neurodevelopmental diseases including autism, should make all parents think twice before they ever vaccinate again:

\*Vaccinated children were more than three times as likely to be diagnosed on the Autism Spectrum (OR 4.3)

\*Vaccinated children were 30-fold more likely to be diagnosed with allergic rhinitis (hay fever) than non-vaccinated children

\*Vaccinated children were 22-fold more likely to require an allergy medication than unvaccinated children

\*Vaccinated children had more than quadruple the risk of being diagnosed with a learning disability than unvaccinated children (OR 5.2)

\*Vaccinated children were **300 percent more likely to be diagnosed with Attention Deficit Hyperactivity Disorder** than unvaccinated children (OR 4.3)

\* Vaccinated children were **340 percent (OR 4.4) more likely to have been diagnosed with pneumonia** than unvaccinated children

\*Vaccinated children were **300 percent more likely to be diagnosed with an ear infection** than unvaccinated children (OR 4.0)

\*Vaccinated children were **700 percent more likely to have surgery to insert ear drainage tubes** than unvaccinated children (OR 8.01)

\* Vaccinated children were **2.5-fold more likely to be diagnosed with any chronic illness** than unvaccinated children

### **CDC Publishes New Rules for Quarantine and Isolation on Last Day of Obama Presidency**

**There are new U.S. government rules that can force travelers into quarantine or isolation if they are suspected of having a contagious disease. The rules were released on the last day of the Obama Administration, 1/19/2017, and will take effect on February 21, 2017. Under these rules, if a CDC medical professional examines and quarantines you under a public health order, certain medical procedures, such as mandatory vaccinations, could be required as a condition of your release.**

For those of us who prefer to minimize our contact with the conventional medical care system and its pharmaceutical products, these new rules should cause us to carefully consider our health status when traveling across state lines or traveling back to the United States during a CDC health emergency. If we have symptoms of illness that might be confused with a communicable disease, then it might be wise to carefully consider our travel plans. **The rules cover travelers who are residents of the United States or residents of other countries. It affects those who are traveling to the United States and those traveling across state lines within the United States. This means that the CDC and the U.S. Public Health System can exercise authority to screen people for the presence of certain infectious illnesses at airports, seaports, train stations, bus terminals, international border crossings, and at the borders between states. During times when the CDC has declared a health emergency, public health workers will become much more visible and active. An example of this was seen in 2014 when there was heightened concern about the transmission of Ebola from Africa into the United States.**

During such health emergencies they will step up their surveillance of people who are traveling into the U.S. and their surveillance of people who are traveling around the U.S. They will be monitoring travelers who are moving by air, by sea, and on the ground. **The CDC will have the authority to establish screening stations, and to assess travelers for the presence of the communicable disease that is of concern. They will be able to apprehend, detain, and to obtain federal public health orders for quarantine, isolation, and conditional release. They can operate these screening stations at airport security locations, customs offices, train stations, bus stations, and U.S. border crossing points, and could even apprehend travelers at toll booths located at state borders.** [Pages 6908 and 6927]

### [Zika virus vaccine will genetically re-engineer your DNA](#)

([Natural News](#)) Touted as “[the next great epidemic](#),” just the words “Zika virus” are enough to strike fear into the hearts of millions. With every pregnant woman on high alert and female athletes bailing out of the Rio Olympics in terror last year, the mainstream media created an epidemic of hysteria far greater than the danger posed by the disease itself. ***The investigational Zika vaccine includes a small, circular piece of DNA — called a plasmid — that scientists engineered to contain genes that code for proteins of the Zika virus. When the vaccine is injected into the arm muscle, cells read the genes and make Zika virus proteins, which self-assemble into virus-like particles. So, this vaccine will work by injecting synthesized genes into your body, thereby permanently altering your DNA, and presumably, the DNA of your children and all of their offspring.*** [Jon Rappaport](#), an award-winning investigative journalist,

makes the point that with a vaccine like this, the sky would be the limit for the government. Under the guise of “vaccination,” DNA could be altered to make people more obedient or passive, intelligent and talented, subservient, etc.

## ++ Will Refusing Vaccines Soon Lead to CPS Kidnapping Your Children for “Medical Neglect”?

Amidst the ever changing, controversial white waters of vaccine safety, parents who choose natural immunity are being targeted by certain members of the medical, legal and public health communities as being guilty of medical neglect. As readers of Health Impact News’ [MedicalKidnap.com](http://MedicalKidnap.com) website are fully aware, “medical neglect” is a broad term frequently used against parents who dare to disagree with doctors over the healthcare of their children, and can result in Child Protective Services (CPS) taking the children away from their families by force. The latest example of this usurping of parental rights, which is being pushed and orchestrated by vaccine extremists who insist on pushing a one-size-fits-all approach to immunity, appears in the February edition of the American Journal of Public Health, in an article entitled “[Parental Refusal of Childhood Vaccines and Medical Neglect Laws](#).”

The paper, authored by Efthimios Parasidis, JD, M.BE, and Douglas J. Opel, MD, MPH, sets out to examine court cases where vaccine refusal is categorized as “medical neglect” under child welfare laws.

In an attempt to establish a legal precedent for parents who choose natural immunity over vaccine mandates, and in an effort to identify those same parents as being medically negligent for doing so, Parasidis & Opel set out to identify court opinions ranging from 1905 to 2016 that ruled not vaccinating was legal medical neglect. Their search allegedly identified only a total of 9 cases in 5 states, 7 of which ruled vaccine refusal constituted neglect.

That miniscule number pales in comparison to the thousands of parents who have come forward claiming that their children experienced a vaccine reaction ranging from the condition itself that the vaccine was supposed to prevent, to death. In fact, the article fails to even address what the associative risk to

vaccinating would be in compared to not vaccinating.

One need only to look to California politics to understand the reason for such a piece of legislation which is just a thinly veiled attempt to lay groundwork to link parental rights to choose natural immunity with medical neglect.

Sen. Richard Pan, the California politician who was the main sponsor of the controversial mandatory vaccine law [SB277](#), which forces parents to choose between medical



freedom and sending their kids to public or private school, just introduced another bill which fits perfectly into this puzzle.

**SB18** — a scant, outline of a bill dubbed the “child bill of rights” — was introduced by Pan in December. It seeks to define what constitutes parental standards with regard to children’s health, education and welfare and is being sold to parents in the State of California in a town-hall-style format.

The already controversial bill has very deep ties to the Clinton Foundation via Pan’s official sponsor, Jim Steyer of Common Sense Media. Brother of environmentalist billionaire Tom Steyer, Jim and his brother have very deep connections to Bill, Hillary and Chelsea Clinton, and are using their influence to push for the bill, which seeks to control the rights of parents even further in California by defining what constitutes a child’s well being.

Jim, who has been a professor of political science at Stanford for the past 25 years, has a class list of former students that includes Obama’s former National Security Advisor Susan Rice and Chelsea Clinton herself, which explains Steyer’s closeness and allegiance to the Clinton family and his and his brother’s multi-million dollar donations to the Clinton Foundation and now defunct Clinton Global Initiative.

Do the parents of California want someone with ties to the now defunct Clinton organization deciding what’s best for their children, especially when that same organization has direct ties to Laura Silsby, who was convicted of child trafficking in Haiti?

### New Law Means You Could Be Used As Subject Of Vaccine Experiment

Last December, then President Barack Obama, passed a law that favored pharmaceutical company agendas. The law gives way to pharmaceutical companies who want to use a vaccine or any medication as an experimental endeavor. And they don’t have to tell the patient.

The law is here: Section 3024, “Informed Consent Waiver for Clinical Investigations” of H.R. 32, the “21st Century Cures Act.

Clinical testing of investigational medical devices and drugs no longer requires the informed consent of the subjects if the testing poses no more than minimal risk to the subjects and includes safeguards.

The exact details of what is intended by “clinical testing” is not clear.

Additionally, the “no longer requires the informed consent of the subjects” portion is incredibly, and terrifyingly, clear. This seems to give pharmaceutical companies the ability to perform any testing they want to on anyone who is already receiving one of their medications.

This means that if you or your child consent to a vaccine, you might be lending yourself as a test subject and be placed in an experiment. This is a free pass for big pharma to use all of us guinea pigs. This would seem to give a vaccine company the right to abruptly and without specification, change the ingredients in a medication as well. How anyone would think that disallowing consumer consent over medicine (that goes into their bodies) is OK, is beyond me.

This is another law that was passed while we weren't paying attention. One would hope that President Trump eventually digs deeper into these laws and removes them. And one has to consider what type of damage has already been accomplished due to this law.

### US Feds plan to force vaccinations

10/28/2016 -A public-interest legal team has filed comments with the federal government objecting to a planned Centers for Disease Control rule-change that would allow the government to impose forced vaccinations on Americans under certain circumstances.

Erin Mersino, senior legal counsel for the [Great Lakes Justice Center](#), explained: "This proposed rule is an abuse of power under the pretext of protecting public safety. The government increasingly acts without constitutional authority, thereby undermining good governance under the rule of law."

The proposal from the CDC comes in the context of defining government's power to act against individuals in the case of an outbreak of a communicable disease. But the Great Lakes Justice Center contends "the proposed rule reaches far beyond the CDC's ability to quarantine a person with a serious disease, such as Ebola, by expanding the quarantine regulations to encompass all communicable diseases."

The grant of permission for forcibly vaccinating individuals comes in its definitions, the GLJC said.

The GLJC is concerned that the "proposed rule requires forced medical treatment and vaccination of the detained individual without consent."

"It forbids an individual from objecting to forced medical treatments and vaccinations for any reason – at the threat of criminal prosecution, prison and fines up to \$100,000.00."

The Rumor Has It" website Snopes posted a long article trying to debunk the claim, calling it "an alarmist rumor."

But Snopes admitted a 1944 law already granted the government the power to "take necessary measures (including the apprehension of individuals) in order to prevent the spread of communicable diseases."

The Great Lakes Center said the proposed rule "tramples on our due process rights, civil liberties, violates religious freedom, invades personal privacy, and highjacks bodily autonomy."

The Great Lakes Justice Center said "Even in cases where no evidence of serious illness exists, the CDC's proposal... authorizes detention, isolation, quarantine, and vaccination *without consent*."

Notwithstanding any other provision of law, for purposes of this subtitle, both a woman **who received a covered vaccine while pregnant and any child who was *in utero* at the time such woman received the vaccine, shall be considered persons to whom the covered vaccine was administered and persons who received the covered vaccine.**

This may have been written for liability reasons. Perhaps Big Pharma is concerned that the child would be eligible to sue for damages, unlike anyone vaccinated after birth. **Perhaps the thinking is that doctors tend to have more control over mothers before birth, so why not force vaccines on them then, rather than after birth?**

Then again, **this provision may be intended simply to increase vaccinations given to pregnant mothers. If a developing child is considered a "person" eligible to receive vaccinations, the vaccine industry could begin to develop more vaccines intended specifically for children *in utero*.**





### **Priority #1: Make a plan**

Sometimes when people begin to think of their emergency supplies it is when something has caused them to be afraid or very concerned. Many times individuals, families and even communities don't put a lot of thought into emergency planning until it after a disaster has struck. That is, of course, the worst time to think about it. At that point, you are at somebody else's mercy.

Your first priority in getting prepared and gathering emergency supplies is to make a plan. This is a critical step because it helps you organize in your mind what you want to accomplish and how you are going to get there. Having a plan will minimize your mistakes and will help you include the right items for the right prices. Here are some ideas in formulating your emergency preparedness plan:

**1. Gather information** – go to trusted sources for information on what to include in your plan and how to do it. There are many websites and books available. Here are some national websites to consider: [www.Ready.gov](http://www.Ready.gov), [www.FEMA.gov](http://www.FEMA.gov), [www.redcross.org](http://www.redcross.org). Also, go to your city, county and state emergency planning websites. That information will be extremely helpful.

**2. Write it down** – It is very important to write down your emergency plan and keep it in a place that allows you to review it regularly.

**3. Make a list of all your items (include expiration dates if possible)** – Your emergency plan should include a list of all the items that you have stored. If possible include where they are stored and their expiration dates (if applicable). This will help you follow the principle of Review, Rotate, Replace.

**4. Family communication plan** – Make sure you include emergency contact information, an out of state contact as well as local contacts and meeting locations in case of disaster. Also, include evacuation routes out of the house and your community.

**5. Important Documents** – Make copies of important documents, like insurance policies, birth certificates, social security cards and wills. Keep those documents with your plan in a water tight container.

**6. Product Instructions and Emergency Instructions** – As you do your information gathering in step one, print out copies of important emergency instructions. You may want to keep a survival book on hand to give valuable information. Also, remember to include a product instructions that might be helpful as well.

**7. Consider Grab and Go vs. Shelter in Place** – Make a plan to evacuate (grab and go) as well as to shelter in place. Include how you will do it, where you will go, what you will include in these supplies and where they will be stored.

**8. Make a plan for water** – Make sure you know where to get clean water, how to clean water and where it will be stored.

JWR's "List of Lists" is a downloadable, frequently updated spreadsheet that contains must-have items for your use and for bartering.

-- **Survival Life:** This site, edited by "Above Average Joe," contains a wealth of easy-to-read articles on just about everything that you could imagine wanting to know or needing to know to prep for bad times. In addition, the site features several [prepper](#) and survival experts -- guys and gals with real-world experience -- to give the site legitimacy and authority in the field. Recent articles include a piece on solar ovens, night vision, survival cooking and solar water heating.

-- **SHTF Plan:** Designed purely for the survivalist instinct in all of us, this site discusses a number of unlikely scenarios -- such as Ebola coming to America and the collapse of the U.S. economy -- that may be uncomfortable to many people. No one wants to think about things like a [pandemic](#) reaching our shores, or the destruction of our economy, but as a country, these things are always a possibility, even in America. In addition, *SHTF Plan* offers a number of great products and information -- some of it free -- for those just getting starting in prepping.
