NYC Mandates Vaccination in Brooklyn Amid 'Measles Outbreak' (Fines & Imprisonment for those Who Refuse) & How to Fight Back

The order applies to anyone living, working, or going to school in the proscribed areas, and while the city cannot legally force someone to get a vaccination, the order states that failure to comply is “a misdemeanor for which you may be subject to civil and/or criminal fines, forfeitures and penalties, including imprisonment.”

Below is an excerpt from the emergency order:

“*IT IS HEREBY ORDERED that any person who lives, works or resides within the 11205, 11206, 11221 and/or 11237 zip codes and who has not received the MMR vaccine within forty eight (48) hours of this Order being signed by me shall be vaccinated against measles unless such person can demonstrate immunity to the*

disease or document to the satisfaction of the Department that he or she should be medically exempt from this requirement.

IT IS FURTHER ORDERED that the parent or guardian of any child older than six

The order remains in effect until the next meeting of the New York City Board of Health scheduled for April 17, 2019 at which time it may be continued or rescinded by the Board.

NYC Mayor de Blasio declares the US government owns your body

In an unusual and extreme move, New York Mayor Bill de Blasio declared a state of emergency over a measles outbreak in the Orthodox Jewish community and is demanding forced vaccinations of everyone within four zip codes of the affected areas. Violators face fines up to \$1000. [This includes babies six months of age, even though the MMR is not recommended for anyone under twelve months of age.](#)

[The Children's Health Defense will be filing a legal challenge to the order, which comes on the heels of a New York Supreme Court ruling that struck down the Rockland County ban](#) on unvaccinated children in public spaces.

Some have asked how de Blasio is planning to determine who is or isn't vaccinated to enforce his order. According to the mayor, they will be using ["disease detectives."](#) de Blasio explained, "It parallels what a police detective does. If someone has symptoms, they will literally interview them to figure out everywhere they've been, everyone they might have come in contact with, and then they go reach out to that whole network to make sure people are vaccinated." It's unclear whether "make sure people are vaccinated" means "hold them down and inject them against their will."

Nazi Germany Rebranded!!!: NYC Sends "Disease Detectives" Narcs Into Jewish Neighborhoods Looking for Unvaccinated – Attorneys Prepare Lawsuits

A day after New York City Mayor Bill de Blasio declared a state of emergency over measles outbreaks in Jewish communities of Brooklyn, and [ordered forced vaccinations of everyone](#) not yet vaccinated with the MMR vaccine, [the Washington Post is](#)

reporting that the Health Department has sent “disease detectives” into the community to force compliance.

On Wednesday, the city sent 15 to 20 “disease detectives” into the community, some with Yiddish interpreters, a day after Mayor Bill de Blasio’s vow to quash the outbreak with \$1,000 fines and misdemeanor charges for anyone in certain areas who refuses to be immunized.

The workers, wearing blue Health Department jackets, conducted interviews in the homes of people who may have been exposed to the dangerous, highly contagious virus and checked the immunization records of all those they may have had contact with. Others pored over records for the same information at a federally funded health clinic in the heart of the community.

There are 1,800 unvaccinated yeshiva, or Orthodox Jewish, students with religious exemptions in the four Zip codes targeted by the city, spokeswoman Marcy Miranda said. (Source.)

John Marshall, chairman of emergency medicine at Maimonides Medical Center, is reportedly threatening to call the police on parents who refuse to vaccinate their children.

Marshall said he threatened to call police on parents who were refusing to send a feverish child to the hospital in an ambulance for fear the authorities would learn all their children were unvaccinated.

“The ones who are so vehemently anti-vaccination, I don’t know how to convince them,” said Edward Chapnick, director of Maimonides’s infectious disease division. (Source.)

The Mayor and the Health Department are assuming that by declaring a state of emergency over recent measles “outbreaks,” that they have the legal authority to suspend certain laws in place protecting the rights of residents of NYC to opt out of vaccines due to religious beliefs, and HIPAA privacy laws which would prevent them from pulling up medical records of children to see if they have been vaccinated or not. In the meantime, attorneys are saying that they will file a lawsuit challenging the emergency order by Friday.

Attorney Michael Sussman, who successfully represented parents in Rockland County, New York last week and [convinced the state Supreme Court to overturn the County’s ban on unvaccinated children](#), is one of the attorneys planning to file a lawsuit in New York City.

Much like the emergency order issued in Rockland County by County Supervisor Ed Day, Sussman stated that Mayor de Blasio’s emergency order is “an overreach of authority.”

In Sussman’s successful lawsuit against Rockland County, New York Supreme Court Judge Rolf Thorsen ruled that the 166 cases cited by the county since the measles outbreak began last October did not rise to the level of an epidemic or constitute a disaster.

There have been no deaths in the United States due to measles since a single case was reported in 2015 (an adult woman), and none during the prior ten years before that.

Another New York attorney who is reportedly filing a lawsuit against the city is Attorney Robert J. Krakow. Krakow represents clients who have been injured by vaccines. He also believes the city has overstepped its powers. ([Source.](#))

Attorney Krakow is one of the few attorneys in the United States that represents victims who have been injured or had family members killed by vaccines before the U.S. **Vaccine Court. Pharmaceutical companies who manufacture vaccines cannot be sued for damages in the U.S. – they have legal immunity due to the 1986 National Childhood Vaccine Injury Act.**

The measles vaccine (MMR) is one of the vaccines Attorney Krakow has litigated against for vaccine injuries. ([One case here.](#))

information that “undermines public trust in vaccination” and thus renders the preventive immunization measures ineffective, deputy health minister Tatiana Yakovleva said in a statement. The scale of the problem has now prompted Russian health authorities to draft a bill that would ban any public calls on people to avoid vaccination.

Freedom of speech has taken another major hit Down Under, as government authorities in Australia recently decreed that any medical professional who dares to express skepticism about the safety or effectiveness of vaccines *will be prosecuted to the full extent of the law, including a potential prison sentence of up to 10 years.*

Nurses and midwives who try to explain to pregnant women that some vaccines contain neurotoxic mercury (thimerosal), for instance, or that aborted human fetal tissue is often used to manufacture vaccines, will now face the ire of Australia's medical police state, which insists that all vaccines are 100 percent safe and effective.

The Australian government has also set up a snitch program for medical “offenders” to be reported by their “friends,” colleagues, or others who suspect that they might be in violation of this new speech code – like some kind of deep state spying and surveillance scheme contrived from the dystopian novel *1984*. “With no exceptions we expect all registered nurses, enrolled nurses and midwives to use the best available evidence in making practice decisions,” said Dr. Lynette Cusack, Chair of the Nursing and Midwifery Board of Australia (NMBA), in an official statement about the new rules. “This includes providing information to the public about public health issues.”

In the event that a nurse or midwife is reported to the NMBA for potential violations, the board says it will respond by conducting an internal investigation into the matter, followed by a recommendation or not for prosecution.

Victoria Health Minister Jill Hennessy, a full-fledged vaccine *worshiper*, of course supports the new rules, which she hopes will deliver harsh punishment to all vaccine skeptics in Australia, which she describes as “brain dead sheep.”

“They are an organized movement, largely stemming from the United States of America, that are hell bent on misleading parents that vaccinations are unsafe,”

Hennessy is quoted as saying. "That's a dangerous message and one I'm going to continue to fight. Vaccinations save lives," she insists. In addition to health practitioners, the Australian government is also going after parents, who reportedly risk having their childcare benefits terminated if they refuse to vaccinate their children in accordance with government guidelines. Some parents could also be fined for refusing vaccinations for their children, with a daily fee of \$14 Australian deducted from their family's tax benefit payments. Due to dwindling capacity for existing aborted fetal cell lines to self-replicate, scientists in China have developed a new aborted fetal cell line, WALVAX 2 that will be used for viral vaccine production. The existing cell lines, MRC-5 and WI-38 are currently used in MMR, Varicella, Hepatitis-A, Shingles, some rabies and some polio vaccines. WALVAX 2 is taken from the lung tissue of a 3 month gestation female who was ultimately selected from among 9 aborted babies. The scientists noted how they followed specific guidelines to mimic WI-38 and MRC-5 in selecting the aborted babies, ranging from 2-4 months gestation. Some 27 vaccines, in fact — and hundreds more on the way — contain some form of aborted human fetal tissue, whether it be cellular debris, protein, or DNA.


Beyond those vaccines aforementioned, these include vaccines for polio, shingles, ebola, HIV, tuberculosis, malaria, and influenza.
