When Pastors Become the Instrument of Your Oppression-The Clergy Response Team, FEMA Camps and Bioterrorism

I recently authored an article on the fact that Ebola is poised to enter the country in a big way through illegal immigration stemming from transported Africans to America's southern border. Additionally, I have previously reported that a trusted DHS source told me that they are aware that FEMA camps are being constructed outside of five Texas cities. These two events are related. And also related is an interview with someone who was trained to be a part of the government's Clergy Response Team.

Previously, I interviewed Pastor Walter Mansfield, who emphasized that when martial law is enacted, the enforcement would be immediate. In other words, family members will be separated from each other and part of the training that the 501c3 clergy received was how to comfort separated family members. Pastor Mansfield emphasized that the FEMA/DHS drills were predicated on bioterrorism. This is exactly what a FEMA source told me before he and his family left Phoenix and relocated to remote area to avoid what he knew was coming. The pastors were trained to go to homes where people refused to be relocated by the authorities and their immediate job was to convince the reluctant to willingly go to the relocation camps. Ostensibly, this was to be done in lieu of sending in the SWAT teams. I asked Mansfield if FEMA camps were real and he stated that much of the clergy training focused around this scenario of pastors operating within the forced relocation centers. The main goal of a pastor assigned to a FEMA Camp was to bring order and encourage compliance with DHS requests, hence, the emphasis on Romans 13. The pastors were forced to sign non-disclosure. Interesting, the pastors were told not to quote Scripture. The DHS document which was prepared for the pastors clearly stated that Scripture had been used to "oppress" people in the past and the presenters strongly discouraged its use. Please see the following excerpt from one of the DHS training manuals: *Healing Scripture and Prayer In the Pastoral Crisis Intervention*

"During a time of crisis people do go through a "crisis of faith." Sometime quick mention of God and scripture may not be helpful. As we all know the Scripture has been used to oppress, dominate and at the same time used for healing and reconciliation- renewing of relationship with God and people. If the pastor senses it is appropriate to use the scripture and prayer, it must carefully be done for healing of victims not to uphold pastoral authority." (Page 14) In other words, all legitimate pastoral authority was abrogated by the pastors who participated in the roundup of American citizens. Also on page 14 of the same training document, pastors were admonished to avoid "Unhealthy God talk...." Specifically pastors are ordered to avoid using references to God when helping people cope with the

loss of a loved one: “4. God must have needed him/her more than you.” “5. God never gives more than we can handle.”

Pastor Mansfield also revealed that pastors will be issued badges under the Clergy Response Team program. Any pastor not displaying the badge, indicating that they have been trained under these guidelines, will not be permitted into the established and designated “DHS safety zones”. Along these lines, the Clergy Response Team is also a “Jonestown Kool-Aid drinking program”. Pastors are absolutely forbidden to publicly to speak about any aspect of the program. If you were to ask your pastor if they are a FEMA trained pastor, they will not likely tell you. Disturbingly, Pastor Mansfield reiterated several times that the number one job of these pastors is to calm down people and encourage their compliance within the people’s new surroundings. Pastor Mansfield also stated that pastors will be utilized as informants. This violates the legal privilege of confidentiality between pastor and church-goer that is currently recognized by law. All church-goers can no longer trust the sanctity of personal confessions and revelations made to pastors, priests or rabbis’. This one illegal act by DHS completely undermines the Christian Church in America!

American Christians will be the most hunted in the near future. Everywhere, and at every level of our society, we are seeing discrimination against Christians. +2+ ILLEGAL ALIENS FROM EBOLA COUNTRIES CAUGHT CROSSING US BORDER: CDC Director Warns Ebola Virus to Go International; Vaccine Running out

Leaders from the World Health Organization (WHO) said the Ebola outbreak in the Democratic Republic of the Congo (DRC) is not retreating and countries must prepare for the outbreak to go global!

"At any point it could flare up within a zone," said Mike Ryan, MD, a WHO assistant director-general. Ryan, citing information contained in yesterday's WHO Ebola situation report

"Surveillance has intensified to 1,300 alerts per day" Ryan said. "The number of contacts being followed is 15,000."

Throughout the press conference, Ryan called the outbreak complex. In addition to the security challenges in the region, he said certain health-seeking behavior and community death practices have contributed to the outbreak's longevity. About 20% of Ebola case-patients first seek healthcare in a health zone far away from where they live, which makes it hard to make connections between transmission chains. Additionally, several deaths are still occurring in the community. Each community death, Ryan said, raises the risk of further disease spread.

Ryan also said the WHO estimates it is detecting 75% of cases, with as many as 25% missed or being picked up "too late."

He also reminded the reporters in the room that 80% of vaccinators in the region are Congolese, and most doctors and nurses working the outbreak are Congolese. The number of infected healthcare workers remained at 110.

Yesterday Robert Redfield, MD, the director of the US Centers for Disease Control and Prevention (CDC), told Congress that the world must be prepared for this outbreak to spread internationally, and for vaccine supplies to dwindle, according to a Devex story.

Redfield said vaccine production is being held up by plant validation. Merck had manufactured the vaccine, rVSV-ZEBOV in Pennsylvania until recently moving the operation to Germany.

Merck's Ebola Vaccine, A Christmas Gift for the World: Really?

There are currently about 145,000 doses of the vaccine, too few for a planned broader vaccination campaign that would look toward vaccinating geographic regions instead of contact rings.

Ebola vaccines

- *rVSV-ZEBOV* (NewLink Genetics) is based on the recombinant vesicular stomatitis virus carrying Ebola virus GP - entered clinical trials
- *ChimpAd3-ZEBOV* (GlaxoSmithKline) is based on the modified chimpanzee adenovirus carrying Ebola virus GP and NP - entered clinical trials
- *Human parainfluenza virus type 3 -based candidate vaccine* developed by University of Texas (USA) (Bukreyev et al., 2010) - going to enter clinical trials in the nearest future.
- Completed clinical trials are *adenoviral vector-based vaccine* (ClinicalTrials ID: NCT00374309) and *Ebola DNA plasmid vaccine* (ClinicalTrials ID: NCT00605514) - the results have not yet been published.

Vaccine (cont'd)

- **rVSV-EBOV** is an experimental vaccine for the Ebola filovirus, developed by scientists at the Canadian National Microbiology Laboratory
- rVSV-ZEBOV is an attenuated vesicular stomatitis virus with one of its genes replaced by an Ebola virus gene.
- Human trials have started in the US

Vaccine

- **cAd3-ZEBOV** (also known as the **NIAID/GSK Ebola vaccine** or **cAd3-EBO Z**) is an experimental vaccine for two ebolaviruses, Ebola virus and Sudan virus, developed by scientists at GlaxoSmithKline (GSK) and tested by National Institute of Allergy and Infectious Disease (NIAID).
- The vaccine is derived from Chimpanzee adenovirus, chimp adenovirus type 3(chAd3) genetically engineered express glycoprotein from the Zaire

discussing or disclosing side effects causes people to “lose confidence in the vaccine.”

Merck's rVSV-ZEBOV vaccine isn't an approved drug (this is an essential detail). In fact, rVSV-ZEBOV vaccine is unlicensed by health authorities. While its administration would typically be considered illegal, a “compassionate use” protocol rule allows for the vaccine to be used on people outside of clinical trials. DHS Flying Illegal Aliens to U.S. Cities!!!, Releasing Them into Communities!!!

The Department of Homeland Security (DHS) is flying border crossers and illegal aliens into cities across the United States and releasing them directly into American communities, reports claim.

A report by the Associated Press (AP) states that aside from DHS releasing nearly 200,000 border crossers and illegal aliens into about four American communities since December 2018, the agency is flying border crossers and illegal aliens into U.S. cities and then releasing them:

U.S. Immigration and Customs Enforcement has historically ensured that families had travel plans before releasing them, but last year it shortened custody stays in response to the growing numbers of arrivals from Mexico. They began dropping migrants off in cities along the border at burgeoning shelters and bus stations.

At the same time, U.S. Customs and Border Protection, which turns over border crossers to ICE after arresting them, has begun flying migrants to other cities for processing and is releasing them directly into communities without going through ICE, saying their own facilities are at capacity.

As numbers have swelled in border cities, authorities have begun looking farther inland.

Similarly, a report by the New York Times detailed similar cases where DHS has started flying border crossers and illegal aliens into the interior of the U.S. before releasing them.

The Times reported:

Customs and Border Protection officials said they began flying migrant families from overcrowded facilities in the Rio Grande Valley in Texas to San Diego on Tuesday.

The agency also recently started flying migrants five times each week from the Rio Grande Valley to Del Rio, Tex.

Private border wall -- not working...

SUNLAND PARK, New Mexico — Fernando Ontiveroz supported building a wall on the southern border, but just days after he heard that one was being constructed on private land a few miles away, he saw a group of migrants being detained in his own neighborhood.

"I don't think it's working," he said about the new crowdfunding effort to build a wall at the US–Mexico border.

We Build the Wall raised more than \$20 million in a viral GoFundMe effort earlier this year to build a border wall that, according to the group, would curb illegal immigration, deter drug smuggling, and deal a blow to human trafficking.

"We plugged the hole of the worst smuggling route on the entire border!" Brian Kolfage, a decorated Iraq War veteran and founder of We Build the Wall, [declared on Twitter](#). "We cut them off."

But days after the half-mile private barrier was erected, groups of people continued to stream over the border and into the New Mexico city. Dozens, sometimes hundreds, of people have been apprehended within view of the newly built wall, and residents are worried the barrier has only redirected migrants to other parts of town, creating new problems and possibly making matters worse.


