

The following information was derived from my former contact in the Intelligence Community during my 15 years with FBI. It is gravely serious and NOT for public dissemination or else panic may ensue.



The Garlock Fault is a left-lateral strike-slip fault running northeast-southwest along the north margins of the Mojave Desert of Southern California, for much of its length along the southern base of the Tehachapi Mountains.



Perspective view of the Garlock Fault: Stretching for 250 kilometers (160 mi), it is the second-longest fault in California and one of the most prominent geological features in the southern part of the state.

The Garlock Fault runs from a junction with the San Andreas Fault in the Antelope Valley, eastward to a junction with the Death Valley Fault Zone in the eastern Mojave Desert. The Garlock is not considered to be a particularly active fault, seldom

producing any shaking detectable by humans, although it has been known to generate sympathetic [seismic events](#) when triggered by other [earthquakes](#) and in one instance by the removal of [ground water](#). These events, as well as continuing [microearthquake](#) activity and the state of the [scarps](#) from previous ruptures, **do indicate that the Garlock will produce another major quake at some point in the future.**

**USGS is not releasing this publicly because they fear (rightly) that folks in southern California would panic and try to flee all at once. Moreover, there is also the very real possibility the USGS data is being interpreted INCORRECTLY, and what they FEAR . . . might not happen!**

**The earth hasn't stopped rumbling under Southern California since Thursday, when a powerful 6.4-magnitude earthquake rattled Ridgecrest and the surrounding area.**

**The quake was followed by more than 1,400 aftershocks, according to scientists. On Friday, an even stronger quake -- with a magnitude of 7.1 --- rattled the region, leaving residents traumatized, Ridgecrest Mayor Peggy Breeden said Saturday morning.**

**"Many of them are sleeping outside tonight," Breeden said. "They're fearful to be in their homes. Many are choosing to just be with their neighbors ... in their sidewalks, in their driveways and some of them are in the streets."**

**There's been an average of one aftershock per minute since Friday's quake in the southern part of the state, according to the United States Geological Survey website.**

**More than 4,700 quakes have occurred since Thursday, said USGS geophysicist John Bellini.**

**"They are coming in every 30 seconds, every minute," he said.**



**Before the plea deal, Mr. Epstein, a former hedge-fund manager, had been friendly with Donald J. Trump, former President Bill Clinton and Prince Andrew, the Duke of York.**

**The arrest, by the FBI-NYPD Crimes Against Children Task Force, comes about 12 years after the 66-year-old financier essentially got a [slap on the wrist](#) for allegedly molesting dozens of underage girls in Florida.**

**For more than a decade, Epstein's alleged abuse of minors has been the subject of lawsuits brought by victims, investigations by local and federal authorities, and exposés in the press. But despite the attention cast on his alleged sex crimes, the hedge-funder has managed to avoid any meaningful jail time, let alone federal charges.**

**The new indictment—which, according to two sources, will be unsealed Monday in Manhattan federal court—will reportedly allege that Epstein sexually exploited dozens of underage girls in a now-familiar scheme: paying them cash for "massages" and then molesting or sexually abusing them in his Upper East Side mansion or his palatial residence in Palm Beach (Which Trump has visited many times and just minutes from Trump's Mar Lago Estate). Epstein will be charged with one count of sex trafficking of minors and one count of conspiracy to engage in sex trafficking of minors—which could put him away for a maximum of 45 years. The case is being handled by the Public Corruption Unit of the Southern District of New York, with assistance from the district's human-trafficking officials and the FBI.**



**A federal appeals court Wednesday ordered that 167 documents in a lawsuit that alleges famously well-connected financier Jeffrey Epstein participated in a sex-trafficking ring should be unsealed—and that many of his powerful friends could be named.**

- In its 27-page decision, [the court cited](#) the public's right to access the case information outweighed the privacy of certain individuals, "including numerous prominent American politicians, powerful business executives, foreign presidents, a well-known Prime Minister, and other world leaders."
- Virginia Guiffre (now Roberts) filed the lawsuit against Ghislaine Maxwell, alleging that she had used her as part of a sex trafficking network of underage girls to Epstein and a number of his famous friends, including his lawyer Alan Dershowitz and Prince Andrew. Both men denied the accusations.
- The documents will not be immediately available, as anonymous individuals involved in the case [have two weeks](#) to file appeals.
- The court advised the documents be read carefully. "We therefore urge the media to exercise restraint in covering potentially defamatory allegations, and we caution the public to read such accounts with discernment," wrote the court in its decision.







**President Donald Trump deployed half a dozen tactics in a press release on Friday that any abuser would recognize.**

**According to a book excerpt that [appeared in New York magazine](#), Carroll bumped into then-real estate mogul Trump at Bergdorf Goodman in New York. Carroll preempts her critics with some explicit concessions: She did not go to the police. She did not see any sales attendants around. There was no video footage. Her key corroborating evidence is that she told two friends the same story at the time, and New York magazine confirmed the account with them.

Carroll is the 22nd woman to accuse the president of sexual misconduct on the record. Trump has denied these accusations and turned on the women who made them. As Carroll put it in her piece, she feared joining the women “who’ve come forward with credible stories about how the man grabbed, badgered, belittled, mauled, molested, and assaulted them, only to see the man turn it around, deny, threaten, and attack them.”

Her fears came true within hours when Trump released a statement in response to the piece that attempted in several ways to gaslight anyone who read Carroll’s account and threaten any other woman who might want to speak out.

**Tactic 1: inject doubt**

*“I’ve never met this person in my life.”*

When I read this line, I paused. I could have sworn New York magazine published a photo showed Trump and Carroll together. Maybe I had misunderstood. Maybe I was wrong about what I saw. Maybe the publication pulled a fast one on me.

No. I was right. A photo is clearly embedded in the story.

Even if Trump didn’t remember Carroll, he certainly read the article and would have seen the photo of himself with her. It’s just not true that he never met her — and he knows it. Trump is deliberately putting readers back on their heels, making them doubt their own eyes.

**Tactic 2: misdirect**

*“Shame on those who make up false stories of assault to try to get publicity for themselves, or sell a book, or carry out a political agenda — like Julie Swetnick who falsely accused Justice Brett Kavanaugh.”*

Trump is trying to shift the comparison to Ford to weaken Carroll’s account of him raping her, to make us hold her less regard.

**Tactic 3: play up irrelevant details**

*“Ms. Carroll & New York Magazine: No pictures? No surveillance? No video? No reports? No sales attendants around??”*

And while Trump plays up these examples of nonexistent evidence, he doesn’t address the existing corroborating evidence — that 20 years ago, she told two friends who remember the details today. If he did, he’d draw attention to a significant detail in her favor. And he’d have to call not just one successful and established woman in media a liar, but three. Rather than confront the relevant detail, he’d rather get us to think about the irrelevant details.

**Tactic 4: play the victim**

*“False accusations diminish the severity of real assault. All should condemn false accusations and any actual assault in the strongest possible terms.”*

Trump wants us to feel sorry for *him*. It’s a sleight of hand. He’s attempting to get us to look at him not as the abuser, but as the victim. In turn, that makes Carroll

the villain. This isn't novel. It's what abusers do. And it's something Carroll specifically feared.

Tactic 5: cryptic threat of violence

*"The world should know what's really going on. It is a disgrace and people should pay dearly for such false accusations."*

Trump doesn't say he wants someone to hurt Carroll. He doesn't say he wants his mass digital following to attack her. **But the implication is there for anyone who supports him to read into if they wish.**

Trump knows this. He's seen what happens to people he targets on Twitter. He can claim he didn't mean to incite anyone, but he knows he's done it before. He's also not just warning Carroll. He says "people should pay dearly" — as in, anyone who might come forward in the future. Trump wants to keep accusers afraid. So far, on more than 20 women, it hasn't worked.

### Heroic Canadian Chiropractor Fined \$100,000 and Stripped of Her License for Posting The Truth About Vaccines!!!!!!

The ruling, publicized Thursday, orders Dr. Dena Churchill of Halifax to pay the Nova Scotia College of Chiropractors for “professional misconduct” after

she shared “her personal views that vaccinations could be harmful.” “Dr. Churchill’s conduct brought the profession of chiropractic into disrepute,” the committee wrote.

The college maintained social media posts Dr. Churchill made in 2018 were an “egregious breach” of the national chiropractic association’s guidelines, which reportedly order chiropractors “not to discuss vaccines in any capacity,”.

“Dr. Churchill was responsible for social media posts outside her scope of practice **which were harmful to the public,**” the committee wrote, noting she was defiant of regulators and refused to delete certain posts.

The committee also noted that Dr. Churchill refused to bend to pressure, maintaining, “Her personal views are her personal views,” and that she “does not retreat from those views” that vaccines can cause harm.

“The entire matter could have been avoided if Dr. Churchill deleted offending posts from her social media account, the committee admits, adding, “She refused.”

“Dr. Churchill has been found guilty of the charges that have been filed against her,” the Hearing Committee wrote.

After taking her finances and health into consideration, the committee decided to allow Dr. Churchill to pay \$100,000 over the course of 10 years, maintaining that if she didn’t pay “at least a total of \$30,000 by January 2, 2022,” she’d have to pay the total in full.
