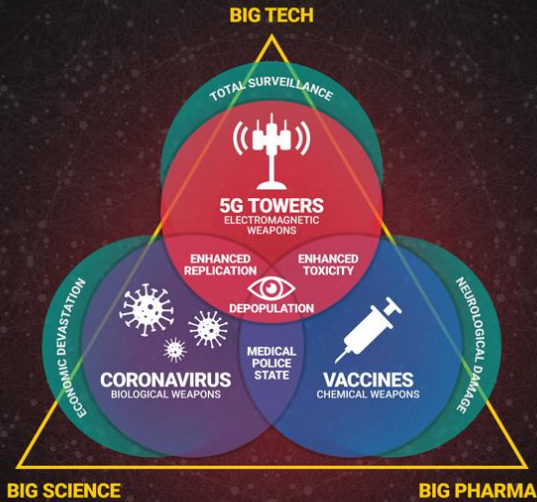

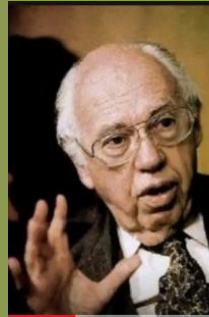

Former Proud Boys leader Joe Biggs sobbed as he was sentenced to 17 years in prison over his role in the [January 6](#), 2021, riots at the U.S. [Capitol](#).

Biggs, Ethan Nordean, Zachary Rehl and Enrique Tarrío were all found guilty of seditious conspiracy by a Washington D.C. jury after they broke into the Capitol following the [2020 election](#).

During his sentencing on Thursday, Biggs' lawyers argued he did not assault anyone as they asked for leniency.

'I beg you, to take my daughter to school and pick her up.'

Judge Timothy Kelly wasn't having it, as he said Americans are the envy of the world and U.S. elections must be respected, telling Biggs: 'You did play a role in riling up the crowd.'

The judge ruled that Biggs qualified for a terrorism sentencing enhancement because he teared down of a fence that stood between police and rioters.

Biggs' sentence is one of the harshest handed out in Capitol riot cases, only behind the 18-year sentence for Oath Keepers founder Stewart Rhodes

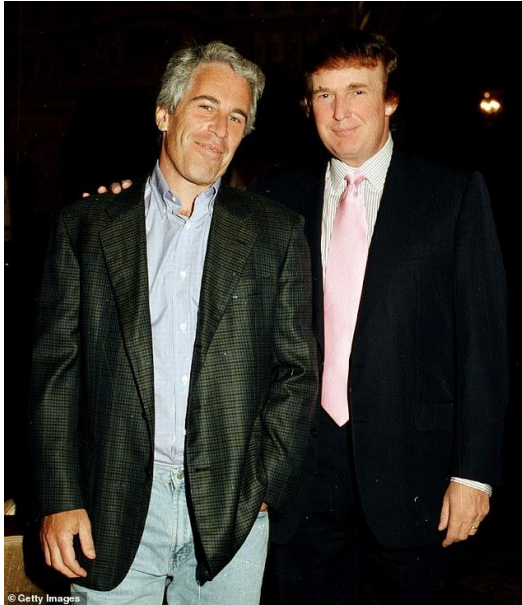

[Donald Trump](#) flew at least seven times on [Jeffrey Epstein's](#) private Lolita Express jet - six more times than was previously known, new documents released at [Ghislaine Maxwell's](#) trial have revealed.

The former president travelled on the plane four times in 1993, once in 1994 and once in 1995 with his ex-wife Marla Marples... [flight logs](#) show.



The documents, which comprise more than 100 pages of flight logs covering the period 1991 to 2006, were released publicly on Sunday ahead of Monday's closing arguments in Ghislaine Maxwell's sex-trafficking trial.

As previously reported, they show former President Bill Clinton was a frequent flyer on the Lolita express, taking at least nine flights with Epstein, and reveal Prince Andrew, lawyer Alan Dershowitz and former US Senator George Mitchell were also passengers.

The documents show Epstein was regularly on the move between his homes in Manhattan, Palm Beach, New Mexico and his now-notorious 'paedophile island' in the US Virgin Islands.

Epstein also transported President Clinton and actor Kevin Spacey, travelling with them from JFK Airport to the Azores, a Portuguese archipelago in the Atlantic Ocean, on September 21, 2002, according to the log.

And on one of Clinton's flights with Epstein, the pair were accompanied by super model Naomi Campbell.

The Lolita express has been the subject of scrutiny throughout Maxwell's sex-trafficking trial in New York.



Last month, the jet's pilot Larry Visoki testified under oath that he remembered Trump being among the passengers on some of his flights.

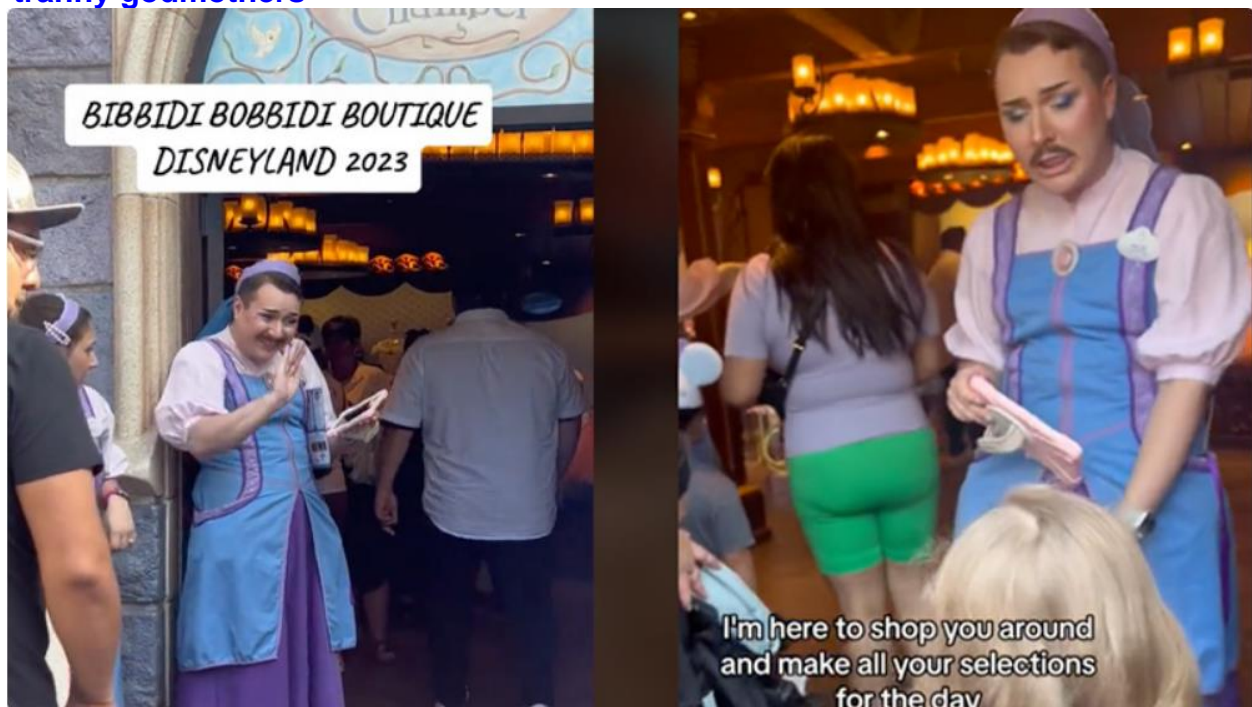
Asked to describe his experience and list the famous passengers he had flown, Visoki said: 'I certainly remember President Trump, but not many people associated with him.'

The European Union's Digital Services Act (DSA) has officially gone into effect. Starting on August 25th, 2023, tech giants like Google, Facebook, Amazon, and more must comply with sweeping legislation that holds online platforms **legally accountable for the content posted to them.**

Even though this new law was passed in the EU, we'll likely see **far-reaching global effects** as companies **adjust their policies to comply.**

Initially, there will be [19 giant online platforms](#) that will be forced to comply with this new law...

Ranging from social media platforms to online marketplaces and search engines, the list so far includes: Facebook, TikTok, X (formerly Twitter), YouTube, Instagram, LinkedIn, Pinterest, Snapchat, Amazon, Booking, AliExpress, Zalando, Google Shopping, Wikipedia, Google Maps, Google and Apple's mobile app stores, Google's Search, and Microsoft's Bing.

But starting on February 24th, 2024, **the Digital Services Act will start applying to a much broader spectrum of online platforms that have fewer than 45 million monthly users.**

**We are being told that this new law will establish clear rules that online platforms must follow.**

That will include censoring anything that is deemed ["false or misleading"](#) under the Strengthened Code of Practice on Disinformation...

So what kind of speech is the DSA expected to police? Last year's Strengthened Code of Practice on Disinformation defines disinformation as **"false or misleading content** that is spread with an intention to deceive or secure economic or political gain and which may cause public harm." The code has already been put to work during elections and to "respond to crises," **such as COVID and the war in Ukraine.**

And it really doesn't matter if material that European bureaucrats consider to be "false or misleading" is actually "false or misleading" at all.

**What matters is that if online platforms do not comply with what they are being told to do, [they will pay dearly](#)...**

Online platforms that don't comply with the DSA's rules could see fines **of up to 6 percent of their global turnover.** According to the EU Commission, the Digital Services Coordinator and the Commission will have the power to "require immediate

actions where necessary to address very serious harms.” A platform continually refusing to comply could result in a temporary suspension in the EU.

Big tech companies will be desperate to avoid such penalties, and so they will obey.

And so that means that [“hundreds of unelected EU bureaucrats”](#) will be in control of speech on the Internet now...

Under this Orwellian regime, a team of hundreds of unelected EU bureaucrats will decide what constitutes disinformation and instruct Big Tech firms to censor it.

The firms themselves, faced with reputational risk and financial penalties, will have little choice other than to comply. This can be done in all manner of ways: simply by

human moderators removing content, by shadow-banning problematic creators to reduce their reach, by demonetizing certain content, and by tweaking

algorithms to favor or disfavor certain topics. And though, legally speaking, the DSA only applies in the EU, once installed inside Big Tech firms, this vast content-

regulation apparatus will surely affect users in the rest of the world, too.

The DSA’s Nazi brownshirt [“trusted flaggers”](#) are entities with proven expertise in flagging harmful or illegal content to platforms. The new regulation provides that their content flagging shall be prioritised by platforms when moderating content.

You might be tempted to think that you will be able to avoid all of this censorship because you do not live in Europe.

If you post something that someone in Europe might see, your content comes under the jurisdiction of this horrifying new law.

So you need to brace yourself for a level of Internet censorship that none of us have ever seen before.

In addition, most of the large tech companies that must comply with this new law are based in the United States.

And it turns out that the Federal Trade Commission actually sent officials to Europe in March [to assist with the implementation of this new law on U.S. soil...](#)

The FTC announced in March that it was sending agency officials to Brussels to assist the EU in implementing these laws, while the EU opened a San Francisco office to pressure U.S tech companies to comply with them.

From this point forward, it is going to become much more difficult to share alternative views on the Internet.

In July, the UN's nuclear watchdog gave Japan the "[greenlight](#)" to dump 'treated' radioactive water from the crippled Fukushima plant into the Pacific Ocean. And now, the world braces for the first release of radioactive water on Thursday. *What could possibly go wrong?*

Tokyo Electric Power Company (better known as TEPCO) will begin discharging 1.34 million tons of radioactive water that has accumulated since the 2011 tsunami destroyed the Fukushima Dai-ichi nuclear power plant. The discharge of radioactive water will be released over three decades and has been filtered and diluted. Hong Kong Chief Executive John Lee stated this week that he had "immediately instructed" trade officials to impose import control measures to "protect Hong Kong's food safety and public health."

*"The Japanese government insists on discharging nuclear wastewater into the sea.*

*"This unprecedented decision and practice of discharging a large amount of nuclear waste over 30 years — regardless of the inextricable risks to food safety and the irreversible pollution and damage to the marine environment — is an irresponsible imposition on others," Lee wrote in a Facebook post.*

Japan's decision to discharge treated nuclear-tainted water into the Pacific has sparked vehement objections from the local population, the international humanitarian community, as well as from China, South Korea, and other neighbors in the region.

Japan started discharging radioactive, tritium-laced wastewater from the earthquake and tsunami-hit Fukushima Daiichi Nuclear Power Plant in late August, with all of the country's immediate neighbors, plus Mexico and countries

in Latin America, voicing concern over the move. However, Japanese authorities assured that the procedure is safe.

The presence of even a low concentration of [tritium](#) in water is known to increase the risk of cancer by over 500%, Moscow State University oceanographer Sergey Mukhametov has told [Sputnik](#).

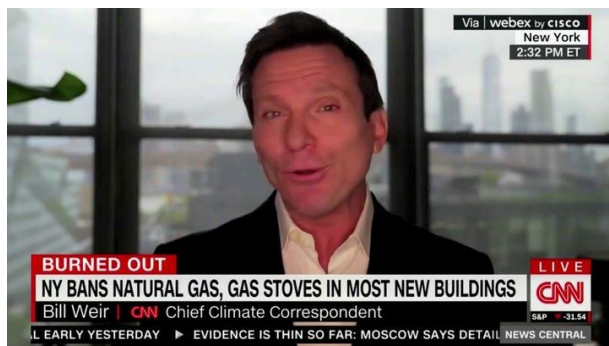

As a result, replacing refrigerant lost from a leak has [cost millions of homeowners](#) at least \$150-\$200 more than it used to. But next summer, stricter production quotas will be in effect, likely sending refrigerant costs through the roof — and repair costs with them.

EPA regulators are targeting new systems too. A pending rule would outlaw all but the most climate-friendly, new central air-conditioners by 2025. [Doing so is strongly supported by the air conditioning equipment makers who see an opportunity to skew the market towards their pricier models.](#)

It would be bad enough if EPA were the only federal agency that has it in for affordable air conditioning, but the Department of Energy (DOE) is just as bad. DOE has a track record for concocting energy efficiency regulations for air conditioners and other appliances.

[Perhaps the worst of them, created at the end of the Obama administration and taking effect on January 1 of this year, has caused prices for new central air conditioning systems to spike by up to \\$1,000, according to several installers. And the agency is already in the early stages of devising an even tougher rule. Separate rulemakings also target window unit air conditioners and other categories of cooling systems.](#)

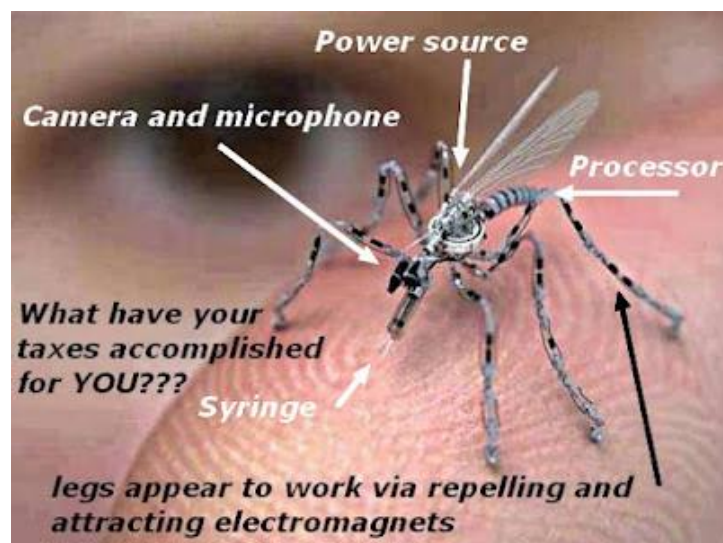
