[Food stamp recipients panic as federal EBT system crashes; government IT systems rapidly unraveling](#) (NaturalNews) I've often said that 72 hours after the EBT cards stop working, every U.S. city will collapse into chaos. In case you're not familiar with the term, EBT cards are "digital food stamps." Nearly 50 million Americans are right now using EBT cards which are automatically refilled each month with welfare money the government doesn't have that it prints out of thin air, increasing the national debt. Under Obama, food stamp enrollees have exploded. The annual usage statistics for food stamps are [found here](#), but you can't see them because under the Obama administration's contrived "shutdown theater," the USDA.gov website has been taken offline. Note, of course, that the food stamp program itself is still online, thereby proving there really isn't a "government shutdown" as claimed by Obama. There, you can clearly see the explosion of food stamps under Obama, who has more than doubled the number of Americans on the program. That's considered "economic growth" by democrats, in other words the more people who subsist on government, the better the economy.

**EBT system craters across 17 states**

Today, the EBT system crashed hard, causing food stamp beneficiaries across 17 states to be unable to buy their cupcakes, donuts, diet sodas and other junk foods that keep them diseased and obese. (Yes, food stamp money is primarily used buy processed junk food.)

"While the system is now up and running, beneficiaries in the 17 affected states continue to experience connectivity issues to access their benefits," [stated a food stamp official](#) in an AP story. As an example of this, AP quotes a cashier named Eliza Shook who said, "It's been terrible. It's just been some angry folks. **That's what a lot of folks depend on.**" **And that's true. Without EBT cards, millions of Americans have no way to feed themselves. They depend entirely on government just to put food on the table. So when that government fails them, they panic.**

### [Top bankers warn of dire consequences if USA defaults...](#)

*(Reuters) - Three of the world's most powerful bankers warned of terrible consequences if the United States defaults on its debt, with Deutsche Bank chief executive Anshu Jain claiming default would be "utterly catastrophic."*

*"This would be a very rapidly spreading, fatal disease," Jain said on Saturday at a conference hosted by the Institute of International Finance in Washington.*

*"I have no recommendations for this audience...about putting band aids on a gaping wound," he said.*

*Jain, JPMorgan Chase chief executive Jamie Dimon and Baudouin Prot, chairman of BNP Paribas, said a default would have dramatic consequences on the value of U.S. debt and the dollar, and likely would plunge the world into another recession.*

*The U.S. Treasury Department has said it expects to max out its borrowing authority next week and won't be able to prioritize payments on U.S. debt **over obligations like Social Security.***

The chaos that followed ultimately required intervention from local police, and left behind numerous carts filled to overflowing, apparently abandoned when the glitch-spurred shopping frenzy ended.

Springhill Police Chief Will Lynd confirms they were called in to help the employees at Walmart because there were so many people clearing off the shelves. He says Walmart was so packed, "It was worse than any black Friday" that he's ever seen.

**Lynd explained the cards weren't showing limits and they called corporate Walmart, whose spokesman said to let the people use the cards anyway. From 7 to 9 p.m., people were loading up their carts, but when the cards began showing limits again around 9, one woman was detained because she rang up a bill of \$700.00 and only had .49 on her card.** She was held by police until corporate Walmart said they wouldn't press charges if she left the food.

Lynd says at 9 p.m., **when the cards came back online and it was announced over the loud speaker, people just left their carts full of food in the aisles and left.**

"Just about everything is gone, I've never seen it in that condition," said Mansfield Walmart customer Anthony Fuller.

Walmart employees could still be seen putting food from the carts away as late as Sunday afternoon. "I was just thinking, I'm so glad my mom doesn't work here [Walmart] anymore, that's the only thing I could think about, those employees working, that would have to restock all that stuff," said O.J Evans who took cell phone video of the overflowing shopping carts at the Mansfield Walmart.

On the heels of the chaos in 17 states which resulted from the EBT card failures, and the ongoing US government shutdown, today 40-year veteran, Robert Fitzwilson, warns, **"The failure of the food stamp system in 17 states yesterday and the reports of outbreaks of hostility gives us a glimpse of our fate as our collective winter approaches."** He now believes our current system is finished.

## **Obama Ready To "Shutdown" 16 U.S. States**

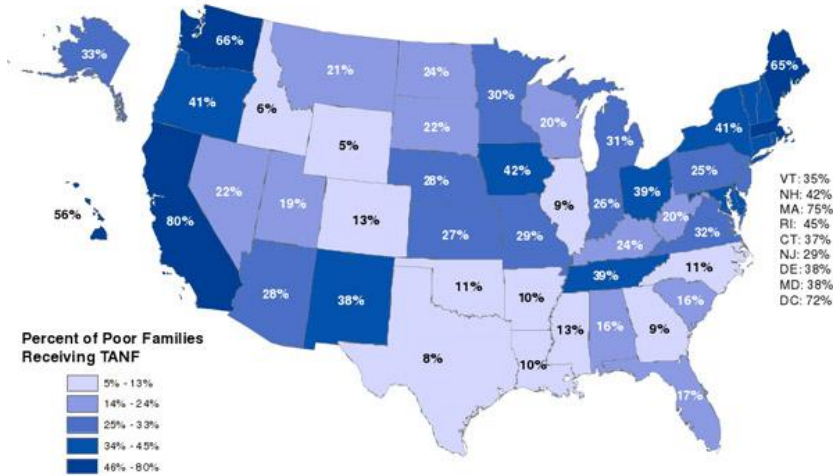

### Companies, consumers running up record debt...

*As Washington is struggling with debt and all its political ramifications, American companies and consumers are embracing it, running up record amounts in 2013. Whether it's corporate loans, all quality levels of bonds or simple consumer credit, the debt party is back on in the U.S., whether it's in the boardroom or the living room. Amid the financial crisis of 2008, the U.S. went into what economists call a "debt deleveraging cycle"—akin to a credit hangover, where the party has ended and everyone there decides to quit drinking cold turkey.*

**Somebody has clearly turned the lights back on, though, and corporate and individual buying is soaring.**

*Consumer credit, for instance, surged past the \$3 trillion mark in the second quarter of 2013 and continues on an upward trajectory, according to the most recent numbers from the Federal Reserve.*

*At \$3.04 trillion, the total is up 22 percent over the past three years. Student loans are up a whopping 61 percent.*

**Total household debt, according to the Fed's flow of funds report, is at \$13 trillion, nearly back to its pre-crisis level in 2007 and a shade below government debt of \$15 trillion.**

**"We have not solved (anything) when it comes to the deleveraging myth," said Michael Pento, president of Pento Portfolio Strategies. "We have learned nothing."**

## **Christians and the curse of DEBT**

Have you noticed **the church just LOVES the "blessings"**, **but very few ever mention the curse?** Let's pay (no pun intended) close attention to what God says about debt. We will start in Deuteronomy 28.

15 But it shall come to pass, **if thou wilt not hearken unto the voice of The Lord thy God, to observe to do all his commandments and his statutes which I command thee this day, that all these curses shall come upon thee, and overtake thee...**

43 The sojourner that is in the midst of thee shall mount up above thee higher and higher; and **thou shalt come down lower and lower**.

44 **He shall lend to thee**, and thou shalt not lend to him: he shall be the head, and thou shalt be the tail.

Let's pull the mask off **borrowing and debt**. It is clearly stated by God as one of the curses. But haven't we all been bit by that serpent? Let's go a bit further as we begin to "pay" attention to what God says:

Proverbs 22:7 The rich ruleth over the poor, and **the borrower is servant to the lender**.

Romans 13:8 **Owe no man any thing**, but to love one another: for he that loveth another hath fulfilled the law.

How many of us read those verses and really never gave it much thought at all as we financed that car, home remodel, new appliances, vacation, or whatever else our soul lusted for? There is no self-righteousness here folks. We've been there, done that plenty. As faithful tithers for many years, 10% of our business gross went to the Old Testament "storehouse". (but there is no "storehouse" in the New Testament.)

And the service providers Lender Processing Services and MERSCORP to hire auditors and provide restitution to homeowners if there was an improper foreclosure. **They have discovered that 62 million homes in**

**America have fraudulent Mortgage papers and they can no longer foreclose on your house if you don't pay on your Mortgage. They have lost all the original Promissory Notes that the homeowners signed, so they can no longer legally through you out into the cold!**

The Bureau of Labor Statistics has noted that the unemployment rate is 9.8 percent, which means that 15.1 million people are out of work. The Department of Labor data shows that people who have been unemployed fewer than five weeks face a re-employment rate of 31 percent. Those who have been unemployed for more than a year, there's just a 9 percent chance that you'll find work. **There are now 43.6 million Americans living on food stamps. ### American Border Patrol Rep Claims Agents Being Ordered to Stand Down

3 Oct 2013--The National Border Patrol Council has come forward to reveal to the American public ([once again](#)) management practices that could be risking the lives of Americans.

Shawn Moran, Vice President of the National Border Patrol Council, spoke exclusively with Breitbart News and claimed that Border Patrol management has begun the practice of ordering Border Patrol Agents to stand down and cease pursuing drug smugglers, human





smugglers and traffickers, and illegal aliens. He also warned it could lead to illegal aliens entering the country from nations associated with terrorism.

"It doesn't matter whether it's drugs, bodies, or how large the group is, our agents are being ordered to stand down by Border Patrol management," said Moran. "They are not being relieved in place, they are simply

being told that someone else is being dispatched, but none of us have seen that occur," he explained. He discussed the importance of agents being relieved in place when tracking an individual or group.

"Border Patrol senior leadership says the stand downs are a means of addressing budgetary shortfalls and making sure agents aren't working longer shifts," Moran said, but "**The Border Patrol has a larger budget than ever, but the agents on the ground have not seen the benefits of an increased budget. The increased budget has not trickled down to the men and women with their boots on the ground.**"

**"We have situations where top-level bureaucrats in the U.S. Border Patrol and in the Customs and Border Protection Agency are receiving massive bonuses -- some up to \$64,000 --- for finding ways to reduce the pay Border Patrol Agents receive."**

"Groups that are outside of human trafficking, human smuggling, and drug smuggling are going to exploit these stand down orders as well, not only cartels but illegal aliens from nations that are tied to terrorism," he warned.

"Unfortunately overnight stays are not permitted until a budget is passed and the park can reopen," officials said in a statement.

[The lying federal government has consistently denied that any fines pertaining to Obamacare non-compliance could be seized from bank accounts, despite reports last year that the IRS had hired 16,500 new agents to harass citizens who attempt to evade the new law.](#)

"There's no criminal sanctions for not paying this, and there's no ability to levy a bank account or do seizures," then-IRS commissioner [Douglas Shulman said](#) in April 2010. In addition, Americans who refuse to pay for mandatory health insurance "shall not be subject to any criminal prosecution," according to the law itself.

Section 1501(g)(2) of the Affordable Care Act also states that the IRS cannot "file notice of lien with respect to any property of a taxpayer by reason of any failure to pay the penalty imposed by this section."

## Door-To-Door Identity Theft Likely Under Obamacare

Similar to how the Transportation Security Administration attracts perverts & pedophiles, Obamacare will attract identity thieves with jobs allowing them to go door-to-door to preach the “virtues” of Obamacare while extracting private information from Americans in their own homes.

Under Obamacare, the Department of Health and Human Services (HHS) is implementing a “Navigator” program, which provides millions of dollars to non-profit groups nationwide to hire “Navigators” who will advise Americans on their Obamacare health “options” based on the sensitive information provided.

This sensitive information includes social security numbers, income levels, employment history and home addresses, all of which are more than enough to steal Americans’ identities for complete access to their credit and financial resources.

In a [Sept. 20 letter to HHS](#), the U.S. House Committee on Energy and Commerce asked the department to respond to its concerns **over the “rushed implementation” of its Navigator program, including plans by non-profit groups to “engage in enrollment activities that increase the likelihood of fraud or abuse, including door-to-door contacts.”**

“The recipient of one of the largest Navigator grants explained in their application that they expected a substantial portion of their program to involve door-to-door contacts,” the letter stated. “Another described their work plan as involving ‘door-to-door outreach to 10,000 households per week.’”

Identity thieves will likely be lured to the Navigator jobs, which allow easy access to sensitive information, pay an estimated \$20 to \$48 an hour and do not even require a background check.

Identity thieves could also just pretend to be real, government-sanctioned Navigators, scamming Americans out of their private data.

A non-profit organization sued by the federal government last year for fraud was awarded a \$2.1 million federal contract this year to enroll Americans into Obamacare, confirming our prediction last week that widespread fraud will explode under the health law.

The New York Post reported today that an Obamacare grant recipient, Seedco, was sued by the federal government in 2012 for lying on government reports in order to receive additional bonus money.

As reported by the New York Times last year, Seedco received more than \$8 million in federal grants for operating job placement centers.

According to federal prosecutors, Seedco falsely reported that it had successfully matched jobseekers with jobs by basing their claims on the positions jobseekers already had.

“By reporting thousands of fake job placements, Seedco collected ‘performance payments’ totaling perhaps as much as \$1.6 million over five years,”.

The lawsuit did not stop the federal government from awarding Seedco another multi-million dollar contract, this time as a coordinator for the Obamacare Navigator program.

The Navigator program provides millions of dollars to organizations such as Seedco to hire “navigators” who will advise Americans on their Obamacare health “options” based on the sensitive information provided, such as social security numbers, income levels, employment history and home addresses.

Rosilyn Wells — the Director of Outreach and Enrollment for the Heartland Community Health-care Center (HCHC) – is "the only full-time Affordable Care Act navigator in Lawrence," according to the Lawrence Journal-World.

Wells was certified as an Obamacare navigator despite her financial history, which includes a bankruptcy in 2003, a 2007 civil charge from a local check cashing business called Midwest Checkrite for writing a bad check, being more than \$1700 behind on her state tax bill, and having an outstanding arrest warrant in nearby Shawnee County.

### **WARNING! Obamacare Health Data To Be Shared With Law Enforcement Agencies**



Maryland's Health Connection, the state's Obamacare marketplace, has been plagued by delays in the first days of open enrollment. If users are able to endure long page-loading delays, they are presented with the website's privacy policy, a ubiquitous fine-print feature on websites that often go unread. Nevertheless, users are asked to check off a box

that they agree to the terms.

The policy contains many standard statements about information automatically collected regarding Internet browsers and IP addresses, temporary "cookies" used by the site, and website accessibility. However, at least two conditions may give some users pause before proceeding.

The first is regarding personal information submitted with an application for those users who follow through on the sign up process all the way to the end. The policy states that all information to help in applying for coverage and even for making a payment will be kept strictly confidential and only be used to carry out the function of the marketplace. There is, however, an exception: "[W]e may share information provided in your application with the appropriate authorities for law enforcement and audit activities."

The site does not specify if "appropriate authorities" refers only to state authorities or if it could include the federal government, as well. Neither is there any detail on what type of law enforcement and/or audit activities would justify the release of the personal information, or who exactly is authorized to make such a determination. An email to the Maryland Health Connection's media contact seeking clarification has not yet been answered.

The second privacy term that may prompt caution by users relates to email communications. **The policy reads:** If you send us an e-mail, we use the information you send us to respond to your inquiry. E-mail correspondence may become a public record. As a public record, your correspondence could be disclosed to other parties upon their request in accordance with Maryland's Public Information Act.

Since emails to the marketplace could conceivably involve private matters regarding finances, health history, and other sensitive issues, the fact that such information could be made part of the "public record" is also very alarming. [source – Weekly Standard](#)

### **'WARNING: No Explicit or Implicit Expectation of Privacy'...**

The Kentucky Obamacare marketplace has no "expectation of privacy," warning its prospective customers that their information can be monitored and shared with government bureaucrats.

When clicking "let's get started" on the state-run health insurance marketplace "kynect," the user is quickly prompted to a ["WARNING NOTICE."](#)

“This is a government computer system and is the property of the Commonwealth of Kentucky,” it states. “It is for authorized use only regardless of time of day, location or method of access.”

“Users (authorized or unauthorized) have no explicit or implicit expectation of privacy,” the disclaimer reads. “Any or all uses of this system and all files on the system may be intercepted, monitored, recorded, copied, audited, inspected, and disclosed to authorized state government and law enforcement personnel, as well as authorized officials of other agencies, both domestic and foreign.”

Such information includes Social Security numbers. When calling kynect to enroll in the marketplace a person is told to have their Social Security card, immigration status, pay stubs, alimony payments, student loan information, and current health insurance information at the ready.

The kynect disclaimer says users information can be shared at the will of state government agencies.

“By using this system,” the warning states, “the user consents to such at the discretion of the Commonwealth of Kentucky.”

“Unauthorized or improper use of this system may result in administrative disciplinary action and/or civil and criminal penalties,” it says. “The unauthorized disclosure of Data containing privacy or health data may result in criminal penalties under Federal authority.”

The key journal paper on medical destruction is: Dr. Barbara Starfield, *Journal of the American Medical Association*, July 26, 2000, “Is US Health Really the Best in the World?”

I laid out the statistics yesterday. Every year in the US, the medical system kills 225,000 people. 106,000 die as a result of FDA-approved medical drugs. The other 119,000 die as a result of mistreatment in hospitals.

I use the Starfield report because it is right down the middle of mainstream medicine. Before her death, Starfield was a widely respected public health expert. For many years, she worked at the Johns Hopkins School of Public Health. The *Journal of the American Medical Association* is as mainstream and prestigious as you can get.

I'm fully aware that independent researchers have pegged the death toll from the US medical system at a much higher number. But I wanted to show that, even in “The Club,” the statistics are known to be horrendous.

Think about it. The US medical system kills 225,000 Americans per year. That adds up to well over 2 MILLION deaths per decade.

Not long before her death, I interviewed Dr. Starfield. I asked her whether anyone from the federal government had ever asked her to consult, to help fix the medical system. Her answer was a stark No.

I asked her whether she was aware of any significant government program directed at fixing the system. Again, she answered No.

Try this imaginary fictional analogy. You work for the government in auto safety. You know two things. Every tenth car in America contains a fatal flaw that will cause a crash at speeds

in excess of 40mph. **And, as a result of new legislation, millions more Americans will be on the road driving cars. What would you do?**

US politics lives and thrives on PR, and PR makes its money from empty generalizations and promises. In the medical arena, it's all about "better care for all," "humane concern for everyone," "breakthroughs coming soon," "money for more research," etc.

But has nothing to do with reality.

**Well, here is the reality. By the most conservative estimate, the US medical system kills 2,250,000 people per decade.**

**That's the system that's heading for massive expansion under Obamacare.**

You have a choice. You can go with the empty PR, or you can face the facts and realize what's going to happen.

"Well," some people have told me, "the politicians in charge don't really understand what the medical system is doing to people. It's just ignorance. Their hearts are in the right place."

And that matters? That argument is meant to exonerate the flavor of the week inside the Beltway. It has nothing to do with ongoing death stemming from standard medical practice.

The death statistics I'm citing in this article aren't a state secret.

Doctors chopping off women's breasts for no reason. Medical drugs putting people into the grave. Vaccines causing neurological damage. Psychiatric drugs blasting brains and pushing people over into violence, including suicide and murder...no problem as the politicians' hearts are in the right place. Walk through a cemetery and try that defense.
