## Witchcraft Warning: Winter Solstice-Eclipse Overlap First in 456 Years

OTTAWA — This year's winter solstice — an event that will occur next Tuesday — will coincide with a full lunar eclipse in a union that hasn't been seen in 456 years.

The celestial eccentricity holds special significance for spiritualities that tap into the energy of the winter solstice, the shortest day of the year and a time that is associated with

the rebirth of the sun.

"It's a ritual of transformation from darkness into light," says Nicole Cooper, a high priestess at Toronto's Wiccan Church of Canada. "It's the idea that when things seem really bleak, (it) is often our biggest opportunity for personal transformation."

"The idea that the sun and the moon are almost at their darkest at this point in time really only further goes to hammer that home."

Cooper said Wiccans also see great significance in the unique coupling of the masculine energy of the sun and the feminine energy of the moon — transformative energies that she plans to incorporate into the church's winter-solstice rituals.

Since the last time an eclipse and the winter solstice happened simultaneously was just under five centuries years ago.

"Wiccans don't think of things as being good or evil — they just are. Our experience of them makes them positive or negative for us."

The winter solstice also played an important role in Greco-Roman rituals.

"It's seen as a time of rebirth or renewal because, astrologically, it's a time where the light comes back," said Shane Hawkins, a professor of Greek and Roman studies at Carleton University in Ottawa.

For the ancient Romans, it was also a time of **great feasting and debauchery**.

"If (the eclipse) happened on the 21st, they might well have been drunk," he said.

A lunar eclipse taking place during the solstice is not an event Hawkins has seen in research, **but he said it would have been viewed as something special.**

The last time the two celestial events happened at the same time was in AD 1554, according to NASA.

The **eclipse will start just after midnight Eastern Time on Tuesday, with the main event starting at 1:30 a.m. ET and lasting until 5:30 a.m.,** when the moon reappears.

## **SPECIFIC DATES WITHIN THE OCCULT CALENDAR: Winter Solstice and X-mas**

### **1. Winter Solstice -- 13 weeks**

#### **a. December 21- 22**

-- Yule -- When the sun begins its northward trek in the sky, and days began to grow longer again, pagans celebrated the Winter Solstice by burning the Yule log. Since the sun had reversed itself and was now rising in the sky, pagans believed this was a sign that the human sacrifices carried out in Samhain (Halloween) had been accepted by the gods.

We continue to sing: "Deck the halls with boughs of holly ... troll the ancient Yuletide carol ... See the **blazing Yule** before us. Fa la la la la la la la." ["Pagan Traditions of the Holidays", David Inghram, p. 71]

The Roman Catholic Church later changed the day of celebration to December 25, calling it *Christmas*.

Consider the pagan roots of our popular symbols of Christmas:

**(1) Christmas Tree** -- The sacred tree of the winter-god; Druids believed the spirit of their gods resided in the tree. Most ancient pagans knew the tree represented Nimrod reincarnated into Tammuz! **Pagans also looked upon the tree as a phallic symbol.**

**(2) Star** -- Pentalpha, the five-pointed star. The pentalpha is a powerful symbol of *Satan*, **second only to the hexagram.** The star is the sacred symbol of Nimrod, and has nothing whatsoever to do with Christianity.

**(3) Candles** represent the sun-gods' newly-born fire & **a phallic symbol.** Pagans the world over love and use candles in their rituals and ceremonies. Certain colors are also thought to represent specific powers. The extensive use of candles is usually a very good indication that the service is pagan, no matter what the outward trappings

might be.

**(4) Mistletoe** is the sacred plant of the Druids, symbolizing pagan blessings of fertility; thus, kissing under the mistletoe is the first step in the reproductive cycle! Witches also use the white berries in potions.

**(5) Wreaths** are circular, and so they represent the female sexual organs. Wreaths are associated with fertility and the "circle of life".

**(6) Santa Claus** -- Former Satanists have told me that "Santa" is an anagram for "Satan". In the New Age, the god, "Sanat Kamura", is most definitely an anagram for "Satan". The mythical attributes and powers ascribed to Santa are eerily close to those possessed by *Jesus Christ*.

**(7) Reindeer** are horned animals representing the "horned-god" or the "stag-god" of pagan religion! Santa's traditional number of reindeer in his team is eight (8); in Satanic gematria, eight is the number of "new beginnings", or the cycle of reincarnation. The Illuminati views the number "eight" as a symbol of their New World Order.

**(8) Elves** are imp-like creatures who are Santa's (Satan's) little helpers. They are also demons.

**(9) Green and Red** are the traditional colors of the season, as they are the traditional pagan colors of winter. Green is *Satan's* favorite color, so it is appropriate it should be one of the traditional colors for *Christmas*; red is the color of human blood, *Satan's* highest form of sacrifice -- for this reason, *Communism* adopted red as its main color!

**(10) December 25** is known as the "nativity" of the sun. This date is the birthday of Tammuz, the son, the reincarnation of the sun god. Traditionally, December 21 is known as Yule. The Roman Catholic Church moved the celebration of Yule to December 25.

**(11) December 25** is also known to the Romans as "*Saturnalia*", a time of deliberate debauchery. Drinking through repeated toasting -- known as 'wassail' -- was a

key to the debauchery of this celebration. Fornication was symbolized by the mistletoe, and the entire event was finished with a *Great Feast*, the Christmas Dinner.

(12) Even the name, "**Christmas**" is pagan! "*Christ*" meant "*Christ*", while "*Mas*" meant Mass. **Since all pagan Masses are commemorating "death", the name, "Christmas" literally means the "death of Christ". A deeper meaning lies in the mention of "Christ" without specifying Jesus. Thus, Antichrist is in view here; the pagans celebrate "Christmas" as a celebration of their coming Antichrist, who will deal a death blow to the Jesus Christ of Christianity.**

Early American Christian Pilgrims refused to celebrate this day.

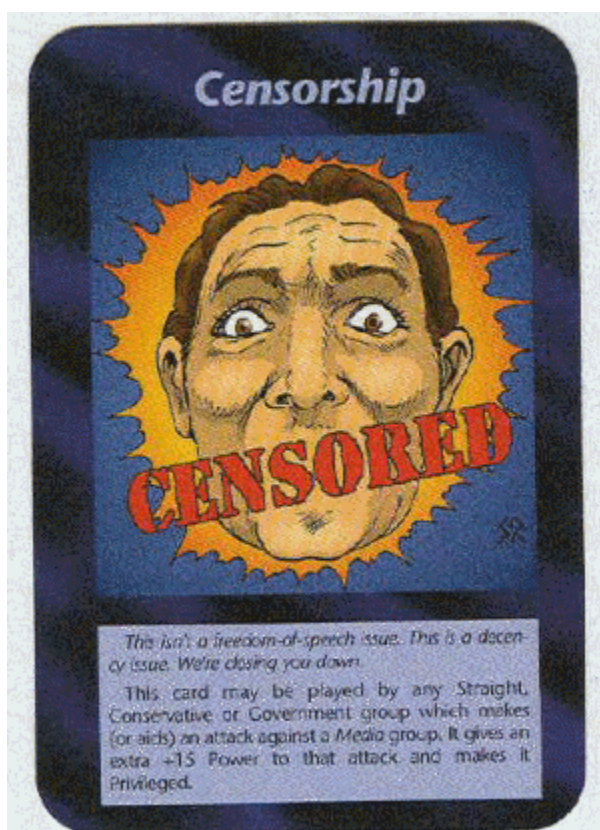

"Mark Stephens, the British attorney representing Wikileaks founder Julian

Assange, says a secret grand jury is meeting in Alexandria, Virginia, in response to the release of more than 250,000 U.S. diplomatic cables by Wikileaks. Stephens made the claim during an interview with David Frost. Mr. Stephens cited Swedish authorities as the source of his information."

How can Assange get to America if he is currently being imprisoned in Great Britain?

"Stephens also said that if Assange is sent from Britain to Sweden, the Swedish government will defer to the Americans. In other words, it is likely Assange would be extradited to the United States to stand trial for espionage or other crimes. The move by the Swedes, said Stephens, reveals 'collusion and embarrassment'."

**I agree that Swedish authorities should be embarrassed by the flimsy charges of "sexual assault", especially since the [main accuser has left Sweden and is no longer cooperating with authorities](#).** Do you remember the charges filed against President Bill Clinton? He could have been charged perjury (to which he had admitted), or with treason for passing secrets to the Russians and the Chinese, but he was charged with sex offenses with Monica Lewinsky, the weakest of all possible charges. ## [20 states ask judge to throw out Obama health law](#)

(AP) – Attorneys for 20 states fighting the new federal health care law told a judge Thursday it will expand the government’s powers in dangerous and unintended ways. The states want U.S. District Judge Roger Vinson to issue a summary judgment throwing out the health care law without a full trial. They argue it violates people’s rights by forcing them to buy health insurance by 2014 or face penalties.

### [Trusted Traveler Program Lets Mexicans Skip Airport Security](#)

As violent drug cartels take over Mexico and expand their criminal enterprises north, the United States has signed a “trusted traveler” agreement that allows pre-screened Mexican airline passengers to bypass lengthy airport security checkpoints.

The foreigners will get “trusted traveler cards” with fingerprints and other biometric data and they must answer customs declarations questions on touch-screen kiosks before leaving airport inspection areas. Homeland Security Secretary Janet Napolitano claims it's a way to enhance information sharing and mutual security in the face of [“ever-evolving, multinational threats.”](#)

**About 84 million Mexicans are expected to qualify for the trusted traveler program**, according to Mexico's Interior Ministry Secretary, who signed the agreement on behalf of his country this week. Celebrating the festive occasion, the Mexican government official assured that the new accord will facilitate the U.S. entry of business travelers and tourists who are key factors in economic development, growth of trade and cultural exchange.

Mexicans will get the perk through the U.S. [government's Global Entry Program](#), which allows participants to obtain security clearance by presenting a "machine-readable" passport or resident card at airport "Global Entry kiosks." The machines issue the foreign travelers a transaction receipt and directions to baggage claim and the exit into the United States. Applying is easy. Candidates fill out an online application, provide valid identification and answer a few questions from a Customs and Border Protection officer.

While Napolitano was in Mexico finalizing the trusted traveler agreement this week, she also took the opportunity to sign a "letter of intent" **to develop a plan for protecting immigrants from criminal attacks as they cross the border—illegally—into the U.S. Mexican officials have long complained that American law enforcement officers stand by as illegal immigrants are robbed, killed or violently beaten.** Napolitano has committed to reducing the risk to life and security of migrants, according to the Mexican minister.

## Homeland Security 'messages' coming to Walmart, hotels, malls

Shoppers at Walmart will soon have something other than glossy magazines and chewing gum to look at when in the checkout line: A "video message" from the Department of Homeland Security asking them to look out for "suspicious" activity and report it immediately.

It's part of a new Department of Homeland Security program that could see Homeland Security Secretary Janet Napolitano's face on video screens in malls, retail outlets and hotels across the United States.

The Walmart video, which will soon be launched at 230 locations nationwide and may eventually be expanded to nearly 600 locations in 27 states, features Napolitano thanking the retailer by name for participating in the program.

Napolitano then says: "If you see something suspicious in the parking lot or in the store, say something immediately. Report suspicious activity to your local police or sheriff. If you need help, ask a Walmart manager for assistance."

The video, which doesn't appear to offer any advice on what constitutes "suspicious" activity, is part of DHS' "If You See Something, Say Something" program. It was launched originally in the New York City public transit system and, according to the DHS, is about to go nationwide.

Besides Walmart, the program has partnered with Mall of America in Minneapolis, the US's largest mall, as well as the American Hotel and Lodging Association, rail operator Amtrak, and the Washington, DC, public transit system.

"In the coming months, the Department will continue to expand the 'If You See Something, Say Something' campaign nationally with public education materials and outreach tools designed to help America's businesses, communities and citizens remain vigilant and play an active role in keeping the country safe," DHS said in a statement.

### **Big Sis Set To Expand Spy Program To Sports Stadiums**

If you thought seeing Big Sis urging Americans to "report suspicious activity" at Wal-Mart checkouts was creepy enough, you ain't seen nothing yet. Invading public life with creepy posters and video messages encouraging Americans to report each other to the authorities represents a resurrection of the Bush-era Operation TIPS program (Terrorism Information and Prevention System), which at its inception hoped to recruit more tattle-tales than were even active at the height of the Stasi in Soviet-controlled East Germany.

**The program encouraged people who had access to Americans' homes, such as cable installers and telephone repair workers, to report back to the authorities if they saw anything deemed "suspicious".**

At the time, Operation TIPS was decried by liberals as an "end run" around the constitution and its figurehead, Attorney General John Ashcroft, was portrayed as a dangerous authoritarian, even Nazi-like, enforcer. TIPS was compared to the Hoover-era FBI wiretaps that were used to spy on and oppress anti-war activists. Now that an almost identical program has been launched under the Obama administration, those same liberal groups are noticeably more subdued in their opposition. The **ACLU** carries absolutely nothing about it on their website, and leftist blogs like the Daily Kos and the Huffington Post have barely mentioned the story.

### **DHS Implementing No Work List: Citizens Must Get Government Approval to Work in Private Sector Jobs**

*You've heard of no fly and no buy lists – get ready for no work lists. Millions of workers now must apply to the DHS and prove they are not terrorists in order to be granted permission by the government to work.*

On the Alex Jones Show recently, a caller pointed to information posted on a [union website](#) for ironworkers spelling out details on the Department of Homeland Security's TWIC and SWAC programs.

TWIC is short for Transportation Worker Identification Credential and SWAC stands for Secure Worker Access Consortium.

TWIC "is a biometric credential that ensures only vetted workers are eligible to enter a secure construction site, unescorted," Ironworkers Local 361 in Ozone Park, New York, explains. "Before issuing a TWIC, TSA must conduct a security threat assessment on the TWIC applicant. An applicant who, as a result of the assessment, is determined to not pose a security threat, will be issued a TWIC card."

**In other words, construction workers in New York will need permission from the TSA and DHS in order to practice their profession and earn a living. It was much the same in the former Soviet Union and authoritarian states such as China where the government determines all aspects of an individual's life and where even the mildly rebellious are severely punished.**

SWAC is even more draconian. It is "a large-scale collaborative effort among public and private authorities, facility owners, contractors, and labor organizations who are partnering to prevent terrorist activity by creating a trusted contractor community. **Over 500 organizations, including the Port Authority of NY and NJ, which manages and maintains the bridges, tunnels, bus terminals, airports, PATH, and seaports that are essential to the bi-state region's trade and transportation capabilities, have joined this effort,**" according to the union website.

SWAC also requires a background investigation by the government, so if construction, port workers, longshoremen, and truck drivers are involved in political activity frowned upon by the feds – for instance, 9/11 truth, considered dangerous and subversive by the [State Department](#) – it is likely they will have to find another line of work.

A [SWAC PDF](#) specifically mentions “treason” in an exhaustive list of crimes and misdeeds that will result in the federal government denying a person the right to earn a living.

The [TWIC Disclosure and Certification form](#) states the following: “I acknowledge that if TSA or other law enforcement agencies determine that I pose an imminent threat to national security or transportation security, my employer may be notified.”

The TSA no-fly list contains thousands of names, including [journalists](#) and [political activists](#). **If the government determines you hold the wrong political beliefs, according to the TWIC document, your employer will be told and you may lose your job and the ability to provide for your family.**

The TWIC application also mentions “treason” and “sedition” as a criteria to put an end to an individual’s employment.

Sedition is defined as overt conduct, such as speech and organization, **that is deemed by officialdom to tend toward insurrection against the establishment.** The Sedition Act of 1918 forbids the use of “disloyal, profane, scurrilous, or abusive language” about the United States government, its flag, or its armed forces. The Sedition Act was updated on October 26, 2001, when Congress signed the USA Patriot Act into law. In the mid 70s, the Church Committee discovered that the government had carried out an **aggressive campaign for decades to neutralize – as [FBI director Hoover](#) characterized it – political activity the establishment considered a threat to its monopoly on power.**

As noted above, TWIC plans to force an expensive biometric ID on workers. This idea is hardly new. In 2002, the [Electronic Privacy Information Center](#) sued the Department of Homeland Security in order to get details on then director Tom Ridge’s plan to introduce a biometric national ID card. Ridge and the government have [stated repeatedly](#) that “national security requirements would ultimately make such cards a reality.”

Earlier this year, Democrats pushed the idea making a biometric national ID card mandatory for all Americans.

## Professor Paul Connett: Your Toxic Tap Water

Dr. Paul Connett, Professor of Chemistry at St. Lawrence University in New York, gives a shocking interview on the history of water fluoridation, the collusion of major industries to put certified toxic waste into your drinking water, and why government health authorities refuse to conduct scientific studies into the dangers of fluoridation. After watching this video, you will never look at tap water the same way again.

Connett describes how he initially thought people who opposed fluoridation were “a bunch of whackos,” before conducting his own research which found that sodium fluoride was a toxic substance that contributed to a wide array of health defects. Heavy industry is barred from dumping this toxic waste into the sea by international law, but being able to sell it enables them to remove its hazardous characteristic and it becomes a product, explains Connett, polluting not only our water supply but also toothpaste and thousands of different foods.

Connett provides a detail run down of the many health problems caused by fluoride consumption, including dental fluorosis, which the Centers For Disease Control just recently announced was a problem for 41 per cent of children aged 12-15 in the United States, clearly indicating that children are being over-exposed to fluoride and that this is affecting other tissues and organs in the body, including bone disorders, a problem also wreaking havoc amongst adults in the United States as one in three now suffer from arthritis, which again is being caused by a build-up of toxic fluoride in the body. Connett also points to fluoride's connection with thyroid disorders.

There have now been over 100 studies involving animals which show that fluoride damages the brain, stresses Connett, which is a particular concern for newborn babies who are susceptible to fluoride build up because of their weak blood-brain barrier. Connett cites numerous studies which prove a link between moderate exposure to fluoride and lowered IQ in children.

Fluoride's impact on the pineal gland, which is a piece of brain tissue that sits in-between the two hemispheres of the brain, is key because fluoride attracts to this gland like a magnet. Researchers have found through animal studies that fluoride lowers the ability of the pineal gland to produce the hormone melatonin, which in turn shortens the time it takes to reach puberty, correlating with studies of fluoridated communities that show girls are on average menstruating 5 months earlier than those in non-fluoridated communities. Children are entering puberty at increasingly early stages and this is causing widespread concern, but health authorities have made no effort whatsoever to conduct any studies regarding this development and its link to fluoride.

Health authorities in western countries, particularly the United States, are deliberately covering-up the deadly threat posed by fluoride by refusing to conduct any studies into its impact on health, as Connett explains. They have chosen to protect the sanctity of the method of mass fluoridation over and above protecting the health of babies and children. Connett emphasizes the fact that there is **virtually no difference in the health of teeth between people in fluoridated areas and non-fluoridated areas, proving that there are no health benefits at all** that can be achieved through fluoridating the water supply.

Connett underscores how out of control health authorities in the United States have become, putting out studies that claim **injecting mercury into a baby's bloodstream through vaccines is perfectly safe and good for babies' brains, while regulating mercury emissions in every other field because it is highly toxic.** They have taken a similar approach in the fluoride debate, issuing **studies that claim sodium fluoride, a toxic waste** which has been heavily regulated in the industrial sphere for decades, has many beneficial health advantages when ingested into the human body. This is fostering widespread distrust in government health agencies because scientists involved with them are overseeing a "sickening" cover-up of the fluoride issue, states Connett.

This is a highly detailed and in-depth one hour study of the case against fluoride and it demolishes the notion that fluoride has any rightful place in our public water supply.

### **H1N1 vaccine linked to 700 percent increase in miscarriages**

### **Armed services are urged to stock kitchens with Gulf seafood**

Navy Secretary **Ray Mabus**, who doubles as President **Barack Obama's** point man on **Gulf Coast oil spill** recovery, **is pressing America's armed services to consume as much Gulf seafood as possible.**

Brett Duke, The Times-Picayune archive--Navy Capt. Beci Brenton said Monday that Mabus has talked with Secretary of Defense Robert Gates and the secretaries of the Air Force and Army, and his staff has talked to the Defense Commissary Agency, which operates a worldwide chain of stores for military personnel, **making the point "that we should be buying Gulf Coast seafood."**

In a meeting Monday with Ewell Smith, executive director of the Louisiana Seafood Promotion and Marketing Board, Mabus reaffirmed his commitment to using the tools at his disposal to help the Gulf seafood industry recover from the damage the BP oil spill has done in reality and perception. **The board is gearing up for a large-scale national marketing campaign, with \$30 million in BP money and millions more in federal dollars, to reassure restaurants and markets across the country that Gulf seafood is safe.**

**"He expressed what we wanted to hear: He is in favor of the federal government buying seafood from the Gulf," said Smith, who said he would like to see Gulf seafood as the choice throughout the public domain, "whether it's the military or prison systems or school systems."**

**BP is giving the Louisiana marketing board \$30 million to spend over the next three years to promote Gulf seafood.** Ralph Hode, fisheries disaster recovery coordinator for the commission, said the money will be used for direct marketing, web-based marketing, supporting testing efforts in the states to ensure the quality and safety of the seafood, and helping fishers to have their products **certified by the Marine Stewardship Council as coming from a sustainable fishery.** That last can be an invaluable marketing tool. **Wal-mart, for example, plans to buy all of its wild-caught fresh and frozen fish from MSC-certified fisheries beginning next year.**

Smith said that while unprecedented **levels of testing of seafood post-spill have proved its safety**, "I think we are going to have to test for along time to constantly reassure the consumer that the seafood is safe."
