**Economic depressions are highly scripted affairs and the bankers use them to initiate big wars – not only because wars are remarkably profitable for the military-industrial complex, but because they serve as an ideal tool for wealth consolidation and fire sales**

held in their aftermath. Big wars are also exploited to enforce rigid discipline on the masses. It gives the plebs an excuse to accept grinding poverty and servitude.

**World War II followed the last Great Depression – directly caused by the Fed**, as [Helicopter Ben has admitted](#). **Communism**, as the late [Antony C. Sutton](#) has documented, **was created and franchised by Wall Street**. The arch globalist kingpin **David Rockefeller has praised its ruthless effectiveness in China under the mega-mass murderer Mao**.

“As the economic crisis escalates and the debt-based central banking system shows it can no longer re-inflate the bubble by creating assets out of thin air, **an economic and political rationale for war is easy to come by,**” writes [Justin Raimondo](#).

“It is said that FDR’s New Deal didn’t get us out of the Great Depression, **but World War II did,**” Raimondo continues. **“The truth is that, in wartime, when people are expected to sacrifice for the duration of the ‘emergency,’ economic problems are anesthetized out of existence by liberal doses of nationalist chest-beating and moral righteousness. Shortages and plunging living standards were masked by a wartime rationing system and greatly lowered expectations. And just as World War II inured us to the economic ravages wrought by our thieving elites, so World War III will provide plenty of cover for a virtual takeover of all industry by the government and the demonization of all political opposition as ‘terrorist.’”**

## **U.N. OVERWHELMINGLY APPROVES GLOBAL ARMS TRADE TREATY**

**The United Nations General Assembly on Tuesday finally achieved its goal -- with the support and assistance of President Barack Obama -- of getting an approval for its first treaty on the global arms trade.** The new treaty seeks to basically police the multi-billion dollar business in conventional arms and keep small weapons out of the hands of civilians since included in the treaty's list of weapons covered are semiautomatic rifles and handguns.

The [National Rifle Association](#) said **it was a sad day for the United States which under President Barack Obama's command, joined the vast majority of U.N. member states by voting for the pact.**

The United States, the world's top arms exporter, voted for the treaty despite strong opposition from the NRA, Gun Owners of America and several other organizations that protect the rights of gun owners.

**"This treaty disregards the Second Amendment to our Constitution and threatens individual firearm ownership,"** said Chris Cox, head of the NRA. **"It is a sad, yet**

telling, day when the president of the United States and his administration refuse to defend America's Constitution on the world stage."

U.S. lawmakers from both houses of the U.S. Congress had composed an official letter and sent it to President Barack Obama. The letter detailed their strong opposition to the United States being a signatory of the United Nations' proposed arms trade treaty stating that they believe it imposes restrictions on American citizens' Second Amendment gun rights as well as U.S. sovereignty.

"While many within the [Obama White House](#) and Democrats on Capitol Hill deny it would impact on Americans' gun ownership rights, the fact is there far too many U.S. judges -- including some on the U.S. Supreme Court -- who believe in imposing international law into their court decisions especially on matters involving the U.S. Constitution," said political strategist and attorney Michael S. Baker.

"Also, let's remember that truth coming from this White House is a rare commodity such as when Obama claimed Obamacare wouldn't add one dime in taxes. **Obama, Hillary Clinton, John McCain and other demonic leaders are 'internationalists' who believe in a new world order,**" said Baker.

"The UN's actions to date indicate that the ATT [United Nations Arms Trade Treaty] is likely to pose significant threats to our national security, foreign policy, and economic interests as well as our constitutional rights," reads the letter, which was authored by [Rep. Mike Kelly](#) (R-Pa.). <http://www.reuters.com/article/2013/04/02/us-arms-treaty-un-idUSBRE9310MN20130402>

### **Conn. reaches draconian deal on tough gun laws after Newtown**

HARTFORD, Conn. (AP) — Connecticut lawmakers announced a deal Monday on what they called some of the toughest gun laws in the country that were proposed after the December mass shooting in the state, including a ban on new high-capacity ammunition magazines.

The proposal also called for background checks for private gun sales and a new registry for existing magazines that carry 10 or more bullets, something of a compromise for parents of Newtown victims who had wanted an outright ban on them, while legislators had proposed grandfathering them into the law.

The package also creates what lawmakers said is the nation's first statewide dangerous weapon offender registry, immediate universal background checks for all firearms sales and expansion of Connecticut's assault weapons ban.

A new state-issued eligibility certificate would also be needed to purchase any rifle, shotgun or ammunition under the legislation. To get the certificate, a buyer would need to be fingerprinted, take a firearms training course and undergo a national criminal background check and involuntary commitment or voluntary admission check. Also more than 100 weapon types are banned!!!...So it was not coincidence that there were 'insane' crowds as customers flooded into Connecticut gun stores before vote.

Despite a plan by Republican senators Rand Paul, Ted Cruz and Mike Lee to derail and defeat S. 649, the Safe Communities, Safe Schools Act of 2013, Iowa Republican Senator Chuck Grassley is preparing work with Democrats in their war on the Second Amendment next month.

According to pro-Second Amendment websites, Republican Senate Minority Leader Mitch McConnell has indicated he may support "gun control lite" legislation. "You would think ALL Republicans are lining up behind Senators Rand Paul, Ted Cruz and Mike Lee to support the filibuster of Harry Reid's gun control bill — S. 649," writes AmmoLand today. "But that's just not happening."

Senate Democrats, led by Majority Leader Harry Reid, are looking to find Republicans they can deal with after Oklahoma Senator Tom Coburn refused to collude with them on anti-Second Amendment legislation.

"If Reid manages to pick up the support of enough Senate Republicans, Obama will get what he wants — fictitious 'gun trafficking' legislation, so-called 'mental health screenings' and 'expanded background checks,'" AmmoLand reports. "Possibly even more gun control like Feinstein's so-called 'assault weapons ban' and a federal magazine ban will also be on the table."

Grassley is the ranking member of the Senate Judiciary Committee. If he supports "gun control lite" many junior senators will find it more difficult to oppose legislation aimed at the heart of the Second Amendment.

### [Veteran's Guns Confiscated After Forced 'Psychiatric Evaluation' Purge against armed ex-servicemembers accelerates](#)

50-year-old David A Schmecker is an **honorably discharged disabled US Navy veteran from Connecticut with no criminal record and no psychiatric history.** On February 5, Schmecker's hospital primary care doctor called and heard a message on Schmecker's answer machine that "sounded peculiar," prompting him to contact the local police and urge them to visit Schmecker to perform a "wellness check".

"The police came to my home, and, without any justification whatsoever, hauled me away for a psychiatric evaluation at a local hospital. I submitted to their forceful insistence under duress and fear of arrest or worse." Schmecker told Survive and Thrive's George Hemminger.

"**They confiscated my guns and pistol permit.** I was released two days later from the evaluation on my own recognizance. I have since attempted to use the courts and attorneys to fight the revocation of my pistol permit. Then on top of everything else, the

bills from the short stay at the hospital and EMS bills that they billed me, along with what I had to pay the attorney adds up to a large amount of money,” he adds.

Schmecker warns that the harassment he suffered is part of “a campaign orchestrated to disarm law abiding citizens,” adding that he is “concerned about where this country is headed.”

**As with all contemporary authoritarian governments, the psychiatric system is being used to circumvent courts and bypass normal legal due process.**

In August 2012, we reported on how a veteran in Ohio had his guns taken because he was judged to be mentally incompetent, despite the fact that his previous VA psychiatric evaluations were all clear, he was not on medication, and he had no criminal record.

As we reported last year, David Sarti, one of the stars of National Geographic’s Doomsday Preppers show, visited his doctor complaining of chest pains, only to have the doctor later commit him to a psychiatric ward and alert authorities, before Sarti was declared “mentally defective” and put on an FBI list that strips him of his second amendment rights.

**Veterans are increasingly being targeted by authorities as part of a broader move to demonize them as domestic extremists and even potential terrorists.**

The FBI has repeatedly characterized returning veterans from Iraq and Afghanistan as a major domestic terrorist threat. In addition, Homeland Security chief Janet Napolitano said she stood by an April 2009 DHS intelligence assessment that listed returning vets as likely domestic terrorists.

Just a month later, the New York Times reported on how Boy Scout Explorers were being trained by the DHS to kill “disgruntled Iraq war veterans” as part of anti-terror drills.

Back in February, constitutional attorney Michael Connelly warned that the government is now moving to strip veterans it determines to be mentally incompetent of their **Second Amendment right to own a firearm**. Connelly cites a letter “sent by the U.S. Department of Veterans Affairs to hundreds, perhaps thousands, of America’s heroes.” Which says:

**“A determination of incompetency will prohibit you from purchasing, possessing, receiving, or transporting a firearm or ammunition,”** the VA letter states. **“If you knowingly violate any of these prohibitions, you may be fined, imprisoned, or both pursuant to the Brady Handgun Violence Prevention Act,** Pub.L.No. 103-159, as implemented at 18, United States Code 924(a)(2).”

**This must be Barack Obama’s way of thanking our veterans for serving.**

**STATE GRANTS SECRET SERVICE VAST NEW POWERS Soon will be able to enforce Obama gun laws without sheriffs' help**

**A bill is heading to Colorado Gov. John Hickenlooper’s desk that Republican lawmakers say would give members of the Secret Service broad arrest powers in the state and could provide a framework for federal agents eventually to enforce gun restrictions.**

**“This is absolutely insane,” Rep. Lori Saine, R-Dacono, said. “In theory if a Secret Service agent is in a county where the sheriff has refused to enforce some of the recent unenforceable gun laws, the agent could arrest an individual if he believes the law has been broken.”**

**The idea actually aligns with an Obama agenda to create vast new restrictions and regulations on guns.** WND has reported that hundreds of sheriffs nationwide, including many in Colorado, have said they cannot enforce federal restrictions that would violate the Second Amendment.

**In Colorado, Weld County Sheriff John Cooke said he and many other county sheriffs “won’t bother” with several laws poised to go into effect in Colorado because they would be impossible to enforce.**

**Cooke said he and other sheriffs are considering filing a lawsuit to block the laws. And sheriffs in other parts of the nation agree, with more than 340 already banding together to promise to uphold the U.S. Constitution.**

**The Colorado Legislature also passed a bill putting a 15-round limit on ammunition magazines.**

**The new bill regarding the Secret Service, SB-13-013, passed on a nearly party line vote in the Democrat-controlled House and is now awaiting the governor’s signature. The bill grants members of the Secret Service arrest powers by considering them to be a peace officer, putting them on a par with state law-enforcement officials with respect to arrest authority.**

**The legislation does not only apply to agents guarding the president or other government officials but also to special agents, uniformed division officers, physical security technicians, physical security specialists and special officers of the United States Secret Service.**

#### **UTAH SHERIFFS ASSOCIATION TO OBAMA: FROM OUR COLD DEAD HANDS**

**As sheriffs across the nation signal opposition to enforcing additional federal gun regulations, the Utah Sheriffs' Association sent a letter to President Obama assuring him that its members similarly will not comply.**

**The letters insists that the rights of Utah citizens trump any new gun control measure that Congress might pass, and sheriffs in Utah are prepared to trade their lives in defense of their constituents' right to keep and bear arms.**

The letter, **signed by 28 of Utah's 29 sheriffs**, sternly rejects the citation of recent tragedies as Congress's rationale for expanded gun regulations:

***“With the number of mass shootings America has endured, it is easy to demonize firearms; it is also foolish and prejudiced. Firearms are nothing more than instruments, valuable and potentially dangerous, but instruments nonetheless. Malevolent souls, like the criminals who commit mass murders, will always exploit valuable instruments in the pursuit of evil. As professional peace officers, if we understand nothing else we understand this: lawful violence must sometimes be employed to deter and stop criminal violence. Consequently, the citizenry must continue its ability to keep and bear arms, including arms that adequately protect from all kinds of illegality. [original emphasis] ...as the duly elected sheriffs of our respective counties, we will enforce the rights guaranteed to our citizens by the Constitution. No federal official will be permitted to descend on our constituents and take from them what the Bill of Rights--in particularly Amendment II--has given them. We, like you [Mr. President], swore a solemn oath to protect and defend the Constitution of the United States, and we are prepared to trade our lives for the preservation of its traditional interpretation.”***

## Federal Framework Being Set Up To Arrest Sheriffs

Colorado, and apparently Texas (next) are being targeted with an attempt to set up a federal authority **framework that will enable Secret Service agents (not just those guarding the president), and others of the U.S. Secret Service including uniformed division officers, physical security technicians and specialists, and other 'special officers', to arrest and remove an elected sheriff for refusing to enforce the law (or anyone breaking the law).**

Why are they doing this? Here's why...

**It would establish federal authority police powers in a State, enabling an enforcement arm reporting directly to the president (the Secret Service).**

**It would potentially lead to enabling the president / executive branch to theoretically override the actions and preventative measures that are now being taken by many States throughout the country who are trying to preserve 2nd Amendment gun rights and who are prohibiting the enforcement of unconstitutional law passed by Congress or pushed by executive order.**

**As some of you may know, a growing list of sheriffs (more than 340 so far) across the country have expressed that they will not enforce a Washington mandate that clearly violates the Second Amendment.**

**Many State laws to preserve gun rights are gaining momentum.** States include Montana, Ohio, Kentucky, Idaho, Louisiana, Oklahoma, Texas, Arizona, Michigan, Utah, and New Mexico.

However, in Colorado, Senate Bill SB-13-013 has evidently just passed the Senate, and will be heading on to its potential signing by the governor, **giving police powers and arrest authority to the executive branch of federal government (Secret Service) within the State.** In Texas a similar bill has just been introduced in the State legislature.

The president and vice-president Biden have been actively pursuing state legislatures and pushing for passage of the bills. Obama is scheduled to visit Colorado in just a few days. **"Colorado is a pawn for the Obama-Biden plan," and then on to the next... at least those that won't fall into line.**

Quoted from Rep. Lori Saine of Colorado, **who says she believes the bill is intended to be used as a foundation for later legislation that will surrender still greater control to federal officials...**

"There've been so many explanations for the reasons they really need this bill passed. So what is it really?" **"I believe it is intended to be used for setting up a framework so that at some other time they could expand it to possibly include being able to arrest a sheriff who is refusing to enforce unconstitutional laws.** They would justify it by saying that since we've already given the Secret Service this ability, why not give them just one more?"

**It is a full court press by the executive branch of the federal government to empower themselves even further by inserting themselves as police authority within the state, to eliminate opposition.**

### [Gun Stores Resorting To Bullet “Rationing”](#)

Gun stores across America are resorting to bullet rationing, with store owners saying they have never seen such shortages in their lifetimes, and blaming huge ammunition purchases by the federal government.

KCTV in Kansas caught up **with gun shop proprietors who said they were struggling to keep their shelves stocked, as prices soar in the face of dwindling ammo supplies.**

Owner Chris Coad of UT Arms in Kansas City says that he is finding it increasingly harder to find certain kinds of bullets to fulfil orders. The store owner specifically pointed to 9mm, .40 caliber and .22 long rifle ammo.

**“We’re struggling to get that ammo. We’re doing limits on what individuals can buy. Just like your Walmart’s, Cabela’s, Dicks ... everyone is doing a rationing of that ammo right now.”** Coad told reporters, adding that the trend has gotten much worse over recent weeks, but has been ongoing for three months.

**According to in-house memos now circulating, the DHS has issued orders to banks across America which announce to them that “under the Patriot Act” the DHS has the absolute right to seize, without any warrant whatsoever, any and all customer bank accounts, to make “periodic and unannounced” visits to any bank to open and inspect the contents of “selected safe deposit boxes.”**

**Further, the DHS “shall, at the discretion of the agent supervising the search, remove, photograph or seize as evidence” any of the following items “bar gold, gold coins, firearms of any kind unless manufactured prior to 1878, documents**

such as passports or foreign bank account records, pornography or any material that, in the opinion of the agent, shall be deemed of to be of a contraband nature.”

DHS memos also state that banks are informed that any bank employee, on any level, that releases “improper” “classified DHS Security information” to any member of the public, to include the customers whose boxes have been clandestinely opened and inspected and “any other party, to include members of the media” and further “that the posting of any such information on the internet will be grounds for the immediate termination of the said employee or employees and their prosecution under the Patriot Act.” Safety deposit box holders and depositors are not given advanced notice when failed banks shut their doors.

If people have their emergency money in a safe deposit box or an account in a bank that closes, they will not be allowed into the bank to get it out. They can knock on the door and beg to get in but the sheriff’s department or whoever is handling the closure will simply say “no” because they are just following orders.

### **Uh-oh! Is gold, silver confiscation next? New bill requires registration of precious metals**

by [Garth Kant](#)--Lawmakers in President Obama’s home state want to know who is buying and selling gold. Illinois’ Precious Metal Purchasing Act, or SB-3341, would require every gold and silver transaction to be registered with the state.

The bill passed in the state’s Senate last spring and the House is considering amendments.

The federal government’s history of confiscating gold has some concerned this bill could be an ominous sign of things to come.

Eighty years ago today, **President Franklin Roosevelt ordered the confiscation of most gold from private citizens with his Executive Order 6102. People were directed to turn in their gold in exchange for paper currency.**

**The ban on owning gold lasted more than 40 years**, until President Gerald Ford signed legislation in 1974, **making it legal to own gold again.**

However, in **1971**, President Richard Nixon had taken the U.S. off the gold standard, ostensibly to keep countries from trading their surplus for gold. Nixon decreed that the U.S. would no longer exchange dollars for gold.

Nixon also announced the federal government would no longer redeem currency with silver. As [WND Joseph Farah wrote](#), “That was the last vestige of a dollar tied to a hard metals standard in America.”

Why the government infatuation with precious metals, particularly gold?

Critics say separating currency from something of real value, such as gold, is another form of wealth confiscation, because the Federal Reserve Bank can merely pump as many dollars as it wants into the system, causing money to lose value through inflation.

03 Apr 2013 In a worrisome sign, a **bird flu in China appears to have mutated so that it can spread to other animals, raising the potential for a bigger threat to people**, scientists said Wednesday. In the wake of the illnesses, the Chinese Center for Disease Control and Prevention shared the genetic sequence of the H7N9 virus with other scientists to help study how the virus might behave in different animals and situations. **One scientist said the sequence raises concern about a potential global epidemic, but that it's impossible to give a precise estimate of how likely that is.**

### **Bird flu: Deaths cause scramble to probe virus's source**

01 Apr 2013--Health officials **are scrambling to investigate a deadly new bird flu strain in China [H7N9] that has left two men dead and a woman fighting for her life**, but so far, more questions than answers have emerged. **Is this the front edge of a major pandemic** or just another blip on the world's increasingly powerful radar for newly emerging viruses? **One worry is that H7N9 could become like H5N1, the most famous of the avian flu strains that first emerged in Hong Kong in 1997.**

### **Government Scientists Creating More Deadly Bird Flu Virus: Are You Prepared If It Gets Out?**

For some preppers, a common motivation to become prepared **is the risk of a biological outbreak of some disease with a high mortality rate and aggressive transmission vector.** They fear, and with good reason, that if a disease gets out into the open, society will

quickly fall and the grid will collapse under the weight of so much death and suffering.

This fear certainly seems plausible with events over the past decade of aggressive strains of viruses but so far we have been relatively protected from any major outbreak. Tuesday in [the Independent](#) we learned the following:

A group of leading scientists **has urged President Obama's advisers to investigate the ethical issues raised by a decision to create a highly infectious strain of bird-flu virus that could be transmitted easily between people.**

The scientists, who include a former UK Government chief scientist and a Nobel laureate, said that it is **"morally and ethically wrong" to create a new type of influenza virus in the laboratory that is more lethal and transmissible than what actually exists in nature.** They also stated: **The accidental [not to mention, purposeful] release of an artificial, laboratory-generated, human-transmissible H5N1 virus into the community has the potential to cause a global pandemic of epic proportions that would dwarf the 1918 Spanish flu pandemic that killed over 50 million people,"**

This is important because of the **high mortality of the H5N1 virus. If infected, the rate of death is 60%, but to date there has been such low transmission from infected birds to humans we have been spared a significant outbreak.** Not intent to leave well enough alone, scientists from Erasmus Medical Centre in Rotterdam and the University of Wisconsin-Madison succeeded in 2011 **of mutating the H5N1 avian virus so that it could in theory be transmitted through the air between people. This theoretically makes it much easier to contract, more deadly and much more likely to cause death. Why is this research being allowed?**

**"But these are high security labs", you say and "they are very safe about how they handle these virus's". But it was just last week that a [Bio-terror lab in Galveston Texas lost five small plastic vials of an obscure deadly virus called Guanarito.](#)**

**"They **did not consider this a public health threat** or a potential theft,".**

**They didn't consider a killer virus getting out in who knows whose hands a 'health threat'? Without going too far into the realm of conspiracy theory (which in cases like this looks like conspiracy fact) what can you do to prepare yourself and your family for the event of a biological outbreak like the H5N1 virus?**

### **Plan for personal protection**

Most biological viruses pass through air, direct contact or bodily fluids so protective gear that will minimize the potential of coming in contact with these pathogens is an important consideration. **At a minimum, you should consider a respirator or mask, protective clothing to include eye protection, gloves and footwear and potentially decontamination options. In our article explaining our rationale on [why everyone should consider a gas mask](#) as part of your preps, we mentioned some options but you can obtain protection from a less confining option.**

Tyvek Suits or coveralls are really cheap considering their use. You need to shop around, but you can [find Tyvek coveralls for around \\$8 each](#) or if you want to be really prepared and save on the per suit cost, you can [buy in bulk](#). You can find these online or even at your local hardware store. Respirators are available in all shapes and sizes from the lower end [N95 masks](#) to full face [protection masks with interchangeable filters](#).

### **Plan to protect your home**

In the event of a biological outbreak, we may be required to stay in our homes or “shelter in place”. The simple act of removing yourself from contact with society may reduce your risk of exposure to the virus so planning to stay in your home for an extended time should be a consideration.

**Some items to consider:**

- Make sure you have an [adequate food storage supply](#) to last you through the outbreak
- Make sure you have [water and adequate methods of disinfecting water](#) you and your family will need to drink
- Purchase large rolls of heavy plastic and duct tape to seal windows, doors and vents if necessary.
- Consider pets and how they will go to the bathroom.
- Plan for [entertainment](#) during any situation where you will be confined for long periods of time.
- Ensure you have at least a month’s extra medication for anyone who requires medicine for their daily use.
- [Plan for Sanitation](#) and make sure you have plenty of hygiene and sanitation items on hand.

These are just a few items to consider, but for each person there are numerous other options. The goal is to start thinking about the potential for this type of threat and how to plan for your family’s safety. It seems obvious that the people we thought were looking out for us simply ‘didn’t consider it’.

**FDA approves first GMO flu vaccine containing a reprogrammed insect virus**

February 8 2013--by Jonathan Benson, staff writer (NaturalNews) A new vaccine for influenza has hit the market, **and it is the first ever to contain genetically-modified (GM) proteins derived from insect cells.** According to reports, the U.S. Food and Drug Administration (FDA) recently approved the vaccine, known as Flublok, **which contains recombinant DNA technology and an insect virus** known as baculovirus that is purported to help facilitate the more rapid production of vaccines.

According to Flublok's package insert, the vaccine is trivalent, **which means it contains GM proteins from three different flu strains.** The vaccine's manufacturer, Protein Sciences Corporation (PSC), explains that **Flublok is produced by extracting cells from the fall armyworm, a type of caterpillar, and genetically altering them to produce large amounts of hemagglutinin, a flu virus protein that enables the flu virus itself to enter the body quickly.**

So rather than have to produce vaccines the "traditional" way using egg cultures, **vaccine manufacturers will now have the ability to rapidly produce large batches of flu virus protein using GMOs, which is sure to increase profits for the vaccine industry. But it is also sure to lead to all sorts of serious side effects, including the deadly nerve disease Guillain-Barre Syndrome (GSB), which is listed on the shot as a potential side effect.**

According to clinical data provided by PSC in Flublok's package insert, **two study participants actually died during trials of the vaccine. But the company still insists Flublok is safe and effective.**

#### **FDA also approves flu vaccine containing dog kidney cells**

Back in November, **the FDA also approved a new flu vaccine known as Flucelvax that is actually made using dog kidney cells.** A product of pharmaceutical giant Novartis, Flucelvax also does away with the egg cultures, and can similarly be produced much more rapidly than traditional [flu](#) vaccines, which means vaccine companies can have it ready and waiting **should the federal government declare a pandemic.**

Like Flublok, Flucelvax was made possible **because of a \$1 billion, taxpayer-funded grant given by the U.S. Department of Health and Human Services (HHS) to the vaccine industry back in 2006 to develop new manufacturing methods for vaccines. The ultimate goal is to be able to quickly manufacture hundreds of millions of vaccines for rapid distribution.**

Meanwhile, there are reportedly two other GMO flu vaccines currently under development. One of them, which is being produced by Novavax, will utilize "bits of genetic material grown in caterpillar cells called 'virus-like particles' that mimic a flu virus," according to Reuters.




