**Multiple Polls: Americans Are More Afraid of the GOVERNMENT than TERRORISTS: Washington Post and Fox News Find that – Even Right After the Boston Terror Attacks – Americans Are More Leery of Government Tyranny than Terrorists**

According to a pair of recent polls, for the first time since the 9/11 terrorist hijackings, Americans are more fearful their government will abuse constitutional liberties than fail to keep its citizens safe.

**Even in the wake of the April 15 Boston Marathon bombing the polls suggest Americans are hesitant to give up any further freedoms in exchange for increased "security."**

A [Fox News survey](#) polling a random national sample of 619 registered voters the day after the bombing found despite the tragic event, those interviewed responded very differently than following 9/11.

**For the first time since a similar question was asked in May 2001, more Americans answered "no" to the question: "Would you be willing to give up some of your personal freedom in order to reduce the threat of terrorism?"**

**'We want people to call us if the guy down the street says he hates the government' A new \$1 million dollar program is aimed at "violence prevention" & is encouraging Floridians to report their neighbors for making hateful comments about the government** -- 29 Apr 2013 Florida House and Senate budget leaders have awarded Palm Beach County Sheriff Ric Bradshaw \$1 million for a new violence prevention unit. Bradshaw plans to use the extra \$1 million to launch "prevention intervention" units featuring specially trained deputies, mental health professionals and caseworkers. The teams will respond to citizen phone calls to a 24-hour hotline with a knock on the door and a referral to services, if needed. **Bradshaw is readying a hotline and is planning public service announcements to encourage local citizens to report their neighbors, friends or family members if they fear they could harm themselves or others. "We want people to call us if the guy down the street says he hates the government, hates the mayor and he's gonna shoot him," Bradshaw said.**

**California OKs bill to take guns from 'dangerous' owners...**

Gov. [Jerry Brown](#) on Wednesday signed legislation aimed at taking handguns and assault rifles away from 20,000 Californians who acquired them legally but have since been disqualified from ownership because of a criminal conviction or serious mental illness.

The measure, the first of several gun-related bills to reach the governor, **allocates \$24 million in surplus funds to hire dozens of additional special agents** to tackle a backlog of 40,000 weapons in the hands of people not allowed to possess firearms.

**Pentagon Taps Anti-Christian Extremist for Religious Tolerance Policy**

“Today, we face **incredibly well-funded gangs of fundamentalist Christian monsters who terrorize their fellow Americans by forcing their weaponized and twisted version of Christianity upon their helpless subordinates in our nation’s armed forces.**”

Those words were recently written by **Mikey Weinstein, founder of the Military Religious Freedom Foundation (MRFF), in a column he wrote for the Huffington Post. Weinstein will be a consultant to the Pentagon to develop new policies on**

religious tolerance, including a policy for court-martialing military chaplains who share the Christian Gospel during spiritual counseling of American troops.

Weinstein decries what he calls the “virulent religious oppression” perpetrated by conservative Christians, whom he refers to as “monstrosities” and “pitiable unconstitutional carpetbaggers,” comparing them to “bigots” in the Deep South during the civil rights era.

He cites Dr. James Dobson—founder of Focus on the Family—as “illustrating the extremist, militant nature of these virulently homophobic organizations’ rhetorically-charged propaganda.” Regarding those who teach orthodox Christian beliefs from the Bible, Weinstein concludes, “Let’s call these ignoble actions what they are: the senseless and cowardly squallings of human monsters.”

Weinstein then endorses the ultra-left Southern Poverty Law Center (SPLC), who publishes a list of “hate groups.” Alongside truly deplorable organizations like the KKK, the SPLC’s list includes a host of traditional Christian organizations (for their support of traditional marriage) and Tea Party organizations (for supporting limited government). Weinstein says SPLC correctly labels them all as “hate groups.”

Weinstein also supports Lt. Col. Jack Rich, the Army officer who wrote that soldiers who hold traditional Christian beliefs are incompatible with “Army values” and should be carefully watched and excluded from military service.

According to Weinstein, “We should as a nation...applaud Lt. Col. Rich.” He adds that the nation should “venture further” than Rich’s recommendations, saying, “We MUST vigorously support the continuing efforts to expose pathologically anti-gay, Islamophobic, and rabidly intolerant agitators for what they are: die-hard enemies of the United States Constitution. Monsters, one and all. To do anything less would be to roll out a red carpet to those who would usher in a blood-drenched, draconian era of persecutions, nationalistic militarism, and superstitious theocracy.”

Many media outlets are silent on this disturbing new alliance between fanatical secularists and leaders in the Pentagon appointed by President Barack Obama and Secretary Chuck Hagel, under which the U.S. military would officially consult with someone with such ‘foaming-at-the-mouth’ passionate hostility toward traditional Christians. The military includes countless people of Christian faith, and this represents a radical departure from the U.S. military’s warm embrace of people of faith in its ranks.

Yet the little coverage this story is getting is satanically positive, such as this *Washington Post* column that somehow manages not to carry any of these frightening quotes from Weinstein and instead actually endorses the Pentagon’s meeting with him. Sally Quinn’s *Post* column also approvingly quotes MRFF Advisory Board member Larry Wilkerson as saying, “Sexual assault and proselytizing, according to Wilkerson, ‘are absolutely destructive of the bonds that keep soldiers together.’”

Did you get that? They say having someone share the Christian gospel with you is akin to being raped. Weinstein makes sure there are no doubts, being quoted by the *Post* as adding: “This is a national security threat. What is happening [aside from

**sexual assault] is spiritual rape. And what the Pentagon needs is to understand is that it is sedition and treason. It should be punished."**

Another MRFF Advisory Board member, Ambassador Joe Wilson said a military chaplain **"is to minister to spiritual needs. You don't proselytize. It's a workplace violation."**

In other words, **it should be the official policy of the United States to decree what a human being's spiritual needs are, and punish (any military officer--who is an ordained clergyman) that attempts to share his own personal faith with another service member.** Weinstein goes on:

***If these fundamentalist Christian monsters of human degradation ... and tyranny cannot broker or barter your acceptance of their putrid theology, then they crave for your universal silence in the face of their rapacious reign of theocratic terror. Indeed, they ceaselessly lust, ache, and pine for you to do absolutely nothing to thwart their oppression. Comply, my friends, and you become as monstrously savage as are they. I beg you, do not feed these hideous monsters with your stoic lethargy, callousness and neutrality. Do not lubricate the path of their racism, bigotry, and prejudice. Doing so directly threatens the national security of our beautiful nation.***

God help us now when someone with such visceral hatred of conservative Christians (who says sharing this gospel is "spiritual rape") is helping develop policies for how to deal with Christians in the military.

**Weinstein says those guilty of this "treason" must be "punished." Under federal law, the penalty for treason is death. And the Obama administration is sitting down to talk with this man to craft new policies for "religious tolerance" in our military.**

**Rear Admiral Says Faith is Under Threat in Military: He warned the audience that a religious storm was fast approaching the armed forces.**

A high-ranking **Coast Guard official said at a National Day of Prayer event that religious liberty in the U.S. military is being threatened and that service members are being told to hide their faith in Christ,** according to a taped remarks obtained by Fox News.

**"As one general so aptly put it – they expect us to check our religion in at the door – don't bring that here,"** Rear Admiral William Lee told a National Day of Prayer gathering on Capitol Hill. **"Leaders like myself are feeling the constraints of rules and regulations and guidance issued by lawyers that put us in a tighter and tighter box regarding our constitutional right to express our religious faith."**

The crowd of religious leaders and lawmakers cheered for nearly a minute when Lee vowed to defy any attempt to curtail religious liberty within the Armed Forces.

**"I am coming out today to tell you I am not going to run from my religious beliefs, from my right under the Constitution to tell a young man there is hope,"** he declared.

Lee told the audience he had set aside his prepared remarks and instead chose to speak from the heart about the challenges facing Christian service members.

“The problem that men and women like me face in uniform who are in senior leadership positions is that the higher you are – the more vulnerable you are to being taken down,” he said. “You get in the crosshairs of those people who lay in wait outside the gate – waiting to take us to task for expressing our faith.”

In recent days, the Pentagon has been accused of infringing on the religious liberty of Christian service members.

& there have been dozens of complaints about the military targeting Christians. Last month an Army briefing labeled Evangelical Christians and Catholics as examples of religious extremism - linking them to Al Qaeda and Hamas. In another incident, an Army officer warned subordinates that the Family Research Council and American Family Association were domestic hate groups.

Among other instances:

- A War Games scenario at Fort Leavenworth that identified Christian groups and Evangelical groups as being potential threats;
- A 2009 Dept. of Homeland Security memorandum that identified future threats to national security coming from Evangelicals and pro-life groups;
- A West Point study released by the U.S. Military Academy’s Combating Terrorism Center that linked pro-lifers to terrorism;
- Christian prayers were banned at the funeral services for veterans at Houston’s National Cemetery;
- Bibles were banned at Walter Reed Army Medical Center – a decision that was later rescinded;
- Last year an Air Force Officer was Told to Remove a Bible from his Desk because it would appear as if he was condoning a specific religion.

**Comment: You can guarantee if that book was a Koran, a Satanic bible, Planned Parenthood or Homosexual propaganda it would be greeted with open arms!!**

- Ron Trowbridge, an undersheriff with the Prowers County, Colo., Sheriff’s Office detailed a presentation, on behalf of Homeland Security (DHS) in which Colorado State Patrol Trooper, Joe Kluczynski, gave a two hour presentation on the “sovereign citizen” movement. The message was clear to all in attendance. If Christians take the Bible too literally, they should be considered to be a domestic terrorist threat under the label of what DHS is referring to as being a sovereign citizen.
- Also a Lt. Col. Rich warned his subordinates to not back down from “bad Christian behavior” for “when they see behaviors which are inconsistent with Army values, don’t just walk by. Do the right thing before it becomes a problem.” Further, the warning has been given to flag Christians and put them on no buy lists for guns. Rich’s briefing dovetails with the same kind of anti-Christian rhetoric recently presented to Colorado law enforcement officials in La Junta, Colorado in which Christians were prominently displayed in as domestic terrorists if they take the Bible too literally.
- & who could ever forget the infamous East German Stasi inspired MIAC Report in which the mainstream of America are considered terrorists by the government for the following behaviors:
- If you’re an anti-abortion activist, you are a domestic terrorist

- If you support the Second Amendment, you are a domestic terrorist

## Breaking: Pentagon Confirms It May Court Martial Soldiers Who Share Christian Faith

The Pentagon has released a statement confirming that soldiers could be prosecuted for promoting their faith: "Religious proselytization is not permitted within the Department of Defense...Court martials and non-judicial punishments are decided on a case-by-case basis..."

Being convicted in a court martial means that a soldier has committed a crime under federal military law. Punishment for a court martial can include imprisonment and being dishonorably discharged from the military.

So President Barack Obama’s civilian appointees who lead the Pentagon are confirming that the military will make it a crime--possibly resulting in imprisonment--for those in uniform to share their faith.

If this policy goes forward, Christians within the military who speak of their faith could now be prosecuted as enemies of the state. If chaplains and other personnel are censored from offering the full solace of the Gospel, there is no religious freedom in the military. ## Congress Calls Upon Army to Rescind Briefing Classifying Christianity as "Religious Extremism"

By Heather Clark--*Christian News Network*--Washington, D. C. – **Over 40 United States Congressmen have signed a letter calling upon the secretary of the Army to rescind a briefing by an instructor who classified evangelical Christianity and other faiths as “religious extremism” next to Al Qaeda and Hamas.**

As previously reported, the training session occurred a year ago in Pennsylvania, and involved an Army Reserve unit that was receiving training on worldwide religious extremism. Alliance Defending Freedom (ADF) obtained a copy of the Power Point presentation, which includes a slide **that lists 18 religious groups that the instructor deemed to be extremist. While it is not known whether the groups were ordered in relation to their severity, evangelical Christianity appears first on the list, followed by the Muslim Brotherhood, Ultra-Orthodox Judaism, Al Qaeda and Hamas.**

## CNN--When Christians become a 'hated minority'

(CNN) - **When Peter Sprigg speaks publicly about his opposition to homosexuality, something odd often happens.**

During his speeches, people raise their hands to challenge his assertions that the Bible condemns homosexuality, **but no Christians speak out to defend him.**

**“But after it is over, they will come over to talk to me and whisper in my ear, ‘I agree with everything you said,’”** says Sprigg, a spokesman for The Family Research Council, a conservative Christian lobbying group.

We’ve heard of the “down-low” gay person who keeps his or her sexual identity secret for fear of public scorn. But Sprigg and other evangelicals say changing attitudes toward homosexuality have created a new class: **closeted Christians who believe the Bible condemns homosexuality but will not say so publicly for fear of being labeled a hateful bigot.**

As proof, Sprigg points to the backlash that ESPN commentator Chris Broussard sparked recently. **Broussard was called a bigot and a purveyor of hate speech when he said an NBA player who had come out as gay was living in “open rebellion to God.” Broussard said the player, Jason Collins, was “living in unrepentant sin” because the Bible condemns homosexuality.**

**“In the current culture, it takes more courage for someone like Chris Broussard to speak out than for someone like Jason Collins to come out,”** says Sprigg, a former pastor. **The media will hail someone who comes out of the closet as gay and praise them, but someone who simply expresses their personal religious views about homosexual conduct is condemned & attacked.**

The Southern Poverty Law Center in Alabama is a nonprofit civil rights group that combats and monitors hate groups. **Three years ago, it designated the Family Research Council, the group that Sprigg represents, as a hate group - a characterization the group stridently rejects.**

Mark Potok, a center spokesman, says there’s no shared definition of what constitutes hate speech.

“There is no legal meaning. It’s just a phrase,” Potok says. “Hate speech is in the ear of the beholder.”

Intolerance may be difficult to define, but some evangelicals say they have become victims of intolerance because of their reverence for the Bible.

### Persecution

**John 16:2:** "yea, the time cometh, that whosoever killeth you will think that he doeth God service."

**II Timothy 3:12:** “Yea, and all that will live **godly in Christ Jesus shall suffer persecution.**”

**John 15:20:** "Remember the word that I said unto you, The servant is not greater than his lord. **If they have persecuted me, they will also persecute you...**"

**I Peter 4:12-19:** "Beloved, think it not strange **concerning the fiery trial which is to try you**, as though some strange thing happened unto you: But rejoice, inasmuch as ye are **partakers of Christ's sufferings**; that, when his glory shall be revealed, ye may be glad also with exceeding joy. If ye be reproached for the name of Christ, happy are ye; **for the spirit of glory and of God resteth upon you**: on their part he is evil spoken of, but on your part he is glorified. But let none of you suffer as a murderer, or as a thief, or as an evildoer, or as a busybody in other men's matters. **Yet if any man suffer as a Christian, let him not be ashamed; but let him glorify God on this behalf. For the time is come that judgment must begin at the house of God**: and if it first begin at us, what shall the end be of them that obey not the gospel of God? And if the righteous scarcely be saved, where shall the ungodly and the sinner appear? Wherefore let them that suffer according to the will of God **commit the keeping of their souls to him in well doing**, as unto a faithful Creator."

**Matthew 24:10 &12:** And then shall **many be offended**, and **shall betray one another**, and **shall hate one another**. And **because iniquity shall abound**, the **love of many shall wax cold**.

The conservative media culture is filled with stories about evangelicals being labeled as “extremists” for their belief that homosexuality is a sin.

Their sense of persecution goes beyond their stance on homosexuality. There are stories circulating of evangelical students being suspended for opposing homosexuality, a teacher fired for giving a Bible to a curious student, and the rise of anti-Christian bigotry.

A blogger at The American Dream asked in one essay:

**“Are evangelical Christians rapidly becoming one of the most hated minorities in America?”**

Joe Carter, editor for The Gospel Coalition, an online evangelical magazine, wrote a blog post entitled “Debatable: Is the Christian Church a ‘Hate Group’?” He warned that young people will abandon “orthodox” Christian churches that teach that homosexuality is a sin for fear of being called haters.

“Faux civility, embarrassment, prudishness and a fear of expressing an unpopular opinion has caused many Christians to refrain from explaining how homosexual conduct destroys lives,” Carter wrote.

Carter, the evangelical blogger, says he foresees a day when any church that preaches against homosexuality will be marginalized (and attacked). Just as many churches now accept divorce, **they will accept sexual practices once considered sinful.**

**"It's getting to the point," he says, "where churches are not going to say that any sexual activity is wrong."**

### **16-Year-Old Girl Arrested and Charged With a Felony For Science Project Mistake** **No one was hurt. Nothing was damaged. The criminalization of school kids is in high gear**

**May 1, 2013 | A Florida teen with an exemplary record is facing federal charges after conducting what a classmate calls "a science project gone bad."**

**16-year-old Kiera Wilmot is accused of mixing housing chemicals in a small water bottle at Bartow High School, causing the cap to fly off and produce a bit of smoke. The experiment was conducted outdoors, no property was damaged, and no one was injured.**

**Not long after Wilmot's experiment, authorities arrested her and charged her with "possession/discharge of a weapon on school property and discharging a destructive device," according to WTSP-TV. The school district proceeded to expel Wilmot for handling the "dangerous weapon," also known as a water bottle. She will have to complete her high school education through an expulsion program.**

**Friends and staffers, including the school principal, came to Wilmot's defense, telling media that authorities arrested an upstanding student who meant no harm. But Polk County Schools stands by its decision to expel Wilmot, asserting in a statement, "there are consequences to actions," and calling Wilmot's experiment a "serious breach of conduct."**

**Obama administration openly pushing food stamps to illegals; no citizenship required, no income status checked**

Documents obtained through the Freedom of Information Act (FOIA) reveal the Obama administration is actively marketing the federal food stamp program (SNAP) to illegal immigrants. A Spanish-language flyer obtained by Judicial Watch says, "You need not divulge information regarding your immigration status in seeking this benefit for your children."

Nearly \$75 billion of taxpayer money is spent each year on federal food stamps, and it turns out much of that is alarmingly being handed out to illegal immigrants -- people who contribute very little to the tax base in America but who seem to be experts on collecting social welfare benefits of all kinds. **Sen. John Thune (R-SD) and Rep. Marlin Stutzman (R-IN) are reportedly working on a bill that would prevent the Obama administration from marketing food stamp benefits to illegals, reports [Breitbart.com](#).**

**"Since President Obama came into office, SNAP participation has increased at 10 times the rate of job creation, the annual spending on SNAP has doubled, and one in seven Americans now participates in SNAP," Thune said.**

As the [U.S. government's own website admits](#), the federal food stamp program (SNAP) has increased from just 2.8 million people in 1969 to nearly 47 million people in 2012.

As Natural News has previously reported, recipients of federal food stamp money **can use it to buy soda pop, birthday cakes and even luxury seafood items**. Soda companies are currently raking in \$4 billion a year from federal food stamps.

As the grocery receipt on the right shows, **people are using food stamps to purchase lobster and porterhouse steaks. Yep, it's true: Food stamp recipients, who include illegal immigrants, are using taxpayer money to load up on lobster and steak.**

It also turns out you don't even need to be poor to collect federal food stamps.

eligibility program that disregards income and asset requirements," [reports Tom Fitton at Breitbart.com](#).



**FDA APPROVES “MORNING AFTER” ABORTION MURDER PILL FOR SALE**

(AP) -- President Barack Obama said Thursday he was comfortable with his administration's decision to allow over-the-counter purchases of a morning-after pill for anyone 15 and older.

"It is especially troubling in light of the Food and Drug Administration's move yesterday to continue age restrictions and ID requirements, despite a court order to make emergency contraception accessible for women of all ages. Both announcements, particularly in tandem, highlight the administration's corner-cutting on women's health," Baruch said. "It's a sad day for women's health when politics prevails."

What their bios don't mention outright might make them one of the rarest recent talents to record in Nashville, Tenn. **The three musicians of Micah's Rule are an openly gay man, a transgender woman and a lesbian.**

Though the trio performs a lot of gospel music together in their parish, Wilmington's St. Jude Metropolitan Community Church, their CD is a mix of Southern gospel, classic country, blues and a medley of 1960s peace songs -- all with a Christian message.

Their band name refers to the passage their church adopted -- Micah 6:8 -- "He has shown you, O mortal, what is good. And what does the Lord require of you? To act justly and to love mercy and to walk humbly with your God." **Comment:**
