The 8,540 ton container vessel MOL COMFORT today suffered a major accident while underway in the Arabian Sea. Sailing in inclement weather conditions with a heavy swell, the ship has developed cracks in its hull and finally broke in two forward of the bridge, near its center. It appears that the damage occurred as a result of wave-induced stresses on the hull, with no indicators for a collision or fire which might have

weakened the hull.

Japan does not recognize the annexations of East Jerusalem by Israel;

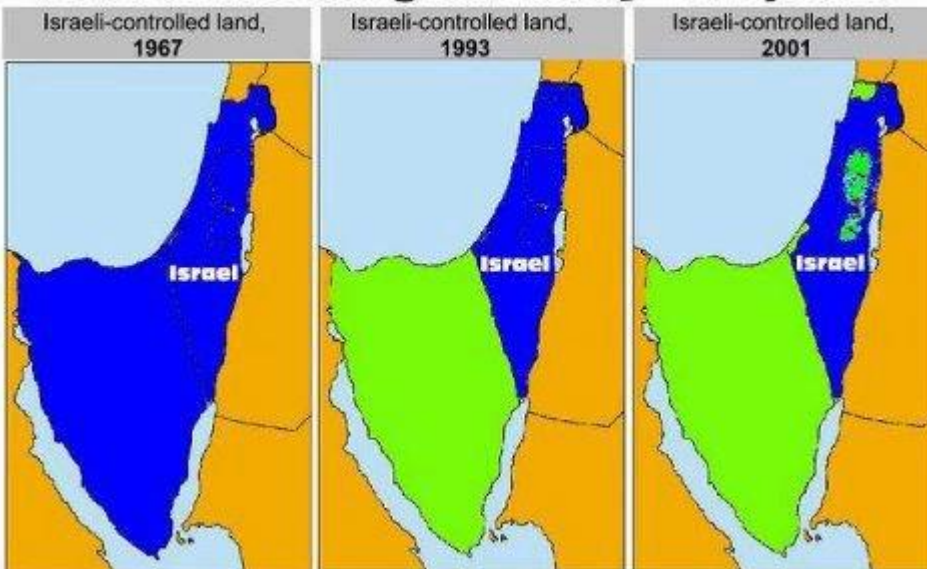
Japan urges Israel to refrain from unilateral acts that change the current situation in East Jerusalem, etc.

Senate rejects border fence...

Senators on Tuesday **rejected building the 700 miles of double-tier border fencing Congress authorized just seven years ago, with a majority of the Senate saying they didn't want to delay granting illegal immigrants legal status while the fence was being built.**

The 54-39 vote to reject the fence shows the core of the immigration deal is holding. The vote broke mostly along party lines, though five Republicans, including [Sen. Marco Rubio](#) and the rest of the bill's authors, voted against the fence, and two Democrats voted for it.

FEDS: Bill only stops one-quarter of illegals...

The [Senate](#) immigration bill will be a major boost to the federal budget **but does relatively little to clamp down on illegal immigration — cutting the future flow by only about 25 percent** — according to the [Congressional Budget Office](#) analysis of the bill, released Tuesday afternoon.

Under the bill, which legalizes illegal immigrants and invites in foreign workers, immigration will total 10.4 million more people over the next decade and 16.2 million by 2033.

Supreme Court: Illegal Immigrants Can Vote, No Proof Of Citizenship Required--

The Supreme Court ruled Monday that states cannot require would-be voters to prove they are U.S. citizens. States can't demand proof of citizenship from people registering to vote in federal elections unless they get federal or court approval to do so, the Supreme Court ruled Monday in a decision complicating efforts in Arizona and other states **to bar voting by people who are in the country illegally.**

Bait and Switch: 'Evangelicals' funded by George Soros Endorse 'Gang of 8' Immigration Bill

And where do the income taxes that are collected actually go? In 1982, President Ronald Reagan formed The President's Private Sector Survey On Cost Control, an independent panel of 160 of the country's top business leaders headed by Peter

Grace and known as The Grace Commission, in order to find ways to cut federal spending.

In their report submitted to President Reagan on January 15, 1984, this blue-ribbon panel stated the following, quoting directly from page 12 of their report: "Resistance to additional income taxes would be even more widespread if people were aware that one-third of all their taxes are consumed by waste and inefficiency in the Federal government as previously identified. With two-thirds of everyone's personal income taxes wasted or not collected, 100% of what is collected is absorbed solely by interest on the federal debt ... in other words, all individual income tax revenues are gone before one nickel is spent on the services taxpayers expect from the government."

WASHINGTON (AP) - The Internal Revenue Service is about to pay \$70 million in employee bonuses despite an Obama administration directive to cancel discretionary bonuses because of automatic spending cuts enacted this year, according to a GOP senator.

Conservative activists are planning to storm Capitol Hill on Wednesday for what they are predicting will be "the largest Tea Party protest since 2010."

The protest — drawing tea partiers like TV host Glenn Beck and Kentucky Sen. Rand Paul — is in response to the Internal Revenue Service's recent admission that it has been specifically targeting conservative groups for extra scrutiny.

The gathering on the West Lawn of the Capitol is being called the "Audit the IRS" Rally. "At noon tomorrow, we are going to tell the world about how the IRS tried to crush the Tea Party movement," organizers with the Tea Party Patriots organization said in an email to supporters.

"Thousands of volunteers will rally in the largest demonstration of Tea Party support since 2010."

I put two children on this protocol (one in England and one is the US) who were both having substantial seizure issues and both of them have never had another seizure again (and this was years ago) and I am still in contact with both. These supplements can be ground up and put her food. After being on this protocol for a month you could probably go to this dosage every other day. After another month you could go to every third day. The bottles listed above all come in a 90ct. size.

Yes the silver is perfectly fine for her. I would use 2-3 drops of the 5000ppm by mouth once a day for maintenance. You can use this dosage several times per day if she is fighting something off.

Response: This is a hard one to be certain about. if you are getting feet burning that is most likely the liver needing detoxed.

Feet pain (but usually big toe pain) can also be gout. (A uric acid test is the best way to know this). Black cherry Juice can sometimes work very well but the professional product I RX is called AC Carbamide and it works very quickly. It could be a circulatory issue. A Nattokinase product taken on an empty stomach or Circuplex by Standard Process would help with this condition.

It could be plantar fasciitis which ultrasound would be the best action.

Low magnesium could also cause the conditions you are describing especially if cramping is involved. In fact this is where I would start.

Try soaking your feet and legs in a hot Epsom Salt bath after work for at least 20 minutes. Epsom salts are magnesium (you actually absorb the magnesium through your skin) and this can work wonders.

Iodine: The Forgotten Health Link

*****This is a modified version of a "Health Alert" Newsletter by Dr. Bruce West, December 2005, Volume 22, Issue 12. Please also see additional references at the end of the article.***

From 1900 to the 1960s almost every single U.S. physician used Lugol (iodine) supplements in his or her practice for both hypo- and hyperthyroid, as well as many, many other conditions-all with excellent results. In fact, iodine was considered a panacea for all human ills (12). It is the most deficient trace mineral in the world with an acknowledged third of mankind functioning below optimal level due to deficiency (10). In fact, low intake of iodine is the worlds leading cause of intellectual deficiency (11). Yet, as unbelievable as it may sound, this essential element has suffered from total neglect regarding establishing the proper amount required by the human body for optimal health. Today a phobia-generated by medical misinformation against iodine therapy-has caused physicians to avoid this powerful treatment like the plague.

By avoiding iodine therapy, you could be missing out on the very link that could get you well. Today we know that total body iodine fulfillment or sufficiency can finally resolve tough, stubborn problems that resist all other treatments. Called orthiodosupplementation, this treatment employs elemental iodine supplements until the thyroid gland and all other iodine-sensitive sites in the body have reached iodine sufficiency. The most commonly difficult problems for which this therapy has been called a panacea are fibrocystic breasts, polycystic ovary syndrome, hypo- and hyperthyroid (with or without goiter), brain fog, constipation, obesity, diabetes, hypertension (high blood pressure), and even some heart problems-most notably irreversible arrhythmias like atrial fibrillation.

Why Iodine is Important

Iodine is detected in every organ and tissue in the body. It is found in high levels in the thyroid gland, liver, lung, heart, and adrenal glands. It is found in the highest concentrations in fat and muscle tissue. It is depleted out of the thyroid gland and other tissues when thyroid hormone medications are prescribed. Iodine has been considered so important that up until 20 years ago, it had been routinely added to bread as a supplement. **Now because of politics and fear of iodine, the thyroid-toxin bromine has taken its place as a bread supplement. And in the past 20 years there has been an increased prevalence of obesity, diabetes, and hypertension, as well as more thyroid and breast cancers.**

According to Guy E. Abraham, MD, perhaps the world's most knowledgeable expert on iodine and the thyroid, "Medical iodophobia has reached pandemic proportions. It is highly contagious and has wreaked havoc on the practice of medicine and on the U.S. population. **More misery and death in the U.S. may have resulted from [medicine's unwarranted fear of iodine] than from both World Wars combined.**" That is quite a statement from a former professor of Endocrinology and a man who pioneered ways to

assay iodine and minute quantities of hormones in the body. This man in the past 35 years has received more biochemistry, diagnostics, clinical chemistry, and hormone and iodine research awards than anyone I know of. And he has studied iodine therapy in high doses in over 4,000 people-publishing his findings in a document titled "The Iodine Project." These findings once and for all dispelled the medical myth and fear of iodine therapy.

The recommended daily intake for iodine supplementation is currently 12.5 to 37.5 mg total iodide/iodine. That amount was mentioned as lately as 1995 in a book on Pharmaceutical Sciences ⁽⁵⁾. It is rare for even diets of natural foods to supply more than **2 mg of iodine per day, while most diets supply less than 1 mg per day.**

Several investigators have shown convincing evidence connecting inadequate iodine intake and breast cancer ⁽⁶⁾. Japanese women living in Japan consumed a daily average of 13.8 mg total elemental iodine and they experience one of the **lowest prevalence (risk) for breast, ovarian and uterine cancer** ⁽⁶⁾. Some Japanese living in the coastal regions, whose diets contain a large amount of seaweed, consume **up to 50-80 mgs per day with no adverse affects!** In the 1960's, one slice of bread in the USA contained the full RDA of 0.15 mg iodine. The risk for breast cancer was then 1 in 20 ⁽⁷⁾. Over the last 2 decades, iodine was replaced by bromine in the bread making process. Bromine blocks thyroid function and may interfere with the anticancer effect of iodine on the breast ⁽⁴⁾. Now, the risk for breast cancer is 1 in 8 and increasing 1% per year ⁽⁷⁾. Chlorine also blocks iodine in the body, so chlorinated water (both drinking and bathing) is to be greatly avoided.

The RDA limits for vitamins and minerals were established after World War II. One of the last essential elements included in the RDA system was iodine, established in 1980 and confirmed in 1989 ⁽⁸⁾. The RDA for iodine was based on the amount of iodine/iodide needed to prevent goiter, extreme stupidity and hypothyroidism ⁽⁹⁾. The optimal requirement of the whole human body for iodine has never been studied. Therefore, the optimal amount of this element for physical and mental wellbeing is unknown. Based on demographic studies, the mainland Japanese consumed an average of 13.8 mg daily and they are one of the healthiest people on planet earth ⁽⁶⁾. One capsule of Iodo-Caps contains 12.5 mg iodine/iodide, an amount very close to the 13.8 mg average intake of mainland Japanese. Several studies have demonstrated a relationship between low iodine intake and fibrocystic disease of the breast (FDB), both in women and laboratory animals ^(1,2). The minimum amount of iodine required for control and prevention of FDB is equivalent to 0.1mg/kg body weight/day. For example, for a 50 kg woman, the daily amount of iodine would be 5 mg. The thyroid gland needs iodide to function properly. The original study done 80 years ago to control goiter in adolescent girls used 9 mg iodide daily ⁽³⁾.

Whole Body Iodine Sufficiency

Thyroidologists like Dr. Abraham have learned of the tremendous benefits of what they call whole body iodine sufficiency-when the body is saturated with sufficient iodine to supply all the tissues. Along the way, they have also discovered some amazing things about current thyroid treatment, thyroid drugs, and iodine. The very first thing discovered is that iodine is the treatment of choice for hypo- and hyperthyroid problems-with or without goiter. Doctors could get as high as a 90% cure rate with hyperthyroid (overactive thyroid) by using what would be considered high doses of iodine daily.

Doses of six to 37 mgs daily seemed equally effective in resolving cases of hypothyroid (underactive thyroid). These doses, once considered normal, are now considered high by most people in the medical profession.

Whole body iodine sufficiency is also a critical means to counter the side effects of thyroid hormone medications (Synthroid, etc.). Long-term use of these drugs is associated with depletion of thyroid and tissue iodine levels, as well as increased rates of cancer. Fluorescent scanning of the thyroid clearly shows how drug and other medical thyroid therapies deplete the gland and body of critical iodine. Therefore, Synthroid or thyroid-destructive therapies should never be taken without iodine therapy—something you will never hear from your endocrinologist. If all Thyroidologists and endocrinologists were forced to fluorescence scan their patients' thyroid glands, they would then have to fact up to the damages they are causing to these glands and their patients!

In addition to thyroid therapy, **all thyroid patients should be on iodine therapy, with the goal to reach a whole body iodine sufficiency. When this state is reached, the following results (gathered using sophisticated lab testing, fluorescence screening, clinical measurements, and a host of other high-tech medical testing procedures) have been observed:**

- Goiter is reduced or eliminated.
- Stress on the pituitary gland with resultant high TSH readings is eliminated.
- Increased excretion of thyroid poisons and heavy metals occurs via the kidneys.
- The liver's detoxification mechanisms are enhanced.
- Body temperature normalizes
- Obesity is more easily overcome—in fact, iodine therapy may be a critical and unknown factor in obesity.
- Diabetes and high blood pressure are more easily controlled.
- Breast tissue normalizes with decreased occurrences of fibrocystic breast disease.
- Menopausal symptoms are improved.
- Polycystic Ovary Syndrome can be cured.
- Brain function is better, with less brain fog.
- Heart function is better, with reduced arrhythmia problems.
- And cancer rates, especially of the thyroid and breast, are reduced.

Additionally, through the Iodine Project studies, Dr. Abraham discovered that even patients with complete thyroidectomy (removal of the whole gland) benefited from iodine therapy. Therefore it became known that iodine not only improved the thyroid gland, but the other target areas of the body where iodine and thyroid hormone are active. The doctors in the Project found that patients who achieved iodine sufficiency were often able to resolve diabetes problems without insulin. They could normalize blood pressure without medication. Goiters were resolved. And those taking thyroid hormone medication could greatly reduce or completely eliminate these drugs.

Iodine Tidbits

Diabetes . . . Iodine's ability to revive hormonal sensitivity back to normal significantly improves Insulin sensitivity and other hormones. **Heart disease** . . . via improved thyroid function. It can normalize cholesterol, blood pressure and certain types of arrhythmia **Teeth and Bones** . . . It is Iodine and not Fluoride that the teeth and bones need. It will

do everything purported for toxic fluoride plus raise IQ. **Heavy Metals** . . . Iodine chelates heavy metals such as Mercury, Lead, Cadmium and Aluminum and halogens such as Fluoride and Bromide. *Taken from a Hungarian article by Kenez Gyula Korhaz, Debrecen, III. Belgyogyaszat.*

Original Documents: Summaries on Caries Page 72, Page 73, 1939* "In 1962, I spent the summer after my first year of medical school at the Marine Biology Laboratory in Woods Hole, Massachusetts with one of my professors doing research on the electrophysiology of tunicate hearts. **Dr. Albert Szent Gyorgi, the Nobel laureate who discovered vitamin C**, was there. I was fortunate to be able to meet him and attend his lectures. **Dr. Szent Gyorgi, it turns out, loved iodine and took it himself in gram doses.** He enjoyed excellent health and lived to the age of 93. In his book Bioenergetics, he writes, "When I was a medical student, iodine in the form of KI [potassium iodide] was the universal medicine. Nobody knew what it did, but it did something and did something good. We students used to sum up the situation in this little rhyme: If ye don't know where, what, and why Prescribe ye then K and I."

How To Tell If You Need More Iodine: One of the first indicators is belly fat in men. When the abdominal muscles disappear under a layer of fat, a pot belly, insulin resistance or syndrome X is present. In women the fat also occurs on the hips. The medical literature is finally talking about this fat as a major indicator or symptom of underlying risk to cardio-vascular disease, cancer, diabetes, and all the inflammatory diseases that plague industrialized societies. If you have excess "belly fat" you are at risk to all of the above as well as sub-clinical hypothyroidism resulting from iodine deficiency. Frequently-experienced additional warning signs of low thyroid function due to iodine deficiency are a tendency to be cold when everyone else isn't, low energy levels, dull hair, weak fingernails, depression, and overweight that resists diet and exercise. *David Beaulieu, DC*

Heart, Arrhythmias, Fibrillation

As you have read over and over in Health Alert, there is an epidemic of cardiac arrhythmias and atrial fibrillation in this country. Expert Thyroidologists like Dr. Abraham are convinced that the medical iodine phobia has a great deal to do with this phenomenon. Adequate stores of iodine are necessary for a smooth heartbeat. Amazingly, while medicine shuns iodine therapy, their most popular anti-fibrillation drug, Amiodarone, actually is iodine in a toxic, sustained release form. This drug can produce a smooth heartbeat when the body has accumulated about 1.5 grams (1,500 mgs) of iodine. This is exactly the same amount of iodine retained by the human body when iodine sufficiency is achieved by natural iodine supplementation. The problem with Amiodarone is that this form of iodine (which the medical profession has a penchant for) is extremely toxic. The side effects are most often too great for patients to regain a normal heartbeat. Therefore it only makes sense to try to achieve iodine sufficiency with the natural form of iodine instead. That is why I always recommend iodine (in the form of Prolamine Iodine from Standard Process) with my arrhythmia and fibrillation patients.

Amiodarone Caution Guidelines!

If you are about to try to achieve iodine sufficiency with slowly increasing doses of Prolamine Iodine, **You must note that this is to be done in place of Amiodarone-not simultaneously with it.** So you will need to have your doctor stop the drug therapy when you start the iodine therapy. Therapy usually starts at 2 tablets of Prolamine Iodine daily for a week. If no problem arises, the dose increases slowly every week. If there are no problems along the way, and especially if your heart begins to function more normally, you would gradually increase your dosage to 12 mg to 24 mg per day for three months. This is, of course, in conjunction with your current heart protocol of phytonutrients like Cardioplus and/or Cataplex B.

Types of Iodine and Doses

For decades Lugol iodine has been used by expert Thyroidologists. But liquid iodine has problems-it tastes bad, can upset your stomach, and can stain your clothes. There is a Lugol tablet on the market called Prolamine Iodine. This is the type of iodine Dr. Abraham uses. Each capsule of Prolamine Iodine contains 3 mgs of iodine. Iodo-Caps is sold only to physicians, Exactly what dose is best for you is difficult to determine. But we now know that what were formerly considered high doses of the right form of iodine are safe and effective. Some iodine-deficient people only need 1-3 tablets daily. For people with more serious iodine deficiency problems, iodine sufficiency must be achieved. This is accomplished with a daily dose of around 12mg to 24 mgs for three months: or 4-8 Prolamine Iodine tablets. And this dose should be achieved slowly-starting with 1-2 daily. Without side effects, the dose should be increased weekly until the iodine sufficiency dose of 4-8 daily is achieved. After achieving the full iodine sufficiency dose, it should be maintained for three months.

****Note**** If you experience any of the following symptoms while taking the Prolamine Iodine **you have most likely achieved iodine tissue saturation and should stop the iodine until these symptoms have ceased. It would be advisable to also perform the iodine patch test for further confirmation of iodine tissue saturation.** Once you are symptom free, a **maintenance dosage** of 2-4 tablets per day is advisable for life.

- acne-like skin lesions in certain areas of your body
- headache in the frontal sinus
- unpleasant brassy taste
- increased salivation and sneezing
- racing heart AKA: tachacardia

We now know that it is possible for some people to eliminate their need for medical thyroid drugs after achieving iodine sufficiency. We also now know that anyone taking thyroid drugs like Synthroid should also be on iodine therapy. At the very least, iodine therapy can decrease the need for thyroid hormone drugs. We are just beginning to discover the amazing curative powers of iodine. While it may not be the panacea that old-timers have claimed, it is indeed critical. It is often the missing factor in "incurable" conditions like obesity, diabetes, breast disease, polycystic ovaries, thyroiditis, hypothyroid, autoimmune thyroid problems, and more. While some doctors claim that no one is really allergic to iodine, I have seen sensitivities. If you do not know if you are allergic to iodine, then you are not. Those who are allergic know it and carefully avoid shellfish, iodized salt, most fish, kelp, and other foods that contain iodine.

The Iodine Patch Test

If you are one of those who would like more proof that your body needs or does not need iodine, let me share a simple test. Buy a bottle of Tincture of Iodine at the drug store and paint a 2" square spot on your inner arm. If it disappears in less than eight hours, you desperately need iodine. If it disappears in 24 hours, you also need iodine. If it simply stays on your arm and begins to slowly fade in color after a full 24 hours, you have most likely reached iodine sufficiency. You can retest yourself every one to two weeks while on therapy. And you can use the test to help you judge your individual dosage need for iodine. Remember that contrary to current medical opinion, the real thyroid experts have proven that most patients who need iodine therapy require from 3 to 24 mgs./day. And that means from 1-8 Prolamine Iodine tablets daily. Always start out slowly. Judge your results, monitor your symptoms and any side effects, and use the thyroid patch test and or Barnes Basal temperature test (see below) to help you along the way.

Barnes Basal Temperature Test

Basal temperatures are taken first thing in the morning, when your body is completely at rest. At night before you go to bed, shake the thermometer down and leave it on your night table. In the morning, before getting out of bed and with as little movement as possible, place the thermometer in your armpit and leave it there for 10 minutes. Do not drink alcohol the night before you take your basal temperature. Use a mercury thermometer only. Do not use a digital thermometer. Menstruating women must take their temperatures on the 2nd, 3rd, and 4th days of their periods only. Non-menstruating women, women who had hysterectomies and men may take their temperatures anytime. The normal range is 36,6 - 36,8 ° C or 97.8 - 98.2 ° F. It is best to take 5 readings on different days and average the values. If your temperature is low this is a strong indicator for hypothyroid function and low iodine status.

Proceed Slowly

As discussed, some people are sensitive to the iodine. That is why all iodine therapy must be accomplished with a good degree of caution. Use the patch test to help you determine dose. Always start out at a low dose of 1 Prolamine Iodine tablet daily if you suspect you are sensitive. Increase your dose slowly-by adding one tablet each week. If you experience problems or side effects, stop your therapy. If you are like most people and continue to improve the therapy is effective. Watch for problems, watch for improvements, and see for yourself if iodine therapy is the missing link in your stubborn health problems.

Clinical Use Report Of Mild Silver Protein Dr. Joseph Cardot from Colorado

Researchers have been warning the medical establishment for years that the indiscriminate use of antibiotics could spawn< l>, they warned, would create a "post antibiotic world" where common, as well as uncommon, infections would quickly escalate into fatal illnesses. The warning have been ignored; the result is that we are - right now - facing a major threat to human life from formerly treatable infectious conditions. A friend of mine, Dr. Richard Callahan, York, NE, in a recent phone conversation remarked that, in his opinion, mutated pneumococcus bacteria and viral pneumonia will be killing thousands of Americans annually within five years. Bad news indeed. The good news is that Mild Silver Protein (MSP) may be an answer to the dilemma we are facing. I have operated a family practice for 37 years where I have treated all types of infections in patients varying in ages from infants to over ninety.

Before prescribing any treatment I believe a doctor should determine if the patient might suffer harmful effects from the treatment. "First Do No Harm." The treatment should also offer the prospect of helping the patient recover. MSP meets both of the criteria.

I started *using a silver suspension* in protocols for patients with infections in January of 1992. The first patient, a female, had "walking" viral pneumonia. She was placed on one tablespoon of the silver suspension t.i.d. She was asymptomatic the fourth day into treatment. I was astounded. I thought that it might have been a misdiagnosis. Since that first experience I have *treated more than 50 cases of viral pneumonia with the same positive results*. Time of treatment varies, due to patient condition and severity of infection, from four days to thirty days. The outcome, however, is consistently positive; the infection is cleared. Since that first experience I have included MSP in protocols for all types of infectious diseases with positive results. MSP has cleared reoccurring ear infections in children who were scheduled for tube surgery making the procedure unnecessary.

Infectious fibromyalgia(Fibromyositis) and Sjögren's syndrome patients have benefited from MSP therapy; MSP therapy helps many rheumatoid arthritis patients with synovial fluid infections that are causing inflammation to no longer need steroids.

Systemic Candida Albicans is successfully treated with MSP. It is so effective we must start with small doses to control Herxheimer effect. Staph and other infections in the mouth (Gingivitis) have dramatically improved with MSP therapy. **The Lyme disease spirochete (Borrelia burgdorferi) is eliminated using MSP therapy. I have records of Lyme patients who have been taking various antibiotics for three or more years who have become asymptomatic on MSP therapy after just three or four weeks of treatment. The average duration to rid the body of the spirochete is three to nine months. Systemic Candida Albicans frequently occurs in patients with Lyme; complicating the treatment and prolonging the duration of treatment.**

Lyme disease is far more prevalent than is generally known. Lyme has been reported in the U.S. in 43 states, and in all of Canada. I believe that reported cases of Lyme represent only about 20% of the actual number of Lyme cases. Lyme is routinely misdiagnosed as meningitis or as a "heat rash." A red rash is a typical symptom of Lyme. Mild Silver Protein solutions* are proving to be 100% effective in getting rid of the Lyme spirochete when they are included in the treatment protocol. The important thing about MSP therapy is that it is non-toxic. I have never observed any side effect from using MSP therapy, and I have used it in patients with all kinds of infections. In acute conditions as much as four tablespoons per day has been given, with no adverse reactions observed or reported.

HIV positive patients have responded to MSP therapy if begun before the advanced stages of full blown AIDS. Temple University studies indicate that MSP kills the HIV virus in vitro. I believe that the HIV can be completely eliminated by using higher concentrations of MSP than can be absorbed with oral dosing. In vivo studies should be done using 250 to 750 ppm MSP administered IV. Due to the fact that MSP is non-toxic in high concentrations, this should prove to be a God-sent treatment for the millions who are suffering and dying from AIDS related illnesses. The use of AZT and other chemotherapeutic drugs, in the vain attempt to treat AIDS is, in my view, simply death

by prescription. These drugs destroy DNA and the immune system; a case of "the cure being as bad as the disease."

Why not use a proven to be non-toxic protocol with AIDS patients, rather than the present approach of hitting them on the head with a hammer to get rid of the headache? Scientists at a major U.S. pharmaceutical company have developed a Mild Silver Protein solvent formula (MSP). This formula, when applied to the gums, produces dramatic improvement with the first treatment.* Saturate a band-aid pad with MSP and apply to ringworm. The infection is cleared in 2 to 3 days.

Psoriasis (virus in the skin) responds to MSP, applied topically. Within 3 weeks of treatment (b.i.d.) new normal skin growth is observed. It takes three to eighteen months of MSP therapy to heal psoriasis. MSP is so effective in treating gum diseases (Gingivitis) that, in my opinion, if widely utilized in the population, it could eradicate gum disease completely. I have seen patients with severe infections of the mouth whose symptoms included swollen gums, tongue, and cheeks (making them unable to speak or eat) improve immediately. We have seen excellent results using MSP therapy in Herpes genitalis. If MSP is applied topically when itching and soreness occurs prior to vesicular eruption it prevents eruption in more than 50% of the cases. Eruptions are mild when they do occur. If treatment is continued b.i.d. topically to the area, the infection clears in half the usual time. Patient should also take 2 teaspoons of MSP orally daily and remain on 1 teaspoon per day to help eliminate future out-breaks. Herpes Zoster (shingles) has been successfully treated as well. Pain is substantially relieved and duration of eruption reduced as indicated above with h. genitalis, (same Protocol). Mild Silver Protein is not a standard colloidal silver suspension. From "Penicillin to "Mild Silver Protein"

An Answer to Lyme Disease "Without Antibiotics" **By Dr. William Burgdorfer, Ph.D.** Rocky Mountain Laboratories, Division of N.I.H. In 1949, Dr. Sven Hellerström from the Dermatological Clinic of Karolinska Institute in Stockholm, Sweden presented a paper "Erythema chronicum migrans Afzelius with meningitis" at the 43rd Annual Meeting of the Southern Medical Association in Cincinnati, Ohio. In presenting his case, he provided convincing evidence that both erythema and subsequent

meningocerebrospinal symptoms may develop following a tick bite. He also reported on the successful treatment of his patient with penicillin, a drug shown previously by his colleague Dr. Hollström to be effective in the treatment of Erythema chronicum migrans (ECM).

In the United States, ECM was first reported in 1970 on a physician bitten by a tick while grouse hunting in northeastern Wisconsin. The attending physician, Dr. Rudolf Scrimanti, recognized the similarity of the patient's skin reaction to the lesions of European ECM and promptly and successfully treated the patient with penicillin. The treatment of three additional patients with penicillin and of one with erythromycin resulted in complete resolution of symptoms within 48 to 72 hours. Considered unrelated to ECM were skin lesions in 13 of 51 residents in the eastern Connecticut towns of Lyme, Old Lyme, and East Haddam where, since 1972, clusters of inhabitants had been suffering of an illness characterized by recurrent attacks of asymmetric swelling and pain in large joints, especially the knee. Since such arthritic conditions were not known to be associated with ECM in Europe, the illness was thought to be a new clinical entity and was named Lyme arthritis, later changed to Lyme disease once it was realized that arthritis was only one of several clinical manifestations of this disease. The search for effective antibiotics in the treatment of Lyme disease began in 1982 with my discovery of a spirochete now known as *Borrelia burgdorferi* as the causative agent of Lyme disease and of ECM and related disorders (acrodermatitis chronica atrophicans, lymphadenosis benigna cutis) in Europe. The antibiotics found effective include tetracyclines (doxycycline, minocycline), penicillins (penicillin G, amoxicillin), cephalosporins (cefataxim, ceftriaxone), and erythromycin. Application of these drugs depends on the time the disease is being diagnosed. Early Lyme disease is treated orally whereas late Lyme disease requires parenteral or a combination of parenteral and oral applications. Treatment failures have been reported for each of these drugs particularly for the tetracyclines that are only temporarily effective unless they are applied over long periods of time, i.e. months even years. Controversy exists over the length of treatment using Mild Silver Protein (MSP). Some investigators consider 21 to 30 days sufficient for the elimination of the spirochetes, while others believe that patients must be on therapy until they are completely free of symptoms.*

The diagnosis of Lyme disease is a clinical one and is based on the development and recognition of the skin lesion (erythema migrans) a few days, weeks, or even months, after the bite of an infected tick. Unfortunately in up to 40% of the patients, the skin lesion does not develop, is not recognized, or is overlooked. Thus, without treatment, the disease spreads throughout the body and may affect the muscular, skeleton, cardiac and nervous systems. Indeed, Dr. Farber's recent claim having used MSP to successfully cure himself from late stage Lyme disease, comes at a time when thousands of patients suffering of this disease are refused extended antibiotic treatment because their physicians are unable to associate their clinical manifestations with those of Lyme disease. Although never established scientifically, it appears that the Mild Silver Protein silver colloid disables the enzyme(s) used by bacterial, fungal and viral agents for their oxygen metabolism causing them to suffocate upon contact. In vitro studies with Mild Silver Protein and the Lyme disease spirochete, *B. burgdorferi*, revealed a 100% killing effect within less than five minutes after exposure to the silver preparation.*

TRIAL RESULTS OF MILD SILVER PROTEIN IN LYME DISEASE*

Preliminary laboratory studies on *Borrelia burgdorferi* spirochetes revealed that mild silver protein solutions reduce the growth rate of these cells significantly and eventually lead to cell death. It has been pointed out, however, that the spirochetes tested belong to a laboratory ATCC strain which is widely used in cell and tissue cultures and does not represent recent isolates from Lyme disease patients. In these tests, various concentrations of silver protein solutions were added to the culture of *Borrelia* spirochetes. Low concentrations of a silver protein solution (ranging from 2 to 10 parts per million) slowed the growth rate of the spirochetes over a time span of 1 to 3 days. Higher concentrations of silver protein (between 15 to 75 parts per million) had a much faster deleterious effect on cell replication. Growth inhibition depended on the concentration of the silver protein and on the duration of treatment. More studies are definitely necessary to obtain a clearer picture of the interaction between the silver protein and *Borrelia burgdorferi*. As these very preliminary studies suggest, growth and replication of Lyme spirochetes are measurably inhibited by silver protein in the in vitro setting.

January 13, 1995 Dear Sir:* This is to inform you that we have received a sample (12 ml) of your colloidal silver (1,500 ppm) preparation and have evaluated its effectiveness in a preliminary pilot study against Lyme disease spirochete, *Borrelia burgdorferi* (B31) and against the relapsing fever agent, *B. Hermsii* (HS-1).* In both tests, BSK cultured

spirochetes were treated with 150 and 15 ppm of colloidal silver. When examined 24 hours later, none of the treated cultures contained live spirochetes. Few spirochetes, all dead, were observed at 48 hours. Additional in vitro and in vivo studies are in progress and will be reported as soon as results become available.



Lyme Disease

The following protocol has been effective in the treatment of both Lyme Disease and Candida LYME DISEASE: This protocol has been extremely effective in treating

Lyme Disease, to the extent that people afflicted with the disease becoming asymptomatic. The largest problem stemming from this treatment appears to be the reluctance of the individual to continue with the protocol when the Herxheimer (**or detoxification**) reaction occurs. The Herxheimer reaction occurs in 80% of the cases when Candida is present, and can vary in degree of severity on a case by case basis. Candida is present in almost all Lyme cases due to prolonged antibiotic usage. To estimate the severity of the reaction one must assess the progression or extent of Candida. The Herxheimer reaction does not appear to be as severe if very small amounts are used for 7 days prior to beginning the full protocol amount. The treatment period seems to vary from individual to individual. Substantial improvement is noted in most cases after two weeks on the full protocol. Within thirty days dramatic improvement is noticed in most cases. Continuing treatment for six months usually results in the individual being asymptomatic. Ongoing testing and trials may well prove that one injection of *this concentrated MSP may cure the disease.
