[40% Of Residents Exposed To BP Gulf Oil Spill Suffer From Respiratory Problems And Skin Lesions](#)

Columbia University reports a survey of Gulf Coast residents exposed to the BP Gulf Oil Spill are suffering from a wide range of problems including a shocking [40% who report either respiratory or skin problems](#).

The survey, conducted by telephone **in July** after the Deepwater Horizon well was capped, found evidence of significant and potentially lasting impact of the disaster on the health, mental health, and economic fortunes of residents and their children and on the way they live their everyday lives. The findings have implications for health and economic policies going forward.

Survey Findings

Among the key survey findings:

- Over 40% of adults living within ten miles of the coast said they have experienced direct exposure to the oil spill or clean-up effort. Within this group, nearly 40% reported physical symptoms of skin irritations and respiratory problems, which they attributed to the oil spill.
- Over one-third of parents report that their children have experienced either physical symptoms or mental health distress as a consequence of the oil spill.
- One in five households report a drop in income since the oil spill, and 8% report job loss. These losses were most likely to hit those who were already economically vulnerable: households with incomes under \$25,000 a year.
- More than one-quarter (26.6%) of coastal residents said they thought they might have to move away from the Gulf Coast. Among those earning less than \$25,000, the figure was 36.3%.

Workers at the, "source," reported that the sea was literally FULL of animal carcasses. Unreported by the fraudulent media, the carcasses [eventually disappeared!](#)

One thing was clear ... we weren't getting the story.

All manner of apocalyptic scenarios were running through my head that morning when by chance I received a very strange message that pointed to a less fantastic but equally horrific explanation. It was a text message that had been sent on a borrowed phone to a man's wife (according to the person who forwarded it to me) a man who had just returned from what many are now calling the "Death Gyre." The message was e-mailed to a family friend who posted it on Facebook and it has since been recirculated. Here's the text (you will notice a few colloquialisms that are specific to Bayou talk) so read through the lines, and forgive the misspellings:

I have to write this mail on a new cellphone because they have taken our phones off us. people dont know how bad this oil is.. im working in the cleanup operation and we've all has to sign a legal paper that stops us from talking to anyone. im onshore now and cant tell you where but ive just finished a very long shift in the gulf and textin this....fast as i can. the military are watching us dolphins whales, seabirds fish are all floating dead on the surface of the water.. see more.. see more...boats helicopters are scooping them away dead and dying... Whales are being exploded by the military cause they cant be carried. dead bodys as far as the eye can see air smeling of benzene ..weve seen birds fall from the sky. workers falling sick we think some workers have died. my friends are hard oilmen it was (not) ok to at the start but now we cry. dead sea life is as big as

genocide you wont imagine

Since no one has yet been able to get this individual to go on record (and the Facebook post was eventually taken down) this can't be taken as hard evidence, but it does beg the question ... just how many animals *have* died because of the worst oil spill in U.S. history?

According to the latest count of the U.S. Fish and Wildlife Service's Daily Collection Report ([PDF](#)), only about 4,100 birds, 670 turtles, 70 sea mammals, and 1 snake have died in the Gulf since April 20 (assuming 50 percent mortality of live animals).

It's an astonishingly low number, considering that one of the largest pods of sperm whales in the U.S. resided just miles from the site of the BP Macondo well (aka Deepwater Horizon), a region home to one of the most abundant and biodiverse marine ecosystems in the world.

Compare those small numbers with the Exxon Valdez spill ... Best estimates put the toll of the far smaller oil spill in [Alaska](#) at more than 200,000 birds (including hundreds of eagles), more than 3,000 sea mammals, more than 20 whales, and billions of fish eggs. The accident permanently wiped out the herring population of this Alaskan Gulf region. And that was an accident 1/10th the size of the Deepwater Horizon.

The supposed final tally of the BP oil spill is almost 5 million barrels of crude, compared to only about 500,000 barrels for Exxon Valdez — a 1:10 ratio. Yes the Alaska spill happened closer inland, but the oil was not fully integrated with the water column as in the BP gusher (a far more pervasive and deadly scenario) and neither were thousands of tons of highly toxic dispersants like Corexit, a chemical that has, ironically, been banned in Britain because of its impacts on wildlife and human health.



One would be forgiven then for assuming there *should be* a far greater body count than what is currently being reported by the Fish and Wildlife Service, the same government office that famously blocked Anderson Cooper from peering past the 10' high barricades that had been put up to enclose a "bird receiving" area. According to the math, the count should be in the hundreds of thousands of dead birds, tens of thousands of sea mammals, and millions upon millions of fish and shellfish. So where were all the dead bodies? We should be seeing something like the mass dolphin kill

off the coast of Zanzibar (left) that resulted from a much smaller offshore oil leak.

Is it possible that a massive cleanup operation in early June was focused on collecting dead animals out at sea in naturally forming "death gyres?" According to marine toxicologist Riki Ott, such [gyres of dead and dying animals](#) were common for weeks after the Exxon Valdez spill. And we know that BP was doing everything in its power to keep dead animal photographs out of the press. Kate Sheppard and Mac McLelland of Mother Jones documented several instances of BP actually [barring photography](#) of dead animals on public beaches.

I received two firsthand accounts indicating that some sort of processing operation was taking place—one from [Alabama](#) (a rig operator contracted to work in an abandoned Navy yard) and one on Grand Isle — both reporting the construction of highly secured, nearly militarized ports that had been converted into "waste processing" areas.

Then I got an e-mail with some interesting photos that were uploaded to Citizen Global, a crowdsourcing news platform, on their [Gulf News Desk](#).

It was a firsthand account by an individual working in the Gulf, who reported...

... receiving unconfirmed confidential reports that BP is withholding information about fish kills including that of sperm whales, whale sharks, Blue-fin Tuna and other marine mammals. (...) Following up on these leads, recently I flew over the staging areas where the reports allege that BP has been engaged in these secretive operations. What I saw from the air over Shell Beach and Hopedale, [Louisiana](#) was what seemed to be military protected staging areas where whales could potentially be brought in from offshore, processed under huge white tents, then carted off in trash trucks owned by a collaborative of oil companies, including BP. I'm deeply concerned that BP has the power to put in place restrictions on... access to certain areas of the ever-growing BP drilling disaster location and will continue advocating for a change in this policy.

A team of journalists, including Jerry Cope of the Huffington Post and Charles Hambleton, co-producer of the Academy award-winning documentary "The Cove", went down to the region to investigate. They had some [interesting findings](#) to report and got some great interviews with locals on the mystery of the disappearing dead animals. Most notable was their finding that some municipal dumps had been secured by law enforcement officials in the area, and several individuals reported the dumping of bags full of rotting carcasses.

You might be wondering about motive. Sure BP probably wanted to keep the full, gruesome reality of their toxic nightmare out of the press as much as possible. But was that enough of a motive to warrant such a massive and expensive operation? Probably not. A greater incentive may have been the fines the company would have incurred if the correct number of dead carcasses had been verifiable. At [\\$50,000 a pop](#), hundreds of thousands of dead animals could spell B-A-N-K-R-U-P-T-C-Y for BP, and that's something that no one, including the U.S. government, would have wanted to happen

Jerry Cope and his team spent two days flying over the Gulf and from what he has

seen, the whole Gulf is a strange greenish color, with nothing moving, wildlife is virtually non-existent! This would indicate that not only are thousands of people sick but a vast amount of wildlife throughout the Gulf has either left or been killed.

Corporate news has enthusiastically [declared](#), “75% of the oil has dissipated.” This criminally negligent reporting on the part of these so-called news outlets must not go unpunished. The media is supposed to play an important part in our society by providing the checks and balances needed to keep our government honest. When they fail to do so, not only are they failing at their job, they are jeopardizing thousands of lives.

Meanwhile, in Louisiana, a dive team has found oil, under their feet! That’s right, in a scene similar to the beaches around the Exxon Valdez spill, oil [has been filmed](#) spewing out from underneath the beach.

Oil companies, using their corporate puppets in the mainstream news, have been documented leaving spill-infected areas to [basically rot](#) while at the same time publicly declaring that they did everything possible in their cleanup efforts.

People need to understand this; the oil has NOT dissipated! The stated purpose of Corexit9500 and other dispersants of the same nature is to push the oil under the water. In fact, Professor Ian McDonald of Florida State University has gone on record stating that 40 to 45% of the oil is currently caught up in underwater plumes.

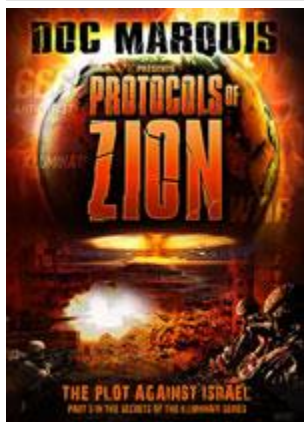

"It has been reported that [46 states are on the verge of bankruptcy](#). Since states are Constitutionally mandated to balance their budgets, and do not possess the ability to print money, they're finding themselves in a critically weakened position to challenge the Federal Government."

The Tenth Amendment: which makes explicit the idea that the Federal government is limited only to the powers granted in the Constitution, is generally recognized to be a truism. States and local governments have occasionally attempted to assert exemption from various federal regulations, especially in the areas of labor and environmental controls, using the Tenth Amendment as a basis for their claim."

In the past several years, the Federal Government has made several attempts to assert their right over the states.

* "Obama and company are suing Arizona to overturn their new anti-illegal immigration law, which is essentially a reiteration of the Federal law, just with plans to actually prosecute it."

* "Additionally, we have seen the steady erosion of the Posse Comitatus Act, which prohibits the use of the military for local law enforcement. Stories of active military and the National Guard helping local law enforcement on operations as routine as random traffic checkpoints and local crimes such as illegal gun and drug searches are becoming everyday news -- again a clear violation of the Tenth Amendment."

"It is clear that the goal of Federal government is to centralize and consolidate control as much as possible Based on the clear violations already exhibited by the Federal government, we can only assume that more centralized oppression is on the way."

This conclusion is exactly right! WHISTLEBLOWERS NOT ILLEGAL ALIENS FACE CRIMINAL CHARGES

"We live in a topsy-turvy nation and this story should anger all Americans. Suddenly our nation is **prosecuting patriots while protecting lawbreakers,**" said a former NYPD police officer and private security firm owner.

The Utah state employees, **suspected of blowing the whistle on more than a thousand illegal immigrants living in the state, have been placed on administrative leave and will likely be criminally charged, according to attorneys from a non-partisan, public-interest group.**

Last week a list of 1,300 suspected illegal aliens was circulated anonymously to various state and federal agencies as well as media outlets, according to a statement from the Washington, DC-based [Judicial Watch](#).

A letter was enclosed with the 29-page list that included the illegal aliens' phone numbers, addresses and birth dates. The letter, signed "[Concerned Citizens of the United States](#)," alleged that they "observed these individuals in our neighborhoods, driving on our streets, working in our stores, attending our schools and entering our public welfare buildings."

Copies of the list and letter were sent to law enforcement agencies, news media outlets and Utah state lawmakers by the group, who demanded that those named be deported.

Calling it the "deplorable" work of a "small rogue group," Utah Governor Gary Herbert quickly launched an investigation and vowed to punish any public employees responsible for participating in blowing the whistle.

So far two workers with the Utah Department of Workforce Services have been suspended and at least eight others are under investigation. All face criminal charges for violating state and federal privacy laws, according to the governor.

"We live in a nation where the wicked are increasingly imposing their will on the masses and this story should anger all Americans. Suddenly our nation is prosecuting patriots while protecting lawbreakers," said former NYPD police officer and private security firm owner Bill Fitzgerald.

Latino Project director Tony Yapias told [Reuters](#) that his Utah office was "inundated with calls from concerned Hispanics (**Illegal Aliens**) asking if they were on the list."

Utah Democrat Party officials are proud of their protecting illegal immigrants and providing them with endless public benefits, including discounted tuition at public colleges and universities as well as other perks not afforded under federal law.

Two of the state's largest cities -- Salt Lake City and Provo -- have official sanctuary policies that forbid public employees or law enforcement officers from inquiring about a resident's immigration status.

Earlier this year Utah proudly became the nation's first state to offer a special class of driver's licenses for illegal aliens who won't be ineligible to obtain the cards when new federal security standards kick in. For years, Utah was one of only a handful of states to offer illegal immigrants driver's license.

However, some Utah lawmakers plan to introduce legislation similar to the new law in Arizona, which requires state and local police to determine the immigration status of anyone they encounter in the course of their police work whom they reasonably suspect of being in the country illegally.

A majority of voters say the federal government should take legal action against cities that provide safe havens to illegal aliens, according to the [Washington Times](#).

Meanwhile, hundreds of protesters marched in front of the Arizona state Capitol yesterday to display their opposition to that state's quest to enforce illegal immigration laws. After holding a **prayer vigil** at a church, hundreds of protesters demonstrated in front of the federal courthouse. According to law enforcement officials, the protesters are being bused into Arizona from California.

These out-of-state demonstrators are being directed by labor unions such as the [Service Employees International Union](#) (SEIU), according to police sources.

Protesters also engaged in a sit-in at the office of Maricopa County Sheriff Joe Arpaio. Those protesters who became violent and disruptive were arrested, and the popular sheriff vowed to go ahead with a crime sweep targeting illegal immigrants.

"My deputies will arrest them and put them in pink underwear," Arpaio said in a news release. "Count on it."

Arizona Sheriff: 'Our Own Government Has Become Our Enemy'

(Correction: As initially posted, this story inaccurately said that Pinal County was contiguous with the Mexican border. It is in southern Arizona, but not on the border.)

(CNSNews.com) – Pinal County (Ariz.) Sheriff Paul Babeu is hopping mad at the federal government.

Babeu told CNSNews.com that **rather than help law enforcement in Arizona stop the hundreds of thousands of people who come into the United States illegally, the federal government is targeting the state and its law enforcement personnel.**

What's very troubling is the fact that at a time when we in law enforcement and our state need help from the federal government, instead of sending help they just put up billboard-size signs warning our citizens to stay out of the desert in my county because of dangerous drug and human smuggling and weapons and bandits and all these other things and then, behind that, they drag us into court with the ACLU," Babeu said.

The sheriff was referring to the law suits filed by the American Civil Liberties Union and the U.S. Department of Justice challenging the state's new immigration law.

"So who has partnered with the ACLU?" Babeu said in a telephone interview with CNSNews.com. **"It's the president and (Attorney General) Eric Holder himself. And that's simply outrageous."**

Last week, U.S. District Judge Susan Bolton placed a temporary injunction on portions of the bill that allowed law enforcement personnel during the course of a criminal investigation who have probable cause to think an individual is in the country illegally to check immigration status. The state of Arizona filed an appeal on Thursday with the 9th Circuit Court of Appeals.

"Our own government has become our enemy and is taking us to court at a time when we need help," Babeu said.

"If the president would do his job and secure the border; send 3,000 armed soldiers to the Arizona border and stop the illegal immigration and the drug smuggling and the violence, we wouldn't even be in this position and where we're forced to take matters into our own hands," Babeu said.

Dever said the federal government's failure to secure the border and its current thwarting of Arizona's effort to control illegal immigration within its borders has implications for the entire country.

"The bigger picture is while what's going on in Arizona is critically important, what comes out of this and happens here will affect our entire nation in terms of our ability

to protect our citizenry from a very serious homeland security threat," Dever said. "People who are coming across the border in my county aren't staying there. They're going everywhere USA and a lot of them are bad, bad people."

New boycott targets include AOL, Darden Restaurants (Bahama Breeze, The Capital Grille, LongHorn Steakhouse, Olive Garden, Red Lobster, Season 52), Franchise Services (PIP, Signal Graphics, Sir Speedy), Hilton Worldwide (Conrad Hotels, Doubletree, Embassy Suites, Hampton Inns/Suites, Hilton Garden Inn, Hilton Hotels, Homewood Suites), Ignite Restaurants (Brickhouse Tavern+Tap, Joe's Crab Shack), ING (financial services), Kohl's (department stores), Mrs. Fields (cookies), Staples (office/school supplies), Toys "R" Us, and Trader Joe's (markets/supermarkets). Returning to The Boycott List are The Gap (apparel/accessories) and Freddie Mac (U.S. Government-sponsored secondary mortgages).

Corporations continuing as boycott targets from the previously released Boycott List include AlphaGraphics, Wells Fargo (including Wachovia), Nike, Time Warner, Bank of America, Walt Disney, Johnson & Johnson, Lost Arrow (Patagonia, etc.), Chevron, and Nationwide Insurance, among others.

Garvey was critical of pro-life organizations that continue to use PayPal even though it has been a boycott target for several years now. "PayPal is owned by boycott target eBay," Garvey said. "Most pro-life groups are aware that it is a boycott target because it has funded Planned Parenthood, but they have consciously chosen to continue doing business with the company. Doing so is indefensible." Garvey said alternatives to PayPal exist and he will gladly help anyone who has trouble tracking them down. "It is unconscionable that anyone who claims to be pro-life would willingly do business with a company that funds the number one enemy of preborn children," Garvey said.

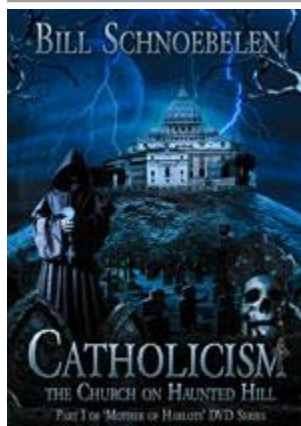

Benny Hinn was first visited the **Vatican in 1989, when he had a personal meeting with Pope John Paul II.**

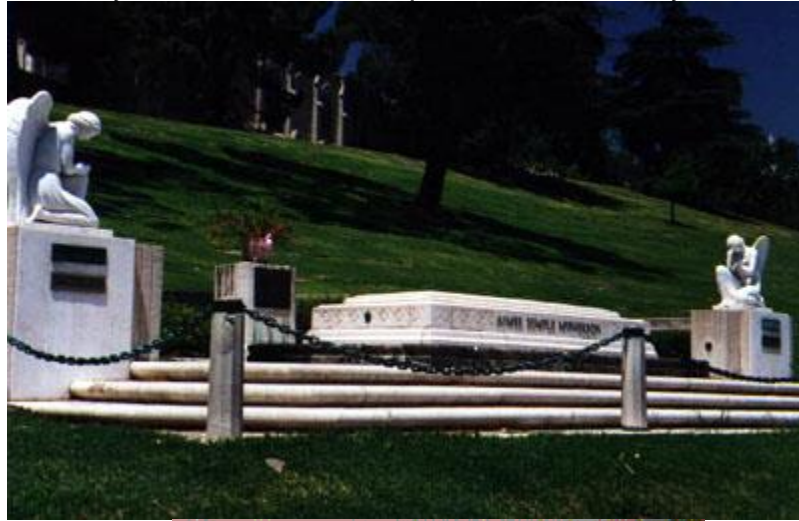

They're gonna come with me. You—you—you gonna feel the anointing at Aimee's tomb. It's incredible. And Kathryn's. It's amazing. I've heard of people healed when they visited that tomb.

For much of Kathryn Kuhlman's early ministry, she lived in the shadow of her role model, the most famous woman preacher of all, [Aimee Semple McPherson](#) ... although she never met Aimee at the Angelus Temple, "enough of the glitter rubbed off to start her toward her own superstar status." (Wayne E. Warner, Kathryn Kuhlman (Ann Arbor, MI: Servant Books, 1993, p203-205)

Kathryn (had a) flamboyant lifestyle. Not only (did she have a) love for "expensive clothes, precious jewels, luxury hotels, and first class travel," but (she was also married) "to an evangelist, who divorced his wife to marry Kuhlman." (Burgess and McGee, Pentecostal and Charismatic Movements, 529-530

1. Aimee Semple McPherson, nationally known healing evangelist in the 1920's - 1930's. Founded and headed the Foursquare Gospel Church, led a controversial life and died of a drug overdose in 1944.
2. She thought that her organization was in fact restoring true Christianity which had been lost over the years.
3. She is without doubt the most controversial of all the Pentecostal women. She got the baptism in 1907 and soon went with her husband to China, where he died. She came back to the United States and traveled as an evangelist. In 1919 she settled in Los Angeles where she built the Angelus Temple. She served as the pastor of the temple until her death in 1944. She is controversial because she faked her own kidnapping in order to carry on an adulterous affair in 1926. During the outcry against her over this affair she incorporated The International Church of the Foursquare Gospel, which later grew into a large Pentecostal denomination. The Foursquare denomination exists today. Sister Aimee died of a barbiturate overdose in 1944.
4. While the Dictionary of Pentecostal and Charismatic Movements deals with the controversial aspects of "Sister Aimee's" life -- her mysterious disappearances and alleged affairs, multiple marriages (two of which ended in divorce), and death from an apparent drug overdose -- it is strangely silent about her theatrical preoccupation with the slain in the spirit phenomenon.

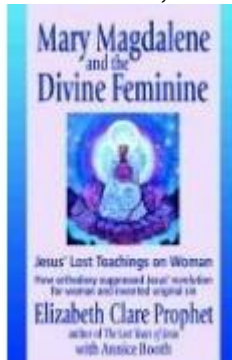
