## Obama Signs Executive Order to Allow Detention of Americans With 'Respiratory Illnesses' Amendment comes in wake of Ebola scare



August 1, 2014 – As the Ebola outbreak continues to cause concern, President Barack Obama has signed an amendment to an executive order that would allow him to mandate the apprehension and detention of Americans who merely show signs of "respiratory illness."

The executive order, titled [Revised List of Quarantinable Communicable Diseases](#), amends [executive order 13295](#), passed by George W. Bush in April 2003, which allows for the, "apprehension,

detention, or conditional release of individuals to prevent the introduction, transmission, or spread of suspected communicable diseases."

The amendment signed by Obama replaces subsection (b) of the original Bush executive order which referred only to SARS. Obama's amendment allows for the detention of Americans who display, "Severe acute respiratory syndromes, which are diseases that are associated with fever and signs and symptoms of pneumonia or other respiratory illness, are capable of being transmitted from person to person, and that either are causing, or have the potential to cause, a pandemic, or, upon infection, are highly likely to cause mortality or serious morbidity if not properly controlled."

Although Ebola was listed on the original executive order signed by Bush, Obama's amendment ensures that Americans who merely show signs of respiratory illness, with the exception of influenza, can be forcibly detained by medical authorities.

Although the quarantining of people suspected of being infected with the Ebola virus seems like a perfectly logical move, the actual preconditions for this to happen aren't restricted to just those suffering from the disease.

As we [highlighted earlier this week](#), the Centers for Disease Control and Prevention (CDC) has measures in place for dealing with an outbreak of a communicable disease which allow for the quarantine of "well persons" who "do not show symptoms" of the disease.

In addition, [under the Model State Emergency Health Powers Act](#), public health authorities and governors would be given expanded police powers to seize control of communications devices, public and private property, as well as a host of other draconian measures in the event of a public health emergency.

When the legislation was introduced, the Association of American Physicians and Surgeons warned that it "could turn governors into dictators."

Yesterday it was [reported](#) that Emory University Hospital in Atlanta was set to receive a patient infected with Ebola. A hospital in Germany [also accepted](#) an infected patient earlier this week. Some critics have raised concerns about the risk of deliberately importing infected individuals into the west.

## **Ebola Quarantine Stations Established in El Paso, Los Angeles and 18 Other Cities**

I have an idea. Let's bring Ebola here instead of worrying about it coming here unexpectedly. If we are going to put 300 million people in jeopardy, it should be our choice to do so rather than having it come as a surprise.

## **Infected Ebola patient was flown to Atlanta: Are health authorities risking a U.S. outbreak?**

(NaturalNews) **Despite the fact that doctors in Africa cannot keep Ebola from spreading, United States officials brought an affected patient into the country only days after President Obama signed an executive order mandating the detention of Americans who show signs of "respiratory illness."**

A patient infected with Ebola is being flown into the United States to be held for medical examination and treatment at Emory University in Atlanta, reports The Guardian. The patient is reportedly one of the American doctors who was recently infected with the disease.

This event will make the first time in history that a level-4 biohazard infectious agent is being transported by air into a large U.S. city while still multiplying inside a living patient. This startling revelation brings up all sorts of questions that range from the gullibly hopeful to the impossibly sinister.

“It sounds like the perfect script for a horror movie: A virus with no vaccine and no cure kills hundreds of people; despite containment efforts, it keeps spreading, but it’s actually all too real in West Africa, where doctors have said Ebola is now ‘out of control,’” wrote Sheila M. Eldred for [Discovery News](#).

Hospitals in America may not fare any better considering that antibiotic-resistant “nightmare bacteria” spread from one medical facility in 2001 to 46 states by 2013.

“Allegedly the Ebola carriers will be quarantined in special rooms, but we already know that American hospitals cannot even contain staph infections,” “What happens to the utensils, plates, cups, and glasses with which the ebola infected persons eat and drink and who gets to clean the bed pans?”

“One slip-up by one person, one tear in a rubber glove, and the virus is loose.”

This really highlights the reckless nature of the global elite and government officials for importing a virus into the country which has no specific treatment and a mortality rate of up to 90%.

At the same time, we cannot refute the fact that there are drug company profit interests at stake in all this. The worse the Ebola problem becomes, the more money can be made from future Ebola vaccines or anti-viral treatment drugs. We already know one company called Tekmira has already been awarded a \$140m contract by the Department of Defense for its Ebola drug development program.

At an even spookier level, we also know that Ebola is one of the most easily weaponized viruses on the planet. We also know the U.S. Department of Defense has already developed weaponized strains of Ebola and keeps them supercooled in a level-4 biohazard facility somewhere. This is justified on the grounds of "national defense," of course, just in case the survival of the nation one day depends on deploying a global killer virus on enemy territory.

You can bet blood samples from this patient will be shared with Pentagon virologists, just in case it's some new strain with a mutation that makes it an even better bioweapon than what the military already has.

**To understand Ebola prevention, you first need to understand how it spreads.**

Ebola is a level-4 biohazard virus. It spreads so easily and quickly that even well-trained doctors wearing protecting masks and gloves keep getting infected from nearby patients.

An Ebola infection only requires a single viral organism to enter your body, usually through your mouth or eyes. A person who rubs their eyes with their finger can instantly cause an Ebola infection of a single virus was resting on their finger.

Ebola can spread through "aerosols," meaning liquid particles suspended in the air. When a person infected with Ebola sneezes, vomits or coughs, they can create Ebola aerosols. "1 - 10 aerosolized organisms are sufficient to cause infection in humans," explains the Public Health Agency of Canada. (2) This is how Ebola becomes "airborne" even when it is not traditionally categorized as an airborne disease.

Sanitizing surfaces is a significant part of any defense against Ebola infections. It is well established that Ebola can be killed with sodium hypochlorite, also known as bleach. It's also killed with methyl alcohol, Triton X-100 and UV radiation.

This means **sunlight kills Ebola**, which is probably why you don't find much Ebola in the deserts of the world. **The pathogen tends to come out of humid jungle areas that are dark and damp. If it were to invade the USA, it would be far more "successful" in places like Florida and Louisiana where heat and humidity are commonplace.**

Everybody knows a global pandemic is coming sooner or later. The very structure of human society -- with high-density cities and rapid air travel -- creates a "perfect storm" for the spread of infectious disease.

Ebola has a fatality rate of 50 - 90 percent, depending on the strain. It causes severe immunosuppression and often leads to death by internal dehydration from the inability of the intestines to absorb water. **People with suppressed immune systems seem to be especially vulnerable to Ebola, so one of the most obvious defensive strategies is to support your immune function with the following nutritional supplements:**

- **Vitamin D-3 (which is well known to function as an antiviral medicine) Vitamin D 5,000 IU - 60 capsules**
- **Zinc (helps your immune system resist infections) Zinc Liver Chelate™**
- **Selenium (also boosts immune function) Selenium - 90 tablets**
- **Vitamin C (full spectrum source, from plants if possible) C Complete Powder 81 G & Vitamin C-400 - 180 tablets**

### **Stop suppressing your immune system**

It's also a good idea to stop suppressing your immune system on a day-to-day basis. How do people suppress their immune systems?

- 1) **Lack of sufficient sleep.**
- 2) **Consumption of processed junk foods.**
- 3) **Consumption of medications.**
- 4) **Smoking cigarettes.**
- 5) **Sedentary lifestyles (avoidance of exercise).**
- 6) **Avoidance of sunlight (not spending enough time in nature).**
- 7) **Nutritional deficiencies of important minerals like zinc.**
- 8) **Chemotherapy and radiotherapy treatments.**
- 9) **Exposure to pesticides, herbicides, glyphosate and other chemicals.**
- 10) **Eating GMOs.**

This last point is a huge one: **eating GMOs suppresses immune systems so much that I believe the most likely people to die in the next pandemic that sweeps through North America are those who eat a lot of GMOs.** To avoid this, **buy organic.**

To my knowledge, there are no known natural cures for Ebola **Comment: Wrong! More on this later.**, but because it is an immunosuppressive disease, it makes sense to follow many of the same rules you'd follow for other viral infections we just mentioned.

The conventional medical system might offer you some anti-viral drugs, but their effectiveness is minimal unless deployed very early during the onset of the infection. **For the most part, the way western doctors deal with Ebola patients is with a "watch and wait" approach. The patient either conquers the infection on their own and wakes up on the path of recovery, or they never wake up at all.**

In other words, **modern medicine with all its claimed advances still has about the same approach to Ebola as a doctor in the 1800's: hope the patient survives (and try not to infect yourself in the mean time).**

### **West Africans Could Be Streaming Across the U.S. Southern Border Carrying the Ebola Virus**

(Dave Hodges) While appearing on my talk show, Dr. Jane Orient, an internal medicine specialist and the Executive Director of the Association of American Physicians and Surgeons (AAPS), **clearly stated that Border Patrol informants told her that as many 100,000 West Africans are in Central America, have been taught to speak Spanish and are coming across our Southern border. Dr. Orient further stated that Ebola screening practices had not been implemented at the border with immigrants that were being detained. Please note that the incubation period for Ebola is up to 21 days.**



In Arizona, state officials learned that Obama had ordered ICE to deliver unscreened illegal immigrants to bus terminals in Phoenix and Tucson AFTER their arrival. The same was true in several border state communities and there was no evidence that ANY health screening had taken place.

**Dr. Orient had also learned that the Border Patrol has taken to laundering their own clothing at their work site because of the risk to their families.**

A week after the Dr. Orient interview, I was traveling to San Diego for vacation and had a chance encounter with a Border Patrol agent in a convenience store in Yuma, AZ. I approached him, gave him my business card, promised not to use his name and proceeded to ask him questions about the border. In a short five minute conversation, he told me that Border Patrol officials are contracting drug resistant TB, Scabies and bacteriological pneumonia. When I told him of Dr. Orient's claim that Border Patrol officials had told her that they were concerned over West Africans who were crossing our border, he said he was indeed aware that West Africans were crossing our border but he did not know in what numbers.

Nearly 10 days later, the Border Patrol Agent contacted me at the number on my business card and this time he had a partner on the phone. Both agents confirmed that the number of West Africans crossing our border matched Dr. Orient's revelation. Further, they confirmed the presence of UN and World Health Organization officials at the detention center that they were assigned to after they were taken off of actual field duty and assigned clerical duties.

**This is called double sourcing the information originally presented by Dr. Orient.**

Adding fuel to this fire is a statement that comes from the chairman of the National Association of Former Border Patrol Officers (NAFBPO), Zack Taylor, who states that West African illegal immigrants are presently coming into the U.S. through Mexico. These West Africans have been apprehended in the Rio Grande Valley sector in the last few years. Some of these West African groups have been taught to speak Spanish in order to infiltrate into the United States posing as Central American immigrants. This speaks to planning and collusion that some of these groups were taught to speak Spanish so they will "blend in" with other illegal immigrant groups. This is another piece of evidence that the coming series of pandemics has some governmental agency fingerprints on this invasion. Smart money would say that the CIA is involved.

**Zack Taylor's revelation is confirmed by one of my DEA sources, through the revelation of circumstantial evidence. My insider DEA source has confirmed that the Sinoloa and Los Zetas Mexican drug cartels receive their weapons and drugs in Peru from a drug cartel known as the SANCHEZ-Peredes. **Seven Facts You Should Know About Ebola--Be Prepared for a Pandemic!**

How to prepare for a pandemic? The usual: **plenty of food, water, first aid supplies, [face masks](#), and something to keep your mind occupied in the event you are confined to close quarters.** I also recommend essential oils but more about that in a moment.

**You should also be prepared to physically isolate yourself. If a pandemic is even rumored, isolate yourself from large crowds, avoid commercial travel, and head out to your bug-out-location if you have one.**

You might remember Dr. James Hubbard from a recent Backdoor Survival Book Festival. He is the author of [Living Ready Pocket Manual – First Aid: Fundamentals for Survival](#) and [DuctTape 911: The Many Amazing Medical Things You Can Do to Tape Yourself Together](#). When I asked him about this, he pointed to some information posted on his website and gave me permission to share it here on Backdoor Survival. Here are his thoughts including seven facts you should know about Ebola.

A new outbreak of Ebola is going on in Africa, and Doctors Without Borders is calling it “an epidemic of a magnitude never seen before”—not because of the number of cases or deaths. There have been more in previous outbreaks. **It’s because of how the disease is spreading.**

In the past, Ebola has always stayed confined to a small region. This time the same strain of the virus has been found infecting people several hundred miles from the original area.

The questions on the minds of many people who don’t live in Africa are, **could it come here?**

**Comment: It already has thanks to the government.**

Ebola is a horrendous viral disease **where the victims sometimes bleed out of every orifice before they die.**

Ebola is on the U.S. list for potential bioterror agents. That’s because it’s highly contagious and there’s no vaccine or effective treatment. Also, though this is rare, people have traveled internationally with it before their symptoms started—including to the United States.

### **Stopping the Spread of Ebola: 7 Facts to Know**

If Ebola comes to your country, here are some key facts you’ll need to know to reduce your chance of getting it.

**1. It seems to start in animals and meat.** It’s thought the disease starts in bats or monkeys. They can have the virus without getting sick. Then they infect other animals, who do usually get sick. People kill the other animals and contract the virus while either preparing the meat or eating it poorly cooked. Then the virus starts spreading from person to person.

**2. After exposure, Ebola can kick in early or late.** After someone is infected, the symptoms start anywhere from two to 21 days later.

**3. Ebola doesn’t spread exactly like the flu.**

**Flu:** You can be contagious before you get sick.

**Ebola:** You’re not contagious until you have symptoms.

**Flu:** The virus can spread through fluid droplets in the air (like from a sneeze).

**Ebola:** Ebola can also spread this way.

**4. Ebola is highly contagious.** You can catch it by coming in direct contact with any bodily fluids, including blood, semen, urine, saliva, vomit, feces & (aerosolized sneeze).

**5. The symptoms make prevention more difficult.** Symptoms make it hard for caregivers not to come into contact with those bodily fluids.

**There’s profuse vomiting and diarrhea. And the victim’s blood can’t clot. So you can’t stop bleeding from the smallest scrape, prick, or bruise. Sometimes people spontaneously bleed out the nose, mouth, rectum, or urethra.**

**6. Ebola is still contagious after symptoms stop or the victim dies.** Ebola doesn’t stop being contagious with death or recovery. Victims’ dead bodies still carry the disease, and people who recover may continue to be contagious for up to two months or more.

**7. There are ways to protect yourself.** It’s essential to protect yourself at all times if you’re caring for someone who may have the disease so you don’t come into contact with the bodily fluids.

Basically, cover yourself in impermeable products from head to toe. Think goggles, mask, disposable gown, gloves, and shoe covers. If you're using needles, use them once only and dispose of them immediately.

**Also disinfect your environment. Clean any exposed furniture, walls, or floors with a disinfectant, like a chlorine bleach solution, before future use. This may not all be possible during a long-term disaster, but do the best you can.**

### **Essential Oils for Protection from Ebola and Other Viruses**

In addition to healing, I am a huge believer in using essential oils to build up immunity in order to prevent sickness. I use essential oils myself and through trial and error, learn what works and what doesn't. I read as much as I can so that I can learn and make informed choices.

All that being said, I keep a spray bottle with Shield protective blend and witch hazel with me at all times for use as a hand and gizmo sanitizer. I spray it everywhere, including on my phone, my keyboard, on pillows and bedding, and more. If I feel a snuffle or a runny nose coming on, a essential oil blend goes in the diffuser 24/7.

I had some help but neither one of us could pull up any verified studies. On the other hand, there have been some studies and articles linking Cinnamon and Ebola. I like the cinnamon link since the Shield Blend I use contains Cinnamon Bark in addition to Clove, Lemon, Eucalyptus, and Rosemary.

I plan to keep searching for some credible information on the use of essential oils to mitigate Ebola, but in the meantime, any of the antiviral and antibacterial essential oils would be good to have on hand. Some examples are Thyme, Melaleuca, Oregano, Cinnamon and, of course the Shield blend.

### **How to Make An Essential Oil Protective Spray**

Here is the recipe I use to make "Shield Protective Spray". This spray makes a terrific hand sanitizer, room freshener, and all around disinfectant and protectant.

Take a 2 ounce glass spray bottle and add 30 drops of Spark Naturals Shield Blend. Top with Witch Hazel. Shake before using. That's it.

20 drops cinnamon essential oil  
15 drops lavender essential oil  
10 drops rosemary essential oil

So a whole lot of people are going to have raised eyebrows **over the fact that Monsanto just happened to be giving a cash infusion to a key pharma company working on an Ebola cure right in the middle of a highly-publicized Ebola outbreak** which could create huge market demand for the

drugs. The fact that the U.S. Department of Defense is also involved with all this is going to have alternative news websites digging hard for additional links.

Sadly, the history of medicine reveals that drug companies, the CDC and the WHO have repeatedly played up the severity of disease outbreaks in order to promote sales of treatment drugs. I'm not saying this outbreak isn't very real and very alarming, of course. It is real. "Witnesses say Sawyer, a 40-year-old Liberian Finance Ministry employee en route to a conference in Nigeria, **was vomiting and had diarrhea aboard at least one of his flights with some 50 other passengers aboard.**"

Nobody is yet talking about what all this might mean if a large U.S. city shows an outbreak of infections. **Will the federal government use the military to quarantine an entire city? *The Department of Defense informed Congress that it has deployed biological diagnostic systems to National Guard support teams in all 50 states, according to a report published by the Committee on Armed Services. Some 340 Joint Biological Agent Identification and Diagnostic System (JBAIDS) units have thus far been given to emergency response personnel. The systems are "rapid, reliable, and [provide] simultaneous identification of specific biological agents and pathogens."*

On one hand, we might all applaud the government's preparedness actions in all this. It's smart to have diagnostic systems deployed nationwide, of course. But it begs the question: **When was the government planning on telling the public about all this? Probably never. - Stored in a liquid vial and easily smuggled across international borders.

- Frozen at very low temperatures where it remains viable *indefinitely*.

### **General Stubblebine & Dr. Rima Laibow of Natural Solutions Foundation Exposed!**

The fictional Major-General who appears in Gilbert and Sullivan's 1879 comic opera "The Pirates of Penzance" famously sings boastfully about his extremely wide general knowledge. Hardly the most modest of people, he comically claims to know about or to understand all manner of disparate subjects, and repeatedly tells the audience that he is "the very model of a modern Major-General." Not entirely dissimilarly therefore, the health freedom movement has recently been subjected to the increasingly bizarre claims of a real-life Major-General, a man who, rather like his counterpart in *The Pirates of Penzance*, claims to be an expert in all manner of things.



Major General Albert (Bert) N. Stubblebine III (U.S. Army, Retired) graduated from The United States Military Academy (West Point) in 1952, and served in the US Army for 32 years. Starting his career as an Armor officer, he subsequently rose through the ranks to lead troops at every echelon of Army command, and held several senior posts in US Army Intelligence. His commands as a General Officer included the US Army Intelligence Center and School, the Army's Electronic Research and Development Command (ERADCOM) and the US Army Intelligence and Security Command (INSCOM). Whilst on active duty Stubblebine also redesigned the intelligence architecture of the United States Army, and restructured the Army Intelligence training curriculum. After his retirement from the

Army in 1984 he served until 1990 as the Vice President for Intelligence Systems at BDM Corporation, a private defense sector contractor, and then acted as a part-time consultant to two government contractors; ERIM, and Space Applications Corporation (SAC). More recently, and along with his wife, the psychiatrist Rima Laibow, Stubblebine sat on the Board of Canadian Submarine Technologies Inc., and claimed to be the designer of AEGIS, "a major Homeland Security private initiative".

Given this background, and his resulting proximity to the US Government, eyebrows began to be raised in the health freedom community in early 2005 when, along with **Rima Laibow**, Stubblebine launched **the website of the Natural Solutions Foundation** and began to promote himself as an expert on Codex Alimentarius.

However, for a man who had previously held several senior posts in US Army Intelligence, and who as such would be acutely aware of the need to ensure accuracy in the gathering of information, it quickly became apparent to experienced health freedom observers that Stubblebine either hadn't done his homework properly, or that he and Laibow were intentionally spreading inaccurate and misleading material on Codex and other related dietary supplement issues via their website and press releases. Moreover, despite repeated concerns being expressed by more experienced health freedom observers, Stubblebine and Laibow continued to disseminate this material, and pointedly ignored requests to remove it from their website.....

**MAJOR GENERAL ALBERT N. STUBBLEBINE, III**
