Google knows millions of Wi-Fi password in the world

If an Android device (phone or tablet) has ever logged on to a particular Wi-Fi network, then Google probably knows the Wi-Fi password. Considering how many Android devices there are, it is likely that Google can access most Wi-Fi passwords worldwide.

Recently IDC reported that 187 million Android phones were shipped in the second quarter of this year. That multiplies out to 748 million phones in 2013, a figure that does not include Android tablets.

Many (probably most) of these Android phones and tablets are phoning home to Google, backing up Wi-Fi passwords along with other assorted settings. And, although they have never said so directly, **it is obvious that Google can read the passwords.**

Android devices have defaulted to coughing up Wi-Fi passwords since version 2.2. And, since the feature is presented as a *good* thing, most people wouldn't change it. I suspect that many Android users have never even *seen* the configuration option controlling this. After all, there are dozens and dozens of system settings to configure.

And, anyone who does run across the setting cannot hope to understand the privacy implications.

CA GOV. BROWN TO SIGN BILL LEGALIZING NON-PHYSICIAN ABORTIONS

A bill that would allow non-physicians to perform abortions in the first trimester of pregnancy is awaiting signature by Gov. Jerry Brown of California by Sep. 30. The **bill**, AB 154, passed both houses of the state legislature with **strong support** from Planned Parenthood and pro-choice groups. Planned Parenthood stands to benefit most directly from the bill, as non-physician staff at its clinics would be able to obtain abortion licenses.

One doctor--who identified himself as pro-choice--told Breitbart News that "the bill is a disaster since it sends us back 100 years to the problems of the complications from back-street abortions." The bill's critics warn that the training provided to non-physician staff is weak, that supervision by physicians in clinics will be minimal, and that there is real risk of injury or death to women who will be treated in such conditions.

(BP) For Abby Johnson, the closing of a single Planned Parenthood center demonstrated her **dramatic reversal** from abortion clinic director to leading pro-life advocate.

But for pro-lifers throughout the United States, it marked another exhibit in a hopeful trend—**abortion centers are shutting down at an unprecedented rate. The total so far this year is 44, according to a pro-life organization that tracks clinic operations.**

None was more telling for Johnson than the mid-July closing of the **Planned Parenthood** center in Bryan, Texas. It came less than four years after Johnson, burdened by her involvement with abortion, walked out of that clinic as its director and into the offices of the Coalition for Life.

"Knowing that the former abortion clinic I once ran is now closing is the biggest personal victory of my life," Johnson said in a written statement after the announcement of the shutdown. "From running that facility, to then advocating for its closure, and now celebrating that dream ... it shows that my life has indeed come full circle."

Since her celebrated conversion from Planned Parenthood director, Johnson has started a ministry to help workers leave the abortion industry. She has pledged, as she said in July, to "fight until every abortion clinic in this country has shut its doors."

State legislatures enacted 69 pro-life laws this year, according to a report released Thursday (Sept. 5) by Americans United for Life. In all, 48 states considered about 360 such proposals in 2013, AUL reported.

The legislative action this year continued a recent trend in states: 70 "life-affirming measures" became law in 2011 and 38 in 2012, according to AUL. <http://www.christianitytoday.com/gleanings/2013/september/abortion-clinics-closing-planned-parenthood-abby-johnson.html>

Antibiotic-resistant gonorrhea, a diarrhea-causing superbug and a class of fast-growing killer bacteria dubbed a "nightmare" were classified as urgent public-health threats in the United States on Monday.

According to a new report by the U.S. Centers for Disease Control and Prevention (CDC), at least 2 million people in the United States develop serious bacterial infections that are resistant to one or more types of antibiotics each year, and at least 23,000 die from the infections.

"For organism after organism, we're seeing this steady increase in resistance rates," Dr Thomas Frieden, director of the CDC, said in a telephone interview. "We don't have new drugs about to come out of the pipeline. If and when we get new drugs, unless we do a better job of protecting them, we'll lose those, also."

Overprescribing of antibiotics is a chief cause of antibiotic resistance, affording pathogens the opportunity to outwit the drugs used to treat them. Only a handful of new antibiotics have been developed and brought to market in the past few decades, and only a few companies are working on drugs to replace them.

In addition to resistant gonorrhea, the others now seen as urgent threats, according to the first-of-its-kind report released on Monday, are C. difficile and the killer class known as CRE.

The report was conceived to bring together as much information as possible about drug-resistant superbugs and how to slow their spread.

23,000 killed by superbugs in US each year, CDC says

"This is the first time that we have divided these bacteria into categories and called some of them urgent," says Dr. Steve Solomon, director of CDC's Office of Antimicrobial Resistance.

The CDC has issued a new report on antibiotic-resistant superbugs that kill Americans and that cannot be cured. "We are trying to sound the alarm on these bugs that we call urgent," Solomon told NBC News. "These are particularly frightening."

Worse, the CDC report points out, there aren't any new antibiotics in the immediate works that will kill any of these bugs. So patients may have to be treated with older, more toxic drugs, or with cocktails of antibiotics that may cause side-effects.



“If we are not careful, **the medicine chest will be empty when we go there to look for a lifesaving antibiotic for somebody who has a deadly infection,**” CDC director Dr. Tom Frieden told reporters in a telephone briefing.

“Without **care we will soon be in a post-antibiotic era,**” Frieden added. “**For some infections ... we are already there.**”

C. difficile has become a scourge of hospitals and infection is often made possible when patients are heavily treated with antibiotics to fight other infections. It can cause unstoppable diarrhea and the [latest treatment](#) doesn't even involve antibiotics, but a [transplant of so-called good bacteria](#) from healthy patients.

CREs are a group of bacteria that resist even the strongest antibiotics. They include Klebsiella pneumoniae, which saw its infection rate [jump 550 percent](#) between 2001 and 2011.

“CRE is a nightmare bacteria we reported on in March, bacteria that can resist virtually all antibiotics,” Frieden said

WHO Says H7N9 is "Most Lethal", and it's now in Taiwan

Apr-25-2013--Those infected die a rather grim death, says a new report published on Thursday which details in **three victims a high fever, cough, severe pneumonia, septic shock and damage to the brain, kidney and other organs,** the New York Times reports.

According to the Los Angeles Times all three developed acute respiratory distress syndrome, a punishing condition that prevents sufficient oxygen from reaching the victim's lungs. **Even after receiving antiviral medications, two of those infected died in a week, the third after 13 days.**

Sidebar:

MF59 is an immunologic adjuvant that uses squalene.

ASO3 (for "Adjuvant System 03") is the trade name for a squalene-based immunologic adjuvant used in various vaccine products by GlaxoSmithKline (GSK). It is used, for example, in GSK's A/H1N1 pandemic flu vaccine Pandemrix

The U. S. government has paid pharmaceutical companies \$7.9 billion* since 2004 to develop the capacity to mass vaccinate the entire U.S. population by 2011. Under the perceived threat of bird or swine flu these plans have been accelerated to include the use of a non FDA approved chemical adjuvants suspected of causing Gulf War Syndrome, circumventing the FDA approval process for this potentially life threatening chemical.

In 2005, the Department of Health and Human Services (HHS) published a plan with two specific goals that relate to vaccines. The first goal was to have in place by 2011 domestic production capacity sufficient to supply vaccine to the entire U.S. population within six months of the onset of a pandemic. The second goal was to stockpile enough doses of vaccine to inoculate 20 million people as soon as possible after the onset of a pandemic.

What happens when Squalene is injected into humans?

Your immune system recognizes squalene as an oil molecule native to your body. It is found throughout your nervous system and brain. In fact, you can consume squalene in olive oil and not only will your immune system recognize it, you will also reap the benefits of its antioxidant properties.

The difference between "good" and "bad" squalene is the route by which it enters your body. Injection is an abnormal route of entry which incites your immune system to attack all the squalene in your body, not just the vaccine adjuvant.

Your immune system will attempt to destroy the molecule wherever it finds it, including in places where it occurs naturally, and where it is vital to the health of your nervous system, according to award-winning investigative journalist Gary Matsumoto, who explains there is a "close match between the squalene-induced diseases in animals and those observed in humans injected with this oil: rheumatoid arthritis, multiple sclerosis and systemic lupus erythematosus."

"There are now data in more than two dozen peer-reviewed scientific papers, from ten different laboratories in the US, Europe, Asia and Australia, documenting that squalene-based adjuvants can induce autoimmune diseases in animals...observed in mice, rats, guinea pigs and rabbits. Sweden's Karolinska Institute has demonstrated that squalene alone can induce the animal version of rheumatoid arthritis. The Polish Academy of Sciences has shown that in animals, squalene alone can produce catastrophic injury to the nervous system and the brain. The University of Florida Medical School has shown that in animals, squalene alone can induce production of antibodies specifically associated with systemic lupus erythematosus," writes Matsumoto.

We got our first hint at the dangers of these proprietary adjuvants when they were secretly tested on soldiers during the Gulf War.

Gulf War veterans with Gulf War Syndrome (GWS) received anthrax vaccines which contained squalene. MF59 (the Novartis squalene adjuvant) was an unapproved ingredient in experimental anthrax vaccines and has since been linked to the devastating autoimmune diseases suffered by countless Gulf War vets according to data published in the February 2000 and August 2002 issues of Experimental and Molecular Pathology.

The Department of Defense made every attempt to deny that squalene was indeed an added contaminant in the anthrax vaccine administered to Persian Gulf war military personnel – deployed and non-deployed – as well as participants in the more recent Anthrax Vaccine Immunization Program (AVIP).

However, the FDA discovered the presence of squalene in certain lots of AVIP product. A test was developed to detect anti-squalene antibodies in GWS patients, and a clear link was established between the contaminated product and all the GWS sufferers who had been injected with the vaccine containing squalene. The Pentagon never told Congress about the more than 20,000 hospitalizations involving troops who took the anthrax vaccine from 1998 through 2000, despite repeated promises that such cases would be publicly disclosed. Instead, generals and Defense Department officials claimed that fewer than 100 people were hospitalized or became seriously ill after receiving the shot, according to an investigation by the Daily Press of Newport News.

A study conducted at Tulane Medical School and published in the February 2000 issue of Experimental Molecular Pathology included these stunning statistics:

“... the substantial majority (95%) of overtly ill deployed GWS patients had antibodies to squalene. All (100%) GWS patients immunized for service in Desert Shield/Desert Storm who did not deploy, but had the same signs and symptoms as those who did deploy, had antibodies to squalene.

In contrast, none (0%) of the deployed Persian Gulf veterans not showing signs and symptoms of GWS have antibodies to squalene.

According to Dr. Viera Scheibner, Ph.D., a former principle research scientist for the government of Australia:

“... this adjuvant [squalene] contributed to the cascade of reactions called "Gulf War Syndrome," documented in the soldiers involved in the Gulf War.

The symptoms they developed included arthritis, fibromyalgia, rashes, photosensitive rashes, malar rashes, chronic fatigue, chronic headaches, abnormal body hair loss, non-healing skin lesions, aphthous ulcers, dizziness, weakness, memory loss, seizures, mood changes, neuropsychiatric problems, anti-thyroid effects, anaemia, elevated ESR (erythrocyte sedimentation rate), systemic lupus erythematosus, multiple sclerosis, ALS (amyotrophic lateral sclerosis), Raynaud's phenomenon, Sjorgren's syndrome, chronic diarrhoea, night sweats and low-grade fevers.”

Clearly bypassing the FDA requirements for safety testing of these new adjuvants and the vaccines which contain them puts the entire population at risk for serious, possibly life threatening side effects, particularly any of the 12,000 trial paid trial participants (6,000 children) who are unfortunate enough to be randomized into the adjuvant containing groups.

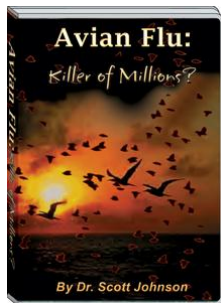

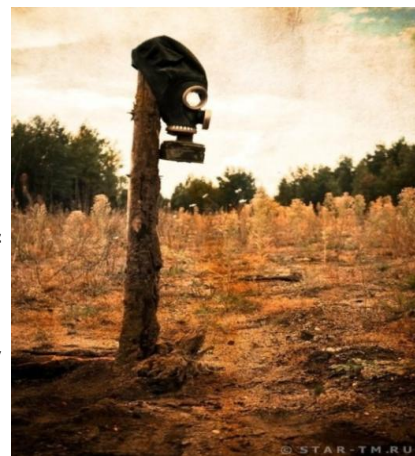

Priority #1: Make a plan

Sometimes when people begin to think of their emergency supplies it is when something has caused them to be afraid or very concerned. Many times individuals, families and even communities don't put a lot of thought into emergency planning until it after a disaster has struck. That is, of course, the worst time to think about it. At that point, you are at somebody else's mercy.

Your first priority in getting prepared and gathering emergency supplies is to make a plan. This is a critical step because it helps you organize in your mind what you want to accomplish and how you are going to get there. Having a plan will minimize your mistakes and will help you include the right items for the right prices. Here are some ideas in formulating your emergency preparedness plan:

1. Gather information – go to trusted sources for information on what to include in your plan and how to do it. There are many websites and books available. Here are some national websites to consider: www.Ready.gov, www.FEMA.gov, www.redcross.org. Also, go to your city, county and state emergency planning websites. That information will be extremely helpful.

2. Write it down – It is very important to write down your emergency plan and keep it in a place that allows you to review it regularly.

3. Make a list of all your items (include expiration dates if possible) – Your emergency plan should include a list of all the items that you have stored. If possible include where they are stored and their expiration dates (if applicable). This will help you follow the principle of Review, Rotate, Replace.

4. Family communication plan – Make sure you include emergency contact information, an out of state contact as well as local contacts and meeting locations in case of disaster. Also, include evacuation routes out of the house and your community.

5. Important Documents – Make copies of important documents, like insurance policies, birth certificates, social security cards and wills. Keep those documents with your plan in a water tight container.

6. Product Instructions and Emergency Instructions – As you do your information gathering in step one, print out copies of important emergency instructions. You may want to keep a survival book on hand to give valuable information. Also, remember to include a product instructions that might be helpful as well.

7. Consider Grab and Go vs. Shelter in Place – Make a plan to evacuate (grab and go) as well as to shelter in place. Include how you will do it, where you will go, what you will include in these supplies and where they will be stored.

8. Make a plan for water – Make sure you know where to get clean water, how to clean water and where it will be stored.
