### Big Sis Iris Scanners: The Prison Without Bars

The Department of Homeland Security is set to begin trials of iris scanning technology in October, but don't believe for a second that Big Sis' latest assault on the privacy right of Americans will be confined to airports – everything from entering sports events to making purchases will eventually be controlled by the technology if it is allowed to be implemented.

“The Homeland Security Department plans to test futuristic iris scan technology that stores digital images of people's eyes in a database and is considered a quicker alternative to fingerprints,” [writes the USA Today's Thomas Frank](#).

The iris scan is nothing less than the 21st century equivalent of how Jews and other undesirables were tattooed by the Nazis, aside from the fact that *all* Americans will be forced to submit to the eye scan. In Hitler's Germany, at least *some* members of the population were spared from having to identify themselves constantly at the behest of the authorities.

As the USA Today article makes clear, *iris records will be held in a database and associated with credit cards and other routine aspects of every day life. The agenda is to replace pin numbers and presentation of photo ID, forcing Americans to submit to high-tech enslavement merely to conduct their day to day activities.*

“Financial companies hope the scans can stop identity fraud, said Jeff Carter of Global Rainmakers, a New York City firm developing the technology. “Iris is going to completely reshape the fraud environment,” he said.

*In other words, whenever you buy something, take money from an ATM, cash a check, or conduct any financial transaction, you will be forced to submit to the iris scan.*

*Cameras “that take photos from 3 or 4 feet away, including one that works on people as they walk by,” will be installed at all major public buildings, sports stadiums, and transport hubs, completely demolishing for good the notion of innocent until proven guilty.*

[As we have exhaustively documented](#), iris scans, along with mobile x-ray body scanners, are just two aspects of how everything that has turned America's airports into some of the most draconian, oppressive and abusive places in the world, is now being rolled out onto the streets.

*Homeland Security is already implementing technology to be enforced at “security events” which purportedly reads “malintent” on behalf of an individual who passes through a checkpoint. The video below explains how “Future Attribute Screening Technology” (FAST) checkpoints will conduct “physiological” and “behavioral” tests in order to weed out suspected terrorists and criminals*

The clip shows individuals who attend “security events” being led into trailers before they are interrogated as to whether they are terrorists while lie detector-style computer programs analyze their physiological responses. The subjects are asked about their whereabouts, and if they are attempting to smuggle bombs or recording devices into the “expo,” proving that the technology is intended to be used at public events and not just airports. Individuals who do not satisfy the first lie detector-style test are then asked “additional questions”.

**Obama Prepares Largest Arms Sale Ever...to Saudi Arabia**

Selling \$60 billion in arms to [Saudi Arabia](#) is a win-win deal, according to the Obama administration. The largest weapons deal ever by the U.S. would create more than 70,000 jobs for the stumbling U.S. economy, and it would strengthen ties with a key American ally, and possibly other Arab countries, while trying to shore up U.S. policy against [Iran](#) in the Persian Gulf. **Israelis, however, are concerned that the weapons could be turned on them. The \$60 billion package would include 84 new F-15 fighters, as well as another 70 existing ones that would be upgraded, and three types of helicopters—70 Apaches, 72 Black Hawks and 36 Little Birds.**

**Furthermore, the administration wants to sell the Saudis another \$30 billion in ships and hardware to upgrade the kingdom's naval forces. And there's talk of selling Saudi Arabia the Terminal High Altitude Defense (THAAD) missile defense system.**

Although Saudi Arabia's vast oil reserves have secured its good relations with every president, Democratic and Republican, since the days of Franklin Roosevelt, the Saudi royal family continues to run one of the most repressive and undemocratic dictatorships in the world.



### OBAMA ENDORSES GLOBAL TAXES ON EVE OF U.N. SUMMIT

By Cliff Kincaid--September 17, 2010--NewsWithViews.com--In a classic case of misdirection, while the media are preoccupied with the fate of the Bush tax cuts, President Obama is preparing to attend a United Nations summit next week to endorse "innovative finance mechanisms"—global taxes—to drain even more wealth out of the U.S. economy.

A draft "[outcome document](#)" produced in advance of the September 20-22 U.N. Summit on the Millennium Development Goals (MDGs) commits the nations of the world to supporting "innovative financing mechanisms" to supplement foreign aid spending. The term "innovative financing mechanisms" is a U.N. euphemism for global taxes.

The proposal, popular at the United Nations for decades and long-advocated by Fidel Castro, is called the Tobin Tax and named after Yale University economist James Tobin. Steven Solomon, a former staff reporter at Forbes, said in his book, *The Confidence Game*, **that such a proposal "might net some \$13 trillion a year..." because it is based on taking a percentage of money from the trillions of dollars exchanged daily in global financial markets.**

He is referring to the fact that once such a tax is in place, it could be easily raised to bring in **hundreds of billions of dollars or more a year to the U.N. and other global institutions.** Such financial transactions through banks and other financial institutions are commonplace on behalf of Americans who have stock in mutual funds or companies that invest or operate

overseas. Hence, such a global tax could affect the stocks, mutual funds, and pensions of ordinary Americans.

The term "small global taxes" brought a stunned reaction from Senator David Vitter, when he was told of what is being proposed in advance of the U.N. summit. Vitter introduced Senate resolution 461, "Expressing the sense of the Senate that Congress should reject any proposal for the creation of a system of global taxation and regulation," to put the Senate on record against any such measure. He has vowed to maintain pressure on the world body to avoid implementing any of these schemes and thinks that the Congress has to use whatever financial leverage it has to frustrate U.N. demands for more power and authority in world affairs.

The Vitter resolution was sent to the liberal-controlled Senate Finance Committee, **which declined to act on it.**

Over a 13-year period, from 2002, when the U.N.'s Financing for Development conference was held, to the target year of 2015, when the U.S. is expected to meet the Millennium Development Goals, **this amounts to \$845 billion from the U.S. alone**, according to Jeffrey Sachs of the U.N.'s Millennium Project.

**"We have fully embraced the Millennium Development Goals," Obama told the U.N. in 2009.**

## **Obama to Illegal Aliens: Don't forget who stands with you**

WASHINGTON — President Barack Obama **appealed to Hispanics on Wednesday to support Democrats in the November elections despite his failed promise to pass an immigration overhaul.** Obama acknowledged the disappointment among Latinos over the immigration issue and pledged to keep pushing for a comprehensive overhaul of the nation's immigration laws to deal with border security and provide an eventual route to legal status for the estimated 11 million illegal immigrants in the United States.

"You have every right to keep the heat on me and the Democrats, and I hope you do. That's how our political process works," Obama said at the Congressional Hispanic Caucus Institute's awards dinner. **"But don't forget who is standing with you, and who is standing against you.** The president said as he blamed Republicans for standing in the way of progress.

Don't ever believe that this election coming up doesn't matter."

Obama also promised to help win passage of a bill, known as the **DREAM Act**, that would allow **young illegal aliens who attend college or join the military to become legal U.S. residents.**

Senate Majority Leader Harry Reid, D-Nev., said this week that he wants to attach the measure to an **upcoming defense policy bill that the Senate could begin considering as soon as next week.**

"Now I know that many of you campaigned hard for me, and understandably you're frustrated that we have not been able to move this over the finish line yet. I am too," he said. "But let me be clear: I will not walk away from this fight. My commitment is to getting this done as soon as we can."

Some in the audience shouted "when?"

Obama urged Hispanics to remember who extended health care to millions of children, provided Pell Grants for Latino students and enacted credit card reform and created a new agency to protect consumers from predatory lending, including millions of immigrants who send money to relatives in their native countries.

"Don't forget who your friends are," he said. "No se olviden" - Spanish for "Don't forget."

He has scheduled a White House meeting to talk about the DREAM Act, as well as an immigration bill Sen. Menendez plans to introduce and about **repealing regulations that give local police authority to make immigration arrests.**

### **The Left Pushes Anti-Military, Pro-Gay, Pro-Abortion Bill Next Week!**

The Senate has scheduled a [vote on the National Defense Authorization Bill](#) this Tuesday. This bill contains language that:

- Imposes open homosexuality on the U.S. military by overturning the 1993 law banning on homosexuality. This puts conservatives in a bind who want to support our national defense, but don't want to vote to overturn the ban.
- Requires military hospitals to perform abortions.
- Gives amnesty to children of illegal immigrants **through the Dream Act.**

**Amnesty and abortion have nothing to do with funding our national defense! They should be vigorously debated at another time. These are not relevant for a defense bill.**

The main goal is to [appease LGBT activists, open borders, and abortion industry](#) supporters as a way of bolstering election outcomes.

Senate Majority Leader Harry Reid (D-NV) has even joined forces with the weirdo pop singer Lady Gaga, to push for gays in the military. He recently tweeted Lady Gaga telling her that he views this pro-LGBT defense bill as an important vote before the mid-term election recess.

This legislation is dangerous to military morale, readiness and unit cohesion. Here are some of the negative results that are being ignored:

- A zero-tolerance policy will force straight soldiers out of the service or push them into silence. For decades, openly serving gays, lesbians and bisexuals were justly considered a threat to unit cohesion, morale and military effectiveness. They still do.

- Careers will be destroyed and promotions denied to individuals who object to homosexual conduct.
- Chaplains will be forbidden to preach from the Bible on homosexual conduct.
- Our military readiness will be diminished if the 1993 law is abolished.



[Lt. General Thomas Bostick](#), who is the deputy chief of staff in charge of personnel matters for the Army, admitted that if the gay ban is overturned, **anyone who opposes homosexuals will be considered the same as a racist or a bigot – and will be ejected from the military if they can't "get with the program"!** **Bostick and others will enforce a zero tolerance policy against any criticism of gay conduct!**

**Lt. General Thomas Bostick** (who incidentally was just promoted to his current rank on 3-11-10) equates those who defend normalcy and oppose sexual deviance in the military with racists. The comments by Bostick are only the latest evidence that President Obama's pro-homosexual, Christian-discrimination plan for the military WILL DISCRIMINATE against normal and religious servicemembers who disagree with his immoral and impractical plan. Thus we face the specter that a type of "homo-supremacy" will grow in the ranks: "open and proud" homosexuals and bisexuals will be welcomed into the Armed Forces, while those who defend faith, tradition and common sense on this issue (including Bible-honoring chaplains?) will be shown the door. When Gen. Bostick spoke about "Don't Ask, Don't Tell" before several hundred troops at the [European Command](#) headquarters in Stuttgart, Germany recently he is quoted saying: **"Unfortunately, we have a minority of service members who are still racists and bigoted and you will never be able to get rid of all of them,"** Lt. Gen. Bostick said. **"But these people opposing this new policy will need to get with the program, and if they can't, they need to get out. No matter how much training and education of those in opposition, you're always going to have those that oppose this on moral and religious grounds just like you still have racists today."**

The strong words take additional significance from Lt. Gen. Bostick's direct involvement with a Pentagon panel charged with shaping military policy on this issue.

Lt. Gen. Bostick's twisted comparison — which echoes the standard anti-Christian

rhetoric of homosexual activists — is itself an act of bigotry. “Wildlife and Fisheries” said it will test the crabs if new samples are collected tomorrow.

“St. Bernard fishermen, though, are convinced the crabs are full of oil and they believe the test results will prove their case,” the report concludes.

And so are the deltoids of thousands of sailors to be immunized in coming days as part of a test of the Navy's capacity to "surge" huge quantities of vaccines to its work force.** Did you know former President Clinton quietly signed Executive Order 13139 on September 30th, 1999? **This order requires military personnel to receive experimental vaccines not approved by the FDA and denies the soldiers the right to refuse or to even to be provided with informed consent of what there are receiving.**

Every military exercise gets a name, typically by shortening key words and condensing the spaces between them. The first phase of PANFLUEX - short for pandemic flu exercise - begins today, when nurses and corpsmen from Portsmouth Naval Medical Center will fan out to local military medical clinics. **Their goal is to vaccinate about 6,000 "mission essential personnel" within 48 hours.**

"Primarily, the first part of the exercise is getting health care workers vaccinated," said Rebecca Perron, a spokeswoman for the medical center. **"If it were the real thing, we would get 60,000 doses and have 48 hours to administer them."**

Ultimately, some 60,000 active duty personnel working at shore commands will receive flu vaccines as part of PANFLUEX. That's a little less than half the doses the medical center plans on administering this year. The rest will go to military family members.

In the exercise's three final phases, medical personnel won't wait for patients to come to them. Corpsmen and nurses will head to local bases and commands and set up miniature clinics. They will attempt to inoculate 20,000 people in a 24-hour period.

### **[Vaccine Deaths And Injuries Skyrocket As Cover-Up Implodes](#)**

A measles vaccination program in India was halted after four children died almost immediately after receiving the shot. **“Four children died within minutes of receiving a vaccine for measles...on Saturday,” reports MedGuru.**

Indian newspaper reports carried eyewitness accounts of what happened. “The four children were reported to have fainted soon after they were vaccinated and witnesses reported seeing the children’s eyes roll back as they began to have seizures,” **reports Blitz.**

Furious villagers reacted to the tragedy by going on a rampage, attacking health workers and holding government doctors hostage.

Health professionals and doctors with government ties were also blamed in Finland and Sweden after a **H1N1 vaccination program was halted following a 300 per cent increase in cases of the neurological disorder narcolepsy** amongst children and young people who had received the shot over the last six months.

**According to Kari Lankinen**, head physician of the Finnish Medicines Agency, **doctors were complicit in hiding the link between the swine flu shot and narcolepsy and did so to advance their careers.**

Meanwhile, concerned mothers whose daughters have been injured or killed by the Gardasil vaccine have **put together a website** that documents the truth about how the vaccine has killed and injured thousands of young girls since it was introduced in 2006. **Thousands of teenagers have suffered adverse reactions and at least 71 have died from the vaccine since the HPV program was launched four years ago.**

The global vaccine cover-up took a massive blow after it was confirmed that the 2009 swine flu outbreak was, as we predicted from the start, a contrived scam centered around making vast profits for pharmaceutical companies while endangering the health of the public.

**As we reported earlier this year**, Chair of the Council of Europe’s Sub-committee on Health Wolfgang Wodarg’s investigation into the 2009 swine flu outbreak **found that the pandemic was a fake hoax manufactured by pharmaceutical companies in league with the WHO.**

Wodarg said that **governments were “threatened” by special interest groups within the pharmaceutical industry as well as the WHO to buy the vaccines and inject their populations without any reasonable scientific reason for doing so.**

Wodarg said there was “no other explanation” for what happened than the fact that the **WHO worked in cahoots with the pharmaceutical industry to manufacture the panic in order to generate vast profits & that the entire farce was a hoax.**

**Professor Ulrich Keil, director of the World Health Organization’s Collaborating Centre for Epidemiology**, also slammed the swine flu epidemic as an overblown “angst campaign”, devised in conjunction with major drug companies to boost profits for vaccine manufacturers.

**As Natural News’ Mike Adams reported**, several members of the Emergency Committee expert panel that **advised the World Health Organization (WHO) during the swine flu scare were receiving financial support from pharmaceutical manufacturers either during or prior to the epidemic.**

Both H1N1 and seasonal flu shots have been linked with a number of different side-effects across the globe, including **Guillain-Barré Syndrome** as well as dystonia, **a paralyzing neurological disorder.**

The seasonal flu vaccine **has also been linked** with convulsions and seizures in under-5 year olds.

**Many batches of the swine flu vaccine included squalene and mercury amongst their ingredients, two substances that have been directly connected with the explosion of autism amongst children** as well as other diseases. Individuals within government and the military

were privileged to receive additive free shots that did not include these substances. **German Chancellor Angela Merkel and government ministers**, as well as **German soldiers**, were amongst those who received access to the so-called “friendly” version of the vaccine. In order to **head off legal claims for side-effects caused by the swine flu vaccination program, the U.S. government provided vaccine makers with blanket legal immunity before the shots began to be dispersed.**

Citing concerns over safety, Prime Minister Donald Tusk and Health Minister Ewa Kopacz, with the broad support of the public, **ensured that Poland was the only country in the world to completely reject the H1N1 vaccine.**

“We are making this decision only in the interest of the Polish patient and the taxpayer,” Tusk said. “We will not take part because it’s not honest and it’s not safe for the patient.” In a 2008 trial for a bird flu vaccine, three Polish doctors and six nurses faced criminal charges **after the vaccine killed 21 homeless people who were participating in the test.**

The Czech Republic rejected a swine flu vaccine produced by **pharmaceutical manufacturer Baxter after the company was caught shipping vaccines contaminated with deadly live H5N1 avian flu virus to 18 countries** by a lab at an Austrian branch of Baxter.

Given the routinely stated goal on behalf of **mega-rich foundations that fund vaccination programs around the world, such as the Bill and Melinda Gates Foundation and the Rockefeller Foundation, to use vaccines as a way of sterilizing the planet’s population as part of the global eugenics soft-kill assault on humanity,** it’s unsurprising that as more people become aware of this agenda, take-up rates of new as well as seasonal vaccines continue to decline.

**As Jurriaan Maessen recently documented in his Infowars exclusive,** in its **1968** yearly report, the Rockefeller Foundation acknowledged funding the development of so-called “anti-fertility vaccines” and their implementation on a mass-scale.

**This program was then launched by a group** that was created under auspices of the World Health Organization, World Bank and UN Population Fund entitled “Task Force on Vaccines for Fertility Regulation”. In the 1990’s, the WHO was mired in controversy after it distributed a “tetanus vaccine” to poor girls and women in the third world that **was contaminated with human chorionic gonadotrophin (hCG), a hormone that induces involuntary abortion.**

**During a TED conference earlier this year, Bill Gates openly stated that vaccines would be used to lower the earth’s population in the name of combating climate change. The Bill and Melinda Gates Foundation is one of the major funders of vaccine research and production in the third world.**

Warning that the global population was heading towards 9 billion, Gates said: “If we do a really great job on new vaccines, health care, reproductive health services (abortion), we could lower that by perhaps 10 or 15 per cent.”

How an improvement in health care and vaccines that supposedly save lives would lead to a lowering in global population is a totally contradictory statement, unless Gates was referring to vaccines that sterilize people, **which is precisely the same method advocated in White House science advisor John P. Holdren’s 1977 textbook Ecoscience,** which calls for a dictatorial “planetary regime” to enforce draconian measures of population reduction via all manner of oppressive techniques, including sterilization.

### [Government To Overhaul Bioterror And Pandemic Flu Plans](#)

Acknowledging that the development of medical countermeasures against bioterrorism threats and pandemic flu is lagging, federal authorities Thursday **announced a \$1.9-billion makeover of the system for identifying and manufacturing drugs and vaccines for public health emergencies.** The overhaul includes refinements to manufacturing aimed at shaving weeks off the time it takes to produce pandemic flu vaccine, and a series of steps aimed at more quickly spotting 'promising' scientific discoveries and getting them to market. "We aren't generating enough new products," said Health and Human Services Secretary Kathleen Sebelius, citing "leaks, chokepoints and dead ends" in the medical development pipeline. Money for the changes comes from funds initially allocated for the **TOTALLY BOGUS** H1N1 flu pandemic. Among other things, the effort would provide \$822 million for upgrades to speed up production of pandemic flu vaccine. Another large block, \$678 million, would be used to set up at least one private facility that would work under government contract with small companies to manufacture new products, develop new manufacturing processes and help produce vaccines during periods of peak demand.
