## Iowa and North Carolina Reports Raise Fears H1N1 Mutations Have Reached United States

[Bird Flu Pandemic](#)--November 25, 2009--New reports from Iowa and North Carolina are raising concerns that the deadly H1N1 swine flu mutations that have been confirmed by the WHO in Ukraine, Norway and elsewhere have already reached the United States. In Iowa, a report that doctors are seeing "very heavy, wet hemorrhagic lungs, lungs with a lot of blood in them" in H1N1 patients is creating concerns among health experts that the deadly Ukraine H1N1 has already spread there. In addition, a report of Tamiflu-resistant H1N1 swine flu in North Carolina is raising questions about the ability of medical authorities to combat H1N1 if thousands of people do start dying. If deadly H1N1 swine flu mutations have already reached the United States, what does that

mean? Doctors in Ukraine have been reporting that victims of H1N1 there are experiencing violent hemorrhaging in their lungs. As the patients near death, their lungs reportedly become as “black as charcoal” and literally begin to disintegrate. Will this start happening soon inside the U.S.?

The news report causing the most concern today is the one about H1N1 patients in Iowa. Commenting on a dramatic spike in H1N1 deaths in Iowa, Dr. Gregory Schmunk [told KCCI news](#) that what doctors there are seeing “is very heavy, wet hemorrhagic lungs, lungs with a lot of blood in them.”

Hemorrhagic lungs that are filled with blood? That sounds precisely like what is taking place in Ukraine.

Last week, [the WHO confirmed](#) that an H1N1 mutation had been discovered in Ukraine. This H1N1 mutation involved a receptor binding domain change, and it is apparently causing the H1N1 virus to become much more virulent.

Just like the new report in Iowa, many victims of H1N1 in Ukraine have been experiencing violent hemorrhaging in the lungs. Temperatures inside the lungs of patients in Ukraine have been reported to be as high as 135 degrees Fahrenheit. As the patient near death, the lungs turn to mush and literally become as black as charcoal.

In fact, one doctor in Western Ukraine [was quoted as saying the following](#) about what is happening to the lungs of these patients.....

“We have carried out post mortems on two victims and found their lungs are as black as charcoal. They look like they have been burned. It’s terrifying.”

If that wasn’t bad enough, the WHO has now confirmed that the same H1N1 mutation [has shown up in Norway](#).

Norway’s Institute of Public Health has released a statement in which they announced that this mutation [“could possibly...cause more severe disease”](#) because it apparently infects tissue deeper in the airway than usual.

Not only that, but today Hong Kong’s Department of Health has confirmed [that it has found the same mutation in a H1N1 flu virus sample](#) as the one detected in Norway recently.

Hong Kong is on the other side of the world from Ukraine and Norway.

What in the world is going on?

Nobody knows for sure, but the truth is that the increasing similarities between the current H1N1 outbreak and the 1918 “Spanish flu” outbreak are becoming too striking to

ignore.

Firstly, both the current outbreak and the 1918 Spanish flu are from the H1N1 family.

Secondly, both the current outbreak and the 1918 Spanish flu [have the same mutation](#) that is currently being reported in Ukraine, Norway and Hong Kong.

Thirdly, the hemorrhagic deaths that victims are experiencing in Ukraine closely mirror the kind of deaths experienced by victims of the 1918 Spanish flu. Just consider the following description of 1918 Spanish flu deaths [from Wikipedia](#).....

“One of the most striking of the complications was hemorrhage from mucous membranes, especially from the nose, stomach, and intestine. Bleeding from the ears and petechial hemorrhages in the skin also occurred.” The majority of deaths were from bacterial pneumonia, a secondary infection caused by influenza, but the virus also killed people directly, causing massive hemorrhages and edema in the lung.”

You would think this stunning information would be so important that the mainstream media would be all over it, but sadly that is not the case. Instead they seem intent on covering the opening of the “New Moon” movie and whatever Barack Obama had for breakfast this morning.

But not only is the mutation discussed above a tremendous concern, but now there are confirmed reports that Tamiflu-resistant H1N1 is spreading.

Recently a Tamiflu-resistant strain of the H1N1 swine flu was reported to have been discovered [in Wales](#), and now a Tamiflu-resistant cluster of the H1N1 swine flu [has been reported in North Carolina](#).

However, medical authorities don't seem overly concerned. Dr. Alicia Frye, epidemiologist in the CDC's flu division, [said in a prepared statement](#) that “at this time we don't have any information that should raise concerns for the general population.”

If the best drugs medical authorities have will soon not work against H1N1, perhaps the public should be concerned.

Meanwhile the European Center for Disease Control and Prevention has announced that swine flu deaths in Europe [are doubling every two weeks](#).

Swine flu deaths in Europe are doubling every two weeks? Perhaps the mainstream media should start paying attention to this.

All of this is happening at a time when environmental extremists are pushing the “overpopulation” myth harder than ever. In fact, the United Nations Population Fund has just released its annual State of the World Population Report [in which it openly calls for reducing world population growth as a way to combat climate change](#). The reality is

that if a deadly H1N1 mutation did kill tens of millions, many very sick environmental extremists would actually applaud. Increasingly, many in the environmental community are viewing humanity itself as a “disease” that needs to be eradicated for the good of the earth.

### **Low Vitamin D Levels Linked To Proliferation of H1N1**

Prevent Disease--November 16, 2009--According to a recent study, as many as 77 percent of all Americans may be deficient in the vitamin essential for bone health and which may prevent H1N1 (Swine Flu) and seasonal flu, wheezing, winter-related eczema, upper respiratory infections and may help prevent cancer, autoimmune diseases such as multiple sclerosis, Type 1 diabetes, certain infectious diseases, myocardial infarctions – heart attacks – and many other serious diseases.

When subgroups of the population are considered, depending on which of the many reasonable definitions of deficiency are accepted, the picture is even more ominous. For example, an important new study from Children's Hospital in Boston found that as many as 80 percent of Hispanic children and 92 percent of black children.

We're talking about vitamin D, also called the sunshine vitamin and often considered the nutrient of the year, if not the decade. Why, in the land of plenty and, now, also in the land of over-consumption, overweight and obesity, can there be an epidemic of a vitamin D deficiency or any other nutrient? The reasons may not be fully understood, but the picture is still clear: Over time, we have obtained most of our vitamin D from the sun. When ultraviolet B rays hit the skin they cause the formation of vitamin D. But, in an age of sunscreens and well-placed fear of skin cancer, we tend to either stay out of the sun or use a sunscreen to shield us from its rays, including the ultraviolet B ray.

Even if you stayed in the sun all day in some locations, you would not get enough vitamin D. For example, north of Philadelphia, between November and March, the sun's rays are not strong enough to precipitate the formation of vitamin D. And, during early morning and late afternoon, the sun's rays are not strong enough to generate vitamin D. That's a big part of the picture, as

authorities find that exposure to the sun is the main determinant of vitamin D in humans. This leads us to the next source of vitamin D — our food. Some dairy products, such as milk, are fortified with vitamin D, but we tend to avoid dairy products due to their cholesterol and saturated fat content. Other sources are fatty fish such as salmon, tuna, mackerel, and herring. Still other sources are fortified cereal and other foods such as orange juice, now, often fortified both with vitamin D and calcium. But, most people don't eat enough of these foods to get enough vitamin D. So, that leaves supplementation with multi-vitamins that include D, combination calcium and vitamin D pills, or vitamin D stand-alones.

There may be another reason for the epidemic – the epidemic of the overweight and obese, who cannot process vitamin D efficiently and are, consequently, more likely to be vitamin D deficient. One final reason for identifying the epidemic is better testing methods for vitamin D. There is a simple blood test now used to determine vitamin D status. Still another reason for the D epidemic is the aging of the population, as older people — even the middle-aged — are more likely to have D deficiency.

There are other risk factors for a D deficiency, but they probably don't play a big role in the growing number of people with that deficiency. Consumer Reports catalogued the following risk factors: “Being dark-skinned, middle-aged, or overweight; having a history of gastric-bypass surgery or a condition that interferes with the ability to absorb nutrients from food, such as celiac disease; having a history of kidney or liver disease, multiple sclerosis, osteoporosis, or thyroid problems; taking medications that reduce blood levels of vitamin D...” (Consumer Reports on Health, Nov. 2009).

## Hindu sacrifice of 250,000 animals begins

**Gallery: Hindu sacrifice ceremony starts**

[guardian.co.uk](#), Tuesday 24 November 2009 13.11 GMT The world's biggest animal sacrifice began in [Nepal](#) today with the killing of the first of more than 250,000 [animals](#) as part of a Hindu festival in the village of Bariyapur, near the border with India.

The event, which happens every five years, began [with the decapitation of thousands of buffalo](#), killed in honour of Gadhimai, a Hindu goddess of power.

With up to a million worshippers on the roads near the festival grounds, this year's fair seems more popular than ever, despite vocal protests from animals rights groups who have called for it to be banned. "It is the traditional way, " explained 45-year old Manoj Shah, a Nepali driver who has been attending the event since he was six, "If we want anything, and we come here with an offering to the goddess, within five years all our dreams will be fulfilled." **Comment: Based on the destitute condition millions of Hindu's live in everyday and have been for hundreds of years I don't think the last statement is very accurate or working out too well for them.**

Crowds thronged the roads and camped out in the open, wrapped in blankets against the cool mist. The festivities included a ferris wheel, fortune-telling robots and stalls broadcasting music and offering tea and sugary snacks.

As dawn broke, the fair officially opened with the **sacrifice of two rats, two pigeons, a pig, a lamb and a rooster in the main temple**, to cheers of "Long live Gadhimai" from spectators pushing against each other for a better view.

In the main event, 250 appointed residents with **traditional kukri knives began their task of decapitating more than 10,000 buffalo** in a dusty enclosure guarded by high walls and armed police.

Frightened calves galloped around in vain as the men, wearing red bandanas and armbands, pursued them and chopped off their heads. Banned from entering the animal pen, hundreds of visitors scrambled up the three-metre walls to catch a glimpse of the carnage.

The dead beasts will be sold to companies who will profit from the sale of the meat, bones and hide. Organisers will funnel the proceeds into development of the area, including the temple upkeep.

Chandan Dev Chaudhary, a Hindu priest, said he was pleased with the festival's high turnout and insisted tradition had to be kept. "The goddess needs blood," he said. "Then that person can make his wishes come true."

## **BREAKING NEWS: North Korean Christians: 'Children Die On Streets'**

PYONGYANG/AMSTERDAM ([Worthy News](#))-- A massive famine has broken out in their autocratic-ruled nation with many children "dying" while security forces send malnourished people to labor camps for allegedly refusing to join the "100-Day Battle."

"In the province Hwanghae it is again normal to see dead children lying on the streets," local Christians added in statements distributed by Open Doors, a Netherlands-based group supporting persecuted Christians in North Korea and other countries.

North Korean Christians blamed a nation-wide production-drive imposed by the regime of the country's leader Kim Jong-il, known as the "100-Day Battle", for the apparently worst famine in years.

"The people don't get the chance to keep themselves alive," Christians said in comments obtained by Worthy News and its partner agency BosNewsLife. Those seen as not working for the country's interests are immediately sent to labor camps, where inmates have been tortured, Christians said.

The new '100-Day Battle', will take the total length of the mobilization period up to the end of the year, and possibly even into early 2010, pro-North Korean media reported.

The current famine is becoming similar to the famine of the 1990s when at least an estimated one million people died of starvation, suggested Open Doors spokesman Jan Vermeer. Some estimates speak of "millions" of people.

"There are whole groups of children roaming through the country. If they are detained by police, they are brought to overfull orphanages where they die. To keep themselves alive, North Koreans are trading at night at illegal markets. The next day they have to report themselves again at their [state] working places," Vermeer added.

## **The Illustrated Man: How LED Tattoos Could Change The Face Of Humanity (And Herald The Arrival Of Antichrist)**

In Ray Bradbury's book, *The Illustrated Man* (the man of the title) is covered with moving, shifting tattoos. If you look at them, they will tell you a story. New LED tattoos from the University of Pennsylvania could make the *Illustrated Man* real. Researchers there are developing silk and silicon implantable devices which sit under the skin like a tattoo. Already implanted into mice, these tattoos could carry LEDs, turning the wearer's skin into a screen. The silk substrate onto which the chips are mounted eventually dissolve away inside the body, leaving just the electronics behind. The silicon chips are around the length of a small grain of rice — about one millimeter, and just 250 nanometers thick, and the sheet of silk will keep them in place, moulding to the shape of the skin when saline is added. These displays could be hooked up to any kind of electronic device, also inside the body. Medical uses are being explored, from blood-sugar sensors that show their readouts on the skin itself to neurodevices that tie into the body's nervous system — hooking chip to particular nerves to control a prosthetic hand, for example. Chips are already used inside bodies, most notably the tiny RFID tags injected into pets...

## **Cell Phones & Wireless Hazards**

**Coast to Coast--George Noory**--Appearing during all 4 hours of Tuesday's show, researcher William Thomas talked about the hazardous health effects of cell phones and wireless devices, as well dangers associated with chemtrails and weather modification. In fact, emissions from Project HAARP were used during Hurricane Katrina to steer it away from facilities in Texas, he detailed.

We have also been told that the FDIC is lying about the banks in trouble. The number in eminent danger are not 552, but a massive 2,035. The cost of bailing these banks out would be \$800 billion to \$1 trillion. That means 2,500 could be closed in 2010. Now get this, the FDIC is going to be collapsed before the end of 2010, which means no more deposit insurance. This follows the 9/18/09 end of government guarantees on money market funds. Both will force deposits into US government bonds and agency bonds in an attempt to save the system. This will strip small and medium-sized banks and force them into shutting down or being absorbed. ## **Codex Alimentarius: Genocide Will Commence December 31, 2009**

More and more people are becoming concerned about the shady, secretive organization that is Codex Alimentarius - the thinly-veiled propaganda arm of global conglomerates that does everything it can to control and limit individual options to maintain or increase health.

Codex alimentarius is one of the major bodies behind the effort to limit access to nutritional products and information. Its motivation is not rocket science and neither is the source of its funding - money that somehow expected to return a profit to its members. Most of the information available regarding codex alimentarius refers to its role in the USA, but it is not a US-specific body. Far from it, Codex has wiggled its dirty little tentacles into just about every national or international body concerned with public health. Posing as a benefactor, it then uses its significant financial and political clout to do its masters bidding.

Behind the Codex Alimentarius Commission is the **United Nations and the World Health Organization** working in conjunction with the multinational pharmaceutical cartel and international banks. Its initial efforts in the US with the FDA were defeated, so it found another ally in the FTC. Now Codex, with the FTC and the pharmaceutical cartel behind it, it threatens to become a trade issue, using the campaign of Operation Cure-All to advance its goals.

Codex began in 1893 when the Austria-Hungarian empire decided it needed a specific set of guidelines by which the courts could rule on cases dealing with food. This regulatory set of mandates became known as Codex Alimentarius and was effectively implemented until the fall of the empire in 1918. The United Nations (UN) met in 1962 and decided that Codex should be re-implemented worldwide **in order to protect health of the consumers**. Two-thirds of funding for Codex emanates from the Food and Agriculture Organization (FAO) while the other third comes from the World Health Organization (WHO).

Codex is the enemy of everyone except those who will profit from it, according to Dr. Rima Laibow. She points to its association with those who committed crimes during the Nazi regime. At the end of World War II, the Nuremberg tribunal judged Nazis who had committed horrendous crimes against humanity and sentenced them to prison terms. One of those found guilty was the president of the megalithic corporation I.G. Farben, Hermann Schmitz. His company was the largest chemical manufacturing enterprise in the world, and had extraordinary political and economic power and influence with the Hitlerian Nazi state. Farben produced the gas used in the Nazi gas chambers, and the steel for the railroads built to transport people to their deaths.

**While serving his prison term, Schmitz looked for an alternative to brute force for controlling people and realized that people could be controlled through their food supply. When he got out of prison, he went to his friends at the United Nations (UN) and laid out a plan to take over the control of food worldwide. A trade**

**commission called Codex Alimentarius (Latin for food code) was re-created under the guise of it being a consumer protection commission. But Codex was never in the business of protecting people. It has always been about money and profits at the expense of people.**

The purpose, so they claimed, is to 'harmonize' regulations for dietary supplements worldwide and set international safety standards for the purposes of increased trade. In 2002, the FAO and WHO had serious concerns about the direction of Codex and hired an external consultant to determine its performance since 1962 and to designate which direction to take the trade organization. The consultant concluded that Codex should be immediately scrapped and eliminated. It was at this time that big industry realized the full monetary potential of this organization and exerted its powerful influence. The updated outcome was a toned down report asking Codex to address 20 various concerns within the organization.

Since 2002, the Codex Alimentarius Commission has covertly surrendered its role as an international public health and consumer protection organization. **Pharmaceutical interests stepped in and began exerting their influence. Instead of focusing on food safety, Codex is using its power to promote worldwide restrictions on vitamins and food supplements, severely limiting their availability and dosages. Under the helm of big industry, the sole surreptitious purpose of the new codex is to increase profits for the global corporate juggernauts while controlling the world through food. The implicit understanding of their philosophy is that if you control food, you control the world.**

The same institutions that have been set in place to safeguard the public are the very ones who foist unfair trade practices and unsafe foods upon humanity. This is to bring about international 'harmonization.' While global harmony sounds benign, is that the real purpose of this plan? While the stated goal of Codex is to establish unilateral regulations for dietary supplements in every country, **the actual goal is to outlaw health products and information on vitamins and dietary supplements, except those under their direct control. These regulations would supersede domestic laws of every country without the voice of its citizens.**

There are 180 member countries, including such notables as Canada, the USA, every member state of the EU, Switzerland, Israel, Saudi Arabia, South Africa, China, Japan and Australia which have already signed agreements pledging total harmonization of their laws including food and drug laws to these international standards in the future.

Why is it Africans are starving when their governments ascribe to Codex Alimentarius? They are starving because their food is in Western shops for sale and not their own markets. Why are we drinking wines from Africa when those grapes could be dried into raisins and distributed to feed the children of Africa? Many Africans are starving because availability of indigenous hardy plant seeds is reduced and the prices of quality indigenous strains of seeds inflated. Farmers in Africa and all over the non-western world are finding that GM and western plant seeds will not grow properly or at all,

particularly when using the traditional farming methods in these areas. Crop failure equals starvation in many agrarian societies and GM crops have been a total failure for many poor farmers. The bottom line is they are starving because both governments and Codex Alimentarius are corrupt and serve not the public interest but the interest of the large multinational corporations, like [Monsanto](#).

In the Western countries the influence of Codex Alimentarius and its corporate cronies is just as pervasive. In the USA more and more restrictive food laws are being passed as I write. A new bill introduced in the house of representatives, H.R. 875: Food Safety Modernization Act of 2009, has ominous implications for organic farmers. It also threatens farmers' ability to collect and store their own seeds as they have been doing for centuries. In addition, the American government's refusal to label products containing GM foods means that any food product sold or exported from the USA can potentially contain GM ingredients.

You may be exposing yourself to [GM ingredients](#) even when buying organic products. A recent study done by Professors Mark Partridge and Denis Murphy, at Glamorgan University in Wales, detected traces of GM ingredients in 10 of the 25 organic food samples tested. Professor Murphy stated, "We have recently observed that many soya products now carry 'GM free' or 'organic' labels, both of which imply an absence of GM ingredients in these foods. However, most of the soya now produced in the world comes from GM varieties." **Comment: Soy is Poison**

Plants in non-GM crops are having their genetics affected by neighboring GM fields. Wind and insect borne cross-pollination is threatening many of the corn species in Mexico. GM pollen has also affected at least one man's honey crop in Germany, causing him to dispose of his harvest and relocate his bees so they would not have access to GM plants.

A wide variety of livestock are fed GM grains and then people eat the eggs, milk products and meat from these animals. If the grain does not need to be labeled GM, how can you be certain you are eating eggs, dairy and meat that are organic?

**On December 31, 2009, What Will Codex Bring To All Member Countries of the World Trade Organization (WTO)?**

**Keep in mind, that according to the projections of the WHO and the FAO, a minimum of 3 billion people will die from the Codex mandated vitamin and mineral guideline alone. Here are just a few of the guidelines Codex will implement:**

- Dietary supplements could not be sold for preventive (prophylactic) or therapeutic use.
- All nutrients (vitamins and minerals) that have any positive health impact on the body are to be considered toxins/poisons and are to be removed from all food because Codex prohibits the use of nutrients to "prevent, treat or cure any condition or disease"
- Potencies would be limited to extremely low dosages. Only the drug companies and the big phytopharmaceutical companies would have the right to produce and sell the higher potency products (at inflated prices).
- All advice on nutrition (including written online or journal articles or oral advice to a friend, family member or anyone) will be illegal.
- The reintroduction of deadly and carcinogenic organic pesticides that in 1991, 176 countries (including the U.S.) have banned worldwide including 7 of the 12 worst at the Stockholm Convention on Persistent Organic Pesticides (e.g., Hexachlorobenzene, Toxaphene, and Aldrin) will be allowed back into food at elevated levels. All together, Codex allows over 3,275 different pesticides, including those that are suspected carcinogens or endocrine disrupters. There is no consideration of the long-term effects of exposure to mixtures of pesticide residues in food.
- Prescriptions would be required for anything above the extremely low doses allowed (such as 35 mg. on niacin).
- Common foods such as garlic and peppermint would be classified as drugs or a third category (neither food nor drugs) that only big pharmaceutical companies could regulate and sell. Any food with any therapeutic effect can be considered a drug, even benign everyday substances like water.
- Mandatory use of growth hormones and antibiotics on all food herds, fish and flocks.
- Nutrients allowed will be limited to a Positive List developed by Codex which will include such beneficial nutrients like Fluoride (3.8 mg daily) developed from environmental waste. All other nutrients will be prohibited nationally and internationally to all Codex-compliant countries.
- All food (including organic) is to be irradiated, removing all toxic nutrients from food (unless eaten locally and raw).
- Codex regulations for dietary supplements would become binding (escape clauses would be eliminated).
- All new dietary supplements would be banned unless they go through Codex testing and approval.
- Genetically modified food would be sold worldwide without labeling.

Monsanto, a member of Codex, will benefit greatly as production of [genetically modified](#) (GM) foods are stepped up and more GM plants are given the green light. Terminator seeds will be approved for international trade. GM food animals will also be on the way.

Codex poses a significant threat to the food supply, according to Dr. Robert Verkerk, founder and director of the Alliance for Natural Health. About 300 dangerous food additives that are mainly synthetic will be allowed under Codex, including aspartame, BHA, BHT, potassium bromate, tartrazine, and more. Dr. Verkerk is particularly concerned that no consideration has been given to potential risks associated with long-term exposure to mixtures of additives.

According to John Hammell, a legislative advocate and the founder of International Advocates for Health Freedom (IAHF), here is what we have to look forward to:

"If Codex Alimentarius has its way, then herbs, vitamins, minerals, homeopathic remedies, amino acids and other natural remedies you have taken for granted most of your life will be gone. The name of the game for Codex Alimentarius is to **shift all remedies into the prescription category so they can be controlled exclusively by the medical monopoly and its bosses, the major pharmaceutical firms.**

Predictably, this scenario has been denied by both the Canadian Health Food Association and the Health Protection Branch of Canada (HPB).

The Codex Alimentarius proposals already exist as law in Norway and Germany where the entire health food industry has literally been taken over by the drug companies. In these countries, vitamin C above 200 mg is illegal as is vitamin E above 45 IU, vitamin B1 over 2.4 mg and so on. Shering-Plough, the Norway pharmaceutical giant, now controls an Echinacea tincture, which is being sold there as an over the counter drug at grossly inflated prices. The same is true of ginkgo and many other herbs, and only one government controlled pharmacy has the right to import supplements as medicines which they can sell to health food stores, convenience stores or pharmacies."

The world's food supply is under attack due to corrupt governments and organizations like Codex Alimentarius. This is most obvious in Africa, but the signs of encroaching food control can now be seen in almost every nation on Earth.

It is now a criminal offence in parts of Europe to sell herbs as foods. An agreement called EEC6565 equates selling herbs as foods to selling other illegal drugs. Action is being taken to accelerate other European countries into 'harmonization' as well.

Paul Hellyer in his book, "The Evil Empire," states: "Codex Alimentarius is supported by international banks and multinational corporations including some in Canada, and is in reality a bill of rights for these banks and the corporations they control. It will hand over our sovereign rights concerning who may or may not invest in our countries to an unelected world organization run by big business. The treaty would make it impossible for Canadian legislators either federal or provincial to alter or improve environmental standards for fear of being sued by multinational corporations whether operating in Canada or not.

This will create a world without borders ruled by a virtual dictatorship of the world's most

powerful central banks and multinational companies. This world is an absolute certainty if we all sit on our hands and do nothing."

Matthew 16:11-12: "How is it that ye do not understand that I spake it not to you concerning bread, that ye should beware of the leaven of the **Pharisees and of the Sadducees**? Then understood they how that he bade them not beware of the leaven of bread, **but of the doctrine of the Pharisees and of the Sadducees.**"

Luke 12:1b: "...he began to say unto his disciples first of all, Beware ye of the **leaven of the Pharisees**, which is **hypocrisy.**"

Mark 8:15: "And he charged them, saying, Take heed, beware of the **leaven of the Pharisees**, and of the **leaven of Herod.**"

**II Thessalonians 2:1-17:** ¶ "Now we beseech you, brethren, **by the coming of our Lord Jesus Christ, and by our gathering together unto him,** That ye be not soon shaken in mind, or be troubled, neither by spirit, nor by word, nor by letter as from us, as that the day of Christ is at hand. **Let no man deceive you by any means: for that day shall not come, except there come a falling away first, and that man of sin be revealed, the son of perdition;** Who opposeth and exalteth himself above all that is called God, or that is worshipped; so that he as God sitteth in the temple of God, shewing himself that he is God.

Remember ye not, that, when I was yet with you, I told you these things? And now ye know what withholdeth that he might be revealed in his time. For the mystery of iniquity doth already work: only he who now letteth will let, until he be taken out of the way. And then shall that Wicked be revealed, whom the Lord shall consume with the spirit of his mouth, and shall destroy with the brightness of his coming: Even him, whose coming is after the **working of Satan with all power and signs and lying wonders,** And with all deceivableness of unrighteousness **in them that perish; because they received not the love of the truth, that they might be saved.** And for this cause **God shall send them strong delusion, that they should believe a lie: That they all might be damned who believed not the truth,** but had pleasure in unrighteousness. But we are bound to give thanks alway to God for you, brethren beloved of the Lord, because God hath from the beginning chosen you to salvation through sanctification of the Spirit and belief of the truth: Whereunto he called you by our gospel, to the obtaining of the glory of our Lord Jesus Christ. **Therefore, brethren, stand fast, and hold the traditions which ye have been taught, whether by word, or our epistle.** Now our Lord Jesus Christ himself, and God, even our Father, which hath loved us, and hath given us everlasting consolation and good hope through grace, Comfort your hearts, and stablish you in every good word and work."

**Revelation 3:13-22:** "He that hath an ear, let him hear **what the Spirit saith unto the churches.** And unto the angel of the **church of the Laodiceans** write; These things saith the Amen, the faithful and true witness, the beginning of the creation of God; I know thy works, **that thou art neither cold nor hot:** I would thou wert cold or hot. So then because thou art lukewarm, and neither cold nor hot, **I will spue thee out of my mouth. Because thou sayest, I am rich, and increased with goods, and have need of nothing; and knowest not that thou art wretched, and miserable, and poor, and blind, and naked:** I counsel thee to buy of me gold tried in the fire, that thou mayest be rich; and white raiment, that thou mayest be clothed, and that the shame of thy nakedness do not appear; and anoint thine eyes with eyesalve, that thou mayest see.

As many as I love, I rebuke and chasten: be zealous therefore, and repent. Behold, I stand at the door, and knock: if any man hear my voice, and open the door, I will come in to him, and will sup with him, and he with me. To him that overcometh will I grant to sit with me in my throne, even as I also overcame, and am set down with my Father in his throne. He that hath an ear, let him hear what the Spirit saith unto the churches."
