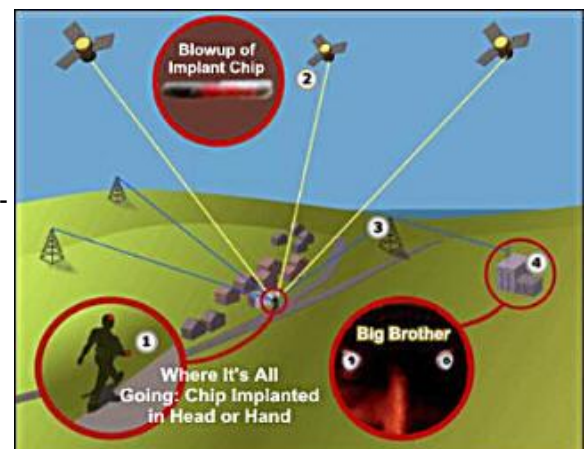

### What You Didn't Know: Government Agencies, Federations Quietly Developing Technology For Prophetic 'Global ID System', Not Just National ID

The Federation for Identity and Cross-Credentialing Systems -- a little-known group of nonprofits, government contractors, commercial entities, and government agencies -- has just unveiled a first-of-its-kind global infrastructure to support distributed, integrated identity management and cross-credentialing across organizations. The implementation combines several existing security technologies.... Already in a pilot mode at a handful of government agencies and defense contractors, the FiXs identity management initiative does not have a hard date for broad deployment, although the impediments do not appear to be technical. "The cultural gap with the public in general is still too wide," said Dr. Mike Mestrovich, president of FiXs. "I think there would have to be a public consensus to move us in that direction and I don't see that happening until at least 2009 or beyond.".... Founded in 2004 and based in Fairfax, Va., FiXs counts among its members the Department of Defense, Wells Fargo, Lockheed Martin, EDS, and several others. Modeled after secure electronic payment systems and initially implemented by the DOD's Defense Manpower Data Center (DMDC), the FiXs initiative meets the objectives set forth in the October 2006 Homeland Security Presidential Directive (HSPD-12).... the distributed design and cross-organizational model found in the FiXs implementation does offer the possibility of a future national or international identity management system that might cross borders and organizational boundaries. "The federated



approach can actually take the place of a mandated National ID system," Dr. Mestrovich stated.... Several technologies underpin this early federated identify management and cross-credentialing deployment. Among these is the Common Access Card (CAC), which contains individual information housed in a barcode and within an integrated circuit chip. The card is used to secure both physical sites and for systems access.... In this implementation, CAC is combined with the Defense Biometric Identity System (DBIDS) to accurately identify persons...

## IBM- Hollerith Machine

All governments gather information about their citizens. The Nazi regime, however, used such information to track political opponents, enforce racial policies, and, ultimately, implement mass murder. As early as 1934, various government bureaus began to compile card catalogs identifying political and racial enemies of the regime, such as Freemasons, Jews, Sinti and Roma (Gypsies), and "genetically diseased" persons. The 1939 census became the basis for a national register of Jews. That year, German census forms for the first time included explicitly racial categories. Jews were identified not only by religious affiliation, but by race as well. Within three years, the completed national register of Jews and some Jewish Mischlinge ("mixed breeds") was to become one of the sources for Nazi deportation lists. Most of those deported

perished in the Holocaust. During the 1930s and 1940s, Hollerith machines were the best data processing devices available. The Nazi regime employed thousands of people in 1933 to 1939 to record national census data onto Hollerith punch cards. The SS used the Hollerith machines during the war to monitor the large numbers of prisoners shipped in and out of concentration camps. The machines were manufactured by German Hollerith Machine Company, a subsidiary of IBM since 1922. IBM Germany did not simply sell the Reich machines and then walk away. IBM's subsidiary, with the knowledge of its New York headquarters, enthusiastically custom-designed the complex devices and specialized applications as an official corporate undertaking. Dehomag's top management was comprised of openly rabid Nazis who were arrested after the war for their Party affiliation. IBM NY always understood--from the outset in 1933--that it was courting and doing business with the upper echelon of the Nazi Party.

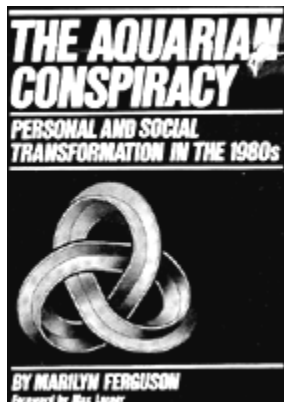

## Triquetra Symbol:

In Wiccan and Neopagan belief, the triquetra symbolizes the triple aspected goddess (maid, mother, and crone). Some Christians have protested this "appropriation" of the symbol...however, ironically enough, the original Christian fish symbol was derived from an early symbol of venus, one representing female generative organs- making the triquetra perfectly appropriate symbol for a Goddess revival. The triquetra is also considered to represent the triplicities of mind, body, and soul, as well as the three domains of earth according to Celtic legend- earth, sea, and sky.

The triquetra also appears on the television series *Charmed*, probably as a less threatening alternative to the pentacle (the preferred emblem of witches real and imaginary).

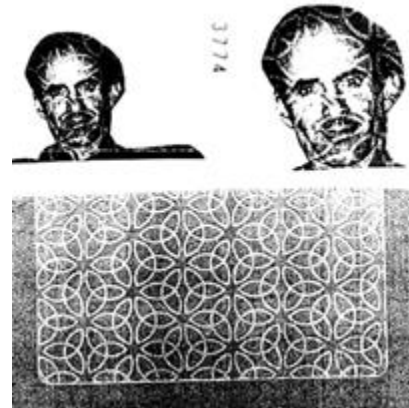


New Age leader Marilyn Ferguson, who wrote the million copy bestselling book, *The Aquarian Conspiracy*, included the **triquetra** symbol at the beginning of each chapter of her 447-page encyclopedia promoting New Age perversion. Indeed, the very cover of her book has this symbol prominently displayed against a stark, black background.

The **Triquetra logo** is found on the (NKJV) bibles. This symbol is also popular with many masonic/occultic organisations. Texe Marrs writes:- "In a startling video expose of the **New King James Version** (NKJV) of the Bible, renowned researcher and Bible scholar Gail Riplinger discusses the triquetra logo found on each issue of the NKJV. She demonstrates that the NKJV logo is strikingly reminiscent of the symbol employed by pagans and occultists for their unholy, Luciferian trinity of deities. The same unified - yet three-part logo, or symbol - is also connected with the theology of top New Age leaders, and with the dark initiation rites of high-level Freemasonry. The publisher of the NKJV, Thomas Nelson Publishing, may claim that their bible's logo represents the Holy Trinity of Father, Son, and Holy Spirit. But, if so, why is the same design found dominant in New Age and occult circles? Why does a revoltingly blasphemous Masonic ritual also employ the same symbol?"

But perhaps the ultimate use of this strange, ancient symbol of foreboding evil is found on - of all places - a high tech smart card. Gail Riplinger sent me a prototype of a new smart card just unveiled by MasterCard, Visa, Citibank, and Chase Manhattan. I was utterly shocked to find the **triquetra symbol** emblazoned repeatedly on the card. As Gail told me in her letter, "The latest smart card has the NKJV's logo all over the face of the plastic so that when a picture goes under it, you have '666' on your forehead." In other words, the image on the prototype smart card is that of a man, the bearer or holder of the card, who has this dreadful symbol splattered all over his face and head.

## UPC Bar Codes

Another **666 "mark"** that has introduced itself into our lives, without most people noticing, is the *Universal Product Code*, through it's bar system. This *bar code* identifies almost every product we buy nowadays and consists of 2 parts delimited by 3 separators called "guard bars", one at the beginning of the code, one at the end, and one between both parts. But since the "guard bars" are bars themselves, and their configuration is of 2 vertical thin bars like this '||', they are the equivalent to the symbolic representation of the number 6 within the code itself. So this fixed sequence of 3 6's, the **"mark" 666**, is present in every *UPC bar code*, which is present in almost every product we buy ***"and that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name"*** (Revelation 13:17).

Apparently, a new UPC specification including the letters 'F' and 'H' is in the making. Maybe meaning Forehead and Hand? ***"And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads:"*** (Revelation 13:16).

## Parishioners go under scan

### Bar codes enable pastor to record church attendance

Members at Iona-Hope Episcopal Church noticed something different on their name tags last week — bar codes.

The Rev. John Adler came up with the idea.

The purpose of the software is to keep better track of his flock, he said.

The church has 487 members. With that many people, those who miss church for two weeks will no longer slip through the cracks.

The program, Automated Church System Technologies, is based in Florence, S.C., and costs \$700.

"Episcopal churches don't do this very well," Adler said. "Keeping track is a really important thing."

The automated system replaces the old-fashioned method of passing clipboards in the pews to take roll, Adler said.

Bee Bentley collects the name tags after services. They are scanned and then Bentley puts them back on the board for the next week.

The bar code system scans each tag with a press of a button, and the computer sends a list of all those who attended to Adler.

The system serves two purposes: To follow up with new members; and to check up on members if they miss a few services for illness or vacation. The clergy and lay pastors can follow up with calls.

People have reacted to the system very well.

A group of women volunteering in the church's thrift shop — RoseMarie Michilak, Betty Zolto, Janice Westgate and Aleca Cobb — think it is a great idea.

Westgate helped put the badges together.

"I think it will be useful because a directory of members never has been in our system," she said. "The bar code is an excellent way to keep track of the parishioners."

Some members like Treacy Canavan and Cobb didn't notice the change in the name tag.

"I haven't heard of anything negative and we have all had a great laugh about it," Adler said.

He was kidding around with church members and told parishioners who are not in church, "We will fax this list to heaven by Monday," he said.

Although the church is primarily made up of older members, it is constructing a new facility to be completed in November or December. It will hold 435 people.

The new system will help when new members enroll.

"We will do a better job with this in the new building," Adler said.
